Such was the case at Oregon A.B.A.T.E.'s March state board meeting. Guests included five former state coordinators along with former state board members. Some of the people present that Saturday have been involved in Oregon motorcycle rights and safety since its early days. (It was almost like a mini-S.T.E.A.M. event.)

What makes these folks so important to us now is that they have organizational memory and experience of how to get things done efficiently. Brian Stovall is another early member of Oregon's motorcycle rights movement and founder of Oregon BikePAC, the legislative

action organization that can directly interact with elected officials and political activities. He has remained directly involved with A.B.A.T.E. for many years, presently as River City's chapter representative. IF you have questions about Robert's Rules of Order for running a meeting, ask Brian.

Rotten Roger is legendary among folks who have been around Oregon A.B.A.T.E. for any amount of time. Although he may seem quiet on the surface, he is passionate about what we can do and the best ways of accomplishing our activities. His gravely yet forceful voice is one that everyone in this organization should be paying heed.

Joe Laurance served as state coordinator from 2003 to 2005 when the board used to meet in a former elementary school in Junction City. What We're About

A.B.A.T.E. is a not-for-profit organization

In Oregon, *A.B.A.T.E.* stands for *A Brotherhood Against Totalitarian Enactments*, which isn't nearly as subversive as it sounds. It means that we act as legislative watchdogs to help ensure that any legislation affecting motorcyclists is fair and that elected officials are fully informed regarding motorcycle issues.

- *A.B.A.T.E.* is a not-for-profit motorcycle organization devoted to raising member and public awareness about motorcycle issues and safety through education and community involvement. We also raise money for organizations that represent motorcyclist's concerns such as *BikePAC*.

- It doesn't matter what brand of bike you ride. We are not a manufacturer-specific organization. All are welcome: bikes, trikes, on-road or off, riders, passengers, or non-riders.

- You don't have to ride a motorcycle to belong to *A.B.A.T.E.* Many of our members just enjoy being around motorcyclists. (We're just *that* wonderful.) And they feel that the social and legislative issues we're working with are important to their community.

So scan through our newspaper. If you like what you read, check out the chapter meeting listing on the back cover. Drop in on a meeting and see what we're about. You just might find a new family in *A.B.A.T.E.* And as Melinda says: "Bikers give great hugs."

A Brief History of A.B.A.T.E.

"You have to know where you've been to know where you're going!"

Easyriders magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the *National Highway Transportation Safety Administration (N.H.T.S.A.)* by joining a new national biker's rights organization called the *National Custom Cycle Association*. But because of a conflict with the acronym, the name was changed in February 1972 to *A Brotherhood Against Totalitarian Enactments (A.B.A.T.E.)*

Easyriders began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. *D.O.T. (Department of Transportation)* was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the *Huns Motorcycle Club* in Connecticut convinced his congressman, representative Stewart Mckinney, to introduce HR-3869 to end the federal authority to withhold highway funds from states without helmet requirements.

In July of 1975, Rob Razor of the *American Motorcyclist Association (A.M.A.)*, Ron

Roloff of the *M.M.A.* of California, and Ed Armstrong from *A.B.A.T.E. of Chicago* presented the house sub-committee on surface transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the *D.O.T.* because governor Ronald Reagan refused to comply with the federal helmet requirement mandate, Roloff helped convince California senator Alan Cranston to offer the language of the bill as an amendment to the *1975 Federal Highway Act*, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by president Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached congress twice over the past few years.

First to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for

bikers, and succeeded in lobbying it through congress.

So, there you have it.

The roots of *A.B.A.T.E.* and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of freedom of the road.

Social species have found that the best chance for individual survival is to be part of a group.

Fish school.

Bees swarm.

Bison herd.

Birds flock.

So what do humans do?

We tribe.

Or at least we did for the majority of our history as a species.

Tribal living means that the group survives or starves together. There may be chiefs, but their roll is arbitrator and decision-maker. They work just as much as everyone else. Every member of a tribe is involved with making their living.

Although most of us have been following a different path for the last hundred centuries, there are still pockets of humanity totally living in their traditional undisturbed tribal ways.

There are also people living tribally within our civilization, but they are easy to miss unless one knows what to look for.

Is A.B.A.T.E. a tribe?

Not as such.

Could A.B.A.T.E. be tribal?
Of course it could. But it would need a different structure and mindset.

The reason *Oregon A.B.A.T.E.* is not tribal is because not all members have a vested interest in the survival of the organization.

We have casual members who merely pay dues while others are doing all the organizational work.

In modern tribes, such as a family circus, every member wants the tribe to succeed, so everyone knows how to do a variety of jobs. If one person is unavailable, someone else steps in to do what needs to be done. Everyone from the ring master to the clowns pitches in – putting up the tent, selling tickets, performing, mucking out animal cages. Everyone contributes, from the young to the elderly, doing what they can.

Can the family circus model work for a motorcycle rights and safety organization?

We certainly have enough clowns to start a circus, but that may not be enough.

Modern tribalism for *A.B.A.T.E.* would mean education and involvement on the part of *every* member, even the clowns. (*Especially* the clowns.) Ideally, we would need to ensure that every member knows how to do every job, that *all* members are involved doing what they can.

It would mean commitment to common goals.

Most of all it would be accepting an attitude of wanting and doing everything possible to help the group survive and succeed.

One key to the success of traditional tribes is their ability to function with people as they are — imperfect humans who may, from time-to-time, behave in selfish, greedy, lazy, lustful ways. Tribal members recognize that such things *will* happen precisely because they are human, so their tribal traditions prescribe what needs to happen in order to restore balance to the tribe, allowing it to continue. Unlike our present legal system, the tribal goal is restoration of balance, not revenge or punishment.

HOW CRYPTOGRAMS WORK: The idea here is that each letter in the cryptogram represents a letter of the alphabet. ("Y" might equal "L" for instance.) Look for word patterns to help establish which word is what. (Single letters will be "I" or "A"; "the" and "and" are common three-letter words; the most widely used English letter is "E".) Spies used to send messages using cryptograms because they kept their opponents busy trying to crack the code while the spies went about their skullduggery.





I.R.S. Plan Could “Stifle Non-partisan Speech”

A new rule proposed by the U.S. Internal Revenue Service would stifle non-partisan speech and create a *de-facto* blackout period around elections, barring some citizens from communicating with elected officials stated Wayne Allard (vice president of government relations for the American Motorcyclist Association) to a congressional subcommittee on Thursday, February 27.

Allard, a former U.S. senator from Colorado, offered comments about the I.R.S. proposed guidance to tax-exempt corporations organized under Section 501(c)4 of title 26.

“The proposed rule the I.R.S. seeks to implement will stifle non-partisan speech in a manner that leads to a less informed electorate,” Allard told the subcommittee.

Since the late 1950s, the I.R.S. has allowed 501(c)4 non-profits (such as the A.M.A.) to participate in issue-based advocacy, as long as their “primary” focus remained social welfare.

Communications about legislation or public policy have never been restricted for this I.R.S. class of non-profit organization.

Among other provisions, the new I.R.S. proposal would classify any communication to the public that even mentions a political candidate within sixty days of an election as political activity.

“This creates an odd situation,” Allard told the committee. “The timing of the speech is what makes it political, not the content.”

This “*de facto* blackout period” leaves the government less accountable to the people it serves, Allard said.

The I.R.S. proposal would outlaw material “without regard to whether the public communication is intended to influence the election or some other,

non-electoral actions,” such as a vote on pending legislation.

At a time when the proportion of eligible voters casting a ballot is declining, the A.M.A. opposes any efforts to restrict access to voter registration drives, voter guides, and information related to their elected representatives’ voting records, Allard said.

Non-profits organized as 501(c)4 corporations could lose their tax-exempt status for violating the rules.

Allard offered his comments to the house oversight and government reform committee’s subcommittee on economic growth, job creation and regulatory affairs.

U.S. representative Matt Cartwright (D-Pa.), ranking member of the subcommittee, thanked Allard for his observations.

“I appreciate your points on the time restrictions,” Cartwright said. “I think that’s worth looking into. Having served on capitol hill, you know about the work that goes on here.”

Senate Bill Would Ban Federal Funding For Motorcycle-Only Checkpoints

A bi-partisan bill introduced today by U.S. senators Jeanne Shaheen (D-N.H.), Ron Johnson (R-Wis.), Kelly Ayotte (R-N.H.), and Joe Manchin (D-W.Va.) would prohibit the use of federal funds in establishing motorcycle-only checkpoints.

This is a similar bill to HR-1861, introduced in the U.S. house of representatives by U.S. representative Jim Sensenbrenner. (R-Wis.)

Specifically, the *Stop Motorcycle Checkpoint Funding Act* would restrict the secretary of transportation from granting funds to any government entity for a program to check helmet use or to create checkpoints for

an operator of a motorcycle or a passenger on a motorcycle.

“During the past two years, federal, state and local governments spent more than a half million dollars on motorcycle-only checkpoints,” said Wayne Allard. (A.M.A. vice president for government relations.) “The A.M.A. believes that money could be better spent supporting programs that conduct rider education, reduce distracted driving, and encourage motorist awareness of motorcycles.”

The A.M.A. has tracked motorcycle-only checkpoints since they were first enacted in New York.

The state of Georgia used funds from the National Highway Traffic Safety Administration in March 2011 to conduct motorcycle-only checkpoints as thousands of motorcyclists rode through the state on their way to Daytona Beach, Florida for *Bike Week*.

Another motorcycle-only checkpoint was conducted in northern Virginia during one of the nation’s most visible motorcycle rallies, *Rolling Thunder*, over the 2011 Memorial Day weekend.

Motorcycle-only checkpoints also were conducted in Utah when thousands of riders attended a world-class road-racing event.

California, Missouri, North Carolina, Illinois, New Hampshire, and Virginia have passed legislation curbing M.O.C.s.

If passed, this federal bill will ensure that riders across the country are safeguarded from ineffective and prejudicial M.O.C.s.

E.P.A. Decisions Favor E-10, Hamper E-15 Availability

New regulations unveiled March 3 by the U.S. Environmental Protection Agency include two key provisions that help protect motorcyclists and all-terrain vehicle owners from damaging their engines and possibly voiding manufacturers’ warranties, the American Motorcyclist Association reports.

The E.P.A. adopted E-10, a fuel containing up to 10 percent ethanol by volume, as its standard test fuel beginning in 2017. The pro-ethanol industry had pressed for adoption of E-15 as the standard test fuel. The A.M.A. submitted comments to the E.P.A. to oppose the E-15 standard

in June 2013.

Also, the agency refused to grant a waiver for E-15 for its vapor pressure limit for fuels. This decision means that E-15 fuels will be available in fewer locales during the warmer months, reducing the likelihood that motorcyclists and all-terrain vehicle (A.T.V.) riders could inadvertently fill their tanks with it.

“The A.M.A. opposes the increased distribution and availability of E-15 fuels,” said Wayne Allard (A.M.A.’ vice president for government relations) “And we will continue to fight against the proliferation of blender pumps at retail locations where consumers could inadvertently fill their tanks with the wrong fuel.”

The E.P.A. has approved E-15 for use in 2001-and-newer cars, light-duty trucks and medium-duty passenger vehicles.

But the fuel is not approved for use in motorcycles or A.T.V.s. And manufacturers have warned that use of E-15 in unapproved vehicles may void the warranties.

Blender pumps dispensing E-15 at service stations create a high potential for inadvertent E-15 misfueling by consumers.

The vapor pressure limit (known as Reid Vapor Pressure or R.V.P.) is intended to reduce the amount of fuel vapors escaping into the air during refueling. During the warmer months, the pressure inside underground fuel storage tanks increases, resulting in more vapors being forced out when the refueling nozzle is open.

The E.P.A. has granted a waiver of one pound per square inch for E-10 fuels, but declined to extend that waiver to E-15. That decision means that fewer service stations will be able to sell E-15 fuels between June 1 and September 15 each year.

In August 2013, the A.M.A. drew attention to this issue when a Wisconsin retail outlet was found to be selling E-15 and E-85 fuel alongside E-10. The warning labels on the blender pump did not meet E.P.A. standards and were placed on the pump in a way that may lead to confusion by consumers.

In response to a letter from Wayne Allard, Wisconsin officials pledged to require clear labels placed above the nozzles to alert consumers of the potential for misfueling.

Motorcycle Riders Foundation

Motorcycle Checkpoint Bill Introduced in U.S. Senate

The United States senate is seeking to end the unfair practice of federally funded motorcycle-only roadside checkpoints, reports the M.R.F. Senator Jeanne Shaheen (D-NH) has introduced legislation, which would further prohibit the federal government from funding mandatory motorcycle-only roadside checkpoints. Joining her as the lead republican on the bill is senator Ron Johnson. Also joining, as original co-sponsors, are senators Joe Manchin (D-WV) and Kelly Ayotte (R-NH).

The federal government funded motorcycle-only checkpoints through a \$70,000 grant in 2011.

Georgia state police conducted two mandatory motorcycle-only checkpoints. They timed the checkpoints with Daytona Florida Bike Week traffic, setting up on the southbound lanes of I-75 and I-95 on March 9th 2012, the same day Daytona Bike Week began. They did the same setup during the closing day, but set up in the northbound lanes.

The M.R.F. whole-heartedly supports this legislation to end these checkpoints and will be working with the United States senate to pass this important legislation.

“Motorcycles are an important part of New Hampshire’s identity and economy,” senator Shaheen said. *“These checkpoints unfairly target motorcycle riders who already have their vehicles inspected and registered, just like all motorists. We don’t have checkpoints that stop cars to check their tire pressure and we shouldn’t for*

motorcycles either.”

“We commend senator Shaheen for taking on this troubling and important issue,” Said Jeff Hennie. (M.R.F. vice president government relations) *“To use taxpayer dollars to inconvenience motorcyclists is a practice that should be stopped immediately and we look forward to working with both senators Shaheen and Johnson to accomplish that.”*

Some states are addressing this issue by either prohibiting any motorcycle-only checkpoints, such as Missouri, Virginia, California, and North Carolina or prohibiting the state from receiving any federal dollars like they did in New Hampshire and Illinois.

The M.R.F. urges you to contact both your U.S. senators and ask them to co-sponsor this important piece of legislation. (A bill number is expected soon.)

C.D.C. Pushes Mandatory Helmets

The M.R.F. reports that a task force that is funded by the Centers for Disease Control (C.D.C.) has issued its findings statement for motorcycle safety, with the singular solution being universal mandatory helmet requirements.

The task force, known as the Community Preventative Services Task Force, is a fifteen-member, non-federal, independent group that utilizes C.D.C. staff and resources to develop

“findings and rationale statements.” The statements make recommendations that run the gamut of topics from asthma control to work place safety.

The recommendations have included motor vehicles in the past, focusing on seat belts, child seats, and alcohol use.

This is the first time the task force has recommended anything to do with motorcycling.

Task force members are appointed by the director of the C.D.C. and serve five-year terms. All current members are doctors, with one exception.

The C.D.C. asserts that fatalities have nearly doubled since 2000 while failing to take into account the increase in registered motorcycles.

In fact, in 2000 there were 2,862 fatal crashes for 4.9 million registered motorcycles. That means in 2000 0.058% of all registered motorcycles were involved in a fatal crash.

In 2010 there were 4,502 fatalities for 8.4 million registered motorcycles, which puts just 0.053% of registered motorcycles, a slight decrease in the ratio of registered motorcycles to fatalities with 3.5 million more motorcycles on the road.

These are just some of the facts about the C.D.C. research that have been presented in all four M.R.F. conferences going back to fall of 2012.

The task force report claims that they used data from 69 studies, but only lists seven in the reference section of the finding statement. The M.R.F. is investigating this and is in talks with the task force staff about how they came to the conclusion that enacting universal mandatory helmet requirements is the only way to save lives.

“It is deeply troubling that some of our brightest researchers refuse to acknowledge rider education and awareness campaigns



as effective means to saving lives,” said Jeff Hennie. (M.R.F. vice president of government relation and public affairs)

Also of note is why the C.D.C. would only focus on head injury.

J. Lee Annett, the director of statistics and programming for the C.D.C., informed the motorcycle community that the C.D.C. does not keep information on motorcycle fatality by body part and that in motorcycle fatalities there are usually multiple injuries, with the primary body part affected difficult to determine. Yet the only solution that the C.D.C. has ever presented in its history is universal mandatory helmet requirement.

The M.R.F. worked with the house of representatives to send a letter to the C.D.C. asking them to not focus on motorcycle safety, but rather leave that to the relevant transportation agencies. The C.D.C.’s response was that they needed to be involved in all preventable injuries, because they have the newest research available.

Use the M.R.F.’s latest *Fact or Fiction* piece (which was made public at this past year’s *Bikers Inside the Beltway* event in Washington D.C. in May of 2013) to educate your legislators. The one page document has information about the C.D.C. and the misconception related to the effectiveness of helmet regulations.

Farm Bill Deters E-15

Opponents of E-15, such as motorcyclists whose vehicles are not approved to use fuel containing higher levels of ethanol, won a major victory on February 7, 2014 when president Barack Obama signed the *Agricultural Act of 2014*, with a provision removing subsidies for biofuel blending pumps.

The provision, tucked into page 735 of the 949-page farm bill, could make it more difficult for gasoline blended with higher concentrations of ethanol to find its way to rural areas, where demand for the fuel is greatest.

Blender pumps mix gasoline and ethanol for sale at gas stations, so restricting the grant money to purchase the pumps necessary to dispense E-15 would greatly deter its distribution. That, in turn, could make it more difficult for the United States to implement a program known as the *Renewable Fuel Standard*, or *R.F.S.*, which mandates increasing amounts of biofuels like corn-based ethanol be blended into the nation's fuel supply.

The Obama administration previously set a goal of installing 10,000 blender pumps to promote consumption of higher-ethanol gasoline, but currently only 59 stations across twelve states sell E-15, compared with 125,000 U.S. gasoline stations.

The win for motorcycle and A.T.V. owners, who risk damaging their machines and invalidating warranties by even inadvertently putting E-15 in their tanks, follows a November move by the U.S. *Environmental Protection Agency* to reduce for the first time the amount of ethanol required to be blended into U.S. gasoline supplies. Ironically, the *E.P.A.* proposed the cuts in part due to concerns over the lack of infrastructure, such as blender pumps needed to sell gasoline with greater concentrations of ethanol.

Motorcycle Sales Increase

[*c.o.e. warning*: Excessive statistics may cause brain numbing.]

The *Motorcycle Industry Council (M.I.C.)* has reported that annual motorcycle sales grew 1.4% in 2013. The 465,783 unit total represents a 6,485 increase from 2012.

The dual-purpose and off-road segments enjoyed the greatest percentage annual growth, with scooter sales declining in 2013.

On-highway motorcycles sales tallied 324,691 for the year, a 2% increase from 2012. The on-highway segment is by far the largest tracked by the *M.I.C.*, and it includes all street-legal bikes excepting dual-sports and scooters. It recorded a 6,485 unit year-over-year (Y.O.Y.) increase.

The smallest volume segment, dual, reported the largest Y.O.Y. percentage increase at 7.8%. The dual category includes small street-legal dual-sports as well as popular adventure bikes. The yearly total for this market was 32,979 for a 2,387 unit increase in 2013.

Off-highway motorcycle sales grew 5.7% for the year. The annual total of 73,371 represents a 3,976 unit boost from last year. The near 4,000-unit gain comes despite a slow finish in 2013, recording a Y.O.Y. decrease of 1,025 units in December.

Scooter sales, which are traditionally more volatile than bike sales, struggled to match 2012 totals. The annual tally of 34,742 was 6,363 units short of the 2012 total, a 15.5% decline.

A.T.V. sales for 2013 posted a nearly identical tally of 228,305 – a mere 0.5% increase over 2012. The quad market benefited from a strong December to push the annual tally into the black, with a 1,799 unit increase Y.O.Y. for the month.

Notably, the *M.I.C.* does not track sales for U.T.V. and side-by-side units, which have reportedly eclipsed *A.T.V.* sales in recent years.

to sell cars, trucks, or motorcycles on Sunday.

Due to archaic “blue laws” influenced by religion during the colonial period, sales are prohibited on the sabbath. But there is a trend brewing and some states are removing this outdated ban.

The latest state to allow Sunday motorcycle sales was Indiana last July, when Hoosiers joined Pennsylvania, New Jersey, New York, and Maryland in removing their Sunday sales ban.

Now Missouri's blue law is being challenged. Legislators are proposing three bills that would allow for motorcycles to be sold in Platte and Jackson counties on Sundays. The reason is because some Kansas city metro dealers feel it is not fair that they can't sell on Sundays when just across the border in the neighboring state of Kansas, dealers can.

Other states that currently prohibit the Sunday sales of motorcycles and automobiles are Colorado, Illinois, Iowa, Louisiana, Maine, Minnesota, Oklahoma, North Dakota, and Wisconsin. In Missouri, dealers are not even allowed to discuss a sale on Sunday, or face a \$300 fine and possible jail time.

Clip This Corner, Avoid A Helmet Ticket

IT IS HEREBY ADJUDGED AND DECLARED that Oregon House Bill 3422 means that as long as a motorcycle rider is wearing a protective covering on his head that has a hard outer shell, padding adjacent to and inside the outer shell and a chin-strap retention system with a sticker indicating that the motorcycle helmet meets standards established by the United States Department of Transportation the rider is in compliance with state law with respect to his helmet and a police officer may not inquire further to determine if the helmet worn meets United States Department of Transportation testing standards.

to see other drivers on the road, not bicyclists and motorcyclists.”

The anti-motorcycle/bicycle legislator from West Islip, New York made those remarks in response to a high school senior who wrote to him as a part of a government class assignment.

On January 29, seventeen-year old Matthew Cutrone wrote to Barraga requesting “some sort of bike lane or maybe even warning signs in certain areas of the county” after his mother was hit by the driver of a van that illegally turned left in front of her.

Stating that he believes that “no one who lives in our hamlet or for that matter Suffolk county should ever ride a bicycle or motorcycle,” Barraga’s callous response lit up social media and prompted a ton of angry responses, though the legislator said he’s standing by his remarks.

Washington State Riders Lobby To Turn Left On Red

Motorcyclists in Washington could turn left at an intersection if the traffic light doesn’t give them the green arrow after a complete cycle under a bill that received strong support from the senate in Olympia.

SB-5141 would change state traffic regulations to account for a problem some motorcyclists have at intersections controlled by sensors that fail to recognize them. They don’t register on the sensor so the left-turn arrow never turns green, said senator Jim Hargrove, a Hoquiam democrat who rides a motorcycle and said he’s experienced the problem first-hand.

Under the proposed legislation, a motorcyclist would have to wait through a complete cycle of lights changing for all directions before making a left-turn when clear.

The bill passed on a 46-2 vote.

The same bill passed the senate last session, but didn’t receive a final vote in the house.




