What We're About

#### A.B.A.T.E. is a not-for-profit organization

In Oregon, A.B.A.T.E. stands for A Brotherhood Against Totalitarian Enactments, which isn't nearly as subversive as it sounds. It means that we act as legislative watchdogs to help ensure that any legislation affecting motorcyclists is fair and that elected officials are fully informed regarding motorcycle issues.

- A.B.A.T.E. is a not-for-profit motorcycle organization devoted to raising member and public awareness about motorcycle issues and safety through education and community involvement. We also raise money for organizations that represent motorcyclist's concerns such as BikePAC.
- It doesn't matter what brand of bike you ride. We are not a manufacturer-specific organization. All are welcome: bikes, trikes, on-road or off, riders, passengers, or non-riders.
- You don't have to ride a motorcycle to belong to A.B.A.T.E. Many of our members just enjoy being around motorcyclists. (We're just that wonderful.) And they feel that the social and legislative issues we're working with are important to their community.

So scan through our newspaper. If you like what you read, check out the chapter meeting listing on the back cover. Drop in on a meeting and see what we're about. You just might find a new family in A.B.A.T.E. And as Melinda says: "Bikers give great hugs."

### A Brief History of A.B.A.T.E.

by Bill Bish (A.B.A.T.E. of California; executive coordinator, National Coalition of Motorcyclists)

"You have to know where you've been to know where you're going!"

Easyriders magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the National Highway Transportation Safety Administration (N.H.T.S.A.) by joining a new national biker's rights organization called the National Custom Cycle Association. But because of a conflict with the acronym, the name was changed in February 1972 to A Brotherhood Against Totalitarian Enactments. (A.B.A.T.E.)

Easyriders began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. D.O.T. (Department of Transportation) was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the Huns Motorcycle Club in Connecticut convinced his congressman, representative Stewart Mckinney, to introduce HR-3869 to end the federal authority to withhold highway funds from states without helmet

In July of 1975, Rob Rasor of the American Motorcyclist Association (A.M.A.), Ron Roloff of the M.M.A. of California, and Ed Armstrong from A.B.A.T.E. of Chicago presented the house sub-committee on surface transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the D.O.T. because governor Ronald Reagan refused to comply with the federal helmet requirement mandate, Roloff helped convince California senator Alan Cranston to offer the language of the bill as an amendment to the 1975 Federal Highway Act, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by president Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached congress twice over the past few years.

First to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through congress.

So, there you have it.

The roots of A.B.A.T.E. and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of freedom of the road.

## A.B.A.T.E. chapter reports -- Central Oregon

Greetings from Central Oregon,

Winter is upon the high desert, so riding times are rare.

If you do not like to ride in the cold, time to park it for the winter and pray for an early spring.

Remember to winterize your bike. If you have a water-cooled bike, check the level of freeze protection by testing or replacing your coolant for a level of protection greater than the coldest your bike will get.

Around Prineville, we will get some days into the negative teens and occasionally colder. (My bike has never had the luxury of heated parking area.)

If you have not recently done an oil change, it would be a good idea to do it. This will keep the nasty stuff in the used oil from attaching or attacking any of the internal parts.

Don't forget the battery. While a battery

tender is optimal, I managed to get twelve years from the factory battery by just starting it and letting it idle for about ten minutes every couple of weeks. Not all of us have nice garages with power outlets handy.\*

For those of us who will go for a ride in the cold, make sure you dress for it. Wind chill factor is a bitch.

For me, heated gloves are a necessity and thinking about a heated vest to help keep me warm.

Also watch for additional road hazards, like patches of frost where the road is shaded.

My favorite hazard is the use of deicer or gravel only in the corners and at intersections. (Can you say "surprise skills test"?)

Remember, you and the bike are one. If you get cold, you get stiff and the bike will not perform as well. Cold also makes our tires harder, resulting in less grip for cornering and braking.

This may be my last report. Someone else will be taking the reins for the chapter. I may write the one for the January issue,



but the new coordinator may want to do it.

Five years has been long enough and it is time for me to take a break.

Many thanks to all the members who served as officers with me and to all who have helped in the planning, donation gathering, staffing, and conclusion of our events. I won't try to name them all because I will forget somebody and you all deserve equal thanks. I could not have done this without you.

## N.C.O.M. Region 1 Meeting

28 October 2017

Holiday Inn - Portland Oregon

Region 1 covers Alaska, California, Hawaii, Idaho, Oregon, and Washington.

This was my first time at any N.C.O.M.

Most of the subjects discussed at this meeting were updates to the N.C.O.M. in Reno. Not sure how much of this was covered then, so some of this might be a repeat of what everyone already knows.

As far as I could tell, California, Oregon, and Washington were represented by C.o.C. (Confederation of Clubs) representatives. Oregon and Washington were represented by A.B.A.T.E. representatives. And Oregon was represented by BikePAC. There were about sixty or sixty-five people in attendance.

A.B.A.T.E. of Oregon sponsored a hospitality suite. Not knowing what to expect I brought a little bit of everything.

Friday night we had several visitors who came up from California.

There were no restaurants around the hotel, so on Saturday during lunch break we had lots of visitors. Good thing we had some sandwiches, sodas, and other snacks.

It was fun meeting people from all over the state. The room only held five or six folks comfortably, but we were able to set up a small table out in the hall so we had "overflow room".

#### **Throughout The Nation**

Richard Lester presented updates on a few current issues:

• 1998 almost sounds like yesterday, when in reality it was twenty years ago. That is when the war against the Mongols Motorcycle Club began. It's like the 100 year war that will go on and on.

The whole government idea of this case was to destroy the Mongols and to create legal precedents that could be used to destroy all motorcycle clubs.

With all trademarked clubs, the questionable area is that of ownership of the organization's logo and its possible forfeiture.



*Mongols* fighting in the court to save their patch have argued in legal documents that their logo is not a trademark such as those used by businesses, but rather represents a "collective membership mark" amounting to protected speech under the first amendment.

In the first legal battle, the court ruled that the government's individual indictments didn't justify the seizure of the collective mark owned by the club.

With this Mongol win, the government then changed strategy, naming the club as the defendant. (Rather than individuals.)

In 2015 that court case was dismissed.

In 2016 the government appealed and in June of 2017 arguments for the appeal began. The appeal overturned the dismal.

It's a continuing battle and whoever has the deepest pockets will win.

The Save the Patch fund was being

managed at the *A.I.M.* office of Richard Lester. A committee was formed between the *A.I.M.* office and representatives of the C.o.C. The fund has been moved to an account that has a C.P.A. keeping track of the account and managed by the newly formed committee.

- The next national *N.C.O.M.* conference will be 08–13 May 2018 in Mobile, Alabama. Two members of each club, chapter, or member organization are invited to be in attendance.
- The states of Washington and Maryland now have profiling regulations on the books. *N.C.O.M.* is working with federal agencies to get a resolution passed, not a regulation, to prevent profiling against motorcyclists.

#### **Waco, Texas Tragedy Update**

-- Sarge

( N.C.O.M. executive coordinator )

There has been over \$98,000 collected and donated to the families and victims of the Waco tragedy. The money is being monitored by the *Shield of Faith Motorcycle Ministry* in Texas.

In May 2015, motorcyclists were in the Waco area to attend an *N.C.O.M.* meeting. The Texas *C.o.C.* was on the calendar.

Enforcement alleged pre-existing confrontation between *Bandidos* and *Cossacks* prompted the need for the police surveillance, for the cameras and for the police to be on the rooftops.

If I got the numbers right, there were nine killed, eighteen seriously injured, 177 arrested, and 153 indicted on organized criminal activity.

Now, two years later the cases are finally coming to trial.

Defense attorneys have filed federal civil rights legal suits against Reyna, the Waco prosecutor, and Stroman. (Waco police chief at the time.) Some of the charges are that they and their surrogates didn't even try to establish probable cause when they arrested the bikers. Instead, the legal suits allege, the officials relied on generic affidavits, filled out by one police detective, that provided no specific evidence about what crime was supposedly committed by each biker. (Rubber stamped indictments.)

Reyna has been caught in several lies about his actions during this investigation and has a pattern of withholding documents from the prosecution.

Time will tell.

#### Know Your Rights During Police Encounters and Other Problems

-- Chris Slater

( A.I.M. attorney, Oregon and Washington )

Chris passed out copies of the third edition *Rider's Rights and Civil Liberties*. (It's smaller and more condensed than previous editions.)

Without going through the whole book, he pointed out the "What to do in case of a crash" section.

Know your rights: discussion about our 4th & 5th amendment rights.

#### • 4th amendment:

#### Protection against search and seizure.

The fourth amendment restricts the government from invasion of an individual's reasonable expectation of privacy. So if you are in your home having a conversation, you have an expectation of privacy. If you are on the street corner having the same conversation and within earshot of others, there is no expectation.

Enforcement know that members of the public are not taught or generally know very little about their rights and obligations. This gives investigators a decided advantage or power.

People talk when it is in their best interest to remain silent.

People consent when it might be in their best interest to refuse.

People have their rights ignored or overstepped without their knowledge.

At the scene, don't volunteer any information.

If an officer asks you, "Do you know why I stopped you?" don't say "because I had my cell phone in my hand?" He might say, "Oh, I didn't see that. I stopped you because your tail light is out."

Don't volunteer any information.

Be polite.

Be cooperative.

Don't be confrontational.

At any time you can say "I invoke my right to be silent."

As a driver, you have to show identification, vehicle registration, and proof of insurance.

As the passenger, you don't have to speak to the officer.

Oregon is a "one-party consent" state. Only one of the persons in a telephone conversation must have knowledge and give consent to a recording of the conversation.

States of Washington and California are "two-party consent" states which means all parties to the conversation must have knowledge or have given consent to a recording.

G.P.S., telephone trackers, video taping, e-mails you send out: Do you have expectation of privacy?

This area is getting more and more grey if using wi-fi in a public place, telephone use out in public, etc.

Some fourth amendment searches or seizures require a warrant. Others do not. Still others are not considered fourth amendment searches. That's why we have legal books and lawyers and judges.

#### • 5th amendment:

### No person shall be compelled to be a witness against himself.

No Miranda rights are required if the person is in a non-custodial setting. So, if you are not under arrest you have not had your rights read, so don't go talking too much.

When asked to pull over, don't try to elude the police because then whatever you did becomes a felony.

#### **Rico And The Man**

-- Sarge

( N.C.O.M. executive coordinator )

R.I.C.O. (Racketeer Influenced and Corrupt Organizations Act) is a United States federal regulation that provides for extended criminal penalties and a civil cause of action for acts performed as part of an on-going criminal organization.

*R.I.C.O.* was brought about to help enforcement fight the Mafia back in the day.

Now the government is using the *R.I.C.O.* Act to fight against motorcycle clubs.

They used *R.I.C.O.* to seize assets and attempt to close down the *Mongols* organization.

For a crime to be considered against the *R.I.C.O. Act*, it has to be treason, piracy, counterfeiting.

It must be by an enterprise, rather than an individual.

Prosecutors must establish a pattern, rather than one act.

The government can go back ten years to prove a "pattern".

*R.I.C.O.* can be used to deprive defendants of due process.

*R.I.C.O.* is an arbitrary penalty enhancer and bargaining tool.

The government's case against the *Mongols* has been on-going for several years. Knowing they have unlimited resources, government agencies keep refilling and counter-filling, hoping to dry up resources of the defendants.

#### In Conclusion

Know your rights.

Be prepared to protect your club or organization.

Protect yourself.

The police are allowed to lie to you but you are not allowed to lie to them. If you do and you get caught, it can bump up the charge to a higher penalty.

#### Reports From Member Representatives

A member rep from each state *C.o.C.* or *A.B.A.T.E.* was invited to sit at the head table to give a report. Listening to these reports, we are reminded that the states in our region are working on the same issues legislatively. And they are having the same declining members and participation as we are.

- Washington A.B.A.T.E. reported that in Washington one of the regulations they are trying to amend has to do with parallel parking. The statute reads "two wheels next to the curb" where we all know that bikes back up into the curb with only one wheel next to or touching the curb. Lots of tickets are being handed out lately.
- An *Oregon C.o.C.* representative asked "What is important to us?" By show of hands, profiling was only a small concern in Oregon; Lane splitting or filtering was important.

Some bars and businesses are still posting "No colors" signs. *C.o.C.* is working with O.L.C.C. (licensing bureau) to add no prejudice for attire.

- *Oregon BikePAC* mentioned needing to add enhanced penalty to the new responsibility regulation.
- *California C.o.C.* reported that numbers are way down. They are working on profiling and *Save the Patch*.

The regional meeting was quite informative. All of this information has been reported by our *C.o.C.* representatives who come back from these conferences. But it's nothing like being there.

I hope to have an opportunity to attend a national meeting sometime in the future.



### Federal Highway Administration Appoints Motorcyclist Advisory Council

The federal highway administration has appointed ten members to the motorcyclist advisory council, which will advise the agency director on infrastructure issues affecting motorcycle riders.

Mike Sayre (A.M.A. government relations manager for on-highway issues) has been named chair of the council.

"This is an important step toward ensuring that motorcyclists are

deeply involved in the planning and implementation of infrastructure changes and improvements and that motorcycles are considered at all stages, especially with regard to emerging technologies," said A.M.A.

president and C.E.O., Rob Dingman. "We are elated that our own Mike Sayre is chairing this group. The motorcyclist advisory council can become a powerful mechanism for promoting motorcycle safety."

#### "Zoom Zoom" Goes R.P.M. Act

It was a delightfully busy week for the long-sought-after legislation, the *Recognizing the Protection of Motorsports Act*. (Also referred to as the *R.P.M. Act*.)

As a reminder, the *R.P.M. Act* clarifies that the E.P.A. needs to keep its hands to itself when it comes to modifying your motorcycle for competition at the racetrack. They tried to suggest they had the authority to do this and though they were shut down, this bill would put that in black and white.

The legislation got attention in both the senate and the house

advancing out of a subcommittee. Here's more:

HR-350, Recognizing the Protection of Motorsports (R.P.M.) Act of 2017, authored by representative Patrick McHenry (R-NC) and committee member representative Richard Hudson (R-NC), passed the subcommittee by a vote of 13-9.

During the hearing, representative Hudson said, "This interpretation by the E.P.A. directly conflicts with the original purpose of the Clean Air Act." (The Clean Air Act is a decadesold statute that the E.P.A. has been using to push the envelope when it comes to their authority over other issues, including climate change. It's a bigger issue than just R.P.M. and many in congress would like to overhaul the original legislation completely.)

The senate also rolled up its sleeves on the *R.P.M. Act*, holding a hearing in an environment and public works subcommittee. Senator Shelly Moore Capito (R-WV) said during the hearing that the E.P.A. tried to circumvent the regulatory regime to hurt the motorcycle industry and U.S. citizens all across the country.

The M.R.F. was a signatory on a

letter that was entered into the record as a part of the senate hearing. The letter supported S–203 and urged the committee to take a vote on the bill. To see a copy of the letter, contact: **Megan@mrf.org** 

All of this recent activity bodes well for the legislation.

It's easy to forget just how many hoops one has to jump through to make it into regulation. There are hearings in the subcommittee and the full committee, then "markup" by both subcommittee and full committee. (Which is the process of editing the bill and adding amendments and making changes.) And then the biggest hurdle is vying for floor time and consideration. And remember, that's just one chamber. We have a bicameral legislature, so that same process has to happen in the opposite chamber. And if they don't pass an identical bill, the process starts once again.

It's not impossible, but it's an uphill battle and it takes determination and patience.

Washington, D.C. is a powerful city, but it moves slowly.



### **Executive and Regulatory Updates**

The M.A.C. is government at its worst. And while its purpose according to the statute is to "advise the federal highway administration on issues of concern to motorcyclists", all but one of the selected council members selected are there to represent the technical of the council, like engineering, construction, and traffic safety systems. Only one seat out of ten was designated for a national motorcycle riders' association to speak for the 8.5 million motorcyclists in the U.S. And though nine of the ten appointees have their motorcycle endorsements, their intended purpose for participation on the council is to represent the infrastructure and technical side of the conversation, not to advocate for riders. Nor do they have the authority to speak on behalf of riders at large, as would other motorcycle riders' associations at the national and regional levels.

So we continue to fight against this injustice. And you can help.

On Tuesday, 05 December, the M.A.C. will hold its first meeting.

I am attending and will be there to personally deliver and enter into the record a petition asking the secretary to add three additional seats to the M.A.C.: One for a national motorcycle riders' association that *only* represents on-street riders and two others for state or regional motorcycle riders' associations.

Will you help me send a strong message by signing the petition? Take it one step further and circulate the link to your friends, colleagues, and family. They don't need to be a rider to sign, they just need to share the *M.R.F.*'s opinion that you can't have a successful motorcycle council with only only person to speak on behalf of 8.5 million riders.

#### Wisconsin and Michigan Deliver the Goods

This week, we announced that congressman Tim Walberg (Michigan) and senator Ron Johnson

(Wisconsin) will be awarded the 2017 Motorcycle Legislator of the Year Award.

Congressman Walberg, who represents Michigan's seventh district, was one of the leading sponsors of a proposed resolution addressing the profiling of motorcyclists (HR–318) introduced in May.

Senator Johnson was the lead republican in sponsoring the senate companion to the profiling resolution. He continues to support the riders in his state through working to ensure motorcyclists' perspective on automated vehicles policies and E.P.A. emissions issues. (*R.P.M. Act*)

Though we had many solid candidates this year, we think these guys went the extra mile. We would like to honor them for that and will be looking to host a special event in conjunction with this year's *Bikers Inside the Beltway Event* in D.C.

### M.R.F. News and Announcements

A few items to report on for this week:

• On Wednesday, the *M.R.F.* hosted a webinar on political action committees. (P.A.C.s are a separate fund with the purpose of raising and spending money to elect and defeat candidates.).

We had twenty-seven attendees call in and follow along as our experts in P.A.C.-building delivered a solid overview of how to avoid jail time if you have a P.A.C. or want to start a P.A.C.

They also highlighted ways you can fund raise for the P.A.C. and things you can do if you are interested in starting your own P.A.C.

Who do we help elect? *Bikers*.

Who do help defeat? Freedom-hating non-bikers.

The *M.R.F.* P.A.C. has over \$20,000 in it, and as next year brings a new election cycle, we'll be looking to cut checks to those who support us.

• A November week bulletin had a picture of the *M.R.F.* testifying at a *N.H.T.S.A.* session on autonomous

vehicles. Though we are still waiting to see if *N.H.S.T.A.* heard us, shortly after the testimony, the *M.R.F.* was contacted by *Bloomberg's* government transportation reporter and *Car & Driver* magazine. Both were interested in what the *M.R.F.* had to say. After doing interviews with both media sources, we should reach some new audiences with our message once the articles are published.

### First Twin Peaks Case Goes To Trial In Waco

Following more than two years of examining trials, hearings, motions to recuse judges and to disqualify prosecutors, appeals court rulings and a host of speedy trial demands, the first case in the Twin Peaks melee has finally gone to trial in Waco, Texas.

Jacob Carrizal, president of the Dallas chapter of the *Bandidos*, appears before judge Matt Johnson of Waco's 54th state district court on charges of directing the activities of a criminal street gang and two counts of engaging in organized criminal activity.

Carrizal is the first to stand trial of the 154 bikers indicted in the Twin Peaks shootout that left nine bikers dead and dozens injured while attending a Saturday, 17 May 2015 meeting of the *Coalition of Clubs* and *Independents*, an affiliation of motorcycle groups.

Many questions will hopefully be answered at long last, including how much of the bloodshed was due to a biker turf war and how much resulted from police enforcement actions.

Authorities tightened security measures around the McLennan county courthouse, including a metal fence around the 115-year old building, and black curtains over the windows. Attorneys have whittled down a jury pool from nearly 150 prospective jurists to eleven men and three women, with two serving as alternates.

### Lowest U.K. Motorcycle Fatalities

In a promising message for motor-cyclists, statistics recently released by England's department for transport (D.f.T.) show that U.K. motorcycle deaths are down by 13%, the lowest figure since records began in 2006, despite an overall increase in motorcycle traffic last year and amidst the highest total of overall road deaths since 2011.

In fact, statistics from the D.f.T.'s "Reported road casualties in Great Britain: 2016 annual report" reveal that motorcyclists were the only road user to see a decrease in fatalities from 2015-16, even though they rode 2% more to cover 2.8 billion miles.

#### A.A.A. Claims Baby Boomers Higher Risk On Bikes

A new report from A.A.A. claims that the baby boomer generation that made motorcycles cool are now more likely to sustain life-threatening or fatal injuries in a crash than younger riders.

The organization, analyzing federal crash data from the national highway traffic safety administration (N.H.T.S.A.), says older riders make up a disproportionate number of motorcycle fatalities. The mortality rate for riders who are 60 or older is more than four times the overall increase in motorcycle deaths for 2015-16, says A.A.A., with motorcycle fatalities rising 5.1% while deaths among older baby boomers increased 22%.

Important to note, the increase in overall motorcycle fatalities is partially the byproduct of a corresponding rise in the number of motorcycles on the road, increasing to 8.6 million motorcycles in 2015 compared with 8.4 million in 2014, according to federal highway administration (F.H.W.A.) data cited by the organization.

### Killer U.K. Drivers To Face Life Sentences?

U.K. drivers or riders convicted of causing death by dangerous driving could face life imprisonment, if new government proposals are adopted to increase maximum penalties.

The move follows a public consultation in which 70% of respondents believed that the maximum penalty for causing

death by dangerous driving should be increased to life imprisonment, the top penalty that British courts offers.

Under the same proposal, the crime of causing death by careless driving while under the influence of alcohol or drugs will also be increased to life imprisonment. Currently, both offenses carry a maximum term of fourteen years imprisonment, while the average sentence imposed is four years.

The government also proposes the creation of a new offense of causing serious injury by careless driving, with a prison sentence up to five years, a measure supported by 90% of those surveyed.

The punishment for cases that involve mobile phones, street racing, or speeding would carry a sentence equivalent to manslaughter.

### Gas Engines Future Questioned

Some world governments are already acting to curtail or eliminate gasoline-powered engines.

Now the governor of California, Jerry Brown, has announced that he is also considering ways to ban the sale of vehicles with internal combustion engines.

During a recent public meeting on U.S. climate alliance in New York, Brown stated; "We're doing something in the face of inaction."

"Eventually, Washington, D.C. will join with us, because you can't deny science forever, you can't deny reality. And the reality is climate change is occurring."

With a zero-emissions mandate currently in place, California is one of the U.S. states that is fully committed to carrying out the objectives of the *Paris Agreement*, which is an ambitious project from the United Nations aiming

to tackle the problems caused global climate change.

Governor Brown's announcement follows a similar dictate from the British and French governments, reflecting plans to move to electrically-powered vehicles within the next few decades.

#### **Self-Driving Cars Closer**

The U.S. house of representatives unanimously approved a bipartisan bill called the *Self-Drive Act*, the first of its kind to push the unmanned market forward by putting federal regulators in charge and barring states from blocking autonomous vehicles or setting performance standards.

This legislation would supersede state-by-state rules, making it possible for autonomous testing to proceed on a level playing field across the U.S.

If it becomes statute (which still requires it to pass the senate), then it would make it possible for companies working on self-driving to field a lot more vehicles per year, as many as 100,000 autonomous test cars annually, in fact.

The proposal would make it possible for car companies such as *Ford*, *General Motors*, and others to bypass certain safety standards that currently apply to human piloted cars, including equipment and controls.

The senate has also been working on its own self-driving bill, which may cover trucking as well.

#### California Measure Ensures Traffic Lights Detect Cycles

Two-wheelers will be detected by all newly installed and replacement traffic signals throughout California, as recently passed senate bill 672 will "ensure that local transportation"

agencies will replace current trafficactuated signals during the course of regular maintenance and upgrade cycles to adopt motorcycle-and bicycle-sensitive signals."

Existing regulations due to sunset provides that, in due course of maintaining or replacing traffic control devices, local governments ensure that the systems are set at a level to that can detect cyclists and motorcycles, thus this bill indefinitely extends these provisions without a specific mandate from Sacramento.

"Since I authored the original [regulation] ten years ago, this common sense measure has proven to be effective at making our roads safer," said senator Jean Fuller (R-Bakersfield).

Signed by governor Jerry Brown on 03 October 2017, SB-672 specifies that "Upon the first placement of a trafficactuated signal or replacement of the loop detector of a traffic-actuated signal [responding to the presence of traffic detected by mechanical, visual, electrical, or other means], the traffic-actuated signal shall, to the extent feasible and in conformance with professional traffic engineering practice, be installed and maintained so as to detect [legal] bicycle or motorcycle traffic on the roadway."

Advanced by A.B.A.T.E. of California, the motorcycle rights organization says of the legislation, "Thanks to governor Brown for signing this permanent extension," stated chairman of the board Glenn Phillips, adding that "With over a million motorcyclists in our state, this legislation is imperative to protect riders on California roads."

#### **New York Would Ban Children From Riding**

Assembly bill 8700 would prohibit children under the age of twelve from riding on a motorcycle.

Introduced by assembly member

Aileen M. Gunther (D-district 100), the bill states, "No person shall operate or ride a motorcycle on a public highway, road, or street in this state with a child under the age of twelve on such motorcycle."

A-8700 has been referred to the assembly transportation committee.

#### Pennsylvania Riders Need Help For Lemon Law

A.B.A.T.E. of Pennsylvania has issued a legislative call to action regarding house bill 74, a bill introduced by representative Pam Snyder that would include motorcycles in the current Pennsylvania automobile lemon law.

HB-74 was introduced and referred to the house consumer affairs committee. On June 12 the house consumer affairs committee approved HB-74, and the measure is now facing consideration by the full house.

"Contact house of representative members and ask them to support HB—74 to include motorcycles in the state's automobile lemon law," urges the state office of A.B.A.T.E. of Pennsylvania. "You can call them, e-mail them, or visit them. But you have to do something if we are to have success in having HB—74 pass the house and be sent to the senate for their consideration."

#### **Motorcycle Thefts Rising**

The annual theft report from the national insurance crime bureau (N.I.C.B.) shows bike thefts rose 2% nationally across the U.S. in 2016, with a total of 46,467 motorcycles being reported stolen, up from 45,555 in 2015.

For the second year in a row, California is the top state for stolen bikes, where 7,506 motorcycles were reported taken. (Compared with 4,482 stolen in Florida and 3,692 in Texas, the next most troublesome territories.) Vermont had only 24 motorcycle thefts in 2016, the least amount of all the states.

New York was the most-plagued city, followed by San Diego, Las Vegas, and Los Angeles, while Los Angeles county was the top county.

The N.I.C.B. study reveals that the bulk of motorcycle thefts predictably occur during the summer months, when more bikes are on the street. August was the top month, when almost twice as many motorcycles disappeared than in December or January.

Some bikes are more popular targets than others or are simply easier to steal. A disproportionate number of Japanese models top the theft list: *Honda* (9,052 thefts), *Yamaha* (7,723), *Suzuki* (6,229), *Kawasaki* (5,221), *Harley-Davidson* (4,963).

The recovery rate for stolen bikes isn't encouraging, according to the N.I.C.B. report, with only 17,463 of the 46,467 motorcycles reported stolen in 2016 being returned to their owners, about a 40% nationwide rate of recovery. The recovery rate in Hawaii was highest at 94%, while the New York rate, at 19%, was the lowest in the nation.

By brand, *Honda* owners had about twice as good a chance of getting their bikes back than owners of *Ducatis*, which had only a 29% chance of coming home.

On a more positive note, bike thievery is down considerably: about 30%, from what it was a decade ago.

#### Philippine Government Seeks Strict Helmet Use Enforcement

The department of interior and local government (D.I.L.G.) in the Philippines is seeking to strengthen enforcement of the mandatory helmet requirement (RA–10054) nationwide.

In a memorandum issued 06 September to all governors, mayors, and other government officials, the D.I.L.G. directs local officials "to implement said [helmet requirement] act, and ensure that the provisions are strictly complied with."

Congressman Cesar V. Sarmiento directly addressed D.I.L.G. during the department's budget hearing in congress, saying he observed several motorbike riders and drivers forgetting to use their helmet, resulting in road crashes and deaths.

The subject of the memo calls for the "observance of the provisions of republic act number 10054, an act mandating all motorcycle riders to wear standard protective motorcycle helmets while driving and providing penalties therefor (sic)."

#### Clip This Corner, Avoid A Helmet Ticket

IT IS HEREBY ADJUDGED AND DECLARED that Oregon House Bill 3422 means that as long as a motorcycle rider is wearing a protective covering on his head that has a hard outer shell, padding adjacent to and inside the outer shell and a chin-strap retention system with a sticker indicating that the motorcycle helmet meets standards established by the United States Department of Transportation the rider is in compliance with state law with respect to his helmet and a police officer may not inquire further to determine if the helmet worn meets United States Department of Transportation testing standards.
