What We're About

A.B.A.T.E. is a not-for-profit organization

In Oregon, A.B.A.T.E. stands for *A Brotherhood Against Totalitarian Enactments*, which isn't nearly as subversive as it sounds. It means that we act as legislative watchdogs to help ensure that any legislation affecting motorcyclists is fair and that elected officials are fully informed regarding motorcycle issues.

We also do business as (DBA) *American Bikers Aimed Toward Education*.

• A.B.A.T.E. is a not-for-profit motorcycle organization devoted to raising member and public awareness about motorcycle issues and safety through education and community involvement. We also raise money for organizations that represent motorcyclist's concerns such as *BikePAC*.

• It doesn't matter what brand of bike you ride. We are not a manufacturer-specific organization. All are welcome: bikes, trikes, on-road or off, riders, passengers, or non-riders.

• You don't have to ride a motorcycle to belong to A.B.A.T.E. Many of our members just enjoy being around motorcyclists. (We're just that wonderful.) And they feel that the social and legislative issues we're working with are important to their community.

So scan through our newspaper. If you like what you read, check out the chapter meeting listing on the back cover. Drop in on a meeting and see what we're about. You just might find a new family in A.B.A.T.E. And as Melinda says: "Bikers give great hugs."

A Brief History of A.B.A.T.E.

"You have to know where you've been to know where you're going!"

Easyriders magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the *National Highway Transportation Safety Administration (N.H.T.S.A.)* by joining a new national biker's rights organization called the *National Custom Cycle Association*. But because of a conflict with the acronym, the name was changed in February 1972 to *A Brotherhood Against Totalitarian Enactments (A.B.A.T.E.)*

Easyriders began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. D.O.T. (Department of Transportation) was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the *Huns Motorcycle Club* in Connecticut convinced his congressman, representative Stewart McKinney, to introduce HR-3869 to end the federal authority to withhold highway funds from states without helmet requirements.

In July of 1975, Rob Razor of the *American Motorcyclist Association (A.M.A.)*, Ron Roloff of the *M.M.A. of California*, and Ed Armstrong from *A.B.A.T.E. of Chicago* presented the house sub-committee on surface transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the D.O.T. because governor Ronald Reagan refused to comply with the federal helmet requirement mandate, Roloff helped convince California senator Alan Cranston to offer the language of the bill as an amendment to the 1975 *Federal Highway Act*, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by president Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached congress twice over the past few years.

First to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through congress.

So, there you have it.

The roots of A.B.A.T.E. and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of freedom of the road.

State Coordinator

We made it to a new year and hopefully you all had a safe and happy new year's.

There are already things on the calendar for the new year for *Oregon A.B.A.T.E.* It looks good for *Fossil Campout* this year. Candy sales have been down right productive for *River City Chapter*.

For the new officers, if you have questions one resource is our on-line operations manual. Another is the officer you are replacing or the state officer of the same office. (Way down the list is me.) We are all here to help.

On a chapter level, the most important tasks needing to be done every month are:

Secretary – Being the right hand of the coordinator, take meeting notes at every meeting, maintain

copies of all chapter minutes, send a copy of current meeting minutes to the chapter coordinator, and state secretary. Send a monthly report to the state board and newspaper.

Treasurer – Keep the books up-to-date, send a copy of monthly bank statements and other required financial information to the state treasurer (Karen Tolle – you can ask her for specifics) so the state treasurer and auditor can work to do our taxes. Any chapter behind in reports for three month can lose their right to vote at state board meetings. Do not forget the monthly report at state board

State representative – This job is a communication link between chapters and the state board. They carry information and communication from the chapter to

the state and the state back to the chapter. To do this, they have to attend state board meetings every month, then accurately report back to the chapter. Otherwise your chapter has no voice, no eyes, no ears. (That equals no say or opinion in how *Oregon A.B.A.T.E.* operates.)

Membership – On a chapter level, it involves checking membership roster when received and updating records, then send corrections to the state membership person. The reason this is important is that the chapter membership person can reach people in their chapters. You know them and they know you. Monthly report at state board

Sergeant-at-arms – Maintains order, reminds members to follow rules (like *Robert's Rules of Order*) if they become disruptive,

maintains civil conversation between members. This is done in coordination with the chapter coordinator. Volunteers at state functions for security.

Coordinator – Keeps the peace, maintains an orderly flow at meetings so topics can be discussed. When necessary, provides topics to promote *A.B.A.T.E.*'s ideas and needs. Represents chapter to outside interests when carrying out *A.B.A.T.E.* mission for chapter activities. Assists in finding solutions when other officers need

I hope this next year of 2019 will be a whole lot better for *Douglas County Chapter*. There should be very good turnouts for our events.


I am proud to say that we have ten new members for our chapter. **Yay!**

River City Chapter has been selling *See's Candies* now since at least 2011, and our candy shack operation has turned into a smooth running machine.

The first year that we did it was experimental. Some of us didn't really believe that it would work. But we took the financial risk of buying a selection of products from the *See's* fundraising catalog and were surprised with a decent profit at the end.

That first year, we used the camp trailer that now serves as the gate booth for the *Fossil Campout*. Boy, was that primitive. It had no way to close the window, and we had to move the candy out every night and store it indoors, to prevent it from freezing. Richard Misener and Brian Stovall wore many layers of clothes that year, stuck it out through all kinds of weather, and sold almost all the candy.

Fast forward to 2018. We now use a trailer that the chapter remodeled and refurbished for this purpose. Many of us have been involved in one way or another with making sure we are ready to sell candy between Thanksgiving and Christmas. We have earned enough to cover the candy costs up front, no longer having to gamble on sales to pay someone's credit card.

With the support of Mike and Tim at *Urness Motors*, we have been located in the same spot every year, and return customers come looking for us there. Quite a few businesses buy their corporate gifts from us. Some customers buy *See's Candies* for their whole family. One couple bought 18 pounds of candy at once, totaling \$369. Our profit on that sale was a little more than \$100. (Around 30%.)

When I tell you that last year we spent \$11,000 on candy, you do the



math.

This project has been a gold mine for our chapter, but it has taken consistency, planning, and perseverance to get there. Now we have a rhythm going, and a team of volunteers who make it work.

We decided early on to use this money to benefit our community as well as ourselves, as *A.B.A.T.E.* members.

We adopt a family through our local charities in The Dalles. We divide up the kids' wish lists among our members who like to shop, add a



U.S. Senate Passes Motorcyclist Anti-profiling Resolution

The American Motorcyclist Association expresses its deep appreciation to the U.S. senate, which adopted a resolution Tuesday promoting awareness of motorcyclist profiling and encouraging collaboration and communication with the motorcycling community and police enforcement officials to prevent instances of profiling.

Senate resolution 154 also urges state enforcement officials to condemn motorcyclist profiling in their policies and training materials.

Senate resolutions do not have the any legal force.

“In 2015, congress wisely acted

to ban federal highway funding for motorcycle-only checkpoints, recognizing that federal funds are better spent on promoting highway safety for all vehicles and drivers,” said A.M.A. vice-president of government relations Wayne Allard. *“Now, the senate has taken a big step further to help end the discriminatory and ineffective practice of profiling motorcyclists.”*

The bipartisan resolution, sponsored by senator Ron Johnson (R-Wis.), was cosponsored by senators Tammy Baldwin (D-Wis.), Michael D. Crapo (R-Idaho), Joni Ernst (R-Iowa), Angus

King (I-Maine), Lisa Murkowski (R-Alaska), Jeanne Shaheen (D-N.H.), and Dan Sullivan (R-Alaska).

As adopted, the resolution recognizes the significant increase in motorcycle registrations during the past twenty years and points out that half of motorcyclists surveyed **believe** they have been profiled by enforcement at least once.

The resolution also acknowledges that motorcyclist profiling occurs across the nation.

Profiling means the illegal use of the fact that a person rides a motorcycle or wears motorcycle-

related apparel as a factor when enforcement officers decide to stop and question, take enforcement action, arrest or search a person or vehicle with or without a legal basis.

In January 2017, the A.M.A. board of directors adopted a formal position statement on motorcyclist profiling.

The A.M.A. continues to recommend that enforcement and highway officials focus their efforts on encouraging highway safety in ways that make America’s roads safer for everyone.

Autonomous Vehicles Hitting Motorcycles

The safety of autonomous cars remains in question, as a self-driving *Chrysler Pacifica* hit a motorcyclist on 19 October in Mountain View, California when the test driver took control of the car to avoid a vehicle that had suddenly moved into its lane.

The manufacturer claims its technology, which can “see 360 degrees in every direction,” could have avoided the incident if the car’s software had remained in control, but reports from around the country indicate that self-driving cars are struggling to handle some driving tasks.

Autonomous cars are hitting the road whether we like it or not, but the presumption that they will be safer than human drivers when it comes to avoiding crashes has so far proven less than promising.

There have been at least three reported cases of an autonomous car crashing into a motorcycle.

On 27 July 2016, a motorcyclist in Norway was seriously injured when she was rear-ended by a *Tesla model S* with its autopilot self-driving system engaged.

Additionally, on 07 December 2017, a California motorcyclist was hurt in a collision with a self-driving *Chevy Bolt* that had aborted a signaled lane change and was returning to its original lane while the rider was lane splitting past it, a maneuver that is legal in California.

Another disturbing incident occurred when an autonomous *Uber* car struck and killed a woman who was walking her bicycle across the road at night. One would think that

the car’s radar and infrared scanners would detect such an object far better than the human eye could. Indeed, the car’s on-board computer detected the obstruction in the road six seconds before impact. Unfortunately, it failed to identify what type of object she was until just 1.3 seconds before impact, at which point it was too late to avoid hitting her. Other factors, such as an inattentive human driver who was supposed to be monitoring the car’s surroundings, also contributed to the fatal crash. But a computer that fails to identify a contact for nearly five seconds should be quite disturbing to motorcyclists who may suffer from this fate as well.

Adaptive cruise control is a radar guidance system that enables a car to change its speed relative to the vehicle in front of it based on traffic conditions. A study by *R.D.W.* has determined that existing adaptive cruise control systems often do not do an adequate job of locking onto a motorcycle rather than a car. These systems seem to have difficulty detecting a motorcycle not riding in the center of its lane, which is a problem since riders often tend to occupy either the left or right tire grooves of a lane.

Another study by *Dynamic Research* shows similar results when it comes to forward collision warning systems detecting motorcycles.

Throughout the tests, forward collision warning systems failed to detect the motorcycle adequately in 40% of trials.

Similarly, 37% of simulated crashes in this test occurred because the car’s on-board detection systems didn’t

see the motorcycle, which is also the number one cause of motorcycle crashes with human drivers.

If autonomous driving systems are designed properly, developed with motorcyclists in mind rather than an afterthought, they could potentially deliver on their promise of making the roads safer for everyone. “*They could be on the lookout for motorcycles and other road hazards in all directions at all times, something even the most attentive human driver can never do,*” according to **RideApart.com**. “*The trick is to design such systems to work in this way as a core functionality. Autonomous vehicles must be able to search, evaluate, and execute the same way the Motorcycle Safety Foundation teaches all riders to.*”

U.S. Senate Seeks Full Funding For Recreational Trails

The Recreational Trails Program (R.T.P.) has aided trail construction, maintenance projects, and programs nationwide since 1991. Created through landmark surface transportation legislation, R.T.P. reflected congressional belief that federal gas taxes paid on motor fuel used in motorized non-highway recreational activities should be used to benefit those paying the tax as well as other users of recreational trails. Tens of millions of hikers and bikers, equestrians and ATVers, snowmobilers and skiers, canoeists and others now enjoy better outdoor experiences because of this action. R.T.P.’s accomplishments unite the

efforts of federal agencies, state and local governments, volunteers and recreation businesses in every state.

Now, a bipartisan effort promises to dramatically increase the benefits of R.T.P.’s proven formula with the recent introduction of S-3604, the *R.T.P. Full Funding Act of 2018* to require a study to estimate the total amount of taxes collected on non-highway recreational fuel, improve reporting on expenditures from the R.T.P., and streamline R.T.P. funding distribution to the states by reducing unnecessary paperwork.

“*Minnesota snowmobilers, hikers, ATV users, cyclists, and countless others who enjoy the outdoors rely on the Recreational Trails Program to explore our state’s natural wonders and support our local businesses,*” said U.S. senator Amy Klobuchar (D-MN), one of the bill’s sponsors. “*This bipartisan legislation will help ensure states receive all of the resources they deserve to protect and improve these trails for generations to come.*”

According to the *Coalition for Recreational Trails*, over the last 27 years the R.T.P. has funded more than 23,000 projects and has attracted hundreds of millions of dollars of matching support from other private and public sources for trails and facilitated healthy outdoor recreation, as well as badly needed economic activity in countless communities.

However, conservative estimates suggest that the R.T.P. currently receives only about one third of the

total taxes paid annually by non-highway “recreationists.” A study to determine the best available estimate of the total amount of non-highway recreational fuel taxes collected will help ensure that these federal taxes are appropriately returned to the states for R.T.P. while helping provide congress with the information it needs as it considers future infrastructure legislation.

Ohio Enacts Distracted Driving Regulation

Since the early days of motorcycling, riders have rightfully complained that car drivers don't see them. Frustrated and infuriated by the lack of respect on the road, motorcycle rights organizations across the country began lobbying for and passing regulations that added fines and penalties for inattentive drivers who cause crashes resulting in injury or death.

So-called R-O-W (right-of-way) regulations have cropped up in numerous states nationwide to punish careless or distracted drivers who carelessly violate our right-of-way, with Oregon being the most recent state to enact such a statute last June, spearheaded by the *Oregon Confederation of Clubs*.

When distracted driving entered the national consciousness more than a decade ago, the problem was mainly people who made calls or sent texts from their cell phones.

Innovations since then, such as car wi-fi and a host of new apps, have led to a boom in internet usage in vehicles that safety experts now say is contributing to a surge in highway deaths.

After steady declines over the last four decades, highway fatalities have increased to the highest levels in years. And distracted driving has been cited as the main culprit.

The national highway transportation safety administration (*N.H.T.S.A.*) claims that distracted driving has led to the biggest spike in traffic deaths in fifty years!

Now distracted driving is about to become a costlier offense on Ohio roads, as effective 29 October 2018, new regulations and penalties went into effect pertaining to what constitutes “distracted driving.” House-bill 95 broadens the description of driving distracted beyond using telecommunications or other hand-held electronic devices while driving. Officers now can cite drivers observed to be engaged in any “*activity that is not necessary for the vehicle's operation and that impairs, or reasonably would be expected to impair, the driver's ability to drive safely,*” according to the legislation.

The bill defines distracted as:

- Using a handheld electronic wireless communications device (including phones, tablets, and computers) except when it is on speakerphone or otherwise hands-free.
- Any activity that is not necessary to the operation of a vehicle and could or does impair the driver.

Governor John Kasich signed the legislation 30 July to make distracted driving a secondary offense in the state.

So, if you're pulled over for speeding or another moving violation and found to be driving while distracted, the new regulation

enhances the fine by an additional \$100 or completion of a distracted-driving safety course. A person can only be cited for distracted driving if the enforcement officer witnesses the offense while the moving violation is occurring, according to the bill.

Texting while driving has already been a secondary offense in Ohio since 2012, but HB-95, which passed the legislature with bipartisan support, applies to distracted driving in all its forms, from putting on makeup to changing the radio station.

Similar regulations are already on the books in Connecticut, Maine, Washington, West Virginia, and the District of Columbia.

The 34th Annual N.C.O.M. Convention will be held Mothers' Day weekend, 10-12 May 2019 at the *Double Tree by Hilton* in Orlando, Florida.

The largest gathering of motorcycle rights activists in the world, the N.C.O.M. convention attracts hundreds of concerned motorcyclists from across the United States to address topics of concern to all riders.

All motorcyclists are welcomed and encouraged to participate in the many meetings, seminars, and group discussions that focus on legislative efforts and litigation techniques to protect our riders' rights and preserve freedom of the road. Special seminars will be held on restoration of rights, leadership 101 and share-the-road motorcycle

safety.

Additional agenda items will cover legal and legislative issues, with special meetings for veterans affairs, women in motorcycling, clean & sober roundtable, and world of sport bikes, as well as the christian unity conference and *Confederation of Clubs* patch holders meeting.

Denmark Moves To Make Helmets Obligatory



Concerned that the current regulation is open to exploitation, Denmark could soon see a helmet requirement overhaul.

In the Scandinavian country, riders are allowed to go helmetless if they obtain a doctor's note or have a legitimate non-medical reason such as wearing a turban. However,

government ministers believe that biker gang types often threaten doctors in order to obtain the note.

According to a report by *The Local*, transport and health ministers have presented a proposal that would eliminate all exceptions. Transport minister Ole Birk Olesen said, “You can see on the streets that many are riding without a helmet,” adding that “If there really is a medical reason to not wear a helmet, those people shouldn’t ride motorcycles in the first place.”

While the ministers conceded they had no idea if false or coerced doctors notes are a major issue in Denmark, they claimed it was an assumption based on a clear hunch.

Olesen also noted that the proposed change is for riders own

good.

If the governments proposal is passed, the new rules will take effect on January first, while those with an existing doctor’s note will be allowed to continue riding helmetless until 01 July.

Police Arrest Striking Motorcycle Factory Workers During Protest

A protest march in India has resulted in police detaining nearly 1,500 motorcycle factory workers on strike. Police stopped the protest in Tamil Nadu, claiming that the strikers had not obtained the proper permits to hold a march.

Factory workers from *Royal Enfield*, *Yamaha*, and *Myoung Shin India* (a supplier of *Hyundai*

India) have been on strike against management since 24 September. Management has shunned their efforts to form unions and demand salary increases, as well as the reinstatement of workers allegedly fired for wanting to start a union.

As a result, *Yamaha*’s factory is operating at just 40% capacity, while *Royal Enfield*’s production has ceased completely, delaying the introduction of new models.

This setback will not deter the striking workers, however, telling *News 18* they intend to intensify their efforts as the companies they are striking against continue refusing to work with them. Sales people will soon join factory workers in the strike, and employees from fifty other companies in the area also plan

to join in, indicating the situation will continue to get worse before it gets better as a result of these strikes.

IT IS HEREBY ADJUDGED AND DECLARED that Oregon House Bill 3422 means that as long as a motorcycle rider is wearing a protective covering on his head that has a hard outer shell, padding adjacent to and inside the outer shell and a chin-strap retention system with a sticker indicating that the motorcycle helmet meets standards established by the United States Department of Transportation the rider is in compliance with state law with respect to his helmet and a police officer may not inquire further to determine if the helmet worn meets United States Department of Transportation testing standards.
