GOOD NEWS!

Washington, D.C. A federal regulation forcing states to require motorcycle riders to wear helmets-or risk loss of federal highway and safety money-is being repealed by Congress.

An amendment removing the helmet requiement from the Federal-Aid Highway Act of 1975 passed the Senate by a 52-37 vote. The House has approved a modified version of the bill, which now goes to conference committee.

If agreement is reached, as expected, and President Ford signs the bill into law, it will remove the threat of federal sanctions against Illinois, California and Utah, the only states without a helmet law.

Under the sanctions the federal government could have cut off \$4 million in highway safety money allocated to Illinois, and up to 10 per cent of the annual \$215 million allocated for highway construction.

The federal motorcycle helmet regulation is part of an 18-point government safety program establishing standards for highway safety. The standards cover motorcycle safety education, including training, licensing and equipment required to safeguard riders and passengers.

"The amendment to the act does not repeal existing state helmet laws", said John Fleming, legislative assistant to Sen. Alan Cranston (D-Calif.) one of the sponsors of the amendment. California was threatened with the loss of \$50 million in federal highway and safety money.

"we're just passing the helmet question back to the states where it belongs." Fleming said.

"To require states to enact mandatory motorcycle helmet laws has little to do with protecting the public against accidents caused by traffic hazards and vehicle defects," said Cranston.

"A helmet may or may not protect its wearer; but there is no evidence that a helmet alone will prevent accidents."

In 1969 the Illinois Supreme Court ruled that the state's mandatory motorcycle helmet law was unconstitutional.

Now we need to concentrate on President Ford, so that he will sign the bill into law. We must flood him with political telegrams and letters. It's now proven that our letters are effective-not all of us bothered to write-it seemed like a lot of work when there were dozens of them to write. Now, you have but one (just 1) letter-surely each and every one of is capable of one letter. WRITE IT!!!!!!!!!!!!!!!

Mr(?) Rockstads' concern has developed into an expressed desire to run us out of the Coliseum-has in fact forced us to change our previously schedualed date. As if it were not enough- the struggle we face at state and federal levels dealing with unfair m/c legislation and bureaucratic entanglements- now right here in our own back yard we are hit over the head with yet another case of big dollar money-mongers restricting motorcyclists freedoms and stiffling educational possibilities.

In several conversations with Rockstad, we have received <u>no</u> satisfaction at all- it has been all take and no give. At one point we were offered money if we would go away and forget the whole thing!--- however, when the question arose as to how to recoup the \$52.85 we had spent on printing and postage for the original date, we drew a complete blank! Thanks a lot jim!

Because of these by now familiar blackmail tactics and in agreement with the Coliseum managment, we cannot have dealer displays. In order to present the ABATE-Northwest Motorcycle Swap-Meet, we must emphasize the point of non-dealer display type participatation.

We do have spaces available and ANY individual. as such, is welcome to these facilities to display their motorcycles, motorcycle parts, and related items.

Let us not become bitter in the face of adversity but get on with the job ahead. Let's make a success of our swap-meet! MAYBE NE'LL OWN THE PORTLAND MOTORCYCLE SHOW NEXT YEAR!!!!!
