Let Those Who Ride Decide

Hey Editor,

I was very interested in your Feb. 1983 issue, especially the article "How Loaded Are You?" So I dug out my Jup caculator (what other kind is there) and arrived at the following numbers.

The New Oregon "Fifth" is 750 millilitters of 80 proff booze.

Translated to American that is 25.4 fluid ounces of 40% Alchol. My stripped, shivering cold naked body weight is a more 230 lbs.

By drawing the lines on the chart from 0.10 (just legaly drunk) to my 230 lbs. Body weight I arrived at 8½ drinks per hour. Riding Dream Ends For Couple On 10th Anniversary

It didn't surprise friends and relatives that Jim and Sandy McKillop would treat themselves to a motorcycle for their 10th anniversary.

They were an adventurous couple. They had lived on a sailboat for a couple of years and recently made a driving tour of the United States, passing up Holiday Inns for choice campsites.

The middle-aged Brandon couple could hardly wait to pick up the shiny, black 1000-cc ifonda from the dealer Monday evening. They knew another couple who owned a motorcycle and looked forward to cruising the highways on weekends with them.

Jim, a 48-year-old executive, had even been talking of joining the Golden Eagles motorcyle club, a group of recreational riders from Pinellas and Hillsborough counties.

But that dream ended in a nightmare on Interstate 275 Monday night on the couple's first outing on the bike. The motorcycle went out of control and smashed into a guardrail, throwing them down an embankment into a drainage

They were rushed to Tampa General Hospital where Sandy, a 47-year-old housewife, died at about midnight.

Following daylong surgery Tuesday, Jim . came out of the operating room in critical, but stable condition.

He is slated to go in for more surgery in a couple of days to set hones in his legs, which suffered compound fractures.

His son, James (III), and daughter-in-law, Sandy McKillop, spent the day anxiously awaiting condition reports in a hospital lounge.

"They were very close," the daughter-in-law said. "They thought alike. They laughed a lot. They were a happy couple."

Although Jim had never owned a motorcycle before, she said she was not surprised at hearing they had one.

"They have friends who ride motorcycles and it sounded like the kind of thing they would do," she said.

The other couple was riding alongside the McKillops when they had the accident, she said.

"The ride wasn't a planned thing. The way I understand it they just rode over to St. Petersburg to where they had their sailboat moored. They went to a restaurant to eat and were just riding back when they had the accident," she ;

She described her father-in-law as a strong person, but said he was so devoted to his wife she - was worried about how he would deal with her. death.

Doctors kept her death from him for several hours but he kept asking about her and they told him during the day, she said.

The son, an Orlando banker, refused to talk about his father and stepmother's "special relationship because it's private." He described them as "very close. Outgoing. Very energetic. Gregarious. They easily made friends and as a result obviously loved people."

He also owns a motorcycle, which he said he will "probably" confinue to ride despite his wife's

"We're still not sure what happened although an accident report has been written. Mechanical failure has not been ruled out," he said.

 According to a Tampa police accident report, the couple was northbound on Interstate 275 near the Orange Street entrance ramp downtown when Sandy McKillop, the passenger, apparently shifted her weight, throwing the motorcycle off

Jim McKillop, an inexperienced motorcyle driver, told the investigating officer that he overcompensated for the shift in weight, causing the motorcycle to go out of control and hit the guardrail, according to the report.

Neighbors of the McKillops in Kingstowne Apartments saw the shiny motorcycle sitting in front of their building Monday evening and wondered who it belonged to.

"I'm scared to death of those things," said next-door neighbor Lorene Hampton. "My son-inlaw rides one back and forth to work every day."

Hampton said the McKillops had only lived at their apartment at 501. Champagne Lane for about three weeks and she had only talked to them briefly.

"She was a real outgoing, friendly person. He seemed real nice, too," she said.

She said McKillop walked to work everyday but she didn't know where he worked.

On Monday, she heard his wife ask him if he wanted her to pick him up at 5 o'clock.

"He was very excited that afternoon (about getting the motorcyle)," said McKillop's boss, Emil Rackay, regional manager for Safeco Title

"Unfortunately, we were talking to him about joining a group called the Golden Eagles. He couldn't wait to go by the dealer's and pick it up. He apparently was trying it out and something went wrong."

Report blames bike accident on rider

Two-thirds of single vehicle motorcycle accidents and one-third of the multi-vehicle mishaps involving "bikes" were caused by rider error, according to a recent study by University of Southern California re-

searcher Harry Hurt.

While the report found that 51percent of all accidents, single or
multi-vehicle, were the fault of "the
other operator", it showed that in almost 40-percent of the 900 accidents
studied, a contributing factor was
that the motorcycle operator was either distracted or simply not paying
attention.

The study asks the question how many of these accidents could have been avoided if the biker had been more attentive or had chosen a more effective evasive maneuver?

It notes that the potential impact of even a moment's inattention "is ominous indeed," for the average reaction time available to the motorcyclist studied was 1.9 seconds.

Even in the Hurt Report cases where riders were paying attention they often were unable to react properly. In some cases the reaction was inappropriate. In others it was just too little too late. Most disturbing is the fact that 32-percent of the riders took no evasive action at all!

Further, the study found that it wasn't a case of inexperienced riders as those involved had been cycling for an average of three years — long enough for the riders to have exchanged many "war" stories" (How to get out of a tight situation) and become familiar with countless traffic situations.

"The riders were learning during those three years but weren't learning things that could keep them alive in a tight situation. It seems significant that only seven-percent had any formal rider training," the report states.

The Motorcycle Safety Foundation is working to increase the number of motorcycle education programs available. However, it realizes that rider education isn't the only answer to motorcycle safety. Education for the other road users is also an important element. Two years ago, MSF wrote a chapter on safe roadway sharing which was sent to all the states to include in their drivers license handbook. Twenty five of the states are either using the material already or planning to do so.

The Massachusetts Registry of Motor Vehicles said that it "will soon" be including the MSF safety phamplet in the Commonwealth's li-

censing handbook.

It points out special cycling situations of which car drivers should be aware giving motorists specific information of how cyclist handle riding conditions such as crosswinds, railroad crossings, bridge grates and highway rain grooves.



At the March 3rd meeting Diane Perter resigned as Leeal Bearetary because of her job and was replaced by Tem Pierce.


We will be serving breakfast at Fossil and are working on getting that organized. Our news will be sausage, eggs, peneakes, and seffee.





Commissioner Robin Linquist introduced a bill (HB 2696) that would make it
mandatory for ALL motorcyclists to wear a helmet. We've all been down this road
before - we managed to stop a similar bill during the last legislative session,
but it took the efforts of all of us, and this time our numbers are greater,
therefore, our chances of success in getting this bill stopped are greater,
provided ALL of us let our lawmakers in Salem know how we feel!!


Along with the helmet bill is HB 2845, which would require that all motor-cyclists carry separate Personal Injury Protection insurance when riding a motorcycle. The cost of PIP to the individual would be staggering, and seems to be a backdoor attempt to get motorcycles off the road. We need to stop this bill while it's still in committee, and the only way to do it is to bury these people in letters against these bills! Stand up and make youselves heard!

On a brighter note, here's some good news. HB 2880, the Motorcycle Safety Education Bill, is in the house transportation committee - this is our bill, rewritten to relax qualifications heeded to teach motorcycle safety and to transfer responsibility for its implementation from the Education Department to the Highway Department. Your letters IN SUPPORT of this bill can help us see this program get started after years of frustration and delay.

We have just begun to fight and the battle is going to be uphill all the way - simply put, the more of you that get out of the sidehack and start pushing, the easier our trek uphill will be. We need your support, and your letters CAN make a difference in the outcome of proposed and existing laws that effect ALL of us. Be informed! 62nd OREGON LEGISLATIVE ASSEMBLY--1983 Regular Session

House Bill 2880

Sponsored by COMMITTEE ON TRANSPORTATION (at the request of Governor's Council on Motorcycle Safety)

SUMMARY

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the essential features of the measure as introduced.

Establishes motorcycle safety program under Traffic Safety Commission. Removes motorcycle driver training programs from Superintendent of Public Instruction and schools. Creates Motorcycle Safety Subaccount to the Traffic Safety Commission Account. Transfers to created subaccount moneys from Student Driver Training Fund that are for motorcycle operator instruction. Makes fee collected on renewal of motorcycle indorsed license and on issuance of motorcycle indorsement payable to new subaccount rather than to Student Driver Training Fund.
