As the Legislative Director for the Organization for the next year, I thought it would be a good idea to submit an article for the newsletter to let people start thinking about how to go about developing an offensive legislative program for the next time the legislature meets in 1985. You can edit this letter any way you want, as long as the message gets through to the people. WE NEED TO WORK TOGETHER. I can't do it by myself, nor do I want to.

What I'm thinking is this; if we can develop an extensive offensive list of motorcycle legislation which will be aimed at putting motorcycles on a less discriminatory basis, we will all be the better for it. There is nothing I'd like better than to have 25-30 such bills ready to present to the Legislature when they get ready to meet again. If only 3 or 4 of them make it through and pass, then that's 3 or 4 we didn't have before. It will also show them that we are a force to be reckoned with, and give us experience to go at it again the next time. I've got a few ideas which I'm working on that are listed below, but I'd appreciate ideas and/or suggestions from the membership at large. Anyone with ideas/suggestions could either submit them at the State Board meetings OR send them to my P.O. Box #17640, Portland, Oregon 97217.

Before I go out on my own, I will be submitting these proposals in a final form to the State Board for approval/disapproval:

- 1) Motorcycle Registration
- 2) Motorcycle Licensing
- 3) Motorcycle Insurance
- 4) Motorcycle Equipment Regulations

STATEMENT BY GOVERNOR VIC ATIYEH

The motorcycle has been a popular sporting vehicle for many years, and continues to assume an increasingly prominent place in Oregon and America in general — that of a fuel-efficient form of everyday transportation.


There are over 90,000 motorcycles registered to use the highways in Oregon. However, the increase in motorcycle registrations has, unfortunately, been accompanied by an even greater increase in the number of accidents involving motorcycles.

Experts in motorcycle safety attribute this rise in accidents in large part to lack of proper training and inexperience on the part of the motorcyclist. This is compounded by the lack of awareness of motorcycles by many automobile and truck drivers. It is important for the entire motoring public to be constantly aware of the importance of safety in operating a motor vehicle, and motorcyclists need to wear an attitude of safety like they do other protective clothing.

Therefore, as Governor, I hereby proclaim October 15-21, 1983, as

"MOTORCYCLE SAFETY AWARENESS WEEK" in Oregon,

and urge the motoring public to recognize the need for greater public awareness of the motorcycles on our highways.

REPORT FROM THE OCTOBER 8th STATE BOARD MEETING

The big news is the implementation of our Education Bill. Squeeze (aka Dave Ruby) gave us a rundown on how the bill will be implemented and it looks like schools should be ready to start up 90 days from October 15th. At this time there is nothing that we, as ABATE members, can do to help the process, but if things go as planned, by next spring there will be coordinated programs to teach beginning and experienced riders how to ride safe on two wheels and to publicize to John Q. Public that motorcycles are here to stay and they'd better be aware of them!

Our Legislative Director, Jim Dodson from St. Johns' Chapter, is asking for suggestions for proposed legislation dealing with motorcycles. Give your suggestions to your Rep to bring to the next State Board meet.

We now have ABATE eagle pins. Your State Rep has a sample and will take orders. Chapter cost is \$5.00 each.

Melinda Morgan from Washington County has volunteered her expertise in Cable TV to help us make our own television commercials and documentaries. If you're interested, see your State Rep for her address and phone number. (See "NEW COMMITTEE FORMED" after the chapter reports - GT) Washington County also distributed ABATE fliers which can be modified for use by any chapter - see your State Rep for these also.

RUN DATES for 1984 ARE DUE BY THE FIRST OF THE YEAR! Chapters that want the same dates they had last year will have first choice for those dates. The rest will be on a first-come-first-served basis. Only runs on the calendar are State Sanctioned Runs. We set up a run calendar to avoid conflicts in dates with other chapter's runs & with State Board meetings. There will only be one event a weekend so everyone statewide can attend events all summer long. Send YOUR run date preference to the P.O. Box. Brian volunteered to make up guidelines for conducting a run - these will be distributed at the State Board meeting; your State Rep will have them.

The next State Board meeting is Nov. 12 at the Gatehouse Pizza in Eugene.

Ride Safe and Free! Barber

At the October State Board meeting I volunteered my services and ended up heading a committee - no pun intended. Public relations is a large part of being an active ABATE member; it happens on an individual level and it can happen in a group. If we pool our talent and enthusiam together we may intice a livlier membership. We might even excite ourselves!

Now, there's lots of ways to get other people's attention, but the way to reach the most people in the least amount of time is through radio and television. A non-legislative year is a good time to work on PR. I'm willing to work with members who are interested in making a few Public Service Announcements for ABATE of Oregon. Then, if we work well together I'd like to produce a series of half-hour programs on motorcycle safety and possibly even a historical documentry on ABATE of Oregon. Here is what you need to do if you're the least bit interested:

- 1) Bring it up at your chapter meeting and see if anyone else has the itch. Set up a video committee in your chapter.
- 2) Find out what cable company is nearest you. It will be in a densly populated area. Remember, that's CABLE not a television station. (A cable company carries many stations.)
- 3) Ask the cable company if they provide a PUBLIC ACCESS CHANNEL. If they say yes*, ask them how you or your committee can get trained and certified to use the equipment. They can provide training to either groups or individuals. This is NOT "school", so it won't take much time, but maiting to get trained will take anywhere from a few weeks to over six months. ACT NDW! (*IF THEY SAY NO. ASK THEM WHY NOT AND HOW YOU CAN COMPLAIN TO THE FCC!)

Ideally, all of our chapters could not only make events happen but we can give these events the additional media attention they deserve. This probably won't happen right away but there's lots of potential here. Home movies and slides are fine if you have the audience, the screen and a projector. Let's make mass media images of what we're about instead of just bitchin' about Hollywood.

I have more to say but don't want to take up any more space - if you'd like to carry on this conversation, please contact me as an interested individual or committee. All comments and questions are appreciated as we are just getting started and are quite flexible. Feel free to call me but I warn you - our 'droid may answer. Ride free & safe!

Woman sentenced for death of cyclist

A 25-year-old Portland woman was sentenced Wednesday to six months in jail for criminally negligent homicide in a March 20 drunken driving accident in which a Gresham motorcyclist was killed.

Multnomah County Circuit Judge Philip T. Abraham imposed the sentence on Laurie J. Ricks of 3385 S.E. 10th Ave. He said he was convinced Ricks drunken driving.

Abraham said drunken driving had reached epidemic proportions in the United States: He said he imposed the jail time with the hope it would deter others from drinking and driving. Under Abraham's sentencing order, Ricks will be eligible for work-release passes during her time in fall.

Ricks was convicted in September

of negligent homicide after a brief trial at which she agreed to let Abraham determine her guilt or innocence by reading police reports.

James E. Hardin, 34, was killed once Northeast Marine Drive near 134th Aveut nue when the pickup truck Ricks was driving veered over the center line, and, struck his motorcycle. According to evidence offered by the state, Ricks had a needed no further deterrence from blood alcohol level of 0.18 percent at the time of the accident, substantially above. the 0.10 percent standard then in effect. for legal drunkenness.

The standard is now 0.08 percent.

At the trial, Deputy District Attors.) ney Charles Ball said Ricks had no memory of the accident. He said one of Hardin's legs was severed in the accident and that he bled to death.

Motorcycle rally kicks off safety week

Between 500 and 1,000 bikers are expected in Salem today for a motorcycle safety rally at noon in front of the Capitol.

The rally, sponsored by the Oregon chapter of A Brotherhood Against Totalitarian Enactments (ABATE), will kick off Motorcycle

Safety Week in Oregon.

"We just want to tell people about motorcycle safety and make them aware that most motorcycle fatalities are caused by cars," said Jim Dodson, ABATE legislative director. "People are not looking."

Dodson said motorcyclists from across the state will enter Salem about 11:30 a.m. from the Interstate 5 exit at Portland Road NE and ride to the Capitol along Fairgrounds Road and Summer Street NE, with a police escort.

The rally will feature four or five speakers, Dodson said, including Gil Bellamy, administrator of the Oregon Traffic Safety Commission.

"But today we like to think of ourselves as pro-legislation, not anti-helmet," he said.

The rally was timed to coincide with the enactment date of House Bill 2880, which transfers motorcycle registration tag funds from the Department of Education to the Department of Transportation for safety education, Dodson said.

"We just wanted to show our appreciation to the state for promoting safety," he said.

We have no word about where the couple will honeymoon.







To Honor Dead

Marian Allen of Alpharetta was complaining to be about what happened when she rode in a funeral procession for a departed friend. The hearse and the cars behind were winding through Roswell.

"Nobody showed any respect," she said. "the expensive cars just whizzed on past. Even when the police escort blocked intersections to allow us to pass, the people who were stopped showed impatience.

"And not one - not ONE - car pulled over to the side of the road. I'm sad this tradition has apparently passed."

I'm sad I had forgotten this tradition. I don't know about the rest of the country, but in the South of my youth, one pulled over to the side of the road out of respect for the dearly departed, without exception.

I can recall meeting a funeral procession once when my mother was driving the family car. We knew who was the guest of honor in the hearse. It was the town bootlegger.

I talked to Jimmy Mayfield, commander of the Georgia State Patrol's Metro Traffic Enforcement Unit, about this long-passed tradition.

"I'm sure that this practice of pulling over when you met a funeral procession started simply out of respect," he said.

"But we still have a law that states when a motorist meets an emergency vehicle with a light flashing, the motorist is supposed to pull over to the right. Most funeral processions are led by police escorts with a flashing light. They should pull over, if not out of respect, then because it's the law.'

The chances of a motorist being ticketed for not pulling over upon meeting a funeral procession are slim, of course, because the only police who would likely be around to do the ticketing are the ones leading the funeral.

"And they aren't going to break off," said Cmdr. Mayfield, "to give out a ticket."

But there is the matter of My mother pulled off the road, respect. Are we too busy, in too myway.

"You're going to pull off the moments to honor, if not the dead, and for HIM?" I asked her. those left with the grief?

Then his buddies from the tavern would come out, hold him up until he got it started, then send him off on his merry weaving way. I ask you, is this the meaning of brotherhood?

And finally, to all you people standing around the grave, laughing, talking, drinking beer, don't you see what's going on here?

The man is dead! You'll never see him again! Doesn't that mean anything to you?

Which one of you will be next, cuz as sure as beer contains alchohol, there will be another funeral. And way too soon.

The only conclusions I can draw from this are a set of personal resolutions:

I will not get drunk and try to ride my bike. If one of my brothers or sisters appear to be too drunk to ride. I will do my best to prevent them from doing so.

I will be extra careful about traffic situations from now on. I will assume that everyone out there on the road is out to get me, and ride accordingly.

I will not be the next one to die. Neither, I hope, will any of you.

Thimp 'goes ape' over biker

COLUMBUS, Ohio (AP) - A 49year-old biker attacked by a 4-foottall chimpanzee who hopped on his motorcycle during a traffic jam says he was hurting too much at the time to get scared.

"I'm just glad to be alive," Gary Morrison, an ironworker with six children, said Friday from his hospital bed in Columbus.

Morrison, who lives in Roseville, Ohio, said he was riding his motorcycle along U.S. 22 south of Zanesville on Thursday afternoon when he saw cars backed up. He slowed down, thinking there had been an accident.

The chimpanzee had wandered out into the highway," said Rick Rose, a deputy with the Muskingum County sheriff's department. "That's when the motorcyclist slowed down because he couldn't believe what he was seeing."

s seeing."
The animal's trainer, Jimmy Estep, who lives in Zanesville and in Tampa, Fla., said the 14-year-old male chimp, named "Bongo," had been chained to a tree in a trailer park. Bongo, a performing chimp, rides a bike, roller skates and walks on stilts.

Rose said Bongo, who weighs 135 pounds, got excited as workers were preparing his pen for the winter and

broke his chain.

Estep, 42, who has owned Bongo for 11 years, said he has been keeping chimps for 20 years and none had ever injured strangers.

Morrison said the chimp walked out in front of his bike, forcing him to

"He came over and came toward me and jumped on the bike with me and started biting me," said Morrison, who figures the primate may have been spooked by his motorcyle hel-

He said Bongo practically pulled him from the bike and that the two tussled in the dirt.

"He got me down and started biting me heavily on my hands and leg,' Morrison sald.

He said he escaped from the chimp at one point, only to be tackled again.

"I was hurting more than I was scared," he said. "We were wallow-ing around. Blood was flying every-

Morrison said Estep finally beat the animal off with a club, five to 10 minutes after the attack began.

Morrison's hands were fractured and cut, and he had a bite on his leg, according to officials at Riverside Methodist Hospital in Columbus, where he was listed in good condition Friday.

AMA gets a 'handle' on Nevada law

The AMA's Government Relations Department has sought clarification of a Nevada law that requires motorcycle operators to keep both hands on the handlebars at all times. The request followed the appearance of a letter to the editor in Road Rider magazine from a reader whose riding partner had been ticketed for removing one hand from the handlebar to adjust his jacket.


While at first glance it may seem logical to want motorcyclists to keep a good hold on the handlebars, it is apparent that the law would have to make exceptions for necessary actions like adjusting a face shield, switching a fuel petcock to reserve and signaling turns on older motorcycles. And the law does make exceptions, but the statute is written in such vague language that an overzealous officer like the one described in the July issue of Road Rider could ticket a rider for simply adjusting his jacket.

According to Nevada Revised Statute 486.211, "The driver of a motorcycle or moped shall drive with one hand on each handlebar at all times, except when it is necessary to use or remove one hand for the safe operation of the motorcycle or moped." Wayne Teglia, director of the Department of Motor Vehicles, notes, "The practice of re-

moving one hand to manually give turn signals would be an exception for safe operation."

Because the statute is open to a wide range of interpretations—is zipping up a jacket or adjusting a radio essential to safe operation?—the AMA warns

riders living in or passing through Nevada to be wary. And Nevada motorcycling activists interested in working to have the law modified when the Legislature returns to session in 1985 are urged to contact the AMA government relations staff.



"Estimating Following Distances"

· Helmet-law protests aren't something uniquely American; England has a similiar mandate that's just as unpopular. But in England the protests take on a decidedly, well, British flair, straight out of Monty Python. Consider the case of Brian Nicholas, a man who rides around with his head wrapped in a turban. Nicholas takes advantage of a quirk in British law that exempts Hindus from having to wear an approved helmet. Cited and called into court, Nicholas-in his turbanchallenged the judge to come up with a legal definition of a Hindu. The judge, even with the help of Scotland Yard, couldn't do it and had to dismiss the case. CYCLE GUIDE

Probably the most critical and most frequent distance a mototcyclist must judge accurately is following distance. For example, if you are following a car at 20 mph your following distance should be 40 feet or more, 80 feet or more at 40 mph. Remember when you change speed, you must change your following distance accordingly. The Two-Second-Count method is a simple way to establish your minimum following distance. Do this: Pick a fixed point ahead of you; when the rear of the vehicle you are folloing passes the reference point, start counting off 2 seconds ("one thousand one-one thousand two"); when you have finished counting, the front of your motorcycle should not be beyond the reference point. reference point can be a shadow, a pavement marking, or any fixed object close to the roadway. The method will work at any speed as long as both vehicles are traveling at the same speed. The distance will automatically be greater for higher speeds and less for the lower speeds. allowing the proper distance for the speed you are traveling.




