
Barber, do you think I left anything out? I'm glad you're not always that long-winded, but when you are, I make sure everyone gets to read what you have to say.

## FEDERAL CASES

• Rep. Robert S. Walker, R-Penn., has, once again, introduced anti-motorcycle legislation in Congress. Walker's House Concurrent Resolution 82, like his Resolution 220 of 1979, calls for the formation of a presidential strike force to investigate and prosecute outlaw motorcycle gangs. Walker wants a federal strike force established in every U.S. judicial district. But, once again, Walker's proposal makes no differentiation between what he terms outlaw gangs and any other group of motorcycle riders.

You may wish to file this in your Don't Give A Hoot folder. The United States Department of Transportation has spent some more of your tax money on their research. According to figures the DOTties released to the Journal of American Insurance and may we point out there is that strange combination of fed transportation people with insurance industry dudes again - anyhow, they've determined the latest highway safety hazard is sneezing. The figures indicate that at 70 mph — and never mind the 55 speed limit; the feds don't observe it either — anyhow, at 70 mph a driver will cover some 330 yards in a dazed and/or semi-blind condition during a single sneeze. 

# LOOPHOLE BIG ENOUGH TO DRIVE A TRIKE THROUGH

British lawmakers are very concerned with the safety of beginner motorcyclists. By law, they must ride 125cc machines of restricted horsepower and display a learner ("L") plate, presumably to warn more seasoned drivers that there is a novice in their midst. The law itself is a little questionable, but it is made utterly idiotic by the fact that a Learner can ride a machine any size or displacement, provided it has three wheels. Apparently the higher-ups feel that three wheels are more stable and, thus, safer than two. This shaky reasoning allows any learner to hop on a chopped turbo CBX sidehack to pick up a few of the basics about riding. It also allows for weird creations like this jolly huge V-8-powered trike. Looks like just the thing for the new rider. The "L" plate is prominently displayed so it's all quite legal and ever so safe too.

Slipped

right past us again this year. May 30 not only was Memorial Day, it also marked the 87th anniversary of the meeting of Evylyn Thomas and Henry Wells. Seems that back in 1896 Evylyn's bicycle and Henry's Motor Wagon collided, an unfortunate occurrence which resulted in a broken leg for Evylyn. Yep, last May 30 was the 87th anniversary of the first injurious auto accident. See all the snazzy trivia you'd miss if you didn't read this column? ROAD RIDER/September 1983

Statistic indicate that seat belted motoists have even more head injuries than bikers do. Why doesn't the government demand that they wear both seat belts and helmets? The costs of hospitalization and other related costs must be overwhelming. If they're really concerned with the safety of the citizens why this oversight?

Nationwide statistics gather by the MSF (Motorcycle Safety Foundation) show that the four safest states to ride in are also non-helmet law states. The four states, in order from the safest) were lowa, Wisconsin, South Dakota and Kansas; all of which have no helmet law or none for adult riders. All four states do have an aggressive motorcycle licensing program. Draw your own conclusions.

You can file this surprising followup in your Justice For Awe file. Last December we reported a tragic and terrifying episode which took place in the Boston area. An automobile chased a motorcycle, knocked it down against a telephone pole and then the car occupants, John Griffen and his son, Michael, got out and attacked the cyclists with a tire iron. David Emanouil, 23, the father of two young daughters, died of a brain hemorrhage two hours later; the passenger, John Gilbride, a cousin of Emanouil's, was hospitalized. Police arrested the Griffens on multiple charges. Early in May their trial began and for the next couple of weeks local newspapers reported such grim details as Michael (age 19) waving a tire iron from the car window, throwing beer bottles at the cycle and its riders and yelling "You're dead. We're going to kill you!" John Gilbride, who now walks with a limp, has breathing problems, has lost his senses of taste and smell, and has lost sight in one eye and hearing in one ear, all as the result of the attack, said, "They're animals. They have two arms and two legs but they couldn't have been human...They told the police they wanted to kill us, that we had kicked their car but that's ridiculous." Michael Griffen testified that the reason the car struck the cycle (at least twice) was because the accelerator pedal had stuck. The jury deliberated for six hours, returned with verdicts for both men of guilty of murder in the second degree, guilty of assault with intent to murder, and guilty of assault by means of a dangerous weapon. The judge sentenced the pair to life imprisonment on the basis of the second degree murder conviction alone, postponed sentencing on the other two convictions until later. It is regrettable that the media coverage was limited to the New England area; it's a story which should have appeared all over ROAD RIDER the country.

## FEDERAL CASES

 Pennsylvania is considering adopting a law which has all the spirit of Nathanial Hawthorne and the Scarlet Letter. SB1561 proposes that motorists convicted of driving under the influence be issued special license plates, thereby marking them as transgressors. Standard colors for Pennsylvania plates are yellow with darkblue letters; convicted offenders would get red plates with yellow letters, the same colors that Hester Prine was forced to wear.

 Quite often something seems so obvious that no one ever bothers to check its validity, and when a study finally is made, the original premise is found to be riddled with holes. A case in point is the daytime headlight-on law for motorcycles, a statute currently on the books of 17 states. The Motorcycle Safety Foundation recently contracted Penn State University to conduct a nationwide survey of all available data concerning the headlight-on laws, and the study concluded that there were no significant merits to the headlight law. Nor, for that matter, were there any benefits found for laws requiring reflectorized helmets. In some cases these laws have been in effect for 15 years and, prior to Penn State's work, the only other study was done by the state of North Carolina. That test was inconclusive.

## Musical Helmets

State legislators in New Jersey, New York. Connecticut and Maine are studying bills that would outlaw the use of helmet-mounted speakers by motorcyclists.

The restrictions are written into bills that would prohibit the wearing of headphones by operators of motor vehicles. Proponents of the bills cited an increase in the number of traffic accidents involving joggers, pedestrians, bicyclists and roller-skaters wearing stereo-headphone sets.

## One For Us

Believe it or not, Big Brother isn't all bad. Congress has finally approved a bill that requires states to allow motorcycles to travel on their highways' car pool or ''diamond'' lanes unless states certify such use would create a safety hazard.

Car-pool lanes were originally designed to facilitate traffic flow in congested areas during peak commuting hours. Until now, car-pool-lane administrators have excluded motorcycles from using diamond lanes while giving the right to buses, van pools and car pools.

At long last, chalk up one for motorcycling.

But that's Daytona's business. Its economy is driven by big-but-brief influxes of cash from tourists, and those who suffer through it all (most profitably, I might add) need only remind themselves of that.






