Summer's here and the weather on the coast shows it. Beaver Creek is upon us - if you made it we hope you had a great time and a safe trip home!

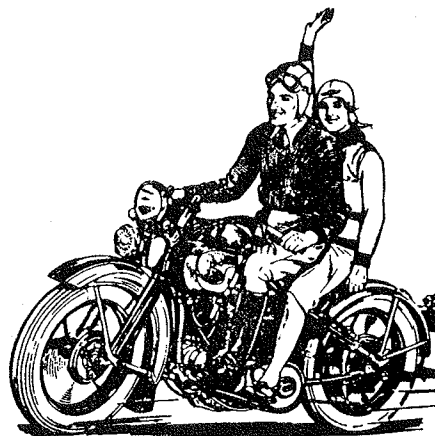
We are now preparing for our Poker Run on September 8th. For more information you can call Rich @265-7628, or Millie @ 265-7586. Flyers will be out soon.

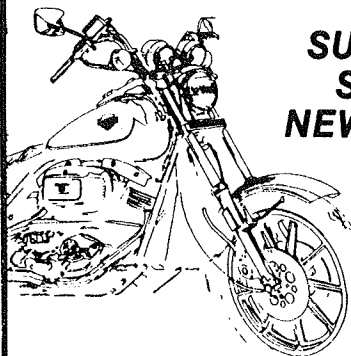

*** WEST PORTLAND CHAPTER ***

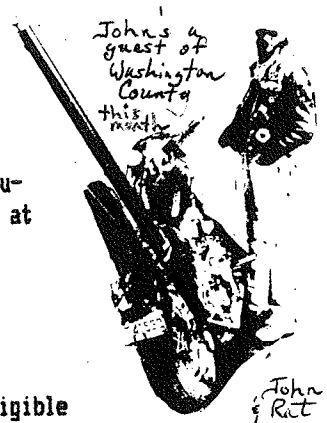

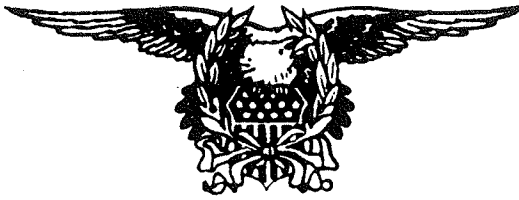

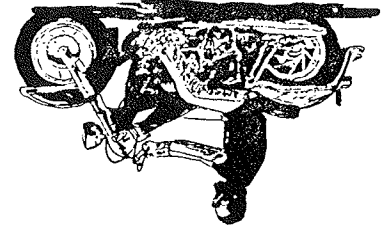
