**STATE BOARD REPORT - SEPTEMBER MEETING**

The September State Board Meeting was held at Elmer's Pancake House in Bend, and was called to order at 1:03pm. It was a total burn-out meeting, lasting almost seven hours!

Central Oregon Chapter had its charter lifted - there had been no reps at the board meetings, nor reports in the newsletter, for three months in a row, nor did they attend this meeting.

Douglas County Chapter was placed on probation for not turning in a quarterly report. Also, the first quarterly report for 1984-85 is DUE THIS MONTH!! You have to turn it in by the October Board meeting on the 13th. All chapters are going to be audited by the State Treasurer; Emerald Valley has been audited already. Everybody got their books in order?

Our ambulance is unable to operate due to a problem with the insurance - we hope to have this cleared up very soon. ABATE also need EMT's that are chauffeur qualified to assist Dr. Dave at runs. There should be a person to drive while another person attends a victim in the rear of the vehicle - as it stands now, anyone seriously injured would have to make the ride to medical facilities without anyone attending them. Contact your rep if you're interested in helping out.

It is now a requirement (not retro-active) that ALL State Board Officers have telephones. State Reps are exempt from the requirement.



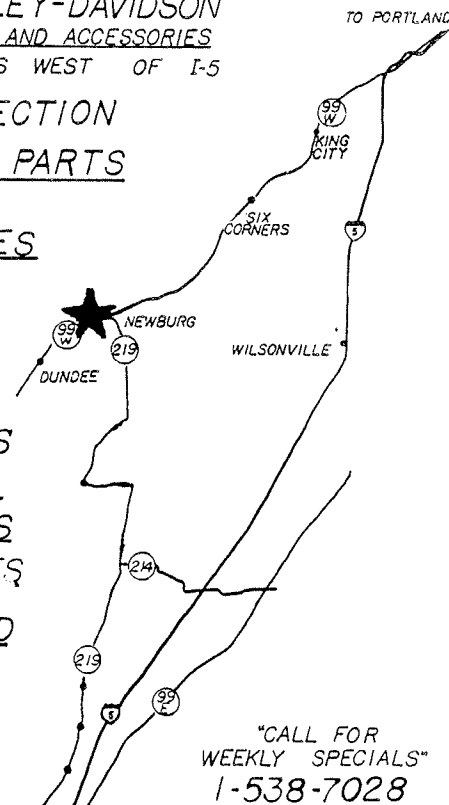

In 1981, I was introduced to, became a member of, and started doing all I could for A.B.A.T.E. of Oregon, Inc. The reason for all of the above was because legislation was in the works to require me to wear a helmet. I was motivated from that moment on to do as much as I could to prevent that legislation from ever happening.

ABATE of Oregon did defeat that legislation in 1981; we did it again in 1983. I'm glad because helmets suck!

In these years I speak of ABATE of Oregon introduced and got passed legislation to provide for education of motorcyclists using the slogans "Educate, Don't Legislate!", and "Education, Not Legislation!" That's fine by me - if I can be taught how to ride my motorcycle better I will appreciate the teaching.

Here's the bitch - when I take the Better Biking Program class, I'll be required for "insurance reasons" (who's insurance?) to wear a helmet while riding my motorcycle during the class. I think this non-helmet wearer was almost totalitarian enacted upon. Other than that, I think ABATE is the number one organization to belong to. -Preston (Klamath Falls)

**\* PLEASE READ THE INFO BELOW FROM TERESA \*  
\*\* IT SHOULD HELP EXPLAIN THINGS A BIT! \*\***

I hear that some members are concerned that ABATE is being hypocritical by sponsoring rider education classes requiring students to wear helmets. Before anyone gets too hot about the subject, we should discuss some facts first:

1. Students are required to wear over-the-ankle boots or shoes, long sleeves, long pants, gloves, eye protection, and helmets. All personal safety equipment is required for insurance reasons, and also as a teaching technique to be sure the student's aware of possible benefits of each item. Once off the range and out of the class, the student is free to make choices based on knowledge and personal preference.
2. "For Insurance Reasons" means that if a student received an injury in class while NOT wearing all required safety gear it would invalidate the BBP's liability policy, thereby opening ABATE of Oregon to a nasty lawsuit - It would almost certainly disqualify ABATE from conducting future rider training classes under the Oregon Traffic Safety Commission and the Motorcycle Safety Foundation, and probably jeopardize the instructors' teaching certifications. The instructors aren't likely to be sloppy or lax in this area - they worked very hard to become certified, and are dedicated to saving lives thru rider training.
3. We HAVE a choice in this matter - we can choose to NOT wear a helmet, and not participate in a class, OR we can choose TO wear one in order to gain whatever skill improvements we might gain that could REALLY save a life some day!!
4. In order to qualify for the grant, ABATE of Oregon, Inc. agreed to comply with the program requirements. Those of us who wrote & approved the grant proposal were aware of the helmet requirement and were willing to compromise on that point in order to begin an ABATE-affiliated rider education program. If this is a particularly offensive point to some of our members, we had better look at it hard NOW, so we'll know how if and how to design an ABATE motorcycle safety program for next year. How 'bout it, members? Tell your reps what you think so we can work it out!

In closing, freedom to choose (and freedom to disagree) is what ABATE is all about. I just hope we are really choosing, and not merely reacting.

THIS Toy Run committee is IS impressed!! Our total goal was only \$500 to give to the artificial limbs department, and we've already surpassed that by almost another \$500!! Our goal now is to be able to donate enough money to enable the hospital to purchase equipment that will enable them to fit artificial limbs "in-house", rather than farming the work out - this would save the hospital a lot of money and time, allowing a limited amount of funds for this specialized work to go a lot further.

We're working on having a few more benefit functions before our Toy Run on the 1st of December. Our donation jars are receiving more contributions each month. If you see one in your favorite local spot, please put some pocket change in it.

We have verbal approval from the mayor's office on our parade route, with a letter to follow. Our new P.R. Officer is working on getting us some coverage on "AM NORTHWEST", and we may even get some national coverage.

Those of you in the East Portland Chapters who'd like to help us make this the biggest success ever, please contact the Toy Run Coordinator from your chapter. A little work and time can go a long way towards helping a child have a happy Christmas and a beautiful forever!

Chasing the crank bag and tokin' became the priority & was the first order of business, every day.

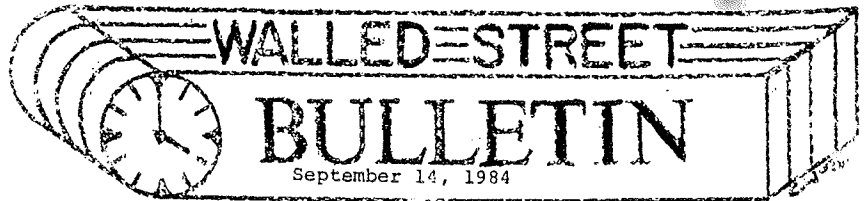
Less than one-third of this club ever owned or rode a motorcycle on the streets.
