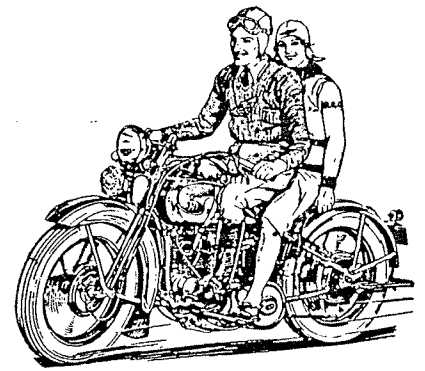


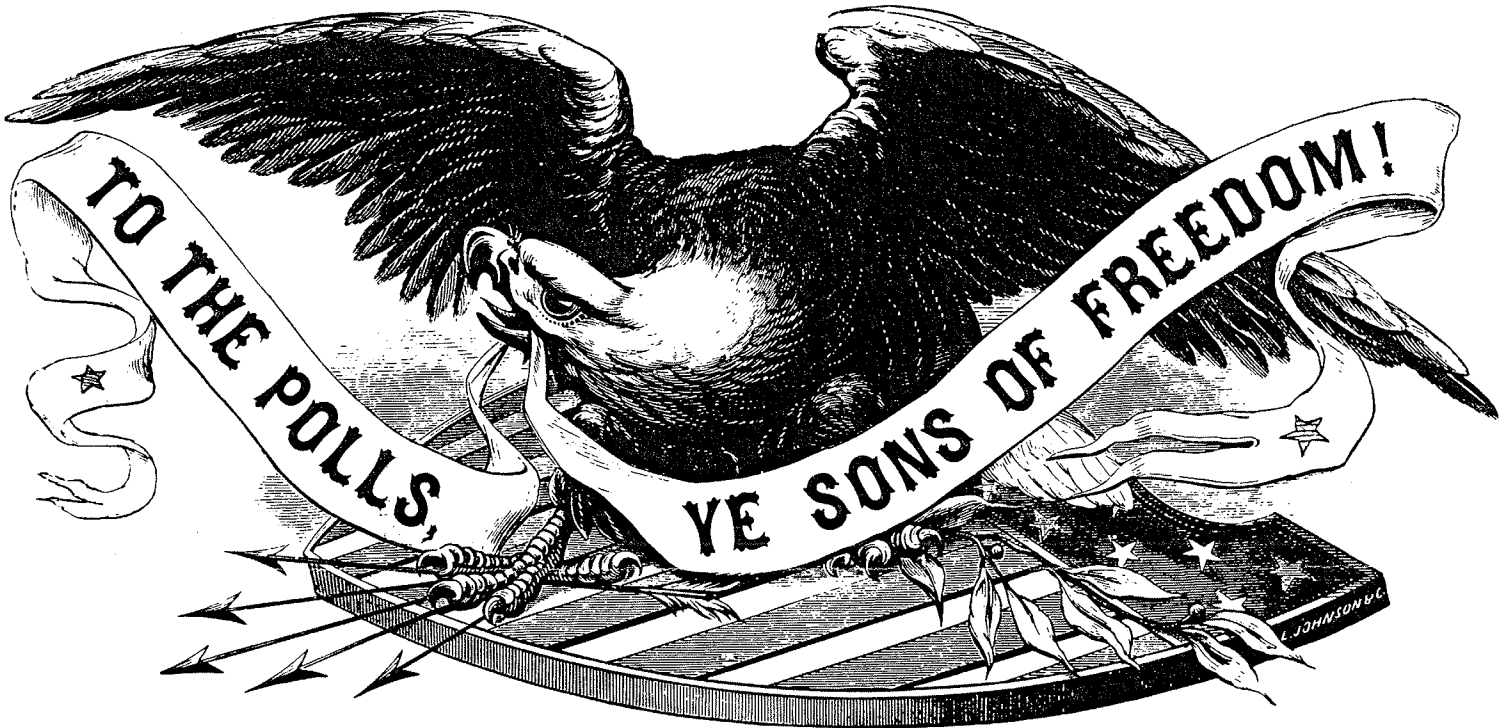

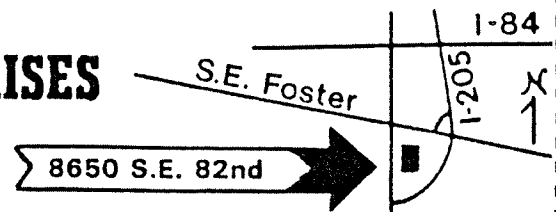

TO THE EDITOR: On behalf of the members in the club here I'd like to respond to the letter from R. Rice that appeared in the October Newsletter.

The club here was shut down by the superintendent, but there is more to it than what was written in that letter. The person who wrote that letter was kicked out of the club by the members after we discovered he was in prison for child molesting, rape, robbery, and shooting a little kid in the head. He turned himself into protective custody and that's where he wrote his letter from. What's he trying to do now, tell on somebody?

Our goals here were to build a motorcycle and have a toy-run, which in fact we did, with the help of people on the streets wanting to participate. I think the people out there know they were appreciated without having to be told, which I think most of you were.

In 1984, this club went further than it ever went before. Things that shut the club down still aren't clear and are being appealed. Too bad things didn't go right but shit, this is a prison!

TO THE EDITOR: As the former Vice-President of the Screaming Eagles Motorcycle Workshop, I'd like to clear up a few matters concerning Robert Rice's letter to your Newsletter (Oct. 84). First off, I don't want to use your newsletter as a chessboard, but Mr. Rice was, in fact, a secretary of the club until he was kicked out for being found out as a child rapo/sodomist, plus he shot a little kid in the head. He lied and denied being a rapo when he was originally screened to join the S.E.M/C.W. We found out what he was charged and sentenced to the prison for when we read the paperwork on this so-called "biker". He checked into protective custody in Feb. '83 and has been there ever since. He never talked like he did in his letter when he was in population with the rest of us. He's nothing but a weak lowlife punk who gets his jollies diddling little kids. If ya don't believe me check it out! Well, enough of that scumbag.

As far as the S.E.M/C.W. getting shut down, it was not because we did anything wrong - we were set up by prison officials and an informant, who turned out to be the guy who got into a fight with the President and could not take the ass-whipping he had coming for disrespecting the prez in front of the shop members. Not only did he have the nerve to tell the prez to leave the drag bike alone; that he couldn't work on it, he also told the prez to f\*\*k off! That seemed to start the whole deal of us getting shut down. It (the super's bulletin) said TWO members attacked another. Bullshit! It was a little fist fight, over in a few minutes, and the guy who got tuned-up for disrespecting the Prez ratted; now the prez is in the hole for 9 months, doubled to 18 months. Our treasurer got 9 months in the hole for just watching the fight! We have all the paperwork to prove these people are screwing us over.

As for drug smuggling, I was accused of bring drugs in, along with the Prez, the treasurer, and our hobby shop section manager - we were charged with unauthorized organizations, conspiracy, manufacture, possession of narcotics, and disobedience of an order; all of these charges are based only on the statements of an informant, who just happens to be the guy who got tuned up by the Prez. There's no evidence; no drugs were found and there are no witnesses. We're being railroaded because the informant has been (is being) compensated by the administration to discredit and defame our club and our reputations as officers of the club, and also so he can get some kind of revenge. Since all this happened we've found out the informant was in Walla Walla prison when the W.S.P.M.A. got shut down, and that he has ratted on other people in other joints, and here we are doing from six to thirty months in the hole.

We tend to believe that this guy is involved in a greater conspiracy with prison officials. I'm doing one year in a 6X9 cell, just for building a good club, getting a racing bike up and teaching other tramps skills that could keep them out of trouble. My brother, Steve Baker, is doing thirty months in a 6X9 for doing the same as me; my brother Dave Taylor is doing 15 months in a 6X9 for being a good treasurer, & Terry Zimmerly is doing 6 months for just making good saddle bags, wallets & other leather goods.

The ammo found in the yard the day of the bike show is the same caliber as the guns used in the prison's guard towers, and that's all I'll say about that. We really got screwed on this, but we'll see them in Federal Court. We're currently on the way to proving how we were set up. I hope you'll print all of this. It's a fact we have done nothing wrong; as for Mr Rice and his little sympathy speech, I don't think his pathological lying, ass-weak mind will ever comprehend brotherhood. It's been the waterheads like him who've slid in and caused excessive heat to our good name. Hey, there's many of you who know us and have been to our meetings. We've done too damn good to screw things off by being stupid! Sure, some of us like smokin' dope, but to jeopardize the whole club is insane! The S.E.M/C.W. was all us locked-down bikers had!

My brothers and I are going to court because we're innocent and can prove it. We know what brotherhood is about and even in prison we strive to keep it strong. Our struggle is never ending as the system pushes us down. We ARE right and won't give up to their injustice. Thanks to all of you for all of your help!! We ain't done yet!

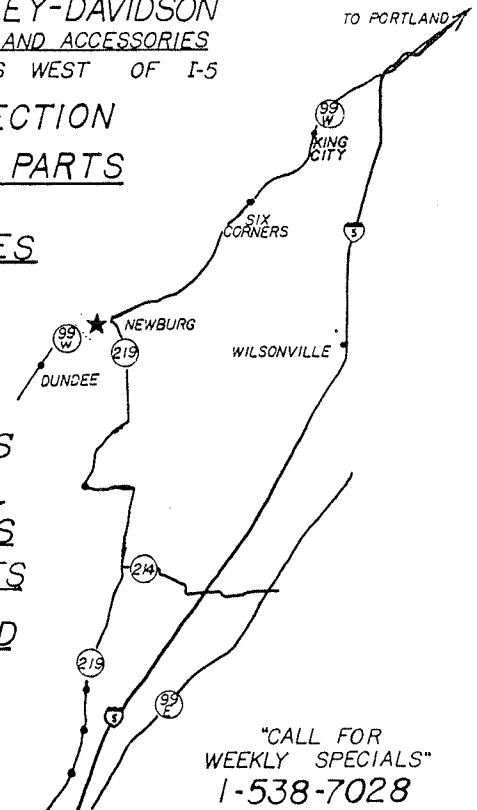
