An Open Letter to A.B.A.T.E. of Oregon

Five years ago when I moved to Oregon from the East Coast, I became a member of A.B.A.T.E. of Oregon. I have taken my membership very seriously both on a chapter level and on the state level because I found here a freedom that is unknown back East.

That freedom is very precious to me. The freedom to ride without a helmet, if I so choose; the freedom to ride with a minimum of hassles from others; and the freedom to ride with a group of people who feel as I do. To protect this freedom, I worked and I fought and I did what I was capable of doing so no one here would have to experience what goes on in other states that do not have these freedoms.

"Mother A.B.A.T.E." with her clipboard has been a very familiar sight to all of you these past five years. Now however, events are forcing me to re-examine this involvement.

Theresa, Dennis, and I were deeply involved in rewriting the State Bylaws to update them. How many members even know that we have By Laws, much less what is in them?

Our Better Biking Program was the result of several years of work on the part of many. My old man and I took a beginning riders course before our course was established; wore helmets for the course; and we both feel, as a direct result of that class, that there was a picture of him in Bikers Lifestyle on crutches and not a tribute to a downed brother.

This past year, A.B.A.T.E. members protested following the rules established by the Motorcycle Safety Foundation regarding wearing helmets for our course and so our goal of training 150 riders fell short.

And, on a more personal level, as I was working the gate at our McNeil Run, I watched my dog get run over by a 72 Chevy Utility 4X. The driver, a member of the S.E. Chapter said she would pay the vet's bill. That was last August and after repeated requests the latest I heard was that it was "just a dog". The owner of the vehicle states that he has insurance but he doesn't want it turned over to the insurance company. The bill came to over \$700. This is the biker "brotherhood"?

Does anyone out there care? Does anyone else believe in the "Brotherhood" of A.B.A.T.E.? Does anyone else fear that the conditions in other states which convinced me that my riding days were over could happen here? Does anyone care?

Ride Free? (For how long!)

TEAM OREGON MOTORCYCLE SAFETY TRAINING SCHOOLS HONORED AT ANNUAL BANQUET

The TEAM OREGON Motorcycle Safety Program of the Oregon Traffic Safety Commission honored three training schools at its first annual banquet Saturday evening at Oregon State University's Memorial Union.

KC Humphrey, Deputy Administrator of the Traffic Safety Commission, presented incentive awards for surpassing training objectives by more than 25% to Clackamas Community College for Most Students Trained and Lane Community College for Most Outstanding Public Information and Education Effort. The Mobile Better Biking Program operated by A.B.A.T.E. of Oregon, Incorporated received an Honorable Mention for training more than 100 students.

Stan Porter, Motorcycle Program Coordinator, gave an overview of program accomplishments which included over 400 students trained, future program activities, and possible new schools in 1985 for Bend, Salem, and Portland.

Steve Garets, OSU Training Specialist, commended all sites and instructors' excellence during first year site operation and urged increased activities for 1985.

The Motorcycle Safety Program is funded from a safety education fee placed on the motorcycle license endorsement by the Oregon Legislature. Training sites are located at:

INFORMATION ON DRIVING UNDER THE INFLUENCE OF INTOXICANTS LAWS

(This information was from a talk Richard Cremer gave at one of Douglas County's meetings.)

The standard used to determine if a person is intoxicated has been lowered several times in the past years. If you blow in the breathalyzer, the current standard is .08%. If a person drank four beers within one hour and then blew in the breathalyzer immediately, it would register .08% or legally intoxicated.

Alcohol goes in to the body faster than other substances because it is absorbed through the lining of the stomach. By drinking one drink (1 ounce of alcohol) an hour, your alcohol level would be .02%.

Your body dissipates (or gets rid of) alcohol at the rate of .01% per hour.

EXAMPLE: 3 drinks with 1 oz. of alcohol
consumed within 1 hour would
equal an alcohol level of06%
Dissipation rate in 1 hour (.01%)
Alcohol level would be05%

If you have no convictions for DUII within the last 10 years, it is a good idea to blow in the breathalyzer. If you refuse to blow, regardless of your condition, you will get an automatic one year suspension of your license.

However, if you do not have any recent convictions and blow .08%, you are eligible for the diversion program. The diversion program requires that you go through alcohol counseling at your own expense but also lets you keep your drivers license.

A second conviction for DUII means jail time, probation and a three year suspension of you license.

Probable cause when stopped - The police have to tell you why they have stopped you. They can not detain you any longer than necessary for the reason you have been stopped. They have the legal right to ask you to get out of your car but YOU DO NOT HAVE TO GET OUT. Try not to breathe in their face if you have been drinking. Crack the window enough to give them your license and talk with them as little as possible.

If you are a passenger in a car you do not have to show your identification.

Field Sobriety test - You do not have to take the road side tests if asked. If you do not take them the cop will have to make his decision about arresting you based on his observations of your driving and your actions after he has stopped you. Even sober people can have difficulties with the road side tests so it is best to never take them if asked.

Searching your car - Your car can only be searched if the police have probable cause that there might be something contraband in the car. If they see you pushing something under the seat or smell pot they can ask to search your car. You do not have to consent but do not resist if the police insist. Simply refuse to give your consent. Lock your car after getting out if you are being arrested. They might want to impound your car. If possible ask them if you can call a friend to come get your car and move it.

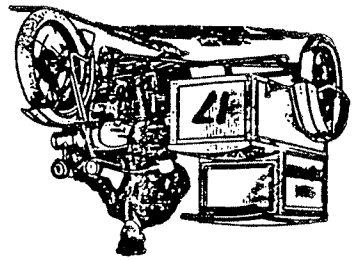
