Our Membership Secretary is still working on getting everybody's name into the computer. Everyone's patience during this changeover is appreciated. On a related matter, the Newsletter mailing list has not been updated in quite some time, therefore, those people who've sent in address changes are also asked to be patient. Our new computer will be printing the labels to mail the Newsletter, but until the programming is finished, we have to use the existing list at AD-MAIL. Also, we're requesting an address correction on this Newsletter — it's hoped that the corrections we receive will enable us to have the most up-to-date list possible. We want to remind everyone to please send in your address change to the P.O. Box. Even if you don't tell the Post Office, tell us, please!! Also, if you're having ANY problems with your membership, PLEASE LET US KNOW ABOUT IT!! We can't correct problems we don't know about!

On the Legislative front, Dr. Dave stated that ABATE's quick action on S.B. 887 (the P.I.P. bill) is the reason the bill is now, for all practical purposes, DEAD! We have been asked to work along with the Senate on coming up with a workable P.I.P. bill. H.B. 2639 (the Helmet Bill) is bottled up in committee, and isn't expected to reach the house floor. Dr. Dave STILL NEEDS SOME HELP, HOWEVER! We'd like to have as much documentation on the COST of Personal Injury Protection Insurance. We want ALL of you to obtain WRITTEN QUOTES for PIP on the following:

A 30 year old driver, male, with a clean driving record.

A 1978-79 Harley-Davidson Lowrider or Superglide.

Cost for Medical Liability only - \$2000 per person, \$4000 maximum.

\$50 Deductable. Also, find out if you can insure the motorcycle as the PRIMARY vehicle, or if it HAS to be "tacked" on an existing auto policy.

Also, include the agent's name and the insurance carrier. We're asking for this in writing, and from as many people as possible. We want as much documentation as we can get. This will help us in our efforts to come up with a workable bill in the future. Send all your findings to Dr. Dave in care of the P.O. Box. Thanks for your help!

THE ARTICLE BELOW IS FROM ABATE OF WASHINGTON'S APRIL 1985 NEWSLETTER, AND DESCRIBES THEIR TRIP TO NEVADA TO SHOW SUPPORT FOR PRO-CHOICE IN THAT STATE. LACK OF ROOM PREVENTS ME FROM INCLUDING THE ENTIRE ARTICLE, BUT THE EXCERPT BELOW WAS THEIR FRONT PAGE STORY, AND I THINK IT SPEAKS VERY WELL FOR THE BROTHERHOOD WE PROFESS TO BE.

We reached Klamath Falls at 6:30 p.m., located our Motel 6 and got checked in. As the men were finding parking spaces near enough to enable them to keep an eye on the equipment and machines, Chuck hit a bump and knocked his bumper loose. As he reached to put it back, it fell off completely and spent the night in the motel room. A couple of phone calls were made to the local ABATE chapter to see where their people usually "watered down." We headed for the The Linkville Station.

We were met at the door by "Merge" who is Klamath Falls Legislative Affairs/Safety and Education person. She made us feel at home while she called around to find more of their active ABATE people.

REPORT FROM THE GOVERNOR'S ADVISORY COMMITTEE ON MOTORCYCLE SAFETY TOWN HALL MEETING, MEDFORD

On February 5, 1985 (this is old news, folks!) the Governor's Motorcycle Advisory Committee held an open meeting in Medford to hear concerns and opinions of area motorcyclists. Committee members were: David Lawson, Chairman (Corvallis), Stan Porter, Team Oregon Coordinator (Salem), K.C. Humphrey, Assistant to the Administrator of the Oregon Traffic Safety Commission (Salem Steve Garets, Team Oregon Training Specialist (Corvallis), and Al Vasquez, representing the Medford Department of Motor Vehicles. Present in the audience were members of ABATE, the Rogue Valley Road Riders, and Retreads, as well as interested individuals.

A brief history of Oregon's rider education legislation was presented, then an outline of the purpose of the meeting: to collect information about motorcycle safety, education, and general conditions in Oregon. The information gathered was to be presented to the Administrator of the Oregon Traffic Safety Commission (OTSC) and shared appropriately with other agencies.

Comments and questions from the audience covered such subjects as how to increase motorists awareness of motorcycles, rider education; highway conditions; motorcycle licensing and testing, including training the examiners so they will be qualified to test applicants; helmets, helmet laws, other protective clothing, seat belt laws; legislation affecting motorcycles; DEQ regulations pertaining to motorcycles; insurance; and more. The questions asked were often quite pointed, and the committee attempted to answer them as completely as possible.

From the 18 pages of minutes from the meeting (none of it boring), it's obvious the riders were eager to be heard; and we finally have a channel to pass our concerns along to the safety bureaucrats in Oregon. Many thanks to the Committee members for their long-standing commitment to rider safety, and to Kathleen Close, Team Oregon's able secretary, for providing us with such quality reading material. Activities like this do a lot to further our continuing efforts to be recognized as citizens and highway users.

If you wonder why ABATE has no official representative on the Governor's Committee, well, so do I. Inquiries made in months past have received the answer that there are no vacancies at this time. (This is not the fault of the Committee members, but of conditions within the Governor's office.) Future Committee activities are not presently scheduled; if and when meetings resume we'll keep trying to get representation. 'Til then, enjoy the summer's new crop of bugs!

BPA DISCUSSES GASOLINE LEAD WITH MOTORCYCLISTS

WASHINGTON, D.C. -- In a session arranged by the American Motorcyclist Association, officials of the U.S. Environmental Protection Agency (EPA) met April 23 with riders concerned about how the agency's plans to limit -- and perhaps ban -- gasoline lead might affect their health, safety and motorcycles.

The motorcyclists -- representing the AMA, the BMW Motorcycle Owners Association, the U.S. Norton Owners Association, the Ducati International Owners Club, the Vincent Owners Club and the Classic and Vintage Motorcycle Association -- repeated their concern that the drastically lowered lead level set to go into effect at the beginning of 1986 may cause engine valve damage. The EPA has not tested motorcycles to determine a safe minimum lead level.

In an action proposed in August 1984, the EPA initiated a timetable for reducing gasoline lead from the current level of 1.1 grams per gallon to .5 gram by July 1, 1985, and to .1 gram beginning January 1, 1986. The agency is strongly considering a leaded-gas ban beginning in 1988.

Richard Kozlowski, the EPA lead project director, made it clear the agency's goal is "zero lead," and the only way leaded fuel will remain available is for concerned citizens to write to the EPA and their congressmen. Kozlowski said the EPA's options range from leaving lead at the .1-gram level to a more gradual phaseout than the 1988 deadline.

Though the EPA is certain that under a lead ban gasoline additives would be available for engines requiring the valve-lubricating properties of lead, the agency does not regulate such aftermarket additives and cannot guarantee whether they would be safe or effective. The motorcyclists, however, were leery of additives and would prefer substances added to fuel by refiners themselves.

"We might be getting some kind of snake oil," said Walt Hoverson of the Ducati club, referring to over-the-counter additives. "An engine seizure due to improper additives would be devastating to motorcyclists."

AMA's Gary Winn pointed out that the amount of leaded fuel used by motorcycles is not insignificant. The AMA estimates that between 45 million and 60 million gallons of leaded gas are used annually by the 750,000 to 2 million motorcycles -- ranging from antiques to some current models -- designed to burn leaded gasoline. "We only want to assure motorcyclists who bought such a motorcycle that they can get many years of service from these machines, and that owners are not endangered by the EPA plans or by gasoline additives." Winn said.

The EPA has yet to set a deadline for public comments on its 1988 lead ban, and the AMA urges motorcyclists to take advantage of the comment period by writing in opposition to a complete removal of gasoline lead. Letters should be addressed to:

Speed bills abound

The release of "55: A Decade of Experience" late last year has spawned a batch of state and federal legislation intended to give states at least some authority to set speed limits above 55 mph. So far, the AMA's Government Relations Department is aware of 10 states with legislation related to changes in highway speed limits. Additionally, the U.S. Congress has three such proposals under consideration.

The aim of most speed-limit legislation has changed somewhat. While previous bills sought repeal of the national speed limit, or a return of a state's speed limits to pre-1974 levels, the majority of 1985's bills would simply modify the law.

The following is a summary of speed-limit legislation and the status of these bills. Readers with such legislation pending in their states are urged to write to the bill sponsor and the chairman of the committee considering the bill. Letters on the federal bills should be directed to the committee chairman, the bill sponsor and to your own legislators as well. Capitol addresses may be found in the Cycle Connection supplement to the March 1985 issue of AM, and the AMA's Government Relations Department will gladly

U.S. Congress House Bill 693—Sponsored primarily by Rep. Dave McCurdy (D-Oklahoma). Would permit governors to apply to the U.S. Department of Transportation to increase speeds on rural interstates up to 65 mph. Requires a status report every five years by the secretary of transportation and allows the federal department to withdraw permission for higher speeds. Referred to the House Public Works and Transportation Committee.

provide additional information.

More on 55-Road Rider magazine and the Citizens Coalition for Rational Traffic Laws (CCRTL) have both attached importance to 1986 in campaigns to change the national speed limit. In the May issue of Road Rider, Editor Bob Carpenter outlines a strategy for changing the speed limit, urging readers to vote in the 1986 elections only for candidates who agree that speed law should be state law. Meanwhile, CCRTL's Jim Baxter (6678 Pertzborn Road, Dane, WI 53529) says his organization is urging state lawmakers to put effective dates of October 1986 on bills increasing state speed limits. If several states have higher speed limits going into effect at one time, Baxter says, it lessens the likelihood that the federal government will single out one state for punishment. Additionally, the effective datecoming just a month before the next congressional elections-will make the speed limit an issue that is guaranteed to be debated by candiU.S. House Bill 1163—Sponsored by Rep. James Hansen (R-Utah). Permits states to set speeds of up to 70 mph on highways outside "traffic-congested areas" (which would be defined by the secretary of transportation). Referred to the House Public Works and Transportation Committee.

U.S. Senate Bill 329—Sponsored primarily by Sen. Chic Hecht (R-Nevada). Permits states to set highway speeds of up to 65 mph on roads outside urban areas with populations of 50,000 or more. Referred to the Senate Commerce, Science and Transportation Committee.

California Senate Joint Resolution 4—Sponsored by Sen. James Ellis (R-San Diego). Urges Congress to permit states to increase speed limits on selected freeways. Before the Senate Transportation Committee.

Iowa Senate Bill 42—Sponsored by Sen. Egar Holden (R-Davenport). Sets speed limit of 65 mph on controlledaccess, multi-lane roads. Before the Senate Transportation Committee.

Iowa Senate Concurrent Resolution 16—Sponsored by the Senate Transportation Committee. Urges Congress to allow states to designate a speed limit of 65 on highways and interstates. Not yet assigned to committee.

Missouri House Bill 201—Sponsored by Rep. Donald Gann (R-Ozark). Establishes a 65-mph limit on highways with four or more lanes. Referred to the House Motor Vehicle Committee.

Nebraska Legislative Bill 71—Sponsored by Sen. Ernie Chambers of Omaha. Sets speed limit at 65 mph on interstate highways. Before the Public Works Committee.

New Mexico Senate Memorial 10-

Sponsored primarily by Sen. Victor Marshall (R-Albuquerque). Asks Congress to make exceptions to the 55-mph speed limit on interstate highways. Approved by the Senate.

New York Assembly Bill 3324—Sponsored by Assemblyman Anthony Seminerio (D-Queens). Allows the State Thruway Authority to set speeds of up to 65-mph on its roads. Assigned to the Assembly Transportation Committee.

New York Senate Bill 2437—Sponsored by Sen. Owen Johnson (R-West Babylon). Identical to the assembly bill. Referred to the Senate Transportation Committee.

Oklahoma Senate Bill 181—Sponsored by Sen. E.W. Keller (R-Oklahoma City). Increases the interstate speed limit to 70 mph. Assigned to the Senate Transportation Committee.

Washington House Joint Memorial 19—Sponsored primarily by Rep. Paul Sanders (R-Bellevue). Requests a national speed limit of 65 mph. Referred to the House Transportation Committee.

West Virginia House Bill 1234—Sponsored by Rep. Carmichael. Sets 65-mph limit on controlled-access and interstate highways. Before the House Judiciary Committee.

West Virginia House Concurrent Resolution 14—Sponsored primarily by Rep. William Carmichael (R-Ripley). Urges Congress to repeal the national speed limit. Referred to the House Rules Committee.

Wyoming Senate Bill 17—Offered by Sen. Jack Pugh (D-Green River). Sets a speed limit of 70 mph on four-lane, divided highways and 65 on all other highways. Reported unfavorably by the Senate Transportation Committee.

More than 7,700 Oregon drivers may find out the hard way this year that driving without liability insurance is a mistake that will result in license suspension for one year.

Under a relatively little-known law that took effect in January 1984, the Motor Vehicles Division must suspend a driver license when a driver has an accident, regardless who is at fault, and the division determines that the driver does not have the required auto liability insurance.

Last year, 3,719 driver licenses were suspended under the new law. That meant about 300 drivers a month lost licenses for "no insurance" at the time of an accident.

During the first quarter of this year, however, 1,926 licenses were suspended under the law - this means 642 drivers a month are being suspended because of uninsured accidents. If that rate continues all year, more than 7,700 drivers will lose licenses on these grounds alone.

Uninsured accident are detected in two ways: First, DMV verifies all insurance coverage reported on accidents by drivers. If an insurance company denies coverage, DMV then suspends the driver license. Second, the 1984 law requires insurance companies and agents to notify DMV when they learn of an accident, even on private property, in which a driver is uninsured. License suspensions also follow these reports once they are verified by DMV.

In addition to the outright one year license suspension, the law also requires these drivers to then file proof of future financial responsibility (insurance) for three years or face continued license suspension. That fact also means these drivers will pay higher premiums for future coverage for the three year period.

Until the 1984 law took effect, Oregon law gave drivers in accidents a chance to get coverage before suspension was imposed, even though the driver was breaking the state's mandatory auto insurance law at the time of the accident. If drivers got coverage, accomplished by having an insurance company make an SR-22 filing for them, suspension was not ordered.

The new law imposes the outright one year suspension and then subjects the driver to the filing for three years after the suspension ends. RIVER CITY CHAPTER of ABATE OF OREGON, INC.
