DEDICATED TO FREEDOM OF THE ROAD!

On August 1st, promptly at 9:00am, six brothers and one sister left Troutdale for Sturgis, South Dakota. In spite of the rain, spirits were high and excitement was in the air; some of the chapter members who were unable to make the run came to see us off and wish us well. Dr. Dave, St. Helens Rick, Mike, Larry, D.B., Reggie from Texas and Ann departed for STURGIS '85.

For a day-and-a-half we rode in hard winds and driving rains until we approached the foot of Lolo Pass in Idaho, and then the rain REALLY began to come down! As we climbed in elevation the roads became more twisting and slick beyond belief. Anyone who's made the run knows what I'm talking about.

Ann and I were well behind the rest of the group, as my new rear tire wasn't holding the road as it should have. Coming towards us from around the next curve was a semi-truck without any mudflaps on its wheels. I managed to duck behind my windshield and miss the blast of water thrown by it, but Ann was not so lucky. The spray blinded her and she veered to the left, driving into a mud ditch. Her front wheel hit a culvert, flipping her and the scooter over.

In the day-and-a-half we rode with Ann, she proved to be an excellent rider, so we feel the accident was not her fault, unless being in the wrong place at the wrong time counts. No, the truck did not stop; the driver was probably unaware he had caused an accident.

Speaking for the group, I would like to thank all of the people who stopped to give assistance to Ann; sorry we didn't get your names but things were happening too fast! We also want to thank the employees of Lochsa Lodge west of the summit, and a special big THANKS to Gail, who, along with all the others, did so much to help us when we needed it. If any of you are riding over Lolo Pass, please be sure to stop in and see Gail and tell her you're from ABATE of Oregon; she and the staff will take good care of you.

Ann is in St. Patrick's Hospital in Missoula, Montana. When we last saw her on our way home, she was not doing very well. Your prayers and thoughts are welcome.

In addition to losing Ann we also lost one of our party in the confusion and spent several hours looking around Missoula for him (we won't mention any names). So the next morning the remaining five pushed on to the land of STURGIS, where it was said an official fun zone had been declared (and so it had!) From the time we rolled in at 10 am Monday 'til we left the following Monday, I totally overdosed on fun. We experienced one tornado, one flood with water half-way up the primary case, hail stones the size of golf balls, at least two days of 100° temperatures and unlimited fun! By late Wednesday it was estimated that 30,000 people had rolled into town and by Saturday night 45,000 were there. AND in spite all of this I'm already making plans for next year's run.

St. Helens Rick

I thought I'd use a bit of space to offer a few of my thoughts on the meaning of "BROTHERHOOD". (That's one of the "perks" that comes with this job!!) The meaning was driven home for me one day recently as I was riding home from work.

I use Marine Drive daily, and when I leave work, I have a choice of two ways to reach it from N. Vancouver Avenue. On this particular day, I found myself following a truck, and the combination of the dust kicked up in my face and a 25 MPH ride in 95° weather prompted me to take the turn-off and use the alternate way - a way I seldom use. If I jammed, I could be on Marine Drive before the truck and not have to follow him clear to Gresham!

This "alternate" way - NE Gertz Road & NE 13th Avenue, join together on a banked, 15 MPH curve I normally go thru at 30 or so. As I approached this curve (it's one of those blind curves that allow the unwary to be ambushed by people in cages), I noticed a pickup parked the wrong way on the right shoulder, and two dudes walking towards a blackberry patch covering a 10 to 15 foot deep ditch. As I rounded the curve, I glanced at where they appeared to be walking and saw the underside of an engine crankcase with four pipes running over it, along with some guy, in the brambles, trying to gain enough of a foothold to right his downed (by now I realized) scooter. All the above was a brief flash to me as I rolled the throttle back on and up-shifted. One of the guys from the pickup appeared to have waved as I went by. Since help was at hand I mentally shrugged my shoulders and continued on. But a little voice kept insisting I turn around, which I did just as I got to Marine drive.

As I slowed near Gertz road, I noticed the pickup was gone. While I was wondering how they'd got that bike out there so fast, I saw movement in the briar patch; that poor fellow was STILL in the damn blackberrys trying to get his bike out. It took the two of us about 10 minutes of pushing and puffing to get his 750 Honda on its wheels, untangled from the vines and up on the street. I asked him where the two guys in the pickup had gone; he said that THEY said I (meaning yours truly on the LowRider) would be back!! Then they left!! I couldn't believe it! I hadn't given those two ANY indication that I'd even SEEN them, much less was going to return! I helped this fellow (I never did get his name) push start the Honda after giving it a once over; the only damage appeared to be cosmetic. He was so shaken he forgot to turn on the gas, but the bike ran great once it had fuel and I followed the guy to his house, just to make sure he got home okay.

After talking a few minutes (an errant cage had forced him into the gravel berm at the edge of the curve, and he'd slid straight into the berry vines - the cage didn't stop either!), I headed for home.

How close I'd been to turning onto Marine Drive rather than take the time to go back . . . so often, it seems that there isn't enough time to pause and help somebody in trouble, especially if they're riding a riceburner. I usually don't stop when I see someone on the side of the road in a metro area; there's always a phone within easy walking distance. On the other hand, this fellow was in some real trouble - there was no way he could have gotten his bike out of that briar patch alone! The fact his ride was a Honda was totally irrelevant; the fact he was on TWO WHEELS is all I was concerned with.

Hit-run victim faces struggle to rebuild life

What started out as a short trip to a friend's house on the night of April 9 turned into a violent brush with death and a vicious nightmare from which Debbie Nordquist can't escape.

At about 6 o'clock that evening, Nordquist was riding her motorcycle near Northeast Cleveland Avenue and Failing Street when she was hit by a car.

"I don't even remember getting hit," Nordquist said.

Witnesses later told Nordquist that a speeding motorist had hit her motorcycle and dragged it for a block, sending her flying across the road onto a nearby lawn. The motorist sped away.

Nordquist's right hip was crushed, and she suffered extensive internal injuries. Her right leg from the knee down had to be amputated. She was on a life-support system for a week at Emanuel Hospital and then spent three weeks in intensive care before being transferred to Kaiser Sunnyside Medical Center for another month. She feels she is lucky to be alive today.

"I remember a voice telling me he was going to have to cut off my leg," said the 32-year-old former bartender, remembering her first conversation in the hospital. Despite initial objections, Nordquist consented to the amputation that has changed her life.

"I had to do a lot of adjusting," she said. "It was a very devastating thing."

A Multnomah County grand jury indicted a suspect on felony charges of second-degree assault and failure to perform the duties of the driver where personal injury is involved. But a witness disappeared and the indictment was dropped.

Without the positive identification of the driver, Nordquist is unable to collect any insurance money to compensate her for her crippling injuries. Her own insurance company gave her \$25,000 of uninsured motorist compensation, but Kaiser Sunnyside Medical Center has placed a lien on the check to pay for the more than \$200,000 in medical bills

that Nordquist owes.

"I don't have any money," said Nordquist, who is living on the \$256 a month she receives from welfare. The rent at her small apartment at 911 S.E. Belmont St. costs her \$240 a month.

"I just try to live each day. It just doesn't seem right. I can't believe a person could hit someone and then just drive away," she said.

According to David Davis, information representative for the Oregon Department of Motor Vehicles in Salem, there are many cases of hit-and-run, which range anywhere from a fender-bender to a fatality.

"We usually average about a hundred a month," Davis said.

In 1984, the licenses of 1,188 Oregon drivers were suspended for failing to perform the duties of a driver at the scene of an accident, and more than 1,200 citations were issued for

failure to leave name and address, he said.

In Portland last month, there were 340 cases of hit-and-run, according to Joe Becraft, traffic analyst of the Portland Police Bureau, who also said that Nordquist's case was not unusual.

"It happens a lot," said Becraft, who spent 4½ years in the Portland Police Bureau's hit-and-run division. "It used to be a traffic infraction, but it was elevated to a crime."

Becraft said that Oregon state statutes defined the crime as a felony when serious injury was involved.

For Nordquist, the nightmare continues despite her efforts to start anew.

"I've got to go to school. I can't go back to what I was doing," said Nordquist, who is unsure if she will ever get off her crutches.

"I've got to go back to school to put my mind off things."

I've included this newspaper clipping because it illustrates only too well how easy it is to get away with hit-and-run in this country. This woman is really out of luck; she doesn't remember getting hit (therefore, she cannot provide the authorities with any info on the car that hit her), and she doesn't have any witnesses. After reading the statistics on hit-and-run in this state, some people might get the idea that they can run down motorcyclists with impunity. And considering the severity of Nordquist's injuries, is it any wonder that the "powers-that-be" are pushing to enact mandatory personal injury protection insurance in this state?

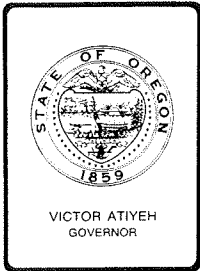
WHAT THE HELL

TEAM OREGON operates two motorcycle skills training courses -- the Motorcycle Rider Course (MRC) for beginning riders and the Better Biking Program (BBP) for experienced riders.

The MRC includes eight hours of classroom and twelve hours of on-cycle training which supplies you with the techniques necessary for successful street riding.
