State Board Report

The September State Board meeting was held on the 12th, at the Sundown Station in Creswell, Oregon. The meeting was called to Order at 1:15pm by Deacon. There was 17 voting reps. present & all but two State Board Officers were present.

Motion #1 was made to elect a new Vice Coordinator. Motion passed. Roger Hendricks (Rotten Roger) of N.E. Portland Chapter volunteered and was appointed our new Vice Coordinator.

MEMBERSHIP SECRETARY: Carolyn stated that as of Sept. 12 we have 779 paid members. She also stated that she had to spend \$275 on the computer to up-date the memory and to fix the printer.

LEGISLATIVE DIRECTOR & LOBBYIST: State Fair Report; Chris of Salem; she thanked everyone who went to work at the booth. They talked about voters rights and people's freedoms. They register people to voter. She also recieved donations of \$450 for the booth from Richard Lester, B.A.M. and A.M.O.

NEW BUSINESS:

A. Angie of Mt. Hood reported that their chapter would like to see a special fund for the volunteer fireman who rescues people going or coming from Fossil.

Motion #2 was made to add to the Fossil Agenda for a benefit at Fossil for volunteer rescue at Condon. Motion passed.

Motion #3 was made to take back now to the chapters the need for funds to Condon E.M.T.'s. Motion passed.

Chris of Salem said that they used some of their chapter funds to help pay for some of the things used at the State Fair Booth. At their next chapter meeting they were going to see if they could donate the \$203.31 they used at the booth to the State Board Treasury. Chris also suggested to see if other chapters could donate towards this cost at the State Fair Booth.

50-50 DRAWING: \$12.50 to the State and \$12.50 to Captain of Washington Co. He donated the money back to the State.

Deacon read a letter of resignation citing he will now in the future will be putting his personal life first before A.B.A.T.E. So he Deacon (John Edwards) resigned effective 9-13-87 at 12:01am, as State Coordinator, State Legislative Director and State Lobbyist of A.B.A.T.E. of Oregon Inc. Roger Hendricks will now become the State Coordinator when Deacon's resignation becomes effective.

STATE FAIR REPORT

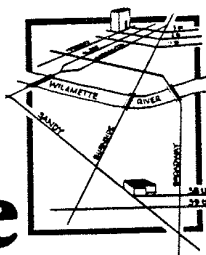

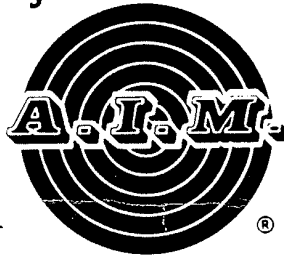

Housewarming gift leads chase — across

Although Barbara Gallaher and Mike Dominguez only recently bought and moved into their North Newark Street home, they are already bringing some excitement into the neighborhood.

The couple's pet, "B.A." — a six-foot Burmese python as thick as a baseball bat — forced its way out of its cage between late evening Aug. 3 and early morning Aug. 4. After searching their house, furniture and yard, the couple faced a broken, empty cage and an open front-room window.

"The only thing it could do is probably scare someone to death," Gallaher said while the snake was still missing. "It hasn't bitten anyone we know of," she continued, adding that, instead of biting, the snake just "swells up and hisses" when it becomes angry or frightened.

Finding nothing in the house and yard, Gallaher contacted the police and county animal control offices. Multnomah County Animal Control referred her to a private animal company that specializes in reptiles and, while a representative arrived promptly, she says the two police officers who came to take some information on the lost pet were a little uncomfortable.

After a description of "B.A." (short for "Bad Attitude"), Gallaher says one officer decided to stand guard at the gate to her yard while the other declined an invitation to inspect the empty cage.

For the next two days, Gallaher kept looking in the

corners of her house and "scouring the yard, hoping he'd drop out of a tree or something," until Thursday she decided to tear everything apart for a second time. After searching through and then straightening out the furniture, she pushed a bookcase against the wall.

"The thing kept sitting crooked and I kept straightening it out," she says, until she realized she had found B.A.

Mary Hart is the owner of Hart's Reptile World, one of the specialized companies to which Multnomah County refers snake escape cases. While she doesn't recommend big snakes as home companions, she says, "a Burmese is usually a nice pet."

"Keep in mind though that an animal that is cornered could bite someone," she adds, whether it is a dog, cat or, as in this case, snake.

The best course of action for someone who finds a snake, she says, is to try to trap it without getting too close by throwing a box over it or just closing a door. Then call Multnomah County Animal Control or one of several private companies that trap exotic animals. Some companies charge for animal retrieval and others, like Hart's, offer the service free of charge.

"Don't kill it," she asks people who find missing a snake. "It's not in that situation because of its own choice."

Hart says "Hollywood and over-enthusiastic journalists" are responsible for many misconceptions about reptiles and top on that list is that there has ever been a "man-eating" snake.

"Snakes don't eat people," she says, "even a human baby is huge" to a snake several times larger than Gallaher's.

Though he didn't leave the house, Gallaher and Dominguez speculate that B.A. was in search of food when he forced his way out of his five-foot Plexiglas cage. Accustomed to eating three or four rats every two weeks, the snake was given two rats the night he left the cage.

"I figure he just went out looking for something to eat," Gallaher says. Dominguez agrees.

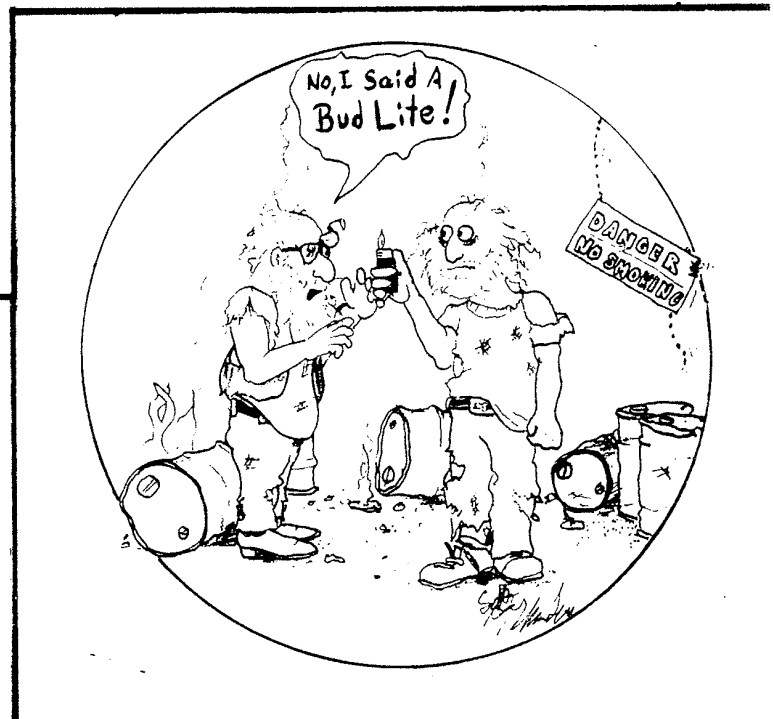
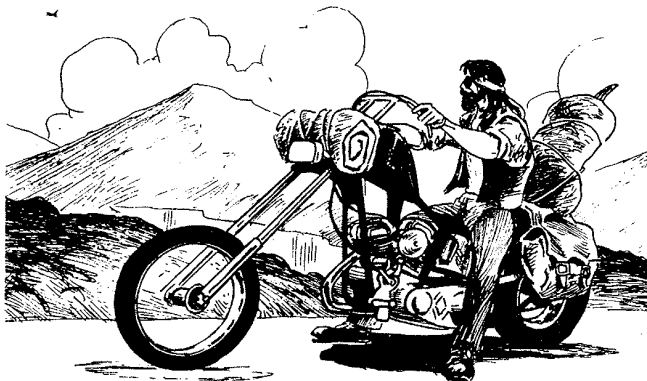
