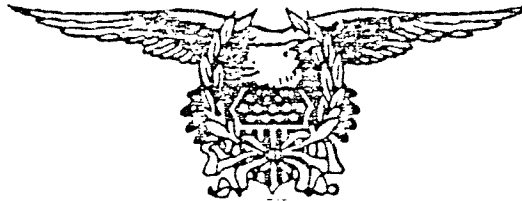

A REPORT FROM YOUR STATE COORDINATOR - ROTTEN ROGER

Many of you people are aware by now that on May 17, 1988 the people of the State of Oregon will vote as to whether all motorcyclists are to wear helmets or not.

On Sunday, November 29, 1987 the State Steering Committee met at the Furniture Barn in Creswell, Oregon to start on the Plan of Attack on Ballot Measure 2. We formed an Argument Committee, a Trifold Committee, Information Committee, Ways and Means Committee, and a Media Committee.

At this time we have 5 arguments on petitions. We need to gather 1,400 verified signatures for each argument in order to get that argument into the voter's pamphlet free. If we do not gather enough verified signatures per argument, it will cost us \$300.00 per argument to put the arguments in the voter's pamphlet.

I would like you to think back this last summer and how nice it was riding down the highway with the wind in your face and enjoying the way you like riding your motorcycle. If you would like to continue riding your motorcycle the way you want to as an individual, please give me all the help, support and cooperation to get the signatures on these petitions so we can get our arguments in the voter's pamphlet. In order to do this, you need to contact your Chapter State Representative. They have the petitions for your chapter.

We have also formed a P.A.C. (Political Action Committee) called "Citizens For Freedom of Choice." For detailed information on this, you must also contact your Chapter State Representative.

Remember, if we all work together and educate the public about "freedom of choice", we can overcome Ballot Measure 2 and continue riding in the wind. Thank you all for your cooperation and support. I know we can do it.

DECEMBER 12, 1987 STATE BOARD MEETING MINUTES

The regular State Board Meeting of A.B.A.T.E. of Oregon, Inc., was held on December 12, 1987 at the Sundown Station in Creswell, Oregon. The meeting was called to order by Roger Hendricks at 12:59 p.m.

CHAPTER ROLL CALL AND SIGN-IN: Douglas County 2, Jackson County 1, Klamath Falls 2, Lane County 2, Lincoln County 2, Mt. Hood 2, NE Portland 2, Salem 1-1 late, SE Portland 2, St. Johns 2, and Washington County 2. Total of 21 voting representatives present.

TREASURER REPORT: See your State Representative for details.

MEMBERSHIP SECRETARY: Carolyn stated that we are down again this month with 751 paid members, down 14 from last month. Jackson County is the largest chapter with 126, SE Portland with 116, and NE Portland with 111. Carolyn is declaring a Statewide Membership Drive. It will start January 1, 1988 and it will last 3 months ending March 31, 1988. The chapter who brings in the most members at the end of the period will win a prize.

NEWSLETTER EDITOR: Need ads.

WAYS AND MEANS DIRECTOR: Barb stated that she has a dozen X-Large T-shirts and 3 XX-Large, 1 long sleeve T-shirt, and 1 sweatshirt. The 1988 year bars have been ordered.

HISTORIAN: Mike Stegmann put a scrapbook together. It has fliers, pictures, newspaper clippings, etc.

STEERING COMMITTEE:

- A. Arguments for the Voter's Pamphlets are finished. Roger is going to break up each individual argument and give two chapters one argument to get the 1,400 signatures statewide so that we can get the arguments into the Voters Pamphlets. The deadline for the Petition to the County Election Board on verifying signatures is 1/27/88. The deadline on getting the arguments in the Voters Pamphlets is 2/11/88.
- B. The Ways and Means Committee's main job is to raise funds for the "Citizens for Freedom of Choice" to fight the helmet law. Roger would like to have at least one member per chapter to help coordinate fund raisers in their chapters.
- C. All monies raised for "Citizens for Freedom of Choice" (CFFOC) must be turned over to CFFOC) ONLY. UNDER NO CIRCUMSTANCES are they to go to A.B.A.T.E. of Oregon, Inc. first. The reason for this is that CFFOC has their own expense reports and records to file with the State of Oregon.

- D. On January 27, 1988 the Trifolds will be available.
- E. Persons on the Steering Committee will have to go out and get prices for TV and radio coverage in your chapter's area. All the expenses for the news media or TV and radio will come out of CFFOC's funds. Roger has a schedule to start on March 20, 1988 to be on several Portland radio stations to talk against the helmet law. He will be working with all the TV network medias starting on April 5, 1988 in the Portland area.

OLD BUSINESS:

- A. Condon EMT's: Roger will be sending a check for \$312.00 to them this week for the money collected, with a letter.
- B. Legislative Pins: People who have pins left over need to distribute them out to the public. If you are out, Roger has plenty more to sell or pass out to help fight the helmet law.
- C. Officers Job Descriptions: Roger would like the ones who didn't turn them in yet to please think about getting them done and turned in.

ARMY ORDERS MOTORCYCLISTS TO TAKE COVER

A new uniform of the day has been ordered for motorcyclists at the U.S. Army's Rock Island Arsenal and the Iowa Army Ammunition Plant near Burlington.

It includes helmets with visors or goggles, gloves, long pants, a long sleeved shirt or jacket, leather boots or over-the-ankle shoes, brightly colored clothing in the daytime and reflective clothing at night. The rule applies to drivers and passengers on motorcycles and mopeds.

Arsenal spokesman Paul Powell said motorcyclists who don't comply won't be allowed on the island. If they take off their equipment after pass-laws in both states have been beaten down by loud protests from motorcyclists.

Arsenal officials said the new reguing the gate they'll be ticketed if caught, Powell said. He said the rules don't apply to motorcyclists using the government bridge that crosses the island and links the cities of Davenport and Rock Island, Ill.

But Powell said the rules do apply to the Burlington plant, which is part of the Army command headquarters at the arsenal.

All of this appears to be a case of the U.S. military charging in where states like Iowa and Illinois have feared to tread. Proposed helmet regulations are based on a Department of Defense directive for all military installations. It stems from an increase in motorcycle accidents involving members of the military and civilian employees at military bases, officials said.

The rules could have an even more far reaching impact. Iowa National Guard officials are reviewing the Army directive to determine whether they apply to such places as Camp Dodge in Des Moines and to Iowa Guard members going to and from monthly drills, said Lt. Col. Jerry Kline, assistant Guard chief of staff.

Kline said he's already advised the members of his unit to comply with the new rules for the time being.

At the arsenal, the rules have drawn complaints.

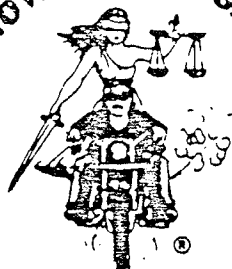
Motorcyclist Doug Fellows, 36, of Davenport, a meatcutter in the arsenal commissary, said he doesn't mind the helmet requirement but thinks the other rules are ridiculous.

"Gloves wintertime and summertime," Fellows said, "A hundred degrees, you're supposed to wear gloves?"

Fellow said he'll comply, however. "I'm going to do it because I have to," he added. "It's either do it or drive a truck with a camper that gets nine miles per gallon."

We, the bikers of the United States of America, join together to enforce the rights and the freedoms that our forefathers fought and died for so that we may have:

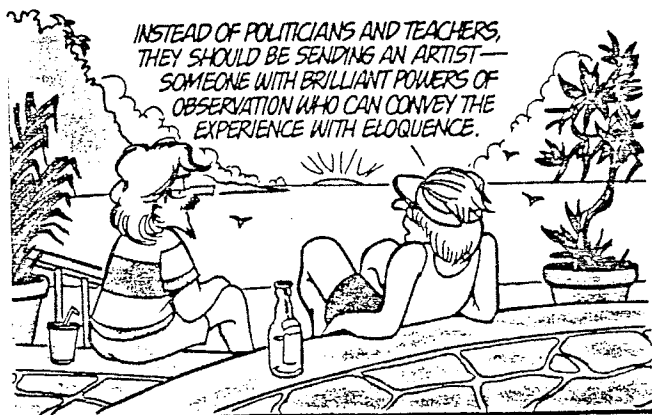
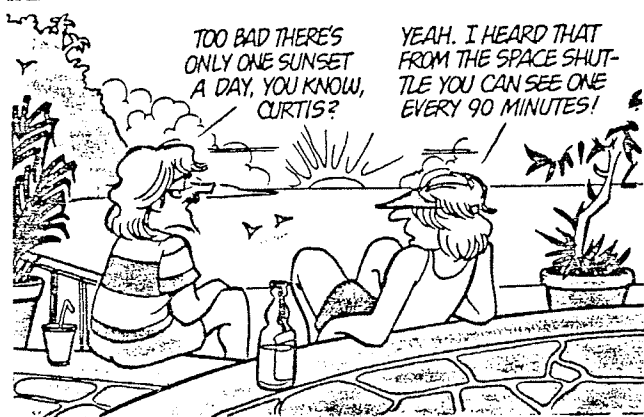
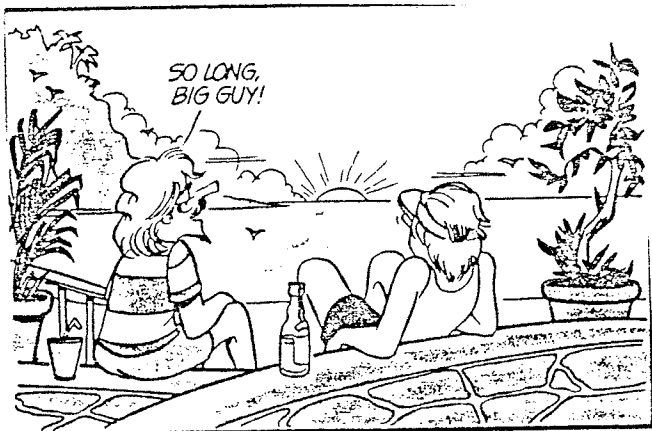
1. The right to ride free without fear of harassment nor prejudiced acts by law enforcement officials.
