Break was called and Freedom Run II T-shirts were disbursed to the chapters for selling to raise money for CFFOC.

There was discussion if this was a motion and Ed said it was meant only as a proposal. Coloring Books - Teach presented a proposal in writing which will be copied and sent to each chapter so it can be considered at the chapter meetings. Vicki said that Lincoln County has voted to donate \$150.00 toward the coloring books. There was interest from Clatsop County and Mel from AMO to get a copy of the proposal for getting estimates on printing from sources that they had contact with.

MRF in Witchita, Kansas - A 3 page outline is included in the agenda. The information at the sessions was very helpfull and there were new ideas presented.

Discussion was held on whether Joy's holding of the reports on the books for non-compliance with the rules of operation was in compliance with the motion made and passed at last state board meeting. It was pointed out that the information was available at the meeting, but the report was not being released to go back to the chapter with the state rep. Joy said she would mail out the information immediately upon compliance by the chapter.

GOVERNOR'S MOTORCYCLE SAFETY ADVISORY COMMITTEE REPORT OCTOBER 20. 1988

TEAM OREGON: Rider training is over for the year. The OTSC is discussing a proposal for a combined media campaign for all safety programs. Steve Garets of TEAM OREGON has been working with DMV to update both the written and riding test for motorcycles and mopeds, held a License Examiners Training Workshop in Salem, and repainting all motorcycle test ranges in the state. Also, all skill test sites will change to the updated ALMOST and new MSF knowledge test.

Update on helmet compliance: A research firm observed helmet use and reported that 803 of 809 riders (99%) and 109 of 112 passengers (97%) in the Portland area were wearing helmets.

DMV UPDATE: The new Oregon Motorcycle Operator Manual was distributed. There are several errors in information as it applies to Oregon riders. The committee was asked to go through the manual for errors.

Waiving skill test for some out of state endorsed riders: it is possible to waive the skill test if the applicant came from a state that requires the same or a more stringent test.

LEGISLATIVE UPDATE: The legislative concepts are back from the Governor's office. More work will be done on the concepts by the Legislative Subcommittee and in a meeting between OTSC and DMV.

MOTORCYCLE INFORMATION SURVEY UPDATE: Results are still coming in and an update on results will be out before the next meeting in December.

POSTCARDS: The Committee has been receiving postcard from motorcyclists stating that people will not be visiting this state because of the helmet law. Each card with a return address will receive a reply. Butch Harbaugh said that the AMO printed 1,000 of these cards and passed them out at Sturgis. About 500 have been returned. The Committee will forward a report on the cards and the reply to the OTSC and the Governor.


NEW BUSINESS: Dr. Dave Lawson of OSU Department of Health was asked if EMTs were trained in proper helmet removal. A report on EMT training and helmet removal will be given at the next meeting.

BORDER SIGNS: To notify motorcyclists of the new helmet law and the headlight on requirement are being investigated. A report will be given at the December meeting.

COMMITTEE GOALS: The Statement of Goals was re-adopted by the Committee.

LOS ANGELES, Nov. 8, 1988 -- Motorcycle riders suffered a political setback today when California Assemblyman Richard Floyd (D-Hawthorne) gained re-election to the 53rd Assembly District in spite of a concerted effort by the nation's motorcyclists to oust him. Floyd had infuriated the bikers by introducing and arrogantly pushing through AB-36, an adult mandatory helmet bill which was eventually vetoed by Governor George Deukmejian.

"Floyd swore that he would re-introduce AB-36 on the first day of the upcoming legislative session," said Harry Roach, chairman of the board for ABATE of California (The American Brotherhood Aimed Toward Education), "so our only recourse was to mount a campaign against him and try to get him out of office."

Spearheaded by ABATE, Bipartisans Against Discriminatory Legislation (B.A.D.L.) and Bikers Against Manslaughter (B.A.M.), the motor-cyclists launched an unprecedented grass roots effort to unite riders nationwide behind their endorsed candidate, Chuck Bookhammer. Motor-cyclists actively backed Bookhammer, pouring thousands of dollars into his election bid and doing much of the campaign legwork, largely because of his Freedom of Choice platform and his stated concurrence with the spirit and intent of the governor's veto of AB-36.

"All too often, government by Nanny tends to step on personal rights in its misguided attempt to protect society from itself," declared Bookhammer, adding that, "My defeat could still be viewed as a victory for the motorcyclists because, although they've been traditionally portrayed as non-involved individualists, this campaign served as a catalyst to bring them together for a common cause -- and I am proud to have earned the support of those who are willing to stand up for their rights."

An optimistic Bob Mannah, Director of B.A.D.L., was quick to point out that the democrat Floyd admitted spending over \$600,000 on his re-election campaign, nearly double Bookhammer's expenditures, yet won by a margin of only 3-2 in a district that boasts more than twice as many registered Democrats as Republicans.

Noting that an incumbent has not lost an Assembly seat in California since 1982, Mannah said, "We have to look beyond what happened in the 53rd district and concentrate on our successes. Our combined organizations raised nearly \$15,000 from motorcyclists throughout California and across the country, allowing us to endorse 14 other candidates and contribute to their campaigns. ABATE, B.A.D.L. and B.A.M. worked hard to organize bikers into a voter bloc that could influence these elections, resulting in victories in 12 of those races."

According to B.A.M. National Director Bill Bish, "Floyd had some very uneasy moments and it was due in a large part to our efforts. We lost this battle, but we made a strong statement in Floyd's area that the 'biker lobby' is alive and active in California."

Leafing through a recent edition of the San Francisco Examiner, Bish refers to an article which begins, "Are bikers emerging as California's newest unlikely political force? If the race in Los Angeles County's 53rd Assembly District is any reliable gauge, the answer is yes."

ITS OVER, ITS OVER--Thank god it's over! (Election day, that is) Time to sit back and congratulate ourselves on the defeat of the Seat Belt initiative--that sounds good doesn't it? Yes it sounds good, but it also sounds defeatest too! Quite frankly, I was surprised at the margin, 55% to 45%. That's not exactly a land-slide!

In Klamath County it's margin was much greater, 64% no/ 38% yes. Lake County was 61% no / 39% yes, about the same. I was not able to get the breakdown for the rest of the state because I had to work for the 2 days following the election. If anyone has the totals for more of the Rural and Metropolitan areas of the state, please publish them next month! It would seem that mainly Rural areas are very much against it.

What's going to happen in two years, four years, six years, etc.? I'll tell you. We will have it shoved down our throats again, and again, and again! And the Pro-seat belt fanatics will have big bucks behind them! Why? Because the Federal Government has mandated that 38 states <u>must</u> have manditory seat belt laws in the near future or Detroit and Japan will have to install air bags in all new cars. They are talking at \$2000 per car extra. At these price increases, they will lose <u>a lot</u> of customers. And those customers mean billions of dollars!

So you can bet the Auto manufacturers and dealers will support any Pro-seat belt law in a generous way--it's tax deductable and they know which side <u>their</u> bread is buttered on!

With a 55%--45% margin, only 5% of the voters have to be persuaded to change their minds. If our stat legislators get the chance to ram it down our throats again, I shudder to think of the result. The last time they voted, it was almost too close to call. Imagine what a couple of million dollars to the "Right" legislators from special intrest groups could do! (all in strict accordance with existing lobbyist laws and ethics, of course.)

If we can find out areas where our efforts are needed most to combat seat belt laws, it could be a big help. We don't have millions of dollars to spend. I'm not saying to cease all efforts in areas that seem secure. But consentrate our big guns on the fronts where they are needed most! Because if we have a manditory seat belt law in Oregon, I'll take bets at 8 to 5 that we will continue to have a manditory helmet law, - and at those odds, you"ll be getting cheated!

Voters say: Don't tread on us

Don't tread on us. Let us make our nown decisions.

bon That is the message Oregon voters sent the politicians and governing bodies Tuesday as they went against national opinion in the presidential orace and resoundingly rejected meassiftes that proposed to put government deeply into their lives.

ment deeply into their lives.

The message ought not be interpreted as overly negative or distrustiful, but rather as a reaffirmation of Qregon's voting independence.

This was clear in Ballot Measure & a proposal to make Oregon the o83rd state to require all occupants of amotor vehicles to wear seat belts. In rejecting that measure, 57 percent to 43 percent, Oregonians were saying that buckling up to save lives ought to be a personal choice, not a government regulation.

They missed the point. Someone has to pay for the carnage — the deaths and serious injury — that beltless drivers and passengers suffer in an accident. Increased insurance premiums will make that adjustment for all of us, but the begislature should continue educating Oregonians to understand that vehicle occupants who do not use seat belts ought to be financially accountable in some way for their independer in the automobile.

Measure the the anti-smoking pro-

Measure be the anti-smoking proposal, is an other example. There was a health issue advanced in this campaign, too, but Oregonians, in rejecting it by a 3-2 ratio, wisely recognized that this measure was an overzealous intrusion by government into the lives of its citizens.

Measure 5, which would have boosted the tax on a pack of cigarettes and a can or bottle of beer by 1 cent, asked these consumers to finance intercollegiate sports, including women's sports, as mandated by the federal government. Again, the voters stiffened.

State government does have to carry out this federal mandate. The Legislature has shirked this responsibility, but it should look again in 1989, while also recognizing the funding squeeze for more important, competing needs. The colleges should do the same thing. Surely they could find some money for the undernourished sports programs in their own budgets, if ahowed.

Passage of Measure 8, which rescinded Gov. Neil Goldschmidt's order prohibiting discrimination against homosexuals by state government, sent a variety of messages.

Voters, in many cases, were saying that they do not want homosexuality to be accepted as an alternative lifestyle. Even though the measure's backers insist that this was not gaybashing, not a retreat from a tough anti-discrimination posture, the sad reality is that the election tally will be interpreted outside the state as a step backward.

Our hypocrisy on belts

Even people who strongly favored the seat belt initiative cannot be all that miserable about the outcome of Tuesday's election.

If nothing else, the defeat of that measure showed that most Oregonians would rather not pass another unnecessary law.

at's a good attitude. It's an attitude the Legislature would do to emulate.

Supporters (including this paper) backed the seat belt measure because similar laws in other states and countries have worked. They have worked to raise the percentage of motorists using safety belts, and this in turn has had a generally good effect in preventing death and injury on the roads.

But the measure clearly was not *necessary* in the same way hat speed laws, say, are necessary to protect the public safety. Even without a law there is nothing to keep motorists from puckling their safety belts. Thousands of people do so every lay.

Unfortunately, though, the measure's defeat knocks out the underpinnings of the voters' decision last May, when Oregon approved the requirement that motorcyclists must wear approved helmets.

The electorate has proved itself hypocritical. The majority was perfectly willing to force its notion of safety on motorcyclists, a small minority. But when it came to applying a similar requirement to everybody who drives and rides in cars—the vast majority—the voters said no.

Nobody said democracy is always logical or fair.


