

I own 5 helmets and rarely ride without one. We were specifically requested by your photographer to remove our helmets before the photograph was taken. I feel that your use of the photograph without our helmets is unfair and is a misrepresentation to the public. My opposition to the helmet law is based on the premise that adults should be permitted to make their own decisions without government dictating the rules and regulations regarding accessories to be worn while operating a motorcycle. I am a strong advocate of driver education and seek more stringent examinations and testing prior to the issuance of a motorcycle license. Further, I am in favor of required usage of helmets for motorcyclists under the age of 21. Motorcycling is a fun sport that must be taken seriously, and I have never advocated the "star status devil-may-care" image you have wrongfully portrayed. Jay Leno, Los Angeles

Busey begins recovery; helmei law reinfroduced

SACRAMENTO, Calif. - As actor Gary Busey recovered from brain surgery at a Los Angeles hospital after suffering serious head injuries in a motorcycle accident, Assemblyman Richard Floyd reintroduced a mandatory helmet law that Busey campaigned against.

Floyd said of Busey's accident: "It's a shame, but it's also a shame that he probably wasn't the only one yesterday who had a motorcycle accident. He's a celebrity, so it's news when he has an accident. But, this year, there will be 800 deaths and more than 25,000 injuries in motorcycle accidents, some of which could have been prevented."

Last year, Floyd's AB36, which required all motorcyle drivers and passengers to wear helmets, easily passed the Legislature but was vetoed by Gov. George Deuk-

Busey's accident did not influence the reintroduction of the bill. Floyd vowed last June, the same day the bill was vetoed by Deukmejian, that he would submit an identical measure the first

By Scripps Howard News Service day of the next legislative ses- ing up his sion.

Floyd reiterated that pledge throughout his re-election campaign, in which he was heavily opposed by motorcycle organizations.

The 1988 version of the bill, identical to last year's, was introduced Monday as AB8. Current law requires anyone under 151/2 years of age who drives or rides a motorcycle on a public road, street or highway to wear an approved helmet. AB8 would make the current law applicable to all

Donna Lucas, Deukejian's deputy press secretary, said, "The people who lobbied the heaviest against the bill were motorcycle operators." Ms. Lucas said the governor would "obviously, look at" the new version of the bill, along with "any new informa-

Busey, 44, was injured Sunday afternoon, moments after pickmotorcycle from a repair shop. A



police spokewoman said Busey, who was not wearing a helmet, lost control of his motorcyle and hit his head on a curb.

A spokesman for Cedars-Sinai Medical Center said: "The early indications are that he was spared brain damage. We're now cautiously optimistic about his chances of recovery.'

Busey is best-known for his 1978 Oscar-nominated periormance in "The Buddy Holly Story," a film biography of the 1950s rock 'n' roli star who died in a plane crash.

Last month, Busey helped to raise funds to pay a lobbyist to fight Floyd's bill.

NEWS NOTES FROM AROUND THE WORLD

Surgeon General Solicits Comments

The Motorcycle Riders Foundation (MRF) has been asked to comment on the draft recommendations from the Surgeon General's Workshop on Drunk Driving. The draft recommendations include, "Promote passage of laws regarding mandatory helmet usage for all motorcycle riders." MRF Co-Chairman Michael Farabaugh noted, "This type of proposal does nothing to prevent the problem of drunk drivers/riders on the road, causing accidents. More of the government's energy should be channelled into the educational and awareness process, instead of trying to control every aspect of each citizen's life." MRF has distributed a questionnaire to over 500 motorcycle rights leaders across the nation, and has pledged to carry the responses received to the Surgeon General's office. The workshop took place in December, and all comments must be in by January 31, 1989. A copy of the questionnaire may be obtained from the MRF office, 25 "E" Street, N.W., 8th Floor, Washington, DC 20001, Attention Wayne Curtin.

California Passes Proposition 103

The California "insurance revolt" initiative measure, narrowly passed by the voters in November, is supposed to accomplish several things: force insurance companies to roll back premium rates for homeowners, car and motorcycle insurance to 1987 levels; give drivers with good records an automatic 20% reduction beyond the original rollback; and force insurance companies to justify rate increases as never before, bringing them "into the light of day." The proposition was immediately challenged in court by the insurance industry. The California attorney general counter-sued, asking the state Supreme Court to allow the cut in rates to take effect while the court reviews the lawsuits. Several insurers have announced that they will pull out of California as a result of passage of Prop. 103. State Farm Insurance, California's largest home and auto insurer, has stopped issuing new policies in California. Thanks to FORR of Missouri Newsletter, December 1988.

Velcro Chin Straps on Helmets Unsafe

According to the Snell Memorial Foundation, the use of Velcro on motorcycle helmet chin straps could cause serious head injuries or fatalities in the event of an accident. Because Velcro is easy to fasten, helmet users might fail to properly thread the chin strap through the "D" ring closure or buckle, allowing the strap to come undone in the event of an accident. Snell will not certify helmets that can be improperly fastened using. Velcro as the prime fastener. Helmets with such a design found in random testing will be recommended for decertification or recall. The Snell Memorial Foundation issues voluntary standards for helmets used in mo-

torcycling, automobile racing, bicycling, equestrian sports and skiing. Each set of standards is revised approximately every five years. The Foundation conducts a random testing program to ensure the continued safety of Snell-certified helmets.

Moscow: Cops & Rockers

According to an Associated Press article, Moscow police have bought powerful motorcycles to battle a Moscow motorcycle gang called the Rockers that has caused accidents and disturbed residents of the capital. Tass, the official Soviet news agency, said police purchased an undisclosed number of German-made BMW's capable of speeds up to 136 mph. Tass said the Rockers will not be able to escape police pursuers because their motorcycles are no match for the BMW's. Tass reported that 10,000 people were killed yearly in motorcycle accidents throughout the Soviet Union, and that since April first Moscow police have detained 62 "supermen on motorcycles" for lacking proper documents, license plates or mufflers, and for speeding or ignoring stop signs. Last year, officials tried unsuccessfully to persuade the Rockers to join official organizations or ride in designated areas where they wouldn't disturb anyone. "Now that they rejected this and that, maybe that's enough persuasion," Tass said. "It's time to move on to legal action."

MOTORCYCLE

Distractions

- You are riding down the highway on a warm afternoon with your jacket halfway unzipped. Suddenly your shirt collar works its way free and begins to flail your neck in a most annoying manner.
- It's winter and you've made a commitment to go the long way home in order to make a delivery—without your heavy gauntlet gloves. Your knees shiver against the tank and your fingers are frozen to the handlebars in a death grip.
- Traffic is slow and the weather looks bad ahead. The faceshield on your helmet begins to fog with each breath. You try exhaling downward, using your upper lip to funnel the moist air out of the helmet and away from the shield. That doesn't work for long, so you revert to wiping the inside with a leather-gloved hand—only to make things worse.
- There is a 1986 sport bike you've been drooling over in the reflection of your rearview mirror. You admire the bike's styling and its well-dressed rider. Suddenly, the car in front of you weaves to reveal a construction worker's ladder in the road.

These are realistic distractions that most motorcyclists have experienced at one time or another. There are, of course, hundreds of such distractions that take our attention away from riding: attractive members of the opposite sex, flashing red lights, other motorcycles, squealing tires, unexpected bad weather and even sneezing, among others.

Concentration on traffic and the road is broken when you are distracted. The SIPDE process (Scan, Identify, Predict, Decide, Execute) is interrupted while your senses shift to a new, distracting source of interest. When a rider is distracted, simple road hazards become dangerous. Trying to tuck in a flapping shirt collar with one hand while riding down the turnpike at 55 mph in traffic not only pulls_away the rider's attention, but also pulls one hand off the controls.

Paying more attention to the distraction than to riding safely can cause serious accidents. It's for that reason that motorcyclists must train to avoid being distracted. There are two primary areas to work on: preparation and selective concentration.

First, make sure you and your motorcycle are well-prepared for the ride. You will want to avoid pesky rattles, mechanical distractions and the like by performing a pre-ride inspection of your motorcycle. Remember "T-CLOCK" to check the motorcycle's components. It only takes a minute and may save you a lot of time and money.

T —tires and wheels C —cables and controls

EDUCATION

A.B.A.T.E of N.Dakota

L —lights and electrics

O -oil and fuel

C -chain and chassis

K -kickstand and centerstand

Nothing is worse for road concentration than wondering if the chain is too loose because it hasn't been tightened in two months. Be sure your luggage is secured safely, too, since a slipping dufflebag can drive you crazy. You want to have confidence in your bike and your load so you can ride without apprehension or distraction.

Such preparation goes for your personal gear as well. If the chin strap on your helmet flaps in the wind because it's too long, fix it before you ride. If you ride in cold weather, prevent condensation and water droplets on your faceshield with a no-fog solution. And be sure that your preparation includes proper regard for all weather conditions as well.

To improve your concentration, you need to be selective about what you give priority attention. Make sure the road and traffic situations are safe and clear before you choose to look at the new freeway billboard. With time, you will become better at evaluating your position in traffic and taking in the scenery. Just make sure you start your selective concentration by studying traffic. The scenery comes later.

There will be times when you have to let an attractive distraction go by without ever looking directly at it. It would be nice to take a better look, but riding in a tight situation requires all of your concentration. It's best to be looking at brake lights or bumpers than bodies or scenic views. Selectively concentrate on what is necessary to ensure a safe ride.

Many riders choose motorcycles as their means of transportation because they allow for greater sensation. They attract attention and feel great. Drivers tend to look at a motorcycle rider more than at other drivers simply because the motorcyclist is more exposed. Riders also are more in contact with their outside environment and, as a result, receive more outside stimuli than the driver of a car.

Our sensory organs are in high gear while riding—and that's why most of us like it. And one can still feel the sun's warmth, smell the flowers and take in the scenery while riding safely. Just be sure to prioritize safety first.

President-elect Bush to stay the course

The election of George Bush as the 41st president of the United States in November probably signals four more years of staying the course set during the Reagan years. In fact, in an interview featured in our November issue, Bush promised that many of the Reagan-era policies will be carried over to the new administration.

In that interview, Bush went on record with his desire to keep the federal government out of such issues as interstate highway speed limits and mandatory-helmet-use laws. "I believe that such decisions should rest in the hands of the states," he said.

Bush added that he favors a well-rounded, comprehensive approach to motorcycle safety, including the type of rider-education programs advocated by the AMA.

Off-road riders can expect increased sensitivity toward recreation issues. The president-elect is an avid fisherman,

boater and outdoorsman and has a personal interest in making recreational opportunities available. He has stated: "All Americans with various interests should have access to public lands...but these lands must be protected and enhanced for generations to come."

So, although Bush has shown a stronger, more evident and personal outdoor ethic, it looks as though compromises will be made. It's quite likely that the Bush administration will tighten the reigns on environmental issues. However, those decisions will be tempered by the president's interest in preserving access to public lands.

The Mandatory Helmet Law Arguements Facts or just assumptions?

Medical trauma center studies and reports:

Pro mandatory helmet law advocates indicate that there is a public burden to society associated with the injuries seen at various hospital trauma centers. A report from a trauma center in Seattle, by F.P.Rivara says that the average expense per patient is around \$25,000. This report also states that around 60% of the related expenses were paid for by society, in one way or another. The report concludes that a mandatory helmet law would be the cure for this public burden to society.

Further evaluation of this report indicates that they are made up of mostly erroneous assumptions. The average expense per patient is not out of line with the rest of the trauma center patients because those treated are "the most

injured of the injured", and that expenses are the average for <u>all</u> the patients at the trauma center regardless of how they received their injuries. These studies fail to include that "as many as 60 percent" of <u>all</u> patients treated in trauma centers are "too poor to pay or carry insufficient insurance" and that the "lack of

Mandatory helmet law proponents indicate that motorcycle accidents involving helmetless motorcycle riders present a financial burden on society that is unacceptable. Let's examine this closer and include some facts.

reimbursement" is a major factor as to why trauma centers are in such deep financial trouble. Reports and studies of this kind typically ignore that this is an important social problem, not just a "motorcycle only" problem. In addition, in one such study indicating 61% of the riders sustained head injuries, the authors didn't indicate how many riders were wearing helmets and how many weren't. The conclusion can only be that motorcyclists treated in trauma centers are no more of a burden to society than the general public in failing to pay the expense of trauma care.

Motorcycles constitute only 1% to 2% of the vehicle population on the road at any time. Combine this with the fact, reported by University of California, Davis, Medical Center, that motorcycle related accidents reported nationally was 0.0307% of registered motorcycles. Simple arithmetic shows that all motorcycle related accidents combined is equal to 0.0006% of the vehicle population on

the road. These figures are not manufactured, but are taken directly from the Department of Orthopaedic Surgery, University of California, Davis Medical Center, Sacramento reports in JAMA, Nov. 1, 1985. Now in most common sense conversations this amount, 0.0006% of the vehicle population (which doesn't even separate the severe from the minor, the head injuries from the non-head injuries, or the helmeted riders from the non-helmeted), cannot possibly constitute a significant cost burden to society. Therefore, this argument is totally biased and without foundation.

Primary safety measures for motorcycle accident head injuries has been to mandate helmet laws. This, too,

requires closer examination.

Bell helmets describes the purpose of the helmet is "to mitigate the adverse effects of a blow to the head". The helmet's ability to do so is determined by how it is constructed, how it fits the wearer, what condition it is in, and

the severity of the impact. Helmet standards and construction materials vary and there is no assurance of the quality of the helmet due to poor quality control standards. For a state to enact such a law might place itself liable for the injuries sustained from helmet use. Helmet use is an adequate option for personal safety, but mandated helmet use is <u>not</u> a motorcycle safety measure.

In conclusion, out of the 14 safest states to ride a motorcycle only 3 have mandatory helmet laws. Out of the 14 most unsafe states to ride a motorcycle 8 have mandatory helmet laws. Please consider the point of view of those you represent that actually ride and live with motorcycles, not those that don't.

IIHS flip-flop—The Insurance Institute for Highway Safety (IIHS), the group that promoted 1987's proposed sportbike ban, has done a flip-flop on the notion of accident research. You may recall that the study used to support that proposed ban on sport motorcycles looked only at the style of the bike, while ignoring vital information about the rider, including age, experience, licensing status and sobriety. When respected motorcycle safety researcher Harry Hurt called the IIHS study "fatally flawed" because of that narrow-mind-

edness, IIHS President Brian O'Neill defended the institute's approach, saying, "It's the standard used for studies of this kind involving passenger vehicles and trucks." However, the IIHS recently released the results of a study to determine the safest automobiles in production based on accident statistics. And guess what? That study includes information about exactly who was driving the car and why the accident happened!

Strap'em on—As of January 1, all ATV riders in California are required to wear a safety helmet while on public lands. The bill requiring helmet use, introduced by Assemblywoman Doris Allen (R-Cypress), was passed by the state Legislature and signed into law by California Gov. George Deukmejian in 1988. The new law applies to all persons, regardless of age, riding three- or fourwheeled ATVs on public lands in the state. The California Department of Parks and Recreation's Off-Highway Motor Vehicle Recreation Division will post new signs in State Vehicular Recreation Areas that will advise riders: "No Helmet = No Ride."

Richard M. Nixon "I Am Not a Crook" Award: to Brian O'Neill of the Insurance Institute for Highway Safety (IIHS), who told American Motorcyclist that his group is a "scientific institute of international repute" and not "a public relations machine backed by a couple of guys with quasi-research credentials." After the AMA spoiled their plans to introduce legislation to ban sportbikes, O'Neill and company then entered their "scientific" study into a national public relations contest and won the "best of show" award!

LEGISLATIVE LIST

ere are some proposals expected to come up in the 1989 Legislature, which opens Monday:

- CAMPAIGN FINANCE: After record legislative campaign spending, proposals are being offered to limit contributions and spending.
- DRUGS: A rerun is expected of efforts to outlaw the sale of drug paraphernalia and to set standards for when workers can be tested for drug or alcohol use.
- EMERGENCY PREPAREDNESS: Local emergency management officials want reversal of Gov. Neil Goldschmidt's refusal of federal funding so the state isn't involved in nuclear-war planning.
- FIELD BURNING: Renewed attempts to limit or ban field burning are anticipated after seven motorists died when heavy smoke drifted onto Interstate 5.
- GAY FOSTER PARENTS: The Oregon Citizens Alliance, which won repeal of the governor's order on gay rights, wants homosexuals barred from being foster parents.
- HAZARDOUS MATERIALS: Goldschmidt proposes a \$10.3 million tax on hazardous waste producers or importers to help state cleanup and handling. Environmentalists want to encourage, or even force, businesses to reduce use of toxic materials.

- MINIMUM WAGE: Organized labor and other groups want an increase in the state's current minimum wage of \$3.35 per hour.
- PLASTICS RECYCLING: A variety of proposals aimed at encouraging or requiring the recycling of plastic products will be introduced.
- SELF-SERVICE GASOLINE: Oregon's ban on self-service gas sales will come under attack again, this time by dealers who want to cut labor costs.
- will request increased penalties for child sex abuse and laws to make prosecution easier. One proposal would create a "genetic fingerprint file" of known sex offenders.
- SCHOOL DISTRICTS: As a cost-savings measure, the Legislature will look at proposals aimed at merging small school districts and those without a kindergarten-12th grade program.
- SOBRIETY CHECKPOINTS: Legislation will be introduced to allow the police to set up roadblocks to catch intoxicated drivers, a practice that state courts had stopped as unconstitutional.


- WEHICLE FORFEITURE: Another antidrunken driving measure would give local governments the authority to seize vehicles of convicted drivers.
- The state's troubled mortgage program will come under scrutiny as legislators decide whether to increase or reduce Goldschmidt's plan to repay the program \$20 million owed from previous years.
- **TVOTE BY MAIL:** Avid supporters of Oregon's mail balloting system want legislative authority to extend it to primary and general elections.
- mess groups would like several more major changes, as the workers' compensation remains one of the country's most expensive despite legislation on the subject in 1987.

■ INTERCOLLEGIATE ATHLETICS:

Whether the state should provide aid for intercollegiate sports will be debated as the governor asks for \$2.3 million for coaching salaries.

- LAND USE: The Land Conservation and Development Commission's controversial attempt to develop new rural land-use policies could trigger legislative action.
- LEMON LAW: A consumer group wants to extend the new vehicle "lemon law" to cover used cars.
- MENTAL HEALTH: The governor wants an additional \$22 million to upgrade the state's mental health institutions, which have been criticized as providing inadequate care.
- METRO: One proposal would allow Metro to impose an excise tax on landfill fees and zoo admissions.

- TAXES AND FEES: Ideas include a surcharge on fishing licenses to finance fish hatchery improvements; boosting the gas tax for road improvements, and increasing the cigarette tax to fund health-care and social service programs. Another idea is allowing local governments to impose vehicle registration fees for improvements to major urban roads.
- TEEN-AGE DRIVERS: A rash of deaths of teen-agers in traffic accidents has prompted proposals including requiring teen-agers to graduate from high school or maintain a certain grade point average before they can get a driver's license.
- TWO-PARENT WELFARE: The governor's decision to only partially fund welfare payments for two-parent families out of work will be debated.
- UNEMPLOYMENT INSURANCE: Organized labor wants workers involved in labor disputes covered by unemployment insurance, while Associated Oregon Industries will try to increase from 18 to 26 the number of weeks of work needed to qualify for benefits.




