

We now have ABATE hats for \$5. She needs contact names and numbers for the run calendar and sanctioned and non-sanctioned runs need to be listed on the calendar.

Ways and Means Director:

The coloring books are almost gone. They have been donated and or sold and the money has been received. Kraig also reported that he is thinking about a multi-directional poker run for the trip to Fossil. The start points would be in three different locations so he will need volunteers who will be responsible for the monies and the cards. The final card would be drawn at Fossil.

Education Director:

Mel talked about the information he received from the MRF. He paraphrased the information and sent letters out to all chapter coordinators. (He read the letter so those who hadn't had meetings could be made aware of the information.) There is a copy of the MRF handout in your rep packets.

State Run Report:

The permit is back, Fossil flyers are ready, posters are being worked on and Roger is working on getting Bud posters.

Ed will be doing the Poker run at Fossil. (Kraig will not be working on this run as he will be looking for people in Eugene, Salem and Portland to help with the multi-start that goes to Fossil)

Vicki said the games will be the same and their will be an obstacle course.

"Pet tickets" were discussed and how to keep pets "under some type of control" was discussed.

Addresses for flyer mailings are requested by Lois for sending information to magazines and other organizations that would publicize our Fossil Run.

He is requesting help from the legislative officers of each chapter to help with this project.

He has more of the "political quiz" flyers, their is an organization in Corvallis that is going national with a 900 number to give out information on how the "national officials" stand on different issues and his thought for the month is "A BAD LAW IS A LAW THAT TRIES TO PROTECT YOU AGAINST YOURSELE".

Health Care Town Meetings will be held on 1-14-92. Roger listed out the where, when and who. Rich brought up that public health care can bring up the issue of public burden.

Motorcycling, as other sports, is coming under increasing fire from the insurance industry, government agencies and a well-meaning but misinformed public.


The voice of an individual is small, and easily ignored - but many individuals joining together in political action can generate a voice that is big enough to be heard.



CATS, DOGS AND COWS

by Bill Ley, our Texas Aid To Injured Motorcyclists Attorney. He has been riding motorcycles for 24 years and is committed to helping fellow bikers with their legal problems.

All riders know that animals are a hazard, but not all riders know their rights if an animal causes an accident.

First, animals are amoral. Only humans can be "in the right" or not. So an accident is never the animal's fault. It can, of course, be the fault of the animal's owner.

Generally an owner is responsible for damage done by his/her animal if he has failed to take responsible precautions to prevent such damage. Just what precautions, if any, are reasonable depends on the animal's history and the circumstances.

For example, if the owner knows his dog chases motorcycles, does nothing about it, and the dog causes a cyclist to lose control, the owner is probably responsible for the damages.

Expanding on this theme, we recently handled a South Texas case in which the owner of a dog, known to chase any noisy vehicle, (mainly trucks), was found responsible for causing a 16 year old boy to lose control of his dirt bike with a defective muffler. This was am ore difficult question, but the dog had also run bicyclists into the curb, and the similarity in the facts was pretty obvious.

Most urban areas have "leash laws", which are really intended to keep down the pet population explosion, rather than to insure motorists' safety; but violation of this law will also subject an owner to liability for traffic accident damages if his unleashed and unfenced dog causes an accident.

Owners of larger animals like cows and horses are usually, <u>but</u> <u>not always</u> required to keep them off the roadway behind fences. Texas, and other jurisdictions, have an umber of "open range" areas, (which should be marked with "Loose Livestock" signs, but sometimes cattle guards are your only clue) where livestock is allowed to run free. In these areas a cow is no different than a deer: If you hit it, it's just your tough luck. In fact, you may have to pay for the animal! *END*



NHTSA CHIEF PRAISES MOTORCYCLISTS FOR IMPROVED SAFETY

Washington, D.C. - The outgoing head of the National Highway Traffic Safety Administration (NHTSA) said today that the motorcycle community was to be commended for its efforts to improve motorcycle safety during 1991, according to the American Motorcyclist Association (AMA).

In announcing a drop in the national traffic fatality toll this year, NHTSA Administrator Jerry R. Curry told a round table group of safety analysts that motorcyclists deserve a share of the credit for lowering fatalities to a projected 41,350 deaths, or 1.9 fatalities per hundred million vehicles miles traveled.

"This marks the lowest number of lives lost in one year since 1962," Curry said. "Motorcyclists have done a good job of helping reduce fatalities."

During the discussion, which was attended by AMA Washington Representative Jim Bensberg, Curry pledged to continue NHTSA's efforts to improve motorcycle safety by briefing his eventual successor on the subject. The Federal Aviation Administration (FAA) is the next stop for Curry, who could be confirmed as head of the FAA by the Senate as early as January.

Bensberg received assurances from Curry that motorcycle safety programs and the cooperative PRO-RIDER public awareness campaign, run by the AMA under a grant from NHTSA, will continue. *END*

CANADIAN VEHICLES

In the Pacific Northwest, many vehicles are owned and licensed to Canadian citizens who have moved to the United States. After they have lived here awhile, they often decide to sell a vehicle that is registered with a Canadian provincial license plate.

Buyer beware!

Most 1988 and older Canadian-licensed vehicles sold in this area are in the U.S. on Formal Entry. These vehicles are only supposed to be here for less than a year. At the end of the year, the vehicles are to be taken back to Canada.

An American citizen buying one of these Canadian-licensed vehicles may be in for some unnecessary hardships because the vehicle cannot be titled here. The Canadian citizen can only bring the vehicle into the U.S. under a bond or must declare that the vehicle conforms to the U.S. emission and safety standards. These steps cannot be accomplished by an American citizen unless they are a license importer certified by the Environmental Protection Agency (EPA). *END*

BikePAC Advisory Board Meeting Minutes - November 10, 1991

Meeting was called to order at 12:20 10/10 at Jack Fassell's house in Lake Oswego. Present: Brian Stovall, Butch Harbaugh, Indian Charlie, Rotten Roger, Angie Jensen, Teresa Hepker, Sam Hochberg, Douglas Wright. The minutes of May 4 meeting read, since the June meeting did not have a quorum and no other meetings have been held since. Balance in treasury as of 10/31/91 was \$1743.14. A motion to send 10% of income since May to the MRF was approved.

OLD BUSINESS

Bulletin: Brian asked for articles for a BikePAC Bulletin. Jack, Butch, Doug, Roger and Sam will send submissions. Jack will provide mailing labels for dealers. It was suggested that the meeting schedule be published.

Television: The subject of public TV was discussed at length, including the offer from BTV to give BikePAC air time in their planned series for public TV, as well as the possibility of using other resources to produce our own show(s). Production quality is a concern, especially because the TV audience is son sophisticated today that viewers turn off poorly-produced shows; also there are many subliminal messages in video that need to be controlled (background and atmosphere of location, lighting, dress of participents, etc.). All agreed that positive image and professional product is vital.

Gil Revilla of BTV has asked for both financial and participatory help from MRO's. What should be the nature of our involvement? Gil's enthusiasm is driving him and he wants to get everything done right away. There is concern that deadlines may make it difficult for BikePAC to participate. Butch will be starting to work in Southern Oregon and should have some time to go work with Gil, to try to put together a pilot tape for consideration by the board at the next meeting.

WASHINGTON UPDATE

The ABATE newsletter contains the latest action guide, just a summary of current info. Soon there will be one last action to do: Senate and House transportation bills have passed, with helmet law language that we opposed. Now a conference committee will meet to meld the two bills together. There is a lot of pressure on to get the bill out. We can start now writing to ask for support of Section 122 of Senate Version, which would be the more preferable of the two versions.

NCOM has opened an office in Washington, D.C., with Debbie Lough as lobbyist.

HJR 107, which would declare a national Motorcycle Safety Awareness month, has few supporters; some congressmen think that Joint Resolutions are just a waste of time and won't participate, while many others simply have not been asked by their constituents to sign on, including some of the Oregon delegation.

AMA Charter status: A letter has come from Rob Rasor, apologizing that he thought our charter was all settled, but it is a problem because the paperwork has been lost. We have for all intents and purposes been chartered for the last year, so we are filling out the membership info again. We can use AMA logo now, Charlie has rules on how it can be used.

BikePAC PROMOTION

Tom Young has agreed to include an info packet to buyers of new or used bikes, and will pay half of membership should buyer wish to join. Sam will remind him as the riding season approaches, and will stop in to review it from time to time. Brian will be going to talk to the new owner of Portland Motorsports (Latus) regarding an MRF supporting membership, and will approach him about BikePAC as well. Teresa needs to redo display boards for brochures, including bigger holders that were sent this time.

Helmet modifications: Sam reported that Mel Yeager did some research regarding tickets on modified helmets. It looks like it is not against the law to modify helmets. Sam is conferring with another lawyer who is opposed to helmet laws, developing a memo to be available for persons who get such tickets. The memo is a legal brief for use in court by defendant; if they lose then Sam would have some ammo for appeal. He is not advising people to deliberately go out and get a ticket!

NEW BUSINESS

Elections in 92 start with the May primary, and will include some federal positions.



BikePAC Advisory Board Meeting Minutes — January 12, 1992

Meeting was called to order at 12:11 p.m. at Main Street Pizza, West Linn. Present: Brian Stovall, Butch Harbaugh, Indian Charlie Benson, Roger Hendricks, Mel & Sharon Yeager, Rich Benson, Sam Hochberg, Craig Blair, Jack Fassel, Ed Halkyard, Teresa Hepker. Minutes were read and approved as corrected. Treasurer's report was approved as read. Income for November was \$270, with no expenses. Income for December was \$220 with \$180 expenses, leaving a balance of \$2,052.25. A motion was approved to send \$49 to the MRF for November and December. Brian will remind the MRF that ABATE of Oregon and BikePAC are also sustaining members and should be listed in the MRF Reports as such.

Newsletter - Jack brought it to the attention of all that BikePAC is AMA CHARTERED (not "sanctioned"). Through oversight we neglected to send the December Bulletin to our legislators, so we will send them first class along with miscellaneous groups on the list. It was proposed and approved that future mailings go to all BikePAC members both past and present; Oregon's state and federal legislators; and all the MRO's around the country for which we have addresses.

Membership - Jack and Charlie will be working on ways to better automate our membership renewal process. Since the Rural Oregon Biker Magazine will no longer be published, Brian and Teresa have allowed their bulk mail permit to expire (BikePAC mailings have been done on that permit). A proposal was made and approved that BikePAC get its own bulk mail permit and research the possibility of making it available to member organizations as a membership benefit. Jack will send a report to the next meeting.

Video - Butch had a hard time getting hold of Gil Revilla of Biker TV, and when he did, was asked to participate the weekend before Xmas and Butch couldn't make that one. Butch has had no further contact with Gil since then.

SE Portland Chapter has six people signed up for orientation classes with Oregon Public Access. At no cost, they will learn how to use the video equipment in the field and studio. They have talked to KPTV and Fox 49, both are interested and will air a good quality publication free of charge. Subject matter they have in mind includes public safety: anti-drunk driving, watch for motorcycles, anti-drug, motorcycle safety, etc. Roger is asking that they present motorcyclists' political positions as well. Members in SE chapter have expressed concern about the quality and lack of input to BTV productions.

Roger read a letter addressed to him from Gil Revilla of BTV which was quite negative about ABATE, AMO and BikePAC failing to wholeheartedly support his efforts and about the controversy regarding his filming at runs. The letter indicated that some off-road riding groups he had approached had also not responded favorably to his proposals. It is proposed and approved that BikePAC do nothing more at this time in regard to the BTV request for money and participation in filming, and re-examine the situation at the next meeting. In the meantime, Roger will check out how much the Lane and Josephine County chapters are participating, and try to get copies of the segments Gil is providing for weekly cable TV shows there.

Federal Legislation - Brian gave a brief Washington, DC, year end report. Mel Yeager and Steve Dodds are researching the financial impact this new law will have on Oregon's Department of Transportation, and Pappy Haag and Debbie Lough are doing the same thing for all states on the NCOM computer system in Washington, DC. ABATE of Washington has been communicating with Roger about the possibility that helmet laws currently in effect

in a number of states may not necessarily qualify those states for the federal money set aside in this bill. If the Oregon Legislature needs to do something to our state law to be in compliance with federal language, it will give us another opportunity to lobby. The current economic situation of helmet manufacturers and availability will play a role in the future of this legislation as well, as will federal examination of helmet standards.

BEST of the West, March 27-29 - Butch, Brian and Teresa will be presenting workshops. Several ABATE of Oregon members are planning to attend, and are working on transportation.

AMA Sanction - A letter from Rob Rasor says our charter application has been received, and that we should be getting a response soon. He apologized for the mixup and length of time this application process has required.

May Primary Elections & '93 Legislative Session - Charlie will get a list of candidates from the Secretary of State after the mid-March filing deadline. Mel and Roger have been working on providing preliminary lists to chapters, and getting individual chapter members to be responsible for meeting with and interviewing candidates about their views. General consensus was that sending out candidate questionnaires requires a great deal of effort for a very poor response from candidates, and that a different method should be used. Charlie stressed the desirability of pre-session introduction of any bills we may decide to pursue - we should have our materials ready by July or August.

Lobbyist - Butch can't commit to full time lobbying for next session, but there are some possibilities that a hired lobbyist could be retained for the session, who would maintain our credibility with the legislature and get the daily work done. Butch and other individuals would continue to do hearing testimony, the financial responsibility needs to be spread out even more across the state to accomplish this. Charlie suggested that BikePAC might be able to go into the Bingo business, since the organization has the appropriate tax status to do so.

It was proposed and approved that Butch do initial research on cost of a lobbyist and what to expect from a lobbyist hired on such basis. It was also proposed and approved that Charlie do initial research with requirements/costs of bingo. They will report back next month.

Articles of Incorporation - Charlie will send a letter to Executive Board Members to notify them that the March meeting agenda will include a proposal to amend the Articles of Incorporation (to comply with changes in state law) and to consider Executive Board Membership status of Christ's Disciples M/C, who have not been participating in Advisory Board Meetings for a lengthy period of time.

Meeting of the Minds '92 - This will be September 25-27 in Columbus, Ohio.

Meeting Dates: The BikePAC Advisory Board is going back to monthly meetings, with the next three set for noon on the 2nd Sunday of the month. ABATE's May Awareness rally is set for May 2, with intention of coinciding with BikePAC's annual meeting.

HELMET FACTS AND FICTION

The following facts about helmet laws and safety have been collected for you to use in correspondence with your legislative representatives.

According to statistics released from the Motorcycle Safety Foundation there is virtually no difference in accidents or fatalities in states where a helmet is required vs a state where none is required. They state that these figures have remained fairly constant for the last ten years. According to the MSF the figures are:

Registrations	Accidents	Fatalities
Helmet States	1,690,338	53,1221,483
Non Heimet States	2,964,371	89,0652,543

Accidents per million registrations

Helmet States 31,427 (104.6%) Non Helmet States 30,045 (100%)

Fatalities per million registrations

Helmet States 877.3 (102.3%) Non Helmet States 857.9 (100%)

The facts indicate that you are more likely to have an accident and that this accident will result in the loss of life in the states in which a helmet is required.

The 10 safest states to ride in have no helmet laws but have <u>Strong Educational Programs</u>.

Polycarbonite Helmets are dangerous.

Preliminary statistics for 1987 from the National Safety Board show motorcycle fatalities down nearly 14% compared to 1986. These figures include statistics on mopeds and dirt bikes. On the other hand, fatalities for drivers of vans and pickup trucks jumped 9%.

A LETTER FROM SPECTRUM VIDEO PRODUCTIONS/BTV - BIKER TELEVISION

As you well know that BTV - Biker Television is on the rights of Bikers no matter what color they may fly or type of bike they may ride. We are bikers for the bikers. As was mentioned to you before, we have the power of the media, although we do not have major network power, we still have a little muscle to flex on behalf of the West Coast Biker. In this case we are fighting on behalf of ourselves and the Washington ABATE members. Enclosed is a letter to the Gig Harbor, Washington, Pierce County Sheriff's Department regarding the Longbranch incident. It will be aired January 1992 with or without a response from the Sheriff's Department. This is another facet of what BTV is all about. I think the letter might be of interest to the membership!

Gil Revilla Spectrum Video Productions BTV - Biker Television

December 16, 1991
To: Pierce County Sheriff Department
Sheriffs Office Public Relations;

We are a Video Production Company that has a weekly talk show covering California, Oregon and Washington on motorcycle issues and motorcycle rights. The name of our weekly show is: "BTV - Biker Television News and Information Show". We have several questions that went unanswered the first time around regarding the incidence that took place on September 13, 14 & 15, 1991 in Longbranch, Washington, Pierce County, with the harassment of motorcyclists who were attending the "ABATE's Washington Fall Bash '91" which was a family motorcycle event for the entire family.

We know for a fact (as we were there filming as well as stopped on an infraction) that a minimum of 29 citations were handed out during a 4 hour period on September 13, 1991, not to mention the entire weekend.

Many of the citations were un-founded and needless other than harassment procedures by your department deputies.

We were the many unfortunates who were stopped. We meet Oregon's vehicle codes yet we're not honored by your County as being legal. Our citation number is, for your records: 0041246 Cited 9-13-91. Being we are Oregon residents and were there only for filming purposes, we could not figure out how we were illegal. When we returned on September 16, 1991, we went to Oregon's State Patrol and asked if we were illegal, the answer was "No" and that your department were just harassing motorcyclists.

QUESTION:

- 1) Does the Pierce County Sheriff's Department recognize the "Reciprocity Law" between the State of Washington and Oregon?
- 2) If so, then why was an infraction given out when there was no illegal infraction in the first place?
- 3) Does Pierce County Sheriff's Department feel they can bend the law that they are suppose to enforce?
- 4) Does Pierce County Sheriff's Department recognize State laws that are in effect between states?
- 5) Is Pierce County Sheriff's Department, exempt from following Washington State law?

On our infraction, it was mentioned to 5 sheriff deputies that were standing around us as the ticket was being written up about our small utility trailer being exempt, and they laughed as we continued on about the "Reciprocity Law." They stated that the next

time we enter Washington, to get a trip permit!

QUESTION:

- 6) Is this how Pierce County Sheriff's Department operates on a daily basis, with this bias and non-professional attitude from 5 of your best?
- 7) Could it be that harassment orders came from the Sheriff himself? Or was this taken upon the 29 patrol cars individually and the 5 Deputies who pulled us over? A Sergeant was included with the five.

When we once again asked about the ridiculous "Trip Permit" your Deputy stated "then don't come into Washington!" We replied with, "you mean Pierce County and not Washington?" with a smile from your deputy "that's right!" Which Deputy are we talking about? It says on the infraction we can't read the name.


QUESTION:

- 8) Is Pierce County Sheriff's Department Covertly starting your own little country within the state of Washington?
- 9) Is Pierce County Sheriff's Department a "Law Enforcement Agency" or Law Makers as you see fit?
- 10) Did the Pierce County Sheriff's Department and deputies know that Children and their parents were scared to what actions if any might be taken at the festivities, with acts of aggressions upon them?
 - 11) Does the Sheriff's Department care?

We would like a response by your department to the questions that were asked. We will be airing our views as to the actions that were taken by your illustrious department on that fateful weekend. We do cover in our airing into the homes across California, Oregon and Washington. If you do not answer these questions, we will also make that known through media updates as to the Longbranch incident. If you or your department does not reply, we will then warn all Motorcyclists across the entire West Coast about the Pierce County Sheriff's Department and the risk they may take entering the Peugeot Sound area.

It is unfortunate that this had happened at all. But your department had no rights at all to harass law abiding citizens who may live different than your expectations, and who are taxpayers like the many of other Americans who make up your state of Washington. We as Americans have rights, and our toes were stepped on needlessly as well as our women and children. Your deputies laughed at us, and we want to know why they laughed? We want to know why your County is above the law of other local agencies. We as the people would like some questions answered.

WHEN THE RIDING BUG BIT ME

When I was in Junior Highschool my folks bought his and hers matching Panheads. We lived in Roseburg, Oregon, and they belonged to the Rumble Bees M.C. This was my first exposure to bikes and bikers. Hoved going to the rallies and watching the people do all those neat riding tricks.

At 16 I ran away from home. I went to Eugene, got false ID and lived on the streets, doing small time burglaries and robberies. That is when I bought my first bike. A Honda 300 dream. It was cherry and I rode the s--t out of it. I didn't own any tools and I didn't know anything about bikes so I didn't do any maintenance or work on the bike. Hell, I never even changed the oil all the time I had it. But I had a bike and I was a biker.

Some old lady gave me a leather flight jacket that had belonged to her son who had just been killed in Nam. One of my friends thought I should have colors, so he painted a hand with the middle finger extended on the back of my jacket, in day glow paint. So now I was set, I had my bike, my leather and my attitude for the whole world to see.

I lost that bike when I got busted on a burglary that went bad. They took the bike saying it would help pay my debt to society. That happened 22 years ago.

In the meantime, I never owned another bike until 5 years ago. I always wanted another bike and I always knew that sooner or later I would buy one. But there was always something to hold it up. No place to keep it, no money, maybe next year. There was always an excuse. Then one day I realized that I was almost 35 years old and that things were never going to get any better and now was the time to buy another bike while I was still young enough to enjoy it.

I knew just what I wanted, because I had been thinking about this for years. A Sportster, as close to stock as I could find was the bike of my dreams. I looked at every Sportster that came up for sale from Medford to Portland. There were several that came close, and I made offers on a few, but it took almost a year to find the one I wanted. Then another year to tear it down and rebuild it. I had no idea what I was doing so I bought books and asked a million questions at every bike shop I went to.

I found everyone extremely helpful and friendly and the free advise was very useful.

I took it slow and easy during the rebuild so I wouldn't make any serious mistakes.

Finally the bike was up and running, and hasn't given me any troubles in the last few years. It always starts and hasn't broken down on the road yet.

I take a few 400 and 500 mile trips each year, but mostly I ride within 100 miles of home, and I always ride to work if the weather is tolerable. I have only ridden with a group of few times. Being a loner, I like to be on my own. However, I do go to all the biker events I can because it's a good excuse for a ride and I find them very entertaining.

Now that I'm back on a bike after such a long time off, I can't believe how stupid I was to have waited so long. And I swear I will never be without one again.

It all boils down to one thing ... when I'm riding, I'm happy.

FREEDOM IS NOT ELECTED

There seems to be a lot of confusion about freedom. Many people tie it to democracy or, to be more exact, representative government. The idea is that freedom is safe as long as elected representatives are sitting in some distant assembly hall. Actually the concepts of freedom and representative government are only distantly related, and the presence of one doesn't guarantee the presence of the other.

Freedom flourishes best under representative government. But such a system of government is no guarantor of freedom. It is only a tool to help with the job. We might say that it is better to drive a nail with a hammer than with a rock, but the mere fact of owning a hammer doesn't mean that anyone is going to be driving nails.

Freedom is something that exists alone, and of itself. A big turnout on election day is meaningless if those elected aren't primarily concerned with the rights of the individual. If, indeed, the people who are intent upon passing laws that impinge on personal freedom, then representative government is working against the people.

We would do well to remember that the United States was founded upon the idea of freedom and not necessarily democracy. Those brave souls who tossed the tea into Boston harbor on that December night in 1773 were not motivated by thoughts of a Senate and a House of Representatives and how much power either one would have. They were interested in freedom, and they were quite content to save the details for another time and place. Patrick Henry was in the same frame of mind when he put forth the liberty-or-death ultimatum, perhaps the most courageous words ever spoken publicly.

The great motivating principle behind our break with Great Britain was the simple, fundamental matter of personal freedom. This was the issue. Our three branches of government, our electoral process, our two-party system, our local government, and even our Constitution are nothing more than tools to achieve this end; they are not ends in themselves. They are important only insofar as they protect individual rights, and when they fail to do this they have stopped working.

Our representatives are not in office to carve comfortable niches for themselves or to pander to bloc votes. Nor are they there to decide what is best for a constituency that cannot think for itself. They are there solely to protect individual liberties. It is ironic that they should be the ones from whom we need protection.

A sitting assembly is no guarantee that anyone's rights are being protected, or even considered. The People's Republics that sprang up in Asia and Eastern Europe after World War II are ample proof that large bodies of people calling themselves legislatures have no direct relationship to the freedom of the governed. Even with the built-in safeguards of our Constitution, a legislature that is bent upon raising taxes and passing laws curtailing individual freedom is not performing any service for those who still consider themselves to be separate entities and not part of an artificially defined economic or social class.

Nor is a high court, in itself, any protection for individual liberty. Judges who tend to legislate, rather than adjudicate, in no way are fulfilling their roles as public servants and are certainly upsetting the system of checks and balances that is supposed to keep the machine running. When the courts choose to work against the public interest, they have ceased to function as instruments of justice.

Legislative assemblies, courts, public buildings, and legal documents are only the trappings of freedom; they are equipment. If this equipment puts restrictions upon individual rights, then it becomes nothing more than an obstacle. Without freedom, government is just something to be bypassed or avoided - it is, in effect,

the enemy.

Anyone who doubts this should reflect upon that night in 1773 when 342 chests of British tea went over the side. I don't think that the point could be made more clearly.

CANADIANS FAVOR "CRIMINAL CONTROL"

by Don Williams

The last issue of AIM, the official publication of the Shooting Federation of Canada, had the results of a recent poll of Canadians regarding the control of criminals and firearms. It goes right along with the polls done in the U.S., and is much different than what the anti-gun, pro-criminal element is presenting. Some of the results included:

- 88% agreed that the new laws should control criminals, not guns, by giving out much tougher penalties to those who use a gun in any crime.
- 86% agreed that the courts are presently much too lenient in punishing criminals using guns.
- 82% agreed that law-abiding sportsmen, recreational shooters and collectors should not lose their guns because of actions of relatively few criminals.
- 69% agreed that passing more severe laws over legitimate gun users will have very little influence on criminals.

When asked which areas the government should mainly address in the proposed gun control laws, Canadians prioritized as follows:

- 33% said guaranteeing severe penalties for any crimes involving guns.
- 29% said tighter screening of new gun buyers.
- 15% said further limiting the types of guns that can be bought.
- 12% said increasing the requirements in safety training, gun use and storage.
- 8% said increasing restrictions over present gun owners.

It really makes no difference where you live; the ideas regarding guns and crime are pretty much the same--punish the criminal and leave the honest person alone!! *END*


MOTORCYCLISTS UNITE TO SAVE GEORGIA SAFETY PROGRAM

Way to go, Georgia motorcyclists. Thanks to your concerted efforts, Gov. Zell Miller has put the brakes on a plan that could have resulted in the elimination of the state's rider-funded motorcycle safety program.

That plan, the brainchild of the Georgia Department of Public Safety, was proposed as part of a comprehensive package designed to help erase the state's multi-million-dollar budget deficit. And at one point, it appeared that the Legislature would approve the department's recommendation within the context of the overall budget-balancing move.

But as a result of heavy lobbying by ABATE of Georgia, Georgia motorcycle dealers, the AMA, the Motorcycle Safety Foundation, local safety instructors and other concerned motorcyclists, the plan to drop the training program has been scuttled. Recently, when lawmakers met in a special session to draw up the new budget, the safety program was removed from the list of items slated for the budget-cutting ax. And now, motorcycle rider training in Georgia is back on course. Congratulations to Georgia's motorcyclists on a iob well done. END







SOCIAL BURDEN ARGUMENT

For nearly two decades now, pro-helmet advocates have largely depended on the logic of Simon vs. Sargent, 346 F. Supp. 277 (1972); namely, that injured motorcyclists constitute a "public burden," presumably because they don't have medical insurance to cover their injuries.

In logic, a faulty premise necessarily produces a false conclusion, and the "public burden" theory is flawed from the beginning because its advocates assume that a helmet always makes a difference between sound health and debilitating injury.

In fact, the helmet rarely ever makes a significant difference, simply because it is not designed, and built to do so. It is designed, and built, to satisfy Federal Motor Vehicle Safety Standard 218, which demands only that the helmet provide protection at impact speeds below about 15 mph.

Above 15 mph, neither the federal government nor the helmet manufacturers claim a helmet provides any benefits to an accident victim. In fact, the helmet manufacturers defend themselves in product liability suits by pointing out that they specifically warn that the helmet cannot protect from severe injury.

No motorcycle helmet manufacturer ever in his sales literature warrants his product as being capable of preventing a killing head injury at speeds excess of 15 mph.


Motorcycle helmet manufacturers do not warrant motorcycle helmets for anything other than preventing cosmetic injury or a skipping type of head injury, where the rider is propelled along the road and does not come into direct contact with an obstacle at a speed above 5-15 mph.

As its second faulty premise, the "public burden" theory assumes that only injured motorcyclists, and no other people, impose a burden on the public health system.

Agreed, a number of motorcyclists about 55% by the more hostile estimates don't have insurance, or enough of it, to cover the medical expenses they incur as a result of accidents. However, about the same percentage of automobile drives lack insurance, too. Thus, motorcyclists impose no more "public burden" than other people who suffer head injuries; for example, people such as automobile drivers and passengers, bicyclists, high school football players, pedestrians and people who fall off chairs while screwing in light bulbs. *END*


