

# Oregon Okays Biker Marriages

*Multiple County* — In a move that surprised both biker supporters and opponents, county commissioners quietly gave their license to biker couples who applied for them. Citing Oregon's constitutional guarantees of equal rights for all citizens, the commissioners received legal opinions from attorneys that confirmed bikers could be married in civil ceremonies.

"This is a great day for Oregon and bikers' rights," declared Valve Cover of *Bikers Ride Oregon*, a nonprofit group dedicated to educating politicians and raising public awareness of motorcyclist issues. "With this basic right secured, we want to show that biker marriages strengthen *all* our communities by providing more long term stable relationships."

Opposition, though initially stunned by the decision, was swift and

vigorous.

"This is just another example of the hidden biker agenda to legitimize their lifestyle and recruit kids to ride motorcycles," declared a picketer from *O.C.A.B. (Oregon Can't Abide Bikers)* outside the Multnomah county courthouse. He refused to give his name to reporters.

Another protester carrying a sign that read "It's bride and groom, not Zoom-Zoom!" declared "They got their domestic shacking up registry already. Why does they gotta want to be as good as the rest of us?"

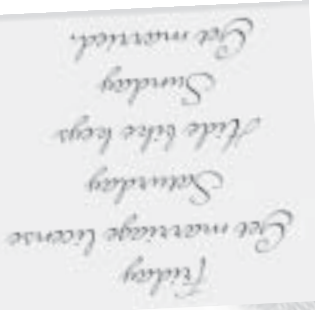
Onlookers had their own opinions on the issue. Shana of the Pearl district observed, "I don't see what the fuss is about. I mean, bikers are human too. It seems to me that the more people who marry, the stronger that the institution of marriage becomes, ya know?"

## What We're About

### A.B.A.T.E. is a not-for-profit organization

In Oregon, *A.B.A.T.E.* stands for *A Brotherhood Against Totalitarian Enactments*, which isn't nearly as subversive as it sounds. It means that we act as legislative watchdogs to help ensure that any legislation affecting motorcyclists is fair and that elected officials are fully informed regarding motorcycle issues.

- We are not a motorcycle club or gang.

Instead, *A.B.A.T.E.* is a not-for-profit organization devoted to raising member and public awareness about motorcycle issues and safety through education and community involvement. We also raise money for organizations that represent motorcyclist's concerns such as *BikePAC*.

- It doesn't matter what brand of bike you ride on.

We are not a manufacturer-specific organization. All are welcome: bikes, trikes, on-road or off, riders, passengers, or non-riders.

- You don't have to ride a motorcycle to belong to *A.B.A.T.E.*

Many of our members just enjoy being around motorcyclists. (We're just *that* wonderful.) And they feel that the social and legislative issues we're working on are important to their community.

So scan through our newsmagazine. If you like what you read, check out the chapter meeting listing on the back cover. Drop in on a meeting and see what we're about. You just might find a new family in *A.B.A.T.E.* And as Melinda says: "Bikers give great hugs."

### MISSION STATEMENT

A.B.A.T.E. of Oregon, Inc. promotes motorcycle awareness, education, safety and liberty through community involvement and legislative action.

### A Brief History of A.B.A.T.E.

*"You have to know where you've been to know where you're going!"*

*Easyriders* magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the *National Highway Transportation Safety Administration (N.H.T.S.A.)* by joining a new national biker's rights organization called the *National Custom Cycle Association*. But because of a conflict with the acronym the name was changed in February 1972 to *A Brotherhood Against Totalitarian Enactments (A.B.A.T.E.)*.

*Easyriders* began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. *D.O.T. (Department of Transportation)* was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the *Huns Motorcycle Club* in Connecticut convinced his congressman, representative Stewart McKinney, to introduce H.R.3869 to end the federal authority to withhold highway funds from states without helmet laws.

In July of 1975, Rob Rasor of the *American Motorcyclist Association (A.M.A.)*, Ron Roloff of the *M.M.A.* of California and Ed Armstrong of *A.B.A.T.E. of Chicago* presented the house sub-committee on surface transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the *D.O.T.* because governor Ronald Reagan refused to comply with the federal helmet law mandate, Roloff helped convince California senator Alan Cranston to offer the language of the bill as an amendment to the *1975 Federal Highway Act*, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by president Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached congress twice over the past few years, first to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through congress.

So, there you have it.

The roots of *A.B.A.T.E.* and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of freedom of the road.

photos to her with names and dates provided. Check to see if you have duplicates you could share with Sara.

Mel also had a very good safety tip: check your tire pressure! Many bikes sit over the winter and the major tire manufactures will tell you that motorcycle tires lose one pound of pressure each month. If your tires haven't been checked in three months, then you've lost 10% of the recommended pressure! That is enough to cause overheating and failure, let alone the handling issues it will bring on. Less steering and less braking are just two more issues you will have to deal with. Is dying or being seriously injured important enough to make you spend a couple of minutes with the air gauge? I certainly hope so!

May is *Motorcycle Awareness Month* and May 1st is the rally at the capitol. A big attendance is needed.

Originally this event drew over 500 motorcycles, now we struggle to get 300. We know there are more bikes now, but where are the people? Are they active at all? Do they know we *need* to be active to protect our rights? Something to think about if you're really in this group to fight for motorcycle rights. There is undeniable power in numbers! Please reach out to anyone you know who rides and invite them to a meeting. We need help!

Carolyn Freeman, education director, is checking out *Team Oregon* classes to let us know what is available and how we can take advantage of it. I know most folks could use a refresher course and remember, *A.B.A.T.E. of*

## Legislative Report

**Rick's Ramblings on stuff**

This month I've pulled this together from three separate reports that were handed out in full detail at the state board meeting. The first part deals with the latest—*M.R.F. Reports*, but condensed a little for my reports.

March 8th: **#04NR10** — The *M.R.F.* introduces the *Young Activist Scholarship Fund*. It's been recognized that our activists/motorcyclist, our membership, and leaders are aging. For this reason the *M.R.F.* is encouraging younger people to become involved in motorcyclists' rights. The *M.R.F.* has created a scholarship fund to recognize deserving candidates under the age of 31.

Candidate criteria:

- 1) 30 years or younger.
- 2) must be a member in good standing of n S.M.R.O.
- 3) Candidates must be nominated by their S.M.R.O.
- 4) Nominations must be submitted between March 15th and July 15th of the year in question and 50 candidates are encouraged, but not required, to submit a 300 word essay on why bikers rights are important to them.

What do winning candidates receive?

- 1) One year membership in the *M.R.F.*
- 2) Round-trip airfare to the *Meeting of the Minds* conference.
- 3) Hotel accommodations, registration fee, and banquet fees

for the conference

March 5th: **#04NR09** — *M.R.F.* e-mail alert subscriber precautions. As some of you have already heard, on March 4th there was an e-mail sent out addressed from the *M.R.F.*, that *was not* an actual *M.R.F.* e-mail alert. It was a "spoof" with an attachment that was virus infected.

Karen Bolin of the *M.R.F.* would like to assure subscribers that the *M.R.F.*'s e-mail distribution list has not been compromised. As a precautionary step, however, additional security for the list has been implemented.

March 2nd: **#04NR08** — *Transportation Equity Act (T.E.A.)* has been extended for (60) days. This replaces the previous four month extension and allows more time to work out the details of this critical legislation. As noted earlier, the senate has already passed its version of *T.E.A.* on February 12th.

The reauthorization of the *Transportation Equity Act* remains the most pressing issue at this time for the *Motorcycle Riders Foundation*. Naturally, we will continue to keep you informed throughout the reauthorization process.

March 03: Forwarded from the Karen Bolin of the *M.R.F.*, senator Ben Nighthorse Campbell of Colorado, won't be seeking reelection. For complete story:

Senator Ben Nighthorse Campbell announced that with ongoing health problems and an ethics investigation into alleged kickbacks in his office, he won't be seeking reelection. Nighthorse, a northern Cheyenne tribal chief is 70 years old, started his legislative senate activities in 1992. Has been a longtime supporter of motorcyclist rights.

## What's Happening in Other States

*Oregon* — As of January 1st, Motorcyclist can now legally run three [head]lights.

*Washington* — Motorcycle awareness education and uninsured/underinsured motorist insurance coverage are both headed for the governor's desk

*Louisiana* — The 1999 freedom of choice is under attack with two bills introduced

*South Carolina* — Right-of way bill gains 20 additional cosponsors. Bill to allow motorcyclists to carry pistols. Bill that would require registration of A.T.V.'s and rider safety classes. Also attempting to stop a bill that a primary seat belt bill with helmets also attached to it.

*Illinois* — Anti-motorcycling bill has language that singles out A.T.V. trespassers.

*Wisconsin* — Helmet bill passes assembly and heads to governors desk. Bill will prohibit courts from reducing damages based on whether you are or are not wearing a helmet on motorcycle's, A.T.V.'s, etc.

*South Dakota* — Janklow tries again to get out, but court denies request.

*Massachusetts* — Now allowing helmetless parades, also being worked is a bill that would allow freedom of choice with helmets.

*Tennessee* — The *Tennessee Volunteer*

*Off-Highway Motor Vehicle Act*, would collect \$10 per registration to support operation and management of off-highway program.

*Ohio* — A.T.V.'s required to display a motorcycle type license plate is in the process of being introduced.

*Washington D.C.* — City council approves *Distracted Driving Act of 2003*. It covers any distractive behavior by drivers. (Includes cell phones)

## Updates On Latest O.D.O.T. and O.D.M.V. Rules and Regulations

Off-road vehicles in the sand dunes including motorcycles must now have flag, headlights and tail lights

Changes in proof of age, identity and address. Amends acceptable proofs of an applicant.

Social security number required for driver license application. [Or renewal.]

Motor vehicle financial responsibility. Allows person to fill bond or deposit in cash in lieu of having insurance.

Fatal accidents. Gives *D.M.V.* authority to suspend drivers license privileges if person causes or contributes to an accident resulting in death, If it is believed that that person was incompetent, reckless, criminally negligent or was unlawfully operating a vehicle

### Notice of Proposed Rule Change

Interstate highway speed gives *O.D.O.T.* authority to set maximum speeds on interstate highways, if they meet certain requirements.

## GUNNY'S SACK



Nearly everyday I read or hear about someone who has been involved in a single-vehicle crash on a motorcycle. The most recent one that comes to mind is a guy who hit a curb and was killed for his trouble. Please, please, don't let something like this happen to anyone I know and care about. I don't know how many times I have begged and pleaded with the riders I know and love to take a motorcycle riding course. Just take a refresher, and you'll be surprised how much you *don't* know! Do it before your riding season gets into full swing.

Listen, my boss Sam Hochberg, our Oregon *A.I.M.* (*Aid to Injured Motorcyclists*) attorney, *he* did that when he started back riding again, back in '85 or so. He'd spent just a few years off of two wheels, so when he couldn't take it anymore and bought another bike, he figured he ought to take the course. But, he figured he'd just take the *advanced* rider ed class, since he'd ridden plenty not all that much earlier. He *did* take the advanced course – and then promptly crashed.

Twice.

He's not ashamed of that story, because he *knows*, like I do, just *how important* it is to take a refresher. He handles those *A.I.M.* accident claims, so he knows all too well what kinds of pain our brothers and sisters have to go through, when they make a mistake. And that's even when it's the other guy's fault. You're still better off *not* having the wreck, aren't you? It's all about defensive riding. So, do me a big favor,

*don't die*, take a rider ed refresher course, and enjoy the rest of your life!

By the way, folks, I already have some idea that most of you know how to keep the round side on the bottom. But, have you ever taken a rider ed course at all? These courses are not meant to teach you how to keep the bike upright. They are there to teach you a little bit more about how to *avoid* problems on the road, and that involved actual riding as well as a little class work.

I'm sure you are aware there are people out there who just plain don't care if you get through the day or not. If you happen to get in front of them on the road and they're in a hurry, they will just run over your sorry butt and never miss a beat. The roads are too crowded with folks who will look you straight in the eye and tell you *they know how to drive*, and you are stupid at best to ride a *murdercycle*. You can bet that they didn't take a driver's ed course, either.

Get with your nearest community college or *D.M.V.* and find out where these rider education courses take place and *please*, spend the few bucks for the training that could give you the tools to survive out there. Just being able to ride that bike isn't enough anymore. Most insurers will shave a few bucks off your premium for it, too. It's cheaper than chrome, and it *will* get you home.

### News Bits-N-Pieces

The *Motorcycle Riders Foundation* (*M.R.F.*) reports the *Transportation Equity Act* (*T.E.A.*) legislation has been extended for another sixty days. This extension replaces the original four month extension. This gives the house the time it needs to complete the work needed to work out details in the final wording of *T.E.A.* We will keep you posted. This affects *all* of us on the road on two wheels, by the way. Read up on it in your local biker publication. Most *A.B.A.T.E.* newsletters, even the national biker rags, are talkin' about it.

*Sioux Falls, South Dakota* — Senator Janklow is appealing his case to the South Dakota supreme court. According to the *Associated Press* Janklow wants to be set free during this process. Ironically, in my mind at least, is the fact that all the judges that will hear the appeal were appointed by Janklow during his terms as governor!

*Flandreau, South Dakota* — How about that, a judge in South Dakota said he would not release Janklow until his appeal is heard, because he thought it would at least delay serving his sentence, if the appeal was denied. Finally, the senator is going to have to face the fact that his actions demand he take responsibility for killing a human being. It's time to grow up, senator, and jail is gonna do that.

*New Hope, Minnesota* — The *Viper Motorcycle Company* has an agreement with *Patrick Racing* to supply these monster 128 cubic inch V-twin

For those of us with a few extra bucks in our jeans, they also found some very cool Swiss Army motorcycles! *No*, they don't have blades and magnifying glasses folding out of them. They were designed for solo dispatch riding, with dual saddlebags, a rifle-rack, and they're street-legal in most places, at least based on classic vehicle laws. American Motorcyclist Association

The *American Motorcyclist Association (A.M.A.)* has announced "Justice for All," a new nationwide initiative that will focus on inadequate sentencing of car drivers who seriously injure or kill motorcyclists.

"Justice for All" will advocate legislation establishing tougher penalties when traffic offenses or criminal actions by other motorists result in a motorcyclist's death or serious injury, a move that also would benefit other vulnerable road users such as bicyclists and pedestrians. The program will include cooperation with state and local motorcycling organizations, efforts by *A.M.A.* community councils, and a variety of opportunities for individual motorcyclists and other concerned citizens to become involved.

"Justice for All" also will feature events that coincide with the 2004 Black Hills Rally in Sturgis, South Dakota.

More details about "Justice for All" will be announced soon on the *A.M.A.*'s website, **AMADirectlink.com**, and in *American Motorcyclist* magazine.

Oregon motorcyclists can now use three headlights on their motorcycles whereas in the past, two was the maximum allowed. They will also be able to use auxiliary lights, either fog lights or driving lights, at all times if the auxiliary lights are no brighter than the headlight and the auxiliary lights are aimed correctly. All other vehicles in Oregon must turn off their auxiliary lights during times when the law

requires drivers to dim their high beam headlights. Finally Oregon riders may use an intermittent pulsing or flashing brake light, as long as the flashing does not interfere with the rear turn signal function. With the help of legislators that are motorcyclists themselves, these new options were passed and signed by governor Kulongoski.

Washington, D.C. city council has approved the *Distracted Driving Act of 2003* by a 13-1 vote. Any distracted behavior by drivers, including cell phone use, will be prohibited, effective July 1, 2004. First time offenders will receive warnings; subsequent offenses will be subject to a \$100 fine per violation. The law specifically exempts police and emergency medical technicians during an incident.

Massachusetts governor Mitt Romney has signed legislation that provides exception that no protective head gear be required if a motorcyclist is participating in a properly permitted public parade and is 18 years or older.

Bay state riders grateful for this action should contact the governor's office and let him know you appreciate his signing this bill at: governor Mitt Romney; state house; office of the governor; room 360; Boston, MA 02133. While you are expressing your gratitude drop in a line to support passage of senate bill 1363, which modifies the helmet law in favor of full choice.

Vermont drivers who operate their

vehicles without insurance or accumulate sufficient points to warrant a driver license or operating privilege suspension may face an additional one-year suspension if a death or serious bodily injury is involved. House bill 496, prefled by representative Mary Morrissey (R – Bennington), seeks to hold motor vehicle operators more accountable for their actions. Many state legislators and the U.S. congress are reviewing legislation that recognizes May 2004 as *Motorcycle Awareness and You Month*. These

include Georgia (HR 1101, SR 673), Massachusetts (HB 1202), North Carolina (HB 54), New Jersey (AJR 63, SCR 76), Oklahoma (SJR 50) and United States senate resolution 168 to create the *National Motorcycle Safety and Awareness Month*. For more information go to <http://www.amadirectlink.com/>

Mississippi house bill 807, introduced by representative Jamie R. Franks, Jr. (D- Lee, Itawamba, Tishomingo) and Charles Jim Beckett (R- Calhoun, Lafayette, Marshall, Yalobusha), along with senate bill 2013, sponsored by senator Bob M. Dearing (D-Natchez) will establish the *Motorcycle Safety and Operator Training Program*.

Magnolia state riders will be levied an additional annual \$5 fee on each motorcycle and additional \$1 for a temporary motorcycle operator's permit, and/or renewing a motorcycle endorsement to be deposited into the *Motorcycle Safety Operator Training Fund*.

The program also includes activities to increase motorcyclists' alcohol and drug effects awareness, motorcycle driver improvement efforts, program promotion activities, and other efforts to enhance motorcycle safety through education, including enhancement of public awareness of motorcycles.

Applicants for a motorcycle endorsement or a restricted motorcycle operator's license would be exempt from the licensing knowledge test and skill test if they present satisfactory evidence of successful completion of

an approved rider training course which includes a similar test of both knowledge and skill.

The efforts of Washington organizations, including the *Northwest Motorcycle Association*, *Northwest Quad Association*, *Skagit Motorcycle Club* and the *Timber Tamers 4WD Club*, in partnership with the Washington state *Department of Natural Resources (D.N.R.)* has lead to the limited re-opening of Walker Valley O.H.V. area.

The trail system was closed to all O.R.V. use on November 1, 2002. Re-opening was originally scheduled for April 1, 2003. Through cooperative efforts of user groups and the *D.N.R.*, a limited number of trails will be returned to use early. About half of the trails will remain closed to either protect resources or allow for on-going logging activities. Many of the trails closed for resource protection will be opened for use on April 1, 2003.[?]

Missouri house of representatives transportation committee, on a vote of 19 yes and 1 present, have passed HB 1080 (*Motorcyclists Matter Legislation* know as "Clutch's Law"). They also voted in favor of both helmet modification bills, HB 1109 (13 to 7) and 770 (14 to 6) and asked that they be combined on the house floor.

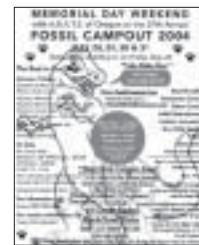
This comes only days after hearing testimony from the

*Missouri Safety Council*, *Freedom Of Road Riders, Inc. of Missouri*, the *Motorcycle Riders Foundation* and the

*American Motorcyclist Association*.

British motorcycle commuters around London are calling on their government to publicly recognize the benefits of traffic congestion relief from motorcycles. A year after local authorities began charging tolls, yet exempting motorcycles, for those entering central London the streets are safer.

Despite a 20 percent increase in motorcycle traffic in the city there has been a 15 percent fall in motorcycle casualties. Yet motorcycle sales are up 20 percent in London. All while the average speed of traffic in central London has risen by 15 percent. (*MCN.com*)

#### Candidate Criteria

- Nominated candidates must be thirty (30) years of age or younger on the first full day of that year's *Meeting of the Minds*.

- Candidates must be a member in good standing of an S.M.R.O. No time requirement for length of membership in an S.M.R.O. is required.

- Candidates must be nominated by their S.M.R.O. Nominations will be accepted from either state or local (district/chapter) S.M.R.O. groups, and must be submitted on an *M.R.F.*-approved application form.

- Nominations must be submitted between March 15 and July 15 during the year in question.

- Candidates are encouraged - but not required - to submit a three hundred (300) word essay on why bikers' rights are important to them. Should nominated candidates choose to submit an essay, they must do so no later than August 1 of the year in question.

- Winning candidates will be announced via an *M.R.F.* e-mail news release on or about August 15. All candidates will also received notification via the *U.S. Postal Service*, regardless of whether they were selected or not.

#### What Do Winning Candidates Receive?

- One-year membership to the *Motorcycle Riders Foundation*, effective the first full day of the *Meeting of the Minds* during the year in question.

- Round-trip airfare to the *M.R.F.'s Meeting of the Minds* conference, or alternate travel expenses so long as those expenses in total do not exceed the cost of traveling by air. If an alternative mode of transportation is chosen, candidates will be required to provide receipts in order to be reimbursed (receipts will be accepted for tickets on other modes of transportation, hotel accommodations, gasoline and food purchased while traveling to and from the *Meeting of the Minds* conference). If there is any question about acceptable travel expenses, it is the responsibility of the candidate to check with the *M.R.F.* prior to incurring said expenses.

- Hotel accommodations at the *Meeting of the Minds* conference. Accommodations will include the hotel room only. Telephone, food, movie rentals, etc. will be the sole responsibility of winning candidates.

- *Meeting of the Minds* conference registration and banquet fees waived.

- Special recognition at the *M.R.F.'s Meeting of the Minds* conference. Said recognition will include a plaque, presentation of one-year membership, and other items or activities as approved by the *M.R.F.* board of directors.

## T.E.A. Extended for Sixty Days

The *Motorcycle Riders Foundation* (M.R.F.) has learned that the U.S. house of representatives passed a 60-day extension for the current *Transportation Equity Act* (T.E.A.) and the U.S. senate approved that extension late last week. This 60-day extension replaces the previous 4-month extension passed by the house, and gives them time to work out the details of this critical piece of legislation before voting on their 6-year reauthorization bill. As the M.R.F. announced a couple of weeks ago, the senate already passed its version of T.E.A. reauthorization on February 12.

The M.R.F. is continuing to work with key legislators to ensure that our motorcycle safety initiatives will be included in the final mark-up of the house version of T.E.A. It is anticipated that the house will be reviewing T.E.A. in various committees and sub-

committees for mark-up around the middle of March. Once the house version is finalized and passed, both the house and senate versions will go to conference to work out the differences between the two.

The reauthorization of the *Transportation Equity Act* remains the most pressing issue at this time for the *Motorcycle Riders Foundation*. Naturally, we will continue to keep you informed throughout the reauthorization process.

# The Price Of Freedom

*A.B.A.T.E. of Florida, Inc.* has concluded an economic impact study for the first three fiscal years of Florida's amended helmet law, and the bottom line reveals that "freedom of choice" has generated over a billion dollars into the state's economy from the increase in ridership. From 2000 to 2003 Florida's motorcycle registrations went from 228,914 to 355,007, which represents a 55% increase. The motorcycle registration figures are compiled from the statistics of the *Florida Department of Highway Safety and Motor Vehicles*. The monetary figures come from the license and registration bureau.

114,457 motorcycles at a low average of \$10,000 each = \$1,144,570,000

Sales tax on motorcycles at 6% = \$68,674,200

Registration fees on motorcycles = \$4,578,280

Change of Title = \$3,406,094

**total** = \$1,221,228,574

"This is a low estimate as it doesn't include accessories and other items bought," according to James "Doc" Reichenbach II, state president and lobbyist for

*A.B.A.T.E. of Florida*, and chairman of the board for the *National Coalition of Motorcyclists (N.C.O.M.)*. "This is over 1.2 *billion dollars* in three years that was put into the economy of the state of Florida."

Over 75 *million dollars* went directly into the state treasury for the general fund. This does not include the tourist money that has increased

because of Florida now being a freedom of choice state. In the past three years, over 1.3 billion dollars has been spent in Florida for *Bike Week* and *Biketoberfest*.

"I hope this report will help anyone who has heard the bad publicity that has come out of our amended law," said Doc. "The motorcyclists have certainly paid their fair share into the Florida economy and it can be done in every state."

### Dutch Safety Expert Wants Motorcycles Off The Road

Dutch road safety expert Matthijs Koornstra wants motorcycles discouraged from using public roads, stating that "all motorcycles should be removed from traffic or at least people should be discouraged from riding them through drastically increasing road taxes and insurance premiums."

The *Federation of European Motorcyclists Associations (F.E.M.A.)* has criticized Koornstra's simplistic views to improve the safety of powered two-wheelers (motorcycles), which they say "favors marginalization of motorcycles to simply make them disappear from the roads." Unfortunately, previous meetings with Koornstra have not been productive, reports *F.E.M.A.*

### Florida Bill Would Fund A.B.A.T.E. Safety Projects

Trauma centers around the state of Florida would get a much needed financial boost from some of their

most frequent patients — drivers who run red lights — under a bill that jacks up the fines for the crime. And house bill 65, sponsored by house speaker pro tempore Lindsay Harrington (R-Punta Gorda) would also turn the motorcyclist advocacy group *American Bikers Aiming Toward Education* into a major educator.

Under an amendment tacked onto the bill Tuesday, February 17, *A.B.A.T.E. of Florida* would receive \$1 million per year "for the purpose of fostering motorcycle safety awareness, education and research programs relating to accident prevention."

Last year, the organization had to "rob Peter to pay Paul" in order to spend about \$150,000 on education programs, James "Doc" Reichenbach II told Greg Martin, a staff writer for the *Sun-Herald*. Reichenbach is the state president of *A.B.A.T.E. of Florida*, its capitol lobbyist, and chairman of the board of the *National Coalition of Motorcyclists (N.C.O.M.)*.

"I want to see this thing go to billboards," Reichenbach said of the education campaign, noting that *A.B.A.T.E.* would post 250 billboards to remind motorists to watch for motorcycles. "I want to send my people into high schools. I want to hold safety seminars to see what we can do to reduce accidents and injuries."

His comments came after the *House Transportation Committee* voted unanimously to pass the bill. Next, it must survive a review by the *Finance and Taxation Committee* before going

to the house floor. A senate version must travel a parallel road.

If passed, the increased penalties would generate an additional \$57.6 million, according to an analysis by transportation committee staff. All but \$1 million for *A.B.A.T.E.* would get put into a trauma center trust fund to be disbursed to each of 22 trauma centers in the state.

Harrington, who is confident of passage, said he sponsored the bill at the request of *A.B.A.T.E.* which expressed concern over judges who had fined motorists as little as \$80 in accidents that killed motorcyclists.

#### News Of The Weird

### Helmet Saves Man From Gunshot

This newsbit from Dixie Rider may be evidence that wearing a helmet can save your life, at least if you're being shot at. According to a *Channel 13 Eyewitness News* broadcast in Houston, Texas, an unidentified man was saved when he was shot by his girlfriend, because he was still wearing his motorcycle helmet.

According to the TV news report, the couple had been riding together earlier in the evening, and an argument erupted when they arrived home around midnight.

Police say the girlfriend then shot the male in the head, but his full-face helmet protected him from serious injury. The female then barricaded herself in a nearby apartment until police hostage negotiation teams were able to convince her to surrender. She was charged with aggravated assault.

### Campbell Announces Retirement

It is with heavy heart that *N.C.O.M.* relays the March 3rd announcement that U.S. senator Ben Nighthorse Campbell will not seek re-election for health reasons.

Campbell is a longtime member of the *N.C.O.M.* legislative task force and has been a champion for bikers' rights for many years, having been actively involved in every piece of motorcycle legislation passed by congress since the eighties. He was elected to serve as a democrat in the Colorado house starting in 1982, serving two terms before being elected to congress. After serving in the U.S. house of representatives from 1987 to 1992, Campbell won the senate seat he now holds. He switched to the republican party in 1995, and was re-elected in 1998 by nearly two-thirds of the vote.

Born April 13, 1933, in Auburn, California, Campbell is one of two children of May Vierra, a Portuguese immigrant, and Albert Campbell, a member of the *Northern Cheyenne Indian Tribe*. The senator is one of 44 chiefs of that tribe, and one of only eight Native Americans ever to serve in congress. He is a renowned jewelry designer whose Nighthorse signature pieces are prized by collectors of fine native jewelry.

Campbell served in the *U.S. Air Force* from 1951-53, and fought in the Korean War as an airman second class. He graduated from San Jose University in 1957 with a degree in physical education and fine arts, and later attended Meiji University in Tokyo in 1960 as a special research student. In 1964, Campbell competed in the Olympic Games as captain of the U.S. judo team.

Motorcycle enthusiasts everywhere will remember senator Ben Nighthorse Campbell as more than their legislative warrior, but as a fellow biker who rode his *Harley* to work in the nation's capital, to events, and throughout Colorado, including the *Four Corners Iron Horse Rally* which he founded. Thanks for everything, Ben, best wishes and we'll see ya down the road!

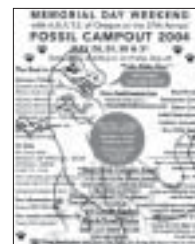

## A Fresh Perspective

# Ethnography

Many would think that a motorcycle organization is a gang of rebel-like people who rain terror upon us. I decided to do a little survey on a group of motorcyclists and find out who they really are and what they do.

My father-in-law, Lee Austin, is the coordinator for the *Southeast Portland Chapter* of A.B.A.T.E. A.B.A.T.E. stands for: *A Brotherhood Against Totalitarian Enactment*. It is an organization of like-minded motorcyclists whom are against the total control of our legislature to pass laws. I am also a member of this organization. I attended a meeting on February 15, 2004. The primacy of my observation was that these people were very welcoming and fun to be around. As the meeting went underway I handed out thirty surveys (got twenty-one of them back) and talked with a few people where I received some wonderful feedback.

Everyone I talked to are members and have been members anywhere from two-weeks to twenty-two years. Most members are in their forties, fifties, sixties. I was informed that there are younger members — they just weren't at the meeting.

Because this is an organization there are duties that certain people fill. Some include: coordinator, vice coordinator, membership secretary, food drive committee, ways and means, P.C.P. (Precinct Committee Person), Awareness instructors, recording secretary, sergeant at arms, legislative director, treasurer, historian, and public relations

director (to name a few). All of these people play an important role in their organization.

I asked the recording secretary what this organization meant to her and she responded: "My duties as a member of A.B.A.T.E. are to represent my chapter and the state in a respectful, knowing manner. I help fight for every citizen's civil rights. It is a platform to help me maintain a standard of life that I choose."

Each person within this organization stands strong behind his/her political stance. They are all registered voters and many of them democrats. When it comes to the helmet law most members feel that it needs to be revised so that it allows choices. For instance: only allowing those persons older than twenty-one to have the right to choose. It's all about choice to these people. Even if they had the decision "to wear or not to wear" many still would.

I asked them what their general concerns were on politics. Many expressed their fear of losing their freedom. They feel that our government is not doing their job right by ways of the economy either. They want to know where all the money is going. One person said that the "U.S.A.P.A.T.R.I.O.T. act is not what we've been lead to believe." Many said that "more people should get involved instead of just sitting around bitching about what is going on around them when they can do something about it. It's our right!"

This organization does many things throughout the community. They

help in getting people elected into legislature (P.C.P.) so that there are more people standing up "for the people." They do a food drive every year where they collect donations, buy perishable foods, and deliver (on their anniversary every March) to the *Lighthouse Mission* downtown Portland. Every year they do what's called the *Shriners Toy Run* where they all ride up to the *Shriners Hospital* and give to the children who are unable to get out of their rooms. Santa is always there and last year they had over three thousand riders. They also donate to provide wheelchairs to the paraplegics there.

Among many other involvements, another huge one where they help in the community is through *M.A.P. M.A.P. (Motorcycle Awareness Program)* is where they go to the high schools and talk about the awareness of cyclists on the road. A member commented, "We are a group that means involvement and efforts that make motorcycling a better activity." They have been recognized in their efforts in motorcycle awareness by persons in the legislative offices, including: Jeff Merkley (house of representatives) and Lonnie Roberts (Multnomah County commission who use to be in the house of representatives for eighteen years). Lonnie Roberts was present at the meeting. You could tell who he was because he was the one in the suit.

When asked if they saw themselves as being "hardcore" more than half said no. One person said "I stand up for what I believe in therefore I am hardcore!" I love that answer. I think that bikers are seen as having a "bad" personality because they are just down to earth and aren't ashamed to stand

up for what they believe in, and (apparently) they don't smile.

Leather is worn as a protection device against weather (cover to avoid road rash) and crashes (preventing bad tears in the skin).

Many members are actually involved in motorcycle organizations outside of A.B.A.T.E. There is the M.R.F. (*Motorcycle Riders Foundation*), Bike PAC (used as legislative tool to help make new laws), G.R.I.P. (*Girls Riding Independently Proud*), and the Washington Harley Club. They all consider themselves to be "freedom fighters." When asked why this organization is better than others most said it was because of the family-like atmosphere and because of their coordinator, Lee Austin. One member stated "it's run from the bottom up."

Most members who have a family or significant other also take part in A.B.A.T.E. They are pretty well cut in half when it comes to married couples and non-married couples.

One of the questions that I had asked was if they were ever in a crash. All of these people had been in a crash. But then I got to thinking, because of the age group that I surveyed maybe that was normal. I guess everyone gets into a crash at some point in their lives.

The majority of the members are from here [Portland] or other areas of Oregon. There were a few from other states including New Hampshire, Illinois, California, and Oklahoma. Most of them grew up around bikes and started riding at young ages. The starting ages ranged anywhere from three to sixteen years. They all went on to finish high school

and more than half of them went to college. Many own their homes and consider themselves as middle-class citizens. Everyone had a different form of occupation.

There was a wide range of hobbies amongst the members. Most of their favorite places to go are anywhere away from the city. Some like the beach and others enjoy the mountains. That's interesting because the reason most like to ride is because it is conducted outdoors and gives them a sense of freedom. About half of the members enjoy group riding as well.

I asked the members if they liked to ride bicycles as a hobby (more importantly *Schwinn*s). This question sure had them laughing. One said that "it's too ritzy for me, I had a *Hawthorne*".

Some of the goals they wanted to achieve in life were: to own a business; to gain financial independence; to have good health; to be comfortable; to survive through the hard times; and to retire happy.

All in all, I have seen the members of A.B.A.T.E. and they are in no way rebels wanting to bring about harm. They are not a gang or a club.

A.B.A.T.E. is an organization of caring, passionate people who are here to help make a change for the people. Just because a group of people all look a certain way doesn't show who they are on the inside.

People didn't think that motorcyclists would have "respectable" family lives outside of riding, but guess what?

They do.

# The Dorchester Report

*Personal Opinions and Observations About Politics*

*Seaside, Oregon* — Dorchester is America's oldest political conference. Founded as a discussion and think tank in 1964 by then state representative Bob Packwood, it has blossomed into one of the great forums on public policy in Oregon. The format of the conference has changed over the years, but has always been designed to involve all attendees in the discussion and voting on various issues. Over the years, various political leaders and elected republicans have participated in the table discussions. One delegate stated, "I was amazed that my opinion counted as much as that of the state legislator in our group." Encouraging participation and enhancing the fun of politics have been two keys to the longevity of the conference.

Lively discussion and insightful speakers are not all the conference has to offer, though. Perhaps the most anticipated event at each Dorchester is the *Tent Show*. Year after year, a group of Dorchester stalwarts poke fun at politicians and current events to entertain the conference audience. All this done to deliver on Dorchester's promise to prove that "Politics *is* fun!"

I am writing this to give an idea of the weekend of Dorchester. For those who are interested in politics it is a very fun and worthwhile weekend. All points of view are welcomed and the interaction is friendly and conversational.

I arrived at Seaside and checked in

to the Days Inn (cheap rates and a short walk to the convention center). This year is the 40th anniversary of Dorchester so there were Dorchester XL signs all over town. Friday night is the kickoff and the Keynote speech by senator Gordon Smith. The turmoil over gay unions right now was very much on everyone's mind. Senator Smith talked about the need for tolerance and courtesy toward our "gay and lesbian brothers and sisters." He spoke how he had tried very hard to reach out to gays and had even voted for hate crime legislation, but was clear that he defined marriage as between a man and a woman. He was hopeful that gay activists would respect his definition of marriage as he has respected their personal lives. Of course, none of that message was reprinted in the *Oregonian* the next day. He also talked extensively about how in his opinion John Kerry is not qualified to be president. He mentioned several things such as how senator Kerry co-wrote the *No Child Left Behind Act* and is now campaigning against it.

Dorchester is mostly social with some issues discussed, so I spend some time networking. There are several good competitive primary races in congressional districts 1 and 5. I had already met Goli Ameri who is a candidate in congressional district 1. I visit some more and meet also with Jim Feldkamp running in congressional district 4. Nina Avery, Bob's wife, is working in Mr. Feldkamp's office and of course she

greet me with a hug. Later candidate Feldkamp insists on getting a "biker hug" as well. I have many friends who know me from over the years in politics. One of my goals is to meet some of the new candidates who are running. The contacts I have made from attending Dorchester in years past have paid off tremendously in legislative sessions later. I also renew some contacts with friends I haven't seen for a while including the chair of *Oregon Republican Mainstream*. This group is opposed to litmus tests for candidates and in expanding the "big tent" philosophy described by Ronald Reagan.

Friday night has several hospitality suites starting with Jackie Winters for congress (ribs and beer) where Darryl Howard, an old friend, is campaign manager. Next is the Feldkamp hospitality suite and also Bob Avery's coming out party in his candidacy for national committeeman. Then it is off to Goli Ameri's suite where I talk with a large group of former state and current representatives. Finally, the Billy Dalto party with live music. Lots of conversations and general fun.

Saturday begins with a talk by *Taxpayers Association of Oregon* and a breakfast. We begin the day with some housekeeping and general rules of the conference. Dorchester randomly assigns you to a table named after a county and you meet those people and spend most of the event at that table. I was at the Tillamook table. Current topics are discussed and people may be assigned

to argue for a position they don't believe in. The point is to discuss the issues and then vote our results, which are tallied for the entire group. Our first topic of discussion was mandates for employers to provide health insurance. I learned many pros and cons on this issue. The group was decidedly against such mandates. I then had to do some business calls, which kept me from the next topic: attorney fee caps in medical malpractice suits. The cap proposal failed as well.

Lunch gives you several different speakers and groups to listen to and I chose the *Mainstream* speaker with former labor commissioner and gubernatorial candidate Jack Roberts. He spoke about how the republican party was growing through the big tent philosophy and that we need to get away from dividing over single issues such as abortion. He has always been a pro-choice republican and did not feel that requiring strict adherence to the platform should be required to be a good republican and a good candidate. He talked about how every time we focus on one issue such as abortion we "form a circular firing squad and start firing." As I agree with many of those points of view I did enjoy the talk.

After lunch former senator Bob Packwood gave a talk. Bob Packwood founded the Dorchester conference in 1964. Bob Packwood gave a talk about how he believes it is time for the abortion plank to be removed from the party platform. He talked about how in Portland in the 1950s it was republicans who put forth an accommodations referendum that would have removed all racial discrimination but the citizens voted

it down. He talked about leading and not following public opinion. It was a good talk for Dorchester, thought provoking and even polemic. The next topic of discussion was in fact removing the abortion plank from the platform. The general consensus was that now was not the time to open old wounds and an unlikely coalition between Oregon *Right to Life* and Jack Roberts, vocally pro-choice, urged people to abstain. Although the issue did pass under the rules that disregarded abstentions, only a minority did in fact vote. There were about 450 attendees and less than 70 cast a vote. The rest all abstained.

State senator Rick Metsger was there as well. I had been trying to meet with him about some transportation matters. We had a nice discussion and got a lot accomplished. I also have to give him and other democrats credit for showing up and taking part. Dorchester is open to all, but most of the crowd is republican.

The last official item Saturday was a town hall with congressman Greg Walden. Some of you might remember Greg Walden from the Oregon state senate. He has always been a good friend of bikers and is very accessible. He was mainly discussing how president Bush has been trying to make things better for rural Oregon by the healthy forests initiative. He agreed that progress has been slow but there is at least a chance that we will be able to salvage some timber and get some people back to work.

At 4:00 we adjourned and it was time for more hospitality suites. First I was off to representative Kropf and senator Bruce Starr's martini theme party, and then I went to one for

*Mainstream*. Next I went to congressman Walden's event which had sushi and good beer. Several members of the media were at this one. Congressman Walden postponed the media to talk with me about biker issues. He specifically wanted to know where we had ended up on the *E.P.A.* issue and was eager to meet with our delegation later this month in D.C.

Saturday night is the dinner and my table partner was former state representative and senate candidate Ron Sunseri. He was always a great friend to bikers and we talked about that, but then started talking about history. Ron Sunseri is a great student of our nation's founding and gives seminars on our founding fathers and their documents around the country. He would be willing to talk at an event in the future such as S.T.E.A.M. After dinner is the tent show that is best described as a freeform amateur talent show except the point is comedy, satire and fun. Talent is hardly required. But it is great fun.

More hospitality suites and I end up staying up until 2:00 at the *Shilo* where a live band was playing and free drinks were provided at an event sponsored by speaker Minnis and majority leader Scott.

Sunday I was a little fuzzy, but I got to the breakfast and we started our table discussions anew. The delegate-selected issue is privatization of the *O.L.C.C.* We have a great discussion about this.

Afterwards there is a meet-the-candidates round table and debate with the 1st and 5th congressional district republican candidates. About 11:45 we adjourn until next year.

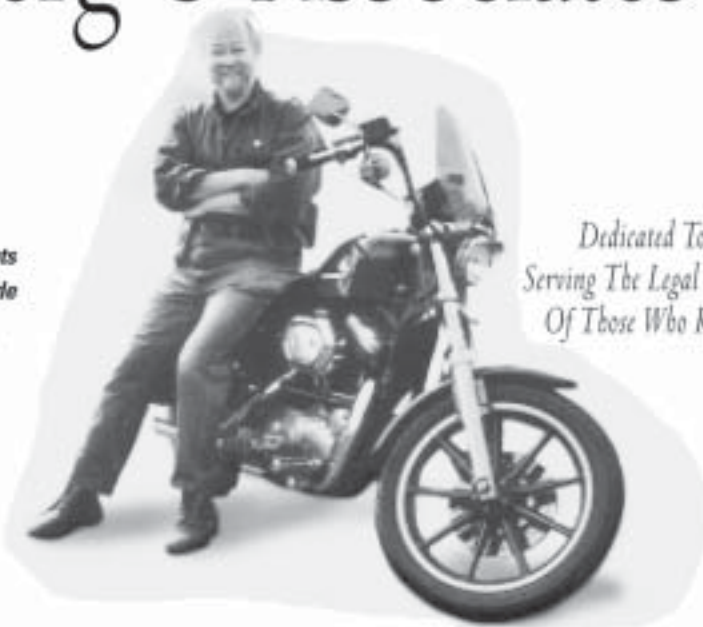
