City administrators and elected officials talk with each other at conferences and via e-mail. These kind of restrictive measures have a way of spreading to other communities if we are not alert. And, according to

N.C.O.M., the Myrtle Beach council is actively lobbying other communities to pass similar ordinances. (Perhaps

officials who knowingly pass unconstitutional measures that restrict citizens' freedoms should face criminal charges.)



What We're About

A Brief History of A.B.A.T.E. by Bill Bish (A.B.A.T.E. of California; executive coordinator, National Coalition of Motorcyclists)

"You have to know where you've been to know where you're going!"

Easyriders magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the National Highway Transportation Safety Administration (N.H.T.S.A.) by joining a new national biker's rights organization called the National Custom Cycle Association. But because of a conflict with the acronym the name was changed in February 1972 to A Brotherhood Against Totalitarian Enactments (A.B.A. T.E.).

Easyriders began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. D.O.T. (Department of Transportation) was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the Huns Motorcycle Club in Connecticut convinced his congressman, representative Stewart Mckinney, to introduce H.R.3869 to end the federal authority to withhold highway funds from states without helmet laws.

In July of 1975, Rob Rasor of the American Motorcyclist Association (A.M.A.),

Ron Roloff of the M.M.A. of California and Ed Armstrong of A.B.A.T.E. of Chicago presented the house sub-committee on surface transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the D.O.T. because governor Ronald Reagan refused to comply with the federal helmet law mandate, Roloff helped convince California senator Alan Cranston to offer the language of the bill as an amendment to the 1975 Federal Highway Act, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by president Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached congress twice over the past few years, first to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through congress.

So, there you have it.

The roots of A.B.A. T.E. and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of freedom of the road. (reprinted with permission



Our Officers at Work A.B.A.T.E. State Board Minutes

08 November 2008 – Almost Home Restaurant; Salem,

Meeting was called to order by Matt Price, state coordinator, at 12:15 p.m. with 13 of 13 chapters represented. (*Salem Chapter* arrived late.) All chapters present were eligible to vote.

Pledge of allegiance.

Moment of silence for downed brothers/sisters and service men/women.

Guests and first time attendees: Lower Columbia Chapter, Laird Atkin (North Coast Chapter legislative director/ historian). (I beg forgiveness if I spelled his name wrong.)

Acceptance of minutes: Motion made by Randy Phipps (*Twin Rivers Chapter*) to accept minutes from October 11th state board meeting as printed in the state newspaper. Jordan Kelley (*Washington County Chapter*) seconded the motion. Motion passed.

Nic read a condensed version (at the request of the state board of directors) of the October 19th state board of directors meeting. A discussion of the results of the planning session and the state board of directors meeting that followed was given with input from various attendees of the planning session/ state board of directors meeting weekend. There were two committees formed at the planning session/state board meeting of 2008. There is a budget committee formed with Kay Sipple and Gene Mortimore co-chairing. Also an operations manual committee with Nic Oliver and Brian Stovall as co-chairs.

The budget committee will be setting a goal of achieving a functional operations budget for *A.B.A.T.E. of Oregon, Inc.* This will fix a lot of the problems that we have been facing with more accountability and better information.

The operations manual committee will be looking to return A.B.A.T.E. of Oregon, Inc. to the basics and get out of the rut of over-regulation of the operations of the organization. Replace bylaws with a condensed version that is not to be redone but perpetual as written and an operations manual with more brotherhood principals and less regulation. Simplified, yet more personal responsibility for the organization by all.

Motion made to accept the report of the planning session of 2008 by Brian Stovall (*River City Chapter*) and seconded by Jordan Kelly (*Washington County Chapter*). Motion passed.

Correspondence: Nic stated that there were periodicals from other states available for anyone who wants to see them. Also there is a mailing from the

state of Oregon for our legislative director to be reviewed. Nic read a letter from the city of Fossil and their getting the grant for an *A.D.A.* public restroom and it was decided that it was now time to send the \$200 pledge made at a previous state board of directors.

Nic read an e-mail letter from Joye "Grace" Howell resigning from *A.B.A.T.E. of Oregon, Inc.* thereby canceling her membership. Motion was then tendered (see motion #2 under new business) and passed to accept her membership resignation.

Nic also read an e-mail letter from *Southeast Portland Chapter* permanently revoking Robert Hale's membership from that chapter due to disorderly conduct. This resulted from an incident that occurred at the fall swap meet in which Robert Hale assaulted Gene Mortimore. (Vice-coordinator east) This incident got police involvement but no charges were made. Nic reported that an emergency executive board meeting took place at the swap meet and it was decided to recommend to the board of directors to remove Robert Hale as state quartermaster and remove him from the membership of A.B.A.T.E. of Oregon. This organiza-tion cannot and will not tolerate violence amongst the membership. We are a group of volunteers in a brotherhood for the good of all and violence will not be tolerated, as it is not in the best interest of the organization. Nic was asked if Robert Hale was aware of this motion and he told the state board of directors that he made Robert aware of it himself and that Robert understood. Different people spoke on this issue and it was noted that there was no time frame put on the motion. Motion was then tendered (see motion #3 under new business) and passed to remove Robert Hale as a state officer and a member.

Coordinator comments: Matt Price reported that the planning session was good and a lot of good work was done. The planning session was a turning point for our focus on education and legislative action. We all need to remember that the good of the organization must come first and nothing else should get in its way. This organization was formed for the public good and we need to conduct ourselves this way. We need to move forward as a team and we need to let them (legislators, etc.) know that we are here. There are approximately 220,000 endorsed licenses in Oregon and we represent all of them. Gas is now at just

over two dollars a gallon but it will go back up. Motorcycles have become much more popular as an economical form of transportation as well as a lot of fun. As an organization, we need to go forward or we will go nowhere.

Vice coordinator-north: Heidi Disrud (Absent)

Vice coordinator-south: Annette Murray reported that she is getting ready, after recovering her medical issues, to start visiting the chapters after the first of the year.

Vice coordinator-east: Gene Mortimore reported that he attended a Fossil city council meeting and talked with them about a building that they have vacant. They set a price of one dollar per year lease of the storage building to us. A motion was tendered (see motion #1 under new business) to purchase a ninety-nine year lease for storage.

Motion passed.

It was also reported that *Douglas County Chapter* has a ticket booth and there is a business trailer, there but they wanted to know what we want to do with the building. Gene suggested we get rid of it for salvage as it is very old. It was agreed to do that. Gene reported that the building is in good shape and sound but it may need a window replaced but it is otherwise ready for our use. It has water and power in it but Gene doesn't recommend that we turn them on as we do not really need them so why have the expense?

Treasurer: Kay Sipple stood and introduced herself to the membership. She then stated that we have approximately, \$22.222.00 in checking, deposited \$2,200 into savings. She said that she needs, from every chapter, the December 31, 2007 statements and report from all chapters right away for tax purposes. She noted a few changes that she is implementing to allow for more accountability for expenses. All reimbursement requests must now be signed by the person making the request and by an executive board member before turning them in to her for funds disbursement. Also, reimbursement requests will generally be handed out one month behind. So, if you turn in a request in November, don't expect a check till the December state board of directors meeting.

Kay stated that she will be making the rounds of the chapters during the next year to assist the chapter treasurers and just to say "Hi".

Lee Austin stated that he has an *A.B.A.T.E.* printer for the auditor or whomever needs it.

It was also mentioned that all invoices need to be copied and we need to submit them with verification of validity before they will be considered for payment. Quotes from a business for services/ products should be obtained before commitment to a service/product purchase so that the price given is not to be just accepted as the one want. We need these quotes in writing to insure that we are getting the best deal for our money.

Kay reported that she has nothing from January 2008 to present. Joye and her are trying to work with each other but holiday scheduling at Joye's work is making it difficult to connect. She also reported that she has purchased an eight month CD (certificate of deposit) for \$3,000.

Membership secretary: Linda Henderson reported that we currently have 1,692 members as of 01 November 2008. She also made mention of personal checks that have bounced in the past and that investigations are just now taking place. These checks are from 2003– 20004 and more information will be brought up when known.

Sanctioning officer: Matt Price and committee. Reported that he needs head counts from all the runs in 2008. This is how our insurance is figured on, total attendance. Once we reach the number of people estimated to attend our functions, then we have to purchase more insurance and the cost is much higher. He had already more than doubled the amount from previous years which was set at about 3,400 to 8,500 this year but we may still go over that. Our run schedules need to be turned in as soon as possible. Brian mentioned that it used to be required that the chapters turn in a run schedule proposal by October of the preceding year so that it could be checked for conflicts with other organization's functions. Matt stated that the state board of directors meeting in January will be starting one hour early to accommodate the new year and Chapters to get their run proposals in.

The A.M.A. and A.B.A.T.E. are the only entities that sanction events in Oregon right now and the comparison was discussed. It now seems that region 28 (the region Oregon falls into) meeting was canceled. We used to have certified members of A.M.A. but without this meeting there will be no one certified in Oregon. Lee Austin stated that Rotten Roger may have more information on this issue.

State auditor: B.J. Speck (Absent)

Newspaper editor: Rot Path thanked everyone for being here. He said that he has chapter reports for only three or four chapters. They have until Monday, November 10th, to get those reports turned in.

Legislative director: Quiet Mike absent but showed up later. Joe Maffei (Mafia Joe) reported that two of the three *BikePAC*-supported candidates won but the winner of the other race was won by someone that is pro-motorcyclist.

Sergeant at arms-north: Randy Phipps reported that regarding the budget committee wanting a budget proposal from every officer is unnecessary for him. The quartermaster covers all his needs.

Sergeant at arms–south: Bill Foster – Nothing to report.

Sergeant at arms-east: (VACANT)

Brian Stovall pointed out that the 2009 officer was in attendance at this meeting and he introduced Jim Middleton.

Products director: Dave Meeker reported that the next *Fossil Campout* will be our thirty-second annual event. Artwork for the t-shirts will be accepted up to March 2009. They must include the words "32nd Annual" and no more than three to four colors. He also reported that \$3,263 was spent this last year on products, most of it for *Fossil*. He did state that we need products for other areas and will be getting prices to the budget committee.

Education director: Patricia Carner reported that the planning session was good and a lot was done. The budget for education includes things like stuff for the classes that are given away to the attendees. Since we are getting into the junior high schools, the idea of pencils with our message on it would be more cost effective and still get the message out. Especially considering that these are not drivers at this point and would not have keys for a key fob. There are other ideas in the works also, such as kickstand pads. Currently working with Laurie, a graphic artist, in getting possible avenues of artwork. She reported that she is also looking into getting grant money for some of this stuff. She discussed the new signs that were authorized and is ready to go forward with securing quotes. Matt Price offered to check into a local company for a quote. Another signage idea was discussed regarding the possibility of putting up signs where a motorcycle crash had occurred to warn future riders of a potentially dangerous curve or whatever. This might help to cut down on crashes from reoccurring in the same place. This might be a good idea for chapter use.

Reported that S.T.E.A.M. was discussed at the *M.R.F.* conference that she attended. She thanked *A.B.A.T.E.* for sending her. She got so much out of the conference. Learned ways of doing things that she had never thought of. It also seems that Washington state and Idaho want to co-sponsor this year's *S.T.E.A.M.* conference, partly because of Slider's presentation.

Education director II: Geoff White (Absent)

Public relations director: Debra Lutje Absent)

Report given by Brian Stovall. He suggested that everyone check out the site:

http://www.oregonridersforum.com was also discussed by Joe Maffei and how it is designed for future expansion and it is already set up to include special smaller groups for each chapter, if they want to use it.

Brian also suggested that each chapter check out their local shops. He handed out a listing of the shops that he found on the web and gave a list of each chapter to the chapter representatives. He stated that a lot of smaller shops are not on the web and should be reached out to.

State run coordinator (Fossil): Howie Long reported that things are starting up and he has turned in to the budget committee his proposal for Fossil this upcoming year of \$13,800. Also spoke on the lease for Bear Hollow being at a discounted rate for \$500 per year. There may be a new bridge needed to be put in there. Announced that this year we will be using one-half sheet flyers and post cards instead of only full size. He discussed the possibility of a run to Fossil this year. The possibility of more starting points from other directions was also discussed, with all ending at the Fossil Run. This had been done in the past and we could make it happen again.

The state newspaper may be putting in that Bear Hollow is a motorcycle only camping area with one vehicle, up to 20 feet long, as a support vehicle for each chapter. Other vehicles are to go to other sites nearby. This needs to be discussed at the chapter level and brought back to the state board next month.

Also reported that John Arron, who owns the property next to Bear Hollow, said that we could use his property. This will give us a lot more room for camping. This is a limited use agreement and all the details were not worked out yet. But this may include no campfires and we do the clearing for the area.

Fossil 2009 will be the *Memorial Day* weekend, as usual, but the tickets are going up \$5. The ticket prices will be \$30-35 for pre-event sales and \$35-40 for tickets at the gate.

Joe Maffei brought up an idea for membership gains through a break in the ticket prices, when signing up for membership, for the pre-event tickets.

Howie announced that he is stepping down as *Fossil* coordinator. He gave as his reason that although he would not stop what he has doing, it is just that he can't handle the politics. He did say that he would consider the run coordinator II position.

State run coordinator II: Jeff Schuaer (Absent)

State swap meet coordinator: Patricia Carner reported the next swap meet will be April 5, 2009. She said that she was very happy with our supporters in this event. She also stated that Laura Stewart of *Stewart's Leathers* gave a lot of support for our event. We had approximately 750 people through the gate and we showed a profit of \$6,100. Better than we had hoped. There were changes made in the money handling so that one person was never alone with the money. We needed to take care of business without any chance of impropriety.

Historian: Linda Marteney (Absent) Web page editor: Trace Ceccacci reported on motorcycle ads not affiliated with *A.B.A.T.E.* and that he will count the hits on our site. Pat thanked him for all that he has done for our site.

Quartermaster: (VACANT)

A.B.A.T.E.'s *BikePAC* representative: Randy Phipps reported that there was no meeting in November due to the elections closing at that time. The next regular meeting will be December 6th at the Salem library at noon. Randy stated that he will be at a toy run that day and Joe said that he would fill in for him.

Confederation of Clubs representative: Pat Williams reported handed in. Treasurer reported \$7,196. A vote to donate \$2,000 to the *Trademark Fund* through Richard Lester's office. New officers include:

Vice chair – Big Kat, (*Gypsy Jokers*) Treasurer – Whistle Bill (*In Country Vets*) Secretary – Jim Gibbons, (*Christ Disciples*) Sgt at arms – Mike Squire (*Free Souls*)

Instead of a poker run there will be an honorary party benefit for Longview Tom. It will be on Saturday, January 17, at a tavern called *The Spot-It*, located downtown Molalla. Lots of good food and a raffle.

A discussion also took place regarding the N.C.O.M. convention and the C.o.Cmeeting there. (Pat turned in a fourpage report on the N.C.O.M.convention.)

The next *N.C.O.M.* conference is May 7-10 in Reno, Nevada at the *Nugget Casino*.

Reported that the Washington state *C.o.C.* said that if you are stopped for a helmet ticket you don't have to take your helmet off unless you are under arrest.

Also said that 99% of helmet tickets in Washington are being won by the motorcyclist. Marty Fox is the Washington *A.I.M.* attorney.

Australia — The source for this on-line scam for "antique *Harley*" was rusty parts. A Victoria man who falsely sold antique motorcycles online to overseas buyers and then sent a crate of rusty metal has walked free from court after receiving a suspended sentence, community service, and restitution of the money he took. He should count himself lucky. In my mind he belongs in jail and receiving instruction from folks who don't care for bikers being scammed.

Gonzales, Texas — A motorcycle rally was curtailed drastically by the city's police here. Folks attempting to enter the rally site wearing club colors were turned away because they refused to leave their colors at the gate. The first Gonzales Thunder Rally wound up showing a huge loss because of the draconian activity of the police, who claimed the no-colors policy was instituted because of the possibility of problems between clubs. Thousands were expected but when the "no colors" word went out, it virtually stopped attendance in its tracks. The promoters said if they tried it again the rally would be held outside city limits to avoid the problem. To me, this is police gangsterism.

New York -- Picketing their knows: On October 21st, American Bikers Aimed Toward Education (A.B.A.T.E. of New York, Inc.) picketed the New York highway safety conference at the Sheraton Syracuse University Hotel and Conference Center, where the New York state police presented their motorcycle safety roadblock scenario to more than 350 professionals from government and private agencies involved in reducing death and injuries on the road. A.B.A.T.E. obtained an all-day public assembly permit for an informational picket and protest outside of the conference

center. It was hoped that media exposure would bring to the forefront the absurdity of the roadblocks. Funds that had been dedicated to motorcycle safety were being used for these roadblocks, to harass motorcyclists, rather than being used for education of riders and the public. United Kingdom — Here is not the brightest bulb on the British porch: A young biker here was brought down by the internet and his own ego. He posted a video he made on YouTube, showing him speeding and doing stunts on his motorcycle. The police used this, of course, to convict him. Sandor Ferenci, 28, will be sentenced at Oxford crown court for three offenses of dangerous driving, according to local police.

Dallas, Texas — Your digital papers, please! The *Tracking Corp* has announced the marketing of a G.P.S. device for motorcycles. It's said to be the next best thing for bikers since anti-lock braking systems. I swear by the A.B.S. brakes for scoots. On slick roads and sudden stops, it's right on. I'm not so sure about G.P.S. It will track your location, just like *On-Star* devices in cars.

You folks make up your own minds. G.P.S. might be a good thing if you have a single vehicle wreck in the middle of nowhere at night. It's available on most new rides through dealerships across the country. Then again, newer cell phones already have some of that technology.

Oregon — Near Portland, Tualatin Valley fire and rescue is attempting to convince folks that using motorcycles in the fire department is a good idea. Obviously, ya can't fight fire on a scooter but you can get medical aid to someone in need much faster. They have initiated a levy to test the idea out. Hope they get it. It is a good idea and being done successfully outside the US.

Australia — New South Wales Deploys "Noise Cameras!"

This one could affect every vehicle on the road in New South Wales, and other state governments across

Australia are poised to deploy automated cameras that mail tickets to vehicles considered by a machine to be too noisy. If ya think it can't happen here, think again. Many of the "gang" laws we are dealing with right now come from other countries.

Washington: State troopers here are stepping up enforcement against bikers, looking at speed, D.U.I., aggressive riding, and failure to wear an "approved" helmet. Bikers are also required to have the proper endorsement on their driver's licenses or face having their bikes towed to an impound lot. Keep your eyes open and in Washington, don't take your helmet off unless you are *under arrest.* By law you should not have to. But don't go to jail on this Gunny's account!






December Observation

N.C.O.M. COAST TO COAST BIKER NEWS

A.I.M. Attorney First To Sue Myrtle Beach Over Anti-Biker Laws

Aid to Injured Motorcyclists (A.I.M.) attorney Tom McGrath filed the first lawsuit against the city of Myrtle Beach, South Carolina challenging the constitutionality of two out of over a dozen new anti-biker ordinances passed to shut down motorcycle rallies.

The suit filed September 29 in Horry county's 15th judicial circuit on behalf of two Myrtle Beach residents and motorcyclists, William and Carol O'Day, challenges the city's new helmet regulation and noise ordinances. The suit questions whether it's within the city's "home rule" authority to supersede state law in both cases.

Both municipal ordinances, according to the lawsuit, are unconstitutional and in violation of South Carolina state law. "It's pretty simple," said Tom McGrath, whose *Motorcycle Law Group* based out of Richmond, Virginia, filed the suit. "It's really a question of whether it's constitutional. Does state law prevail?"

"Home rule doesn't allow a city to pass laws that are inconsistent with state law in areas where the state has already acted," he explained. "and South Carolina already has a helmet requirement for riders 21 and younger, and they already have a muffler statute in state law."

McGrath is a graduate of the University of South Carolina and is licensed in the state of South Carolina as well as Virginia and Tennessee. As an avid motorcyclist and motorcycle rights activist, Tom founded the Virginia Coalition of Motorcyclists and provides legal counsel to A.B.A. T.E. of Virginia. "We go fight for the rights of people," he added, "that's what we do...that's the kind of firm we are."

Two additional lawsuits, both filed in federal court on behalf of local businesses, have since been filed against Myrtle Beach in response to the city council's unanimous approval of fifteen new regulations aimed to crack down on a 70-year tradition of motorcycle rallies in the city, which include restricting vendor permits, imposing liability on promoters, limited bike parking, more restrictive loitering and public drinking laws, and other regulations designed to dissuade rally-goers.

Among other arguments, the federal lawsuits claim the ordinances are vague, interfere with people's first amendment rights, do irreparable harm to businesses, and interferes with interstate commerce.

Law enforcement began enforcing some of the new regulations at roadblocks set up recently during the fall "pilgrimage" bike rally, prompting many bikers to skirt the city in protest and spend their time and money at other nearby rally locations, such as Myrtle Beach *Harley-Davidson*, where a sign warned riders that city limits were 200 feet ahead.

Meanwhile, Myrtle Beach is lobbying other local municipalities and the county to enact similar ordinances.

"A.B.A.T.E. of South Carolina abhors these types of totalitarian enactments that remove liberties and freedoms of individuals and eventually, will start eroding individual rights granted to us under our constitution," said the state motorcycle rights organization in a press release. "A.B.A.T.E. of South Carolina challenges the council on the grounds that the municipal power is exceeding the entity's corporate powers, acting as if it is above state law."

The Carolina Harley-Davidson Dealers Association Spring Rally has been a fixture in Myrtle Beach for 68 years, and is the oldest, continuous running motorcycle rally of Motorcyclists

in the country, but the city council decided to get rid of all bike rallies following complaints from residents, primarily during the *Atlantic Beach BikeFest* attended mostly by black urban sportbike riders, after efforts to police the event led to several discrimination lawsuits filed by the *N.A.A.C.P.*, which were eventually settled out of court.

D.O.T. Proposes New Federal Safety Rules To Bar Novelty Helmets

The best-selling motorcyclehelmet decals at a popular biker web site include fake bullet holes, skull and crossbones, the American flag – – and \$1 stickers that say "D.O.T."

The latter has created a problem for U.S. highway safety regulators, because fake *Department of Transportation* stickers can be used to counterfeit safety certification of cheap novelty motorcycle helmets, which they claim are one cause of rising crash fatalities.

"We're proposing new safety rules to make it harder for vendors to sell unsafe novelty helmets or for riders to get away with wearing them," said transportation secretary Mary Peters, herself a *Harley* rider. "We are proposing to do that by requiring manufacturers to place a larger, tamper-proof *D.O.T.* label on the back of certified helmets that have been through a wider range of safety tests."

The current federal standard, implemented in 1974, requires a *D.O.T.* emblem on the rear of the helmet, indicating it passed certification tests. Manufacturer and model data are located on a label inside the helmet. The new proposal calls for a *D.O.T.*-symbol decal to be applied to the helmet beneath its clear coating, with the manufacturer's name and helmet model added above the symbol and the word "certified" below it.

The new rule also would refine the tests manufacturers do to certify their helmets to meet *D.O.T.* standards for impact, penetration, and retention.

Novelty helmets, which have thin

protective liners, failed all the federal performance tests, said Stephen Kratzke, associate administrator for rule making at the *National Highway Traffic Safety Administration*, but when police spot a helmet that doesn't look like the real thing, riders can claim they thought the *D.O.T.* sticker meant it was certified. Sellers of the labels say it stands for "Doing Our Thing".

"It makes it really hard to enforce helmet laws," said Kratzke. The goal of the new rule is "to make sure in helmet-law states it is easier for police to enforce the regulation."

N.H.T.S.A. estimates that 15% of the motorcycle riders in the 20 mandatory helmet law states wear "beanie" helmets that don't meet the current F.M.V.S.S.–218 federal standard. "It's a political statement against the helmet requirements," said Eric Anderson, chairman of an industry helmet task force. "It's fashionable to be anti-helmet."

Regulators estimate it would cost manufacturers, who turn out 5.2 million certified helmets annually, only about 2 cents each or \$100,000 to comply with the new rule.

Motorcycle groups said the time and money would be better spent, and more lives saved, through rider education and motorist awareness programs. Public comments will be taken until December 1.

A.B.A.T.E. of New York To Picket Safety Conference

A.B.A.T.E. of New York announced their intention to picket the New York Highway Safety Conference, October 21st, in Syracuse, where the New York state police are presenting their motorcycle safety roadblock scenario to more than 350 professionals from local, state, federal, and private agencies "involved in the effort to reduce deaths and injuries related to traffic crashes."

A.B.A.T.E. of New York has obtained an all-day public assembly permit to conduct an informational picket/protest outside of the conference center to express their dissatisfaction with motorcycle-only





roadblocks, as well as draw public attention to the irony of New York state's misdirection of designated motorcycle safety funds to those very same enforcement tactics being promoted at the conference.

With support from A.B.A.T.E. of New York and in cooperation with the National Coalition of Motorcyclists (N.C.O.M.), A.I.M. (Aid to Injured Motorcyclists) attorney Mitchell Proner recently put the New York state police and D.M.V. on notice that a class action suit will be filed in protest of the discriminatory road checks being conducted on state highways during events that draw thousands of motorcyclists.

"Since motorcycles operated in New York are already required to pass annual safety inspections, the current N.Y.S.P. initiative serves only to harass, intimidate, and inconvenience motorcyclists, and is an abuse of discretionary power as specifically acknowledged by the New York state court of appeals," said *A.B.A.T.E.* in a statement.

Wyoming Bikers Fend Off Noise Ordinance

A proposed noise ordinance is on the "back burner" after scores of motorcyclists flooded the Casper city council chambers. The council voted unanimously and to a raucous applause to table the proposed change to a noise ordinance, which means it will not be discussed again unless a council member brings it back.

The proposed change read: "No person shall operate any motor vehicle in the city in such a manner that the public's attention is drawn to the noise created by the motor vehicle."

One biker after another spoke before the council to testify about how "loud pipes save lives." Loud exhaust keeps drivers aware of bikers and prevent crashes, said Jim Siri, a member of *Wyoming Central A.B.A.T.E.*, a motorcycle advocacy group. "Many things distract drivers, and if they aren't paying attention they won't always see motorcyclists, but they may still hear them," he told the Jackson Hole *Star-Tribune*.

Abuse of a motorcycle on city

streets is unacceptable, but motorcyclists also don't want to be unfairly targeted, said Russ Reddick, vice-president of *Wyoming State A.B.A.T.E.* and co-director of the *National Coalition of Motorcyclists* (*N.C.O.M.*) in region three. He told the newspaper that he wants to educate riders on how to ride respectfully and also educate drivers on how to be more aware of motorcyclists.

Motorcyclists and the council plan to work together to help solve "irresponsible riding" through residential neighborhoods, both groups agreed.

With mounting pressure from state and federal agencies we are facing motorcycle smog laws, low noise ordinances, a motorcycle safety summit that is working in conjunction with the C.H.P. and N.H.T.S.A. to impose more restrictions on riding your motorcycle, helmet laws and cities that want to limit gatherings

by motorcyclists.

In order to strengthen our position we are committed to working with all M.R.O.'s including N.C.O.M., M.R.F., A.M.A., M.M.A., and any state motorcycle rights organizations that strengthens our lobby on legislative issues and on motorcycle safety.

Our united front with these other M.R.O.s make us better prepared to attack issues on a broader scope by having access to legal assistance, promoting the sharing of information among the S.M.R.O.s and different groups, supporting and increasing political and legal effectiveness through free assistance with legislative strategy, safety projects, public awareness, information updates and assistance in both the legislative and judicial arenas. We are proud of our alliance with these organizations and look forward to the success that this collective effort is sure to bring.

WEIRD NEWS N.B.A. Player Suspended Over Moped Crash

The *Golden State Warriors* suspended 22-year old guard Monta Ellis for thirty games without pay for violating his contract after he seriously injured his ankle in a moped crash and then compounded his mistake by lying about spraining his ankle playing pickup ball.

The high-scoring high-paid guard probably never imagined that trouble would cost him about \$3 million. There's no doubt Ellis violated paragraph 12 of the *N.B.A.*'s uniform player contract, which prohibits a player from engaging "in any activity that a reasonable person would recognize as involving or exposing the participant to a substantial risk of bodily injury," including "driving or riding a motorcycle or moped."

Ellis, who agreed to a six-year deal worth \$66 million in July, underwent surgery to repair a torn ligament and is unlikely to be healthy enough to return before mid-December anyway, but the suspension means the guard won't be paid during his absence.

He was the second-leading scorer for the *N.B.A.*'s highest-scoring team

last season, averaging 20.2 points, 5.0 rebounds and 3.4 assists.

10:50 – Returned to breakout groups for finalization of work being done.

Noon – Concluded breakout groups and adjourned the planning session for 2008. State board meeting to take place in a few minutes.

Breakout Group Reports

Further reports of breakout groups included only two of the four groups at the time of this report being typed. Still needed are the *Fossil* discussion and public relations groups. It is possible that the public relations group was included with the education report to follow. This is due to Patricia Carner, head of the education group had to leave early and Debra Lutje took over for her.

Organizational Manual Group

(Headed by Nic Oliver and Brian Stovall.)

Reported that we want to return to two documents only. Not the mess that we now have. It was noted that we have fallen into the same trap that the government is in. Too many rules that overlap and are rewritten without research. Too many redundancies that need to be removed.

The two documents needed are:

1. Short, essential bylaws.

2. All the rest of what we need to operate the organization be presented in one document/manual in outline form and indexed for ease of use. We want to build into all the job descriptions an introduction of the primary responsibilities of the members and officers to help and support the organization functionally, financially, and morally.

One definition of brotherhood: "The state of being a brother; an association of people of the same order; the mutual regard resulting from this association."

Education Group

(Headed by Patricia Carner)

Motorcycle Awareness Rally – May 2, 2009.

Speaker agenda: Follow mission statement, get legislators committed to speaking before rally.

Harley Warranty Hosed

Let's start out with a discussion and handouts by the *American Brotherhood Aimed Towards Education of California*.

If you are riding your Harley and need to fill up at a single-pump gas station, it is a huge problem and can make your Harley warranty invalid. If you pull into the gas station and the car before you has filled up with low octane gas, the hose will still have some residual fuel. The pump is equipped with a single hose that dispenses all three octane grades of fuel. The first bit of gas coming from the pump will still contain from one quart to one gallon of the previously pumped gas. If the previous vehicle was a car and selected 87 octane, then the leftover fuel is deposited in the motorcycle's tank. The manufacturer's warranty for Harley requires that premium 91 octane fuel be the only gas used and this lower premium gas could lead to possible mechanical issues and the warranty becoming invalid.

Please join the brotherhood in fighting for separate hoses for different grades of gasoline.

[crusty ol' editor's note: One of the idiosyncrasies of gasoline chemistry is that if two different grades of fuel are blended together, the resulting octane rating will be higher than either of the grades used. Aircooled VW owners (whose engines share many of the same operating characteristics as V-twin engines) used that fact to their advantage when leaded fuels were being phased out, much to the chagrin of gas station operators.]

Mongols R.I.C.O. Act (Racketeer Influenced and Corrupt Organization)

Currently the federal government has been trying to use the *R.I.C.O.* statute to seize the *Mongol* trademark, which includes the patch and anything with the word "*Mongol*" printed on it. he government will then own and make money off the trademark. At the moment there is a government restraining order that forbids anyone from using the *Mongol* patch. The government has seized homes, cars, motorcycles, and bank accounts as well as any profits from book sales, posters, or other items.


The federal government has stated that the *Mongol* patch has value and is considered an asset and has filed a current application to seize the trademark.

While at the meeting, a vote was taken to move \$56,000 from the *Patriot Fund* to a fund called the *Trademark Fund*. This fund will be used to hire an attorney who is an expert in this field. Richard Lester and other attorneys have urged all clubs to copyright their patches so the government cannot take these sorts of actions.

Miscellaneous Notes

• Sputnik gave a big thumbs up to *Team Oregon* and said it was one of the best motorcycle training courses in the United States.

• The road block bill is being used by the government to stop motorcycles. While the bike is stopped, the police are checking for valid driver's licenses and loud pipes. Road blocks are now being called "check points."



• There was a report from Australia about recent changed in regulations being used against motorcycle riders. There are stationary sound cameras along the road that measure exhaust and stereo noise levels. The camera automatically takes a photo which is then used to issue a ticket and a fine. This system will eventually be exported and used here in the United States.

• In Texas, five to six thousand motorcyclists showed up for biker days at the capitol and met with legislators. They were recognized on both the house and senate floors.

• Marty Fox (Washington state A.I.M. attorney) spoke briefly about insurance and recommended a minimum of one hundred-thousand dollars of under/ uninsured coverage. he said that people should carry more, if possible.

A lot of insurance coverage on club runs cover only spectators and not participants. He recommended that clubs check around for insurance that will cover riders and participants.

• The *Texas Defenders* are now called the *Confederation of Clubs U.S. Defenders*.

Each club will either elect, appoint, or otherwise designate two of its members to act as a representative. (One primary, one alternate.) The representatives will be known as "defenders" and wear a state-owned *C.o.C.* "defenders patch".

They will be required to attend regional *C.o.C.* meetings and events as well as act as a liaison between the defenders program and their club. In the event of a "call to action", the defenders will be called in to be briefed and trained on the action needed and to take the information back to their respective clubs. The clubs will then be trained and able to participate in the action needed by writing letters and making phone calls to state or local government officials.

This is a grass roots effort. The most valuable asset is members of clubs, their friends and families.

The call to action is a notification about a specific political campaign that has been identified as falling within the criteria of the defender's parent organization.

For example:

1. A motorcycle rights organization or other such group notified the state *C.o.C.* that it desires a call to action campaign and it is requesting the support of the *U.S. Defenders.*

2. The state *C.o.C.* will initiate a review board to research the call to action to ensure that the campaign falls within the *C.o.C.*'s criteria.

3. If the review board approves the call to action, it will present the campaign to the state chairperson for authorization to activate the state's *U.S. Defenders*.

4. If the campaign is sanctioned, the state's defender field commander will call in all *U.S. Defender* units for a briefing concerning the call to action program and the necessary training to carry out the action.

5. The unit commander will call in all their defenders and provide them with training, then they will return to their clubs and groups. They will share the training and implement the call to action, making sure to include documentation of all letters and phone calls about the issue.


