Since 01 January 2000 Simon has been engaged on an around-the-world motorcycle ride to raise money for basic health care world-wide. Using a bike custom-built for the trip, the plucky Englishman has had his share of adventures and mishaps. Yet he picks himself and the pieces of his bike up after every rough landing, gets it all put back together, then continues on his journey. And that is one of the underlying messages that emerges from hearing him speak: you can't give up — you have to keep going because you have no choice.

It means that we act as legislative watchdogs to help ensure that any legislation affecting motorcycists is fair and that elected officials are fully informed regarding motorcyclle issues.

• We are not a motorcycle club or gang. Instead, A.B.A.T.E. is a not-for-profit organization devoted to raising member and public awareness about motorcycle issues and safety through education and community involvement. We also raise money for organizations that represent motorcyclist's conerns such as BikePAC.

• It doesn't matter what brand of bike you ride on.

We are not a manufacturer-specific organization. All are welcome: bikes, trikes, on-road or off, riders, passengers, or non-riders.

• You don't have to ride a motorcycle to belong to A.B.A.T.E.

Many of our members just enjoy being around motorcyclists. (We're just *that* wonderful.) And they feel that the social and legislative issues we're working on are important to their community.

What We're About

A Brief History of A.B.A.T.E.

"You have to know where you've been to know where you're going!"

Easyriders magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the Nationa Highway Transportation Safety Administration (N.H.T.S.A.) by joining a new national biker's rights organization called the National Custom Cycle Association. But because of a conflict with the acronym the name was changed in February 1972 to A Brotherhood Against Totalitarian Enactments (A.B.A.T.E.).

Easyriders began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. D.O.T. (Department of Transportation) was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the Huns Motorcycle Club in Connecticut convinced his congressman, Rep. Stewart Mckinney, to introduce H.R.3869 to end the Federal authority to withhold highway funds from states without helmet laws.

In July of 1975, Rob Rasor of the American Motorcyclist Association (A.M.A.), Ron Roloff of the M.M.A. of California and Ed Armstrong of A.B.A.T.E. of Chicago presented the House Sub-Committee on Surface Transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the D.O.T. because Governor Ronald Reagan refused to comply with the federal helmet law mandate, Roloff helped convince California Senator Alan Cranston to offer the language of the bill as an amendment to the 1975 Federal Highway Act, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by President Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached Congress twice over the past few years, first to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through Congress.

So, there you have it.

The roots of A.B.A.T.E. and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of Freedom of the Road.

Insurance companies throughout the nation are making it harder and harder to insure assembled bikes.



Hello, Everyone:

I'm Joseph Laurance, your new Vice-Coordinator, South. My job will be to assist State Coordinator, Ted Tracy and to provide a liaison between Ted and the chapters of southern Oregon. I take over from Bob Avery who has become a powerful voice for us within the Republican Party at both state and national levels.

Your job, as a member of A.B.A.T.E., will be nothing less than *Freedom Fighter*.

As a fighter for motorcyclists rights, you join a force engaged in battle for 40 years and in Oregon since 1975. Your fight for the right to ride won't require years of experience as a motorcyclist (I've been riding-hardfor two years). It won't require that you ride a hardtail panhead chopper (I ride a Suzuki 1400 Intruder). It won't require fostering a "hard" image (my colors are those of the Christian Motorcyclists Association, my badges are A.B.A.T.E., my ribbon is Vietnam service with 3 stars). In this organization appearance does not equate with effectiveness. What is required is your willingness to join the front-line, to participate instead of relying on others to do your fighting for you.

How?

First, become a more confident and capable motorcyclist.

One way is by enrolling in an appropriate TEAM Oregon rider course.



Another way is by studying both technical skills and motorcycle safety and then joining A.B.A.T.E.'s Motorcycle Awareness Program or becoming a TEAM Oregon instructor.

A.B.A.T.E. is justifiably proud of these programs, having been instrumental in their creation.

Your increased skill will underscore A.B.A.T.E.'s emphasis on accident avoidance instead of "dressing for the wreck" as is so often promoted elsewhere. Nothing so weakens our arguments as a bike on it's side or a media report of an injured motorcyclist. Taking safety to the next level, that of courtesy, enhances our public image and increases our effectiveness at all levels of our fight (yeah, I,m working on that one, too).

Next in importance after surviving the ride would be to actively and energetically participate in your local A.B.A.T.E. chapter. Make plans to attend every meeting. Let them know you're there by voicing your opinion on the issues at hand. Sign up for special committees, work details, as well as run and rally assignments. If a chapter event occurs, be there. Watch and learn from your chapter officers and then run for position during the next election.

Sounds simple, right?

It must not be, for in A.B.A.T.E., as in most organizations a small minority tends to do all the work. Burnout is probably the greatest single threat to the strength of your chapter. Your involvement not only strengthens the chapter but enables you to become a more effective fighter by honing your organizational and communication skills.

OK, now you're a confident and capable rider and you've polished those communication and organizational abilities by becoming an important part of your local chapter.

Now travel! Now communicate! Now organize!

Travel to Salem for S.T.E.A.M.

Travel to as many State Board meetings as you can.

Travel to the Motorcycle Awareness Rally at the state capitol.

Plan to attend *Best of the West* in Spokane.

Be at Fossil.

Study the run and events calendar in the newsletter or at the state's website http:// www.A.B.A.T.E.oforegon.org for planning and organizational meetings that you can attend.

Add some fun by riding that bike when convenient and bring others along. Our issues increase in importance before the public with our increased visibility on the highway.

As you attend these meetings, look to either side of you. There you will see Brian and Theresa, Randy, Mel and Iris, Ted and Jill, Geoff, Roger, Bob, Melinda, Charlie and many others. These are the proud veterans of our fight. Among them are the founders of this organization, those who lobby for us in government, those who represent us in political parties, those who have kept this brotherhood alive, those who have fought for so long and so tirelessly for your rights.

Learn their names and listen to what they say. Look to these people as your mentors, teachers who can show you the way. Follow them where they lead! Help them where you can!

They, and you, are the frontline of our fight!

A.M.A. Picks Up Support In Campaign Against Apparel Regulation

Pickerington, Ohio — Motorcyclists have picked up support from U.S. Rep. C.L. "Butch" Otter (R-Idaho) for their campaign to keep the federal government out of the business of regulating motorcycle apparel, the American Motorcyclist Association (A.M.A.) reports.

During a hearing Thursday before the U.S. House Highways and Transit Subcommittee, Otter spoke out against a federal proposal to report clothing defects to the National Highway Traffic Safety Administration (N.H.T.S.A.).

During the hearing, Otter told N.H.T.S.A. Administrator Jeffrey Runge that "It was never the intent of Congress to regulate motorcyclists clothing under the T.R.E.A.D. (Transportation Recall Enhancement, Accountability and Documentation)" Act.

"I urge the administration to reconsider this rule and focus our limited resources on highway safety instead of intrusive bureaucracy," Otter added.

The proposal is part of a package the federal government has drafted that would, if approved by Congress, require motor vehicle manufacturers and their suppliers to report customer satisfaction and other information to the federal government to help the N.H.T.S.A. identify defects related to motor vehicle safety.

The A.M.A. had previously told N.H.T.S.A. officials that including motorcycle rider apparel in the

reporting requirements appears to go beyond what Congress intended in approving the T.R.E.A.D. Act, and that such a requirement appears to be "impractical and unworkable." Although the A.M.A. supports improvements in rider-safety apparel, the Association notes that bringing federal bureaucracy into the marketplace could cripple an industry that has, on its own, made tremendous advances stretching back several decades.

Otter's office is working with the A.M.A. to have rider apparel deleted from the proposed reporting requirement. Otter's office said the congressman adopted the position in response to numerous constituent calls from motorcyclists.

Edward Moreland, A.M.A. vice president for government relations, added, "We look forward to working with more elected officials like Rep. Otter to ensure that federal traffic safety officials seriously consider the concerns of motorcyclists on this issue."

Guide for Building Off-Road Trails Now Available

Pickerington, Ohio — The American Motorcyclist Association (AMA) has re-released its technical handbook for constructing off-highway motorcycle and all-terrain vehicle trails.

Called Off-Highway Motorcycle & A. T.V. Trails Guidelines for Design, Construction, Maintenance and User Satisfaction, by Joe Wernex, the 55page book is a how-to manual for government officials, motorcycling clubs and others who need detailed information on constructing and



managing trails. The book takes the reader step-by-step through the entire process, from planning the trail system to construction to monitoring and management.

The booklet is a re-release of the second edition of the report, which was printed in 1994. But this latest version includes a revised list of resources, additional photographs to better illustrate trail design and maintenance, and a revised *Noise Management and Sound Testing* chapter that reflects lower noise-level recommendations made by the Motorcycle Industry Council.

The document is available as a booklet or a CD-ROM.

A.M.A. Takes Motorcyclists' Message on New Emissions Standards to the Environmental Protection Agency

Pickerington, Ohio — The American Motorcyclist Association (A.M.A.) reiterated its concerns that new U.S. Environmental Protection Agency emissions regulations could spell the end of two-stroke off-highway motorcycles during a visit to the E.P.A.'s vehicle emissions testing facility in Ann Arbor, Michigan, on January 22.

The A.M.A. delegation, led by Edward Moreland, vice president of A.M.A. government relations, also discussed with federal officials proposed emissions standards for road motorcycles that are soon to be released.

The A.M.A. delegation also included Director of State Affairs Sean Maher, and Legislative Affairs Specialists Royce Wood and Imre Szauter.

"We were encouraged by the open exchange that we had with the federal officials, and we look forward to providing the E.P.A. with more insights into how riders would be affected by their proposals," Moreland said. "We want the E.P.A. to know that riders are watching these proposals very closely and are concerned."

The E.P.A. has proposed national emissions standards covering offhighway motorcycles and allterrain vehicles (A.T.V.s) only slightly less stringent than the requirements now in place in California, which severely limit the use of two-stroke motorcycles. Currently, there are no national emissions standards governing offroad motorcycles and A.T.V.s.

Under the standards, which will be finalized by September 13, new off-highway motorcycles and A.T.V.s would be subject to strict emissions requirements that would be phased-in beginning in 2006. Full compliance would be required by the manufacturers in 2007. Also, A.T.V.s would be required to meet even tougher standards beginning in 2009.

The requirements wouldn't affect machines built through 2005, but would apply to machines built in 2006 and thereafter. The E.P.A. said it expects that manufacturers will meet these new, stringent offhighway standards by using fourstroke engines exclusively for trail machines. The E.P.A. has proposed off-road exemptions for competition-only machines, which would mean that two-stroke motocross bikes would be unaffected.

The A.M.A. delegation urged E.P.A. officials to create E.P.A. rate emissions standards for four-stroke and two-stroke motorcycles and A.T.V.s, considering safety, cost and performance. The delegation also argued that the federal government has significantly overestimated the amount of use of off-highway motorcycles and A.T.V.s nationwide, resulting in



projections that suggest those vehicles are responsible for more emissions than they actually are. And the Association suggested officials fine-tune the exemption for competition motorcycles so that enduro and other types of competition machines besides motocrossers are available to amateurs.

On the street side, the E.P.A. has indicated that it will release proposed emissions standards for public comment within the next couple of months. A draft of the proposal obtained by the A.M.A. indicates that the E.P.A. wants to adopt a two-tier standard already approved in California on a delayed basis.

The first tier of California standards will go into effect in 2004, with the second tier scheduled for 2008. The federal E.P.A. is proposing to adopt the same standards, but on a two-year delay, meaning tier one would take effect in 2006 and tier two in 2010.

Road motorcycles built before the 2006 model year would be unaffected by the new regulations and would remain legal to ride.

If adopted, the new federal emissions regulations are expected to result in increased use of fuel injection and catalytic converters on new motorcycles.

The draft proposal contains no new anti-tampering provisions.

The delegation also discussed catalytic converters and brought up cost and safety issues associated with their use on motorcycles.

The proposed regulations aren't expected to differ from the draft obtained by the A.M.A. Important provisions contained in the proposal include an exemption that gives small manufacturers until the 2008 model year to meet the tier-one national emissions standard. Those manufacturers — with sales of fewer than 3,000 bikes a year and having fewer than 500 employees — wouldn't be required to meet the tougher tiertwo standards.

Virginia Plates Support Safety

Virginia's House Bill 385, introduced by Del. Leo Wardrup, Jr. (R -Virginia Beach) would provide special license plates to supporters of the Motorcycle Rider Safety Training Program.

The plates bear the legend: "Share The Road" and for each set of license plates issued, in addition to the prescribed cost of state license plates, a one-time fee of ten dollars will be credited to the Motorcycle Rider Safety Training Program.

California Tries Taking Off Helmets

A.M.A. Western States Representative Nick Haris attended and presented written testimony to the California Senate Transportation Committee in support of SB 1057, a bill that would eliminate the motorcycle helmet requirement for operators and passengers of motorcycles 18 years of age and older. The bill, authored by Senator Bill Morrow, was presented by the senator along with representatives from A.B.A.T.E. of California and the California Motorcycle Dealers Association. Ultimately the bill failed to muster the necessary votes needed to pass out of committee and failed by a vote of 3 to 5.

N.H.T.S.A. Crash Data Released

The National Highway Traffic Safety Administration has released its Traffic Safety Facts 2000: A Compilation of Motor Vehicle Crash Data from the Fatality Analysis Reporting System and the General Estimates System. This report combines data from two key crash databases, providing statistics on traffic crashes of all severities.

B.L.M. Releases More Pulp

The Bureau of Land Management (B.L.M.) is creating a new national land management document which updates its vegetation treatment and land management practices. B.L.M. has scheduled meetings beginning in late January to March 12, 2002, to discuss a proposed Environmental Impact Statement (E.I.S.) addressing changes in land management on



B.L.M. lands in the western states, including Alaska.

You can help ensure that B.L.M. considers input from recreationists by attending a meeting, submitting comments at a meeting or in writing before the March 29, 2002 deadline, or putting your name on the "Stakeholder Mailing List" to receive mailings by calling B.L.M. at:

This national management document will be the basis for land management decisions made in 16 western states. It will address land management activities and is your opportunity for responsible outdoor recreationists to get to know local B.L.M. staff.

THREADS FRAY ON N.H.T.S.A. CLOTHING CONTROL BID

In partnership with A.B.A.T.E. of Michigan, the Motorcycle Riders Foundation visited the Michigan Congressional delegation this week to find Members of Congress and their staffs uniformly critical of N.H.T.S.A.'s bid for clothing control (see M.R.F. RIDER ALERTS #02NR04 and #02NR06 at:

www.M.R.F..org/newscurrent.php

Agreement was widespread that the National Highway Traffic Safety Administration's bid to regulate certain motorcycle rider apparel was neither desirable nor authorized by the T.R.E.A.D. Act. Among the giants in Congress we spoke to: U.S. Rep. John Dingell (D-MI) — ranking member of the powerful Energy and Commerce Committee that oversees NHTSA's implementation of the T.R.E.A.D. Act — and a key staffer with U.S. Rep. Fred Upton (R-MI) - the man who wrote the original law (without the motorcycle rider apparel language).

E.P.A. AND HEALTH CARE REMEDIES PUSHED

Michigan's Chuck Johnson, Tony Diaz, Butch Brown, M.R.F. REP John Silk and A.B.A.T.E. President Russ Martin joined me to brief the staffs of U.S. Reps. Bart Stupak, Peter Hoekstra, Dave Camp, Fred Upton, Dale Kildee, Joe Knollenberg, Sander Levin, Lynn Rivers and gubernatorial hopeful David Bonior. We also met in person with Mike Rogers, John Dingell and — a first for A.B.A.T.E. and M.R.F. - John Conyers, who invited A.B.A.T.E. to call on him again in his Detroit office this summer. Every motorcyclist in America owes a debt of gratitude to the membership of A.B.A.T.E. of Michigan for supporting this vital State Motorcycle Rights Organization (S.M.R.O.) visit at a most critical time.

TALKIN' TO THE CHAMP

Highlight of the visit: extensive personal discussions and great companionship with Congressman Jim Barcia, the M.R.F. Champion of Motorcyclists' Rights & Safety in Michigan. IDAHO and OKLAHOMA ACTION!

Thanks to former M.R.F. Communications Director Charlie Williams and A.B.A.T.E. of Oklahoma, U.S. Rep. Ernie Istook (R-OK) wrote a letter to N.H.T.S.A. calling on the agency to strike the rider apparel lingo in its proposed rulemaking on the T.R.E.A.D. Act. Also, U.S. Rep. Butch Otter (R-ID) spoke against clothing control on the House floor, thanks to the Idaho Coalition for Motorcycle Safety.

MOTORCYCLE SAFETY IMPROVEMENT PLAN ON HOLD

Washington, D.C. The Motorcycle Riders Foundation has learned that, according to the National Highway Traffic Safety Administration (N.H.T.S.A.), the proposed Motorcycle Safety Improvement Plan (McSIP) has been placed on hold by N.H.T.S.A.'s new Administrator, Jeffrey Runge, M.D. Dr. Runge is reexamining N.H.T.S.A. priorities, so N.H.T.S.A. is not issuing new plans until his review process is completed.

In other N.H.T.S.A. news, the agency indicated that it would release a Request for Proposal (R.F.P.) (in short, a solicitation for bids) to expand their understanding of the increase in motorcycle fatalities described in recently released reports. The R.F.P. will be available on the web site for the Commerce Business Daily (http:/ /cbd.cos.com/) in the near future.

Regarding the National Agenda for Motorcycle Safety (N.A.M.S.), N.H.T.S.A. is releasing a video that discusses N.A.M.S. and encourages organizations to implement the recommendations. The video is aimed at encouraging other entities (states, businesses and associations) to step forward and support the implementation of N.A.M.S.

As always, the Motorcycle Riders Foundation will keep you posted on further developments regarding the proposed *Motorcycle Safety Improvement* plan and the implementation of the National Agenda for Motorcycle Safety.

M.R.F. ATTENDS TRANSPORTATION RESEARCH BOARD ANNUAL MEETING

Washington, D.C.-- The Transportation Research Board (T.R.B.) convened its 81st Annual Meeting January 13-17, 2002 in Washington, D.C. The T.R.B. is a part of the National Research Council, organized by the National Academy of Sciences.

The A.B.A.T.E. of Ohio Legislative Seminar last weekend was a romping, stomping good time, and that was just the educational part of the seminar. A.M.A. Board Chairman and M.R.F. Ex-Officio Board Member Rick Gray - the fellow who talked me into taking a job with the M.R.F. - was banquet speaker. Rick spoke about September 11th and how our motorcycling lifestyle prepares us to be leaders when tragedy strikes. Steve Zimmer urged attendees to roll on the state and federal fronts - by seizing an issue that burns in your heart and carrying that fire back to the counties and regions. A.B.A.T.E. Legal Services Rod Taylor urged Ohio and other S.M.R.O.s to focus on membership growth. Looking ahead, A.M.A.'s Terry Lee Cook warned that reauthorization of TEA-21 is months ahead. If there was one lesson to be learned, it was this: you can't talk to a legislator once a year and expect to hold your edge. In his wrap-up remarks, Hairy George spoke about the need for all of us to stay active, so we keep our activism and our effectiveness as sharp as a knife. I thank A.B.A.T.E. of Ohio for its kind invitation - and for its leading role at the federal level, especially in combating unreasonable emissions standards for street motorcycles.

Newton Dewey: Rider Without A Clue

To The Editor,

As a newcomer to the world of motorcycling, I am constantly learning of the quaint mannerisms that riders have developed in order to separate themselves from mainstream society. However I wish to call attention to a routine gesture that is so inherently dangerous that I feel it should be totally banned forever. I am referring, of course, to that potential killer, the motorcyclist "wave".

Before I directly attack the issue at hand, allow me to digress to the background of my complaint.

While avidly reading my first copy of Republican Rider magazine, I came across a reference to "the wave". However, no precise description of the activity was given in the article. Neither was enlightenment available via the Encyclopedia of Motorcycling Etiquite and Rituals.

I was rather shocked when all of them, both male and female, undertook to reveal wobbly portions of their respective anatomies and began wiggling them back and forth.

I began to suspect that they had not taken my question seriously, so I strode resolutely from their rude presence. Unfortunately, as I was angrily backing the Vespa around, I seemed to have struck one of their overlylarge machines which initiated a nonpolitical domino effect. When their owners burst out of the tavern, I pointed out that the situation would not have occurred had they opted for using the more stable center stand for parking their "pigs" rather than the less supportive side stand.

At first I assumed that their stunned silence indicated calm acceptance of constructive criticism. But when they began producing baseball bats and chains, I decided that my efforts had been in vain and deemed it best to withdraw from the immediate area as rapidly as possible.

When I was approximately half way home, I began to hear the thrilling sound of heavy motorcycles roaring around behind me. However, when I heard the shout of "There's the little asshole!", I thought it best to seek refuge in a nearby police station.

At this point I must point out that there is a motorcycling minority who create a negative public image for the majority of law abiding riders.

Although I parked the Vespa properly at the curb in accordance with local regulations before proceeding into the police station, the riders who followed me inside didn't even bother dismounting first. I must say the desk sergeant was not impressed with their riding prowess. In fact, quite an altercation broke out as the rest of the tavern patrons converged on the station house.

The remainder of the evening is somewhat of a blur in my memory, but I seem to recall the extensive use of fire hoses and National Guard troops. Journalists dubbed it the "Midtown Midnight Motorcycle Melee".

After calm had been restored and statements taken, I was released on my own recognizance. As I was lead out past the cells where the other motorcyclists were confined, I felt impelled to make amends for the damage I had caused. I stopped and promised to provide each individual with a bottle of touch-up paint for his or her motorcycle.

They seemed to be stunned into silence

by my generous offer. Taking advantage of their attention, I proceeded to point out that their actions of the previous night had given the remaining ninety percent of motorcyclists, including myself, a poor public image. I was about to continue my gentle rebukes when all of them lunged for the bars of their cells, reaching out towards me. I wanted to return their enthusiasm by shaking each outstretched hand, but my police escort hustled me out of the detention area.

Despite the flurry of activity my research had occasioned, my question regarding the "wave" had still not been answered.

When I finally arrived home at three AM, I immediately phoned my third Motorcycle Safety Course instructor, taking advantage of their offer to call whenever we had questions about safe riding. I identified myself and patiently answered his enquiry concerning the time. I then asked what the "wave" was, however he replied by making an unlikely suggestion concerning selfprocreation, then seemed to repeatedly drop his handset on the floor. After the line went dead, I phoned 9-1-1 to report a possible cardiac arrest.

I then decided to turn on my television receiver on the off chance that my hero, Dane Quayl, might be speaking. As I changed channels, I happened to find a program of sports highlights and discovered that it contained the answer of what the "wave" was.

The next day I discovered just how inherently dangerous the wave was when I saw another rider approaching. Upon detecting her, I quickly up-shifted to neutral, then balancing carefully, I stood up and raised my arms over my head in a graceful, fluid motion. Instead of returning my salute, she merely stuck her hand out to the side and wiggled it. Just then my front wheel

struck a pot hole.

The doctors here at Midtown General Hospital/Veterinary claim that I should be out of traction by next week. They tell me that the accident would have been a lot worse if the Vespa's training wheels hadn't taken the brunt of the fall.

A nurse has just informed me that there is a large contingent of people waiting to visit me. I find the news very heart-warming since I didn't think I had any friends in this town. The group outside seem to be members of a newly-formed motorcycle club calling themselves the Ten Percenters. I can hardly wait to see their reaction when I tell them of my plans for a ballot measure requiring mandatory training wheels for *all* motorcycles.



HELMET FREEDOM, WHO'S NEXT?

A storm is brewing over the mid-Atlantic states, a storm of Freedom Fighters that is, as statehouses in Maryland, Virginia and West Virginia have all been besieged with helmet repeal legislation.

In West Virginia, House Delegate Greg Butcher, a long time biker and member of the National Coalition of Motorcyclists (N.C.O.M.) Legislative Task Force, has introduced a bill to allow motorcyclists and their passengers to ride without a helmet if they are older than 21 with at least two years of experience. On January 23, HB-2156 passed out of the Roads & Transportation Committee with only one dissenting vote. Next it goes to the House Judicial Committee. Maryland?s motorcycle helmet bill, SB-167 would eliminate mandatory helmet use by adult riders, and was given a first reading in the State Senate on January 16, 2002. The first vote on this bill will be in the Senate Judicial Proceedings Committee.

Meanwhile, the Commonwealth of Virginia has introduced not just one helmet repeal bill, but *four*, each with a different twist. Two of the bills were recently voted down by slim margins. Thirty other states have modified their helmet laws to exempt adult riders, and several other states are hoping to be the next to win their Freedom of Choice.

N.H.T.S.A. NUMBERS CALLED INTO QUESTION Despite being barred by

Congress from lobbying for helmet laws, every time a state considers modifying their helmet law, the federal National Highway Traffic Safety Administration pokes their nose into the state?s business and tries to dissuade legislators with bogus statistics. None of that is new to those in the front lines, but a recently released N.H.T.S.A. "study" has come under fire from the insurance industry, normally one of N.H.T.S.A.'s allies!

The U.S.A.A. Taillights column printed the N.H.T.S.A. report on increases in deaths in Arkansas and Texas since their helmet law repeals (U.S.A.A. is one of the nation's largest insurance companies.)

A Louisiana rider wrote to U.S.A.A. to challenge the validity of the statistics and asked whether the report took into consideration the increased number of motorcycles and number of miles ridden. He also asked whether any effort had been made to determine whether a helmet could have saved any of those lives. Here is the response he got from the editor;

"Editor's Note: We reprinted statistics from the National Highway Traffic Safety Administration on increases in the fatality rates of motorcyclists following the repeal of helmet laws in Texas and Arkansas. After receiving member feedback questioning these statistics, we took a closer look at the N.H.T.S.A. study results and found the statistics we reported had not been adjusted for increases in registrations and miles traveled. When registrations are factored in, fatality rates in Arkansas dropped from 11.54 percent per



10,000 motorcycles in 1996 to 10.92 in 1998. In Texas, the fatality rate increased from 6.99 per 10,000 motorcycles to 8.85 per 10,000. The N.H.T.S.A. study does not attempt to determine whether wearing a helmet would have prevented any reported fatalities."

In defending against the N.H.T.S.A. study, Sputnik, founder of the Texas Motorcycle Rights Association and member of the N.C.O.M. Legislative Task Force, reported that "In 1997, prior to the Texas helmet law repeal, there were 115 people who died in accidents, motorcycle and registrations had dropped to 143,000. By 1999, after the helmet law was repealed, deaths had risen to 181, but registrations had increased to 253,000. Given these figures, which N.H.T.S.A. ignored, it would show that while fatalities increased by 58 percent during this 2-year period, registrations increased by 77 percent!"

BIKERS DUEL WITH FALLEN W.T.C. COPS FAMILY OVER VEST

The family of a New Jersey Port Authority police officer killed in the World Trade Center attack and the motorcycle club he belonged to are sparring over his black leather riding vest, and the dispute may wind up in court.

According to the Associated Press, Officer Paul Laszczynski was a member of the Renegade Pigs, a motorcycle club for police officers, who was killed after being called to the trade center on September 11 from his post at Jersey City's Journal

Square P.A.T.H. station.

His white and blue Harley-Davidson motorcycle and vest were proudly displayed at a memorial service since no body was recovered from the W.T.C. wreckage, and now the officer's family wants the vest as a keepsake, but the club refuses to turn it over, claiming it is rightfully theirs because club rules clearly state that member's "colors" are the property of the club.

Although Laszczynski was divorced from their mother, his two daughters have retained a lawyer and are preparing for a court battle to get the vest back. They already have claimed their father's motorcycle, his car, his big-screen TV, his jewelry, clothes, papers, medals and citations, not to mention his shore house in Manahawkin, but they claim they need the vest to remember their dad. Meanwhile, the club wants to frame the vest and display it.

Neither side is budging, so it may take a judge and jury to sort things out.

BIKERS FIGHT AGAINST COURTHOUSE DISCRIMINATION

A dozen leather-clad bikers had no problems entering the 9th U.S. Circuit Court of Appeals in San Francisco recently to argue their case for blocking a Carson City, Nevada courthouse dress code that prohibits biker "colors," under which they were arrested or cited last year.

Bikers from the Hells Angels, Branded Few, Vietnam Veterans and His Royal Priesthood motorcycle clubs have asked the appeals court to at least temporarily stop Carson City from enforcing the dress code until their civil-rights lawsuit on the rules can be heard. The bikers say it infringes on their constitutional rights of free speech.

Rick Eckhardt, a member of the Christian motorcycle club His Royal Priesthood, told the Reno Gazette-Journal that the dress code discriminates against motorcycle riders by limiting what they can wear in a public building.

"It's very important that we're able to enter the federal building and the courthouse, especially if we have a hearing to go to or need to go to court in support of one of our friends," said Eckhardt. "We just want the same rights everyone else has to go in the court and be heard."

Eckhardt and nine other bikers were cited for trespassing at the Carson City courthouse last March 26 for refusing an order from court security officers to either remove their motorcycle jackets or leave the public building. They were among the 35 or more motorcycle riders who showed up at the courthouse that day in support of two Branded Few Motorcycle Club members who had been arrested two weeks earlier on the same charge.

The initial incident involved bikers Scot Banks and Steve Dominguez of Reno, who went to the courthouse March 9 to contest a traffic violation but were told by security officers that they couldn't wear their swastikadecorated club colors inside. They were arrested and their vests were confiscated after they refused to remove their vests or leave.

The bikers cited two weeks later wore jackets that carried a variety of symbols, including an angel over the background of a Christian cross and the American flag. All have pleaded innocent and are waiting for a hearing date in state court to argue the constitutionality of the rules before going to trial on the trespassing charges, said lawyer Kevin Karp, who is representing the bikers on the criminal charges. Karp is the Northern Nevada A.I.M. Attorney, and serves as legal counsel to the Northern Nevada Confederation of Clubs.

The 9th Circuit panel took the case under advisement and set no date for a ruling.
