### A.B.A.T.E. is a not-for-profit organization

In Oregon, A.B.A.T.E. stands for A Brotherhood Against Totalitarian Enactments, which isn't nearly as subversive as it sounds. It means that we act as legislative watchdogs to help ensure that any legislation affecting motorcyclists is fair and that elected officials are fully informed regarding motorcycle issues.

- We are not a motorcycle club or gang.

Instead, A.B.A.T.E. is a not-for-profit organization devoted to raising member and public awareness about motorcycle issues and safety through education and community involvement. We also raise money for organizations that represent motorcyclist's concerns such as BikePAC.

- It doesn't matter what brand of bike you ride on.

We are not a manufacturer-specific organization. All are welcome: bikes, trikes, on-road or off, riders, passengers, or non-riders.

- You don't have to ride a motorcycle to belong to A.B.A.T.E.

Many of our members just enjoy being around motorcyclists. (We're just *that* wonderful.) And they feel that the social and legislative issues we're working on are important to their community.

### MISSION STATEMENT

A.B.A.T.E. of Oregon, Inc. promotes motorcycle awareness, education, safety and liberty through community involvement and legislative action.

### A Brief History of A.B.A.T.E.

*"You have to know where you've been to know where you're going!"*

*Easyriders* magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the National Highway Transportation Safety Administration (N.H.T.S.A.) by joining a new national biker's rights organization called the National Custom Cycle Association. But because of a conflict with the acronym the name was changed in February 1972 to A Brotherhood Against Totalitarian Enactments (A.B.A.T.E.).

*Easyriders* began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. D.O.T. (Department of Transportation) was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the Huns Motorcycle Club in Connecticut convinced his congressman, Rep. Stewart McKinney, to introduce H.R.3869 to end the Federal authority to withhold highway funds from states without helmet laws.

In July of 1975, Rob Razor of the American Motorcyclist Association (A.M.A.), Ron Roloff of the M.M.A. of California and Ed Armstrong of A.B.A.T.E. of Chicago presented the House Sub-Committee on Surface Transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the D.O.T. because Governor Ronald Reagan refused to comply with the federal helmet law mandate, Roloff helped convince California Senator Alan Cranston to offer the language of the bill as an amendment to the 1975 Federal Highway Act, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by

President Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached Congress twice over the past few years, first to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through Congress.

So, there you have it.

The roots of A.B.A.T.E. and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of Freedom of the Road.

Lastly, a message of hope. In a recent episode of *Touched by an Angel* there was a story about a man who was trying to save a woman from being crushed by a huge wooden beam. As the story goes, the woman was jogging with her dog when the dog ran into an old mine. The woman went after

the dog and the roof of the mine fell in on her. The dog escaped and was outside of the abandoned mine barking. A man driving by saw the dog and pulled over to see what the problem was. As he walked up to the barking dog, he peered inside the opening of the mine hearing the woman calling for help. He immediately went in to rescue her and the roof of the mine started to fall in again. As a huge wooden beam was starting to fall on the woman and crush her, he said, "Oh God, help me!" and immediately got underneath the beam and held it up for five hours. Many times the woman told him to let go and look behind him because there was an angel holding up the beam. He refused to turn around and look fearing that she was wrong and the beam would fall and crush her. So for five hours he strained to hold up the beam until help arrived. Help finally arrived and he became a big hero taking all the credit for holding up the beam. He became such a publicity hound and jerk that the press, as well as his wife, stopped talking to him. He finally came to his senses realizing he could not of held up the beam – the only conclusion being that the hurt woman was right all along — that he had God's help. So the moral of the story is:

Obey leash laws at all times.

Avoid abandoned mines like the plague.

Lifting weights can save a life.

**\*\*\* Officers Reports \*\*\***

**Legislative Director:** Rick Maish included an *E.P.A.* breakdown from *A.M.A.* in the chapter rep packets. *BikePAC* is doing a good job with voter information. *BikePAC* membership is down to 140, need to get the membership up. You could upgrade your chapter membership. You can listen to *M.R.F.* archives of *Meeting of the Minds* on their website [www.mrf.org](http://www.mrf.org). Call your Congressman at (202)-225-3121 to co-sponsor *The Barcia Act HR5433* or fax or e-mail them.

**A.B.A.T.E.'s BikePAC representative:** Brian Stovall reports headlight repeal work done by Mel and Albany area people. Vehicular assault: Randy has been working on this and had to check out a lot of laws to see what we can do about it. Randy had to sort through those laws to see which vehicle would work best. *H.I.P.P.A.*: Brian working on this one, has one person who has exclusion on a

student policy. Read the real policy under exclusions to see what exclusions are on your policy. Lane splitting: Geoff White wants opinions about lane splitting and any info. Anti discrimination is in limbo due to not enough examples. Helmet law: going with same language, looking for someone to sponsor it.

*A.B.A.T.E. of Oregon, Inc.*, contracts with *BikePAC* to do lobbying work for us. The State Board contracts \$5,000 a year, a total of \$10,000 in biennium. *A.B.A.T.E. of Oregon* cannot have a major expense for lobbying out of our budget. This was set years ago and our budget is larger now. Brain plans to advocate changing the amount. *BikePAC* has an open membership which is different than donation. You can pay more for the membership than what the actual is. An *M.A.B.* is \$200. You can spend more.

The identified candidates were given money. We asked for your list of candidates last month.

**Biker Days:** We have set three in advance and plan to set two more. Not planning on one opening day which is January 13, but if you can be there on opening day, do so, in leathers. The first *Biker Day* is February 3.

**Confederation of Clubs representative:** Ed Vaughn told Ted that he has a *Confederation* meeting Sunday and one will be at the *N.C.O.M.* conference.

**Education Director:** Geoff White said possible donation to *Team Oregon*, still have some planning to do. They need training facilities first. # Education Director

Greetings from Nora Rohde and Geoff White,

Fall is here, and with it comes the weather that we know will require some extra care and respect. The Oregon winter in many areas is luxurious due to the fact that we are able to ride and enjoy motorcycling when many of our fellow riders from other states have long since packed their toys away until warmer spring climates return.

I believe that riding in Oregon is a true sense of using a motorcycle as a valid alternative form of transportation. With the right protective clothing and a respect for the elements and road conditions, motorcycling can be a sensible and enjoyable means of commuting to work or enjoying a cool winter's adventure.

Here some points to remember and practice during your travels on two wheels when the weather is less than perfect. This information is a compilation of materials from many sources and references on safe riding practices. These practices are useful to help keep your ride upright when the handling becomes a bit unpredictable. These points may possibly mean the difference between an post - ride cleanup and a major repair or even worse. Winter riding is not an experience to fear. It is enjoyable and efficient when it is done wisely.

A major practice to consider in wet weather is "ride smooth, dude".

Motorcycles today are the product of research and development. The

technology is always being tested, and improvements bring a safer and better performing machine to our world of riding. This does not mean that that you can laugh at the conditions of the wet road. That wet roadway will let you know who's boss faster than you can say "Where'd the pavement run off to?" Give the accelerator that easy twist. Pulling away from a stop will just have to take a little longer this time. When exiting a curve, roll on the gas nice and smooth. Tires, today, are much more effective in the wet weather than they were back when your mom and dad were riding, but that does not mean that water on the road is not just as potentially dangerous. Add a little oil from the traffic and you've got "slip and slide" material.

If rain follows a particularly dry period, remember, that oil has had a chance to build up. The rain will eventually wash much of it away, but right at the beginning it will be pretty slick for a little while.

Apply those brakes with that same "smooth" attitude. Remember that the traction range for both acceleration and deceleration will always be reduced on wet surfaces. Wet brake discs and pads will often have a certain "lag" time. Be prepared for this. Skilled brake modulation is a must under these conditions. Give a little more space to compensate for some of the brake lag symptoms. Panic stops are even more tricky when the road surface is wet. A sufficient space cushion may help you to avoid some of the emergencies. Practice

acceleration and braking when possible to get a "feel" for the performance under wet conditions, and this will help to prevent the unpredictable situations.

Scan a larger picture in the wet weather. Search the road ahead for possible traction deficiencies or difficulties. Certain road surfaces and water don't mix well. Watch for painted surfaces. Paint can become very slick in the rain. Avoid riding on the painted lines in the roadway whenever possible.

Some commercial businesses paint the driveways and entrances to their parking lots or entryways. Watch out! These can really be a surprise in the rain.

Metal in the roadway can be very slippery when the rain comes along. Manhole covers sewer grates, bridge panels, grates, and seams, railroad tracks, and construction plates can all take your traction away at least temporarily. Be ready for these surfaces. Don't panic. Usually your "footing" returns as soon as you have cleared the metal surface. Wood surfaces, bricks, tar, and many smooth pavement areas can hold water or become slippery in the wet weather. Holes in the road can tend to "disappear" when the rain fills them. A deep hole can look like any other puddle. Avoid riding through the puddles if at all possible to reduce the risk of hitting a deep hole unexpectedly. Remember that intersections and places where cars are stopped frequently will have a concentration of oil or fluids. Wet leaves are extremely potentially treacherous for motorcyclists. Always keep them in mind while enjoying your Fall ride.

“Be seen” out there. Try to keep your bike in a position where the traffic can spot you easily. It’s a fact that less of us will be riding in the rainy or foul weather. The automobile drivers will not necessarily be expecting to see you out there on a motorcycle more than in the good weather. The car drivers may also be struggling with visibility in foul weather. Never assume that they see or hear you.

Go ahead and use your high beam headlight in the daytime for extra visibility. It’s probably not going to blind an oncoming driver in the daylight.

The drivers of the automobiles will probably have their windows up.

The rain and wheels running through water will tend to block out some of the sounds outside the vehicle. Try to give a little more space in the wet weather.

Have a great fall and winter of riding! “Ease” yourself into winter riding, even if you are an experienced operator. Have sympathy for those who are waiting to get their bikes out when the snows melt.

Start thinking about our S.T.E.A.M. conference. (Scheduled for February 15th, 2003). Get involved with your organization’s processes and functions. We have a very busy year coming up, and you are our greatest resource. Welcome to the Salem Chapter in the field of the motorcycle awareness program. I apologize, but I’m still not able to get a complete tally of classes and students reached for the 2001 / 2002 school year. I’m still waiting for some of the reports.

So, for now...bundle up, pull it out, warm it up, rev it up, and run!

Oh yeah, spread the awareness, ya’ll!

### News Bits'n Pieces

*Toronto* — Here's some more media hype I saw; this one on-line. The headline: "Dozens of Outlaw motorcycle gang members, including some top leaders, were arrested in raids on biker clubhouses in Canada and the United States."

In Canada there were supposedly over 500 officers involved in this abomination, but the press made it look even bigger than it really was.

In the U.S.A., the same game is

being played.

I'm not saying I think all riders are saints. We have a few sour apples, too. Our biggest problem as I see it is much the same as the

*Harley* parked outside a bar that everybody sees but no one ever sees the five or six pick-ups parked there too.

*Harrisburg, Pennsylvania* — This is some good news. Pennsylvania motorcyclists have "taxed" themselves to ensure safer riding. They voted in some increased funding for their state Motorcycle Safety Program. It's the *best* way to prevent motorcycle accidents, injuries and deaths, says *A.B.A.T.E. of Pennsylvania*. And Joe Public still thinks we have a death wish because we ride. This bill had 68 co-sponsors.

All S.M.R.O.'s (State Motorcycle Rights Associations) could take a lesson here. In Oregon we did about the same thing a couple of sessions ago and it works.

*Nova Scotia, Canada* — This bit comes to me (word for word) from Animal, my good buddy from the north country: "*Each year I MC to a toy run up in New Brunswick. This year we raised over \$10,000 in cash and toys which is an awesome amount for up here. \$5,000 of it came from the inmates of the Dorchester Penitentiary.*" Wow! Even convicts in Canada love kids. And why not.

*Tokyo* — Government is stickin' it's paws where they shouldn't be again, this time in Vietnam, and it's about

motorcycles. In September, their government put a cap on how many bikes and bike parts they would allow Yamaha build in their Vietnam plants. I guess they wanted to give a leg up to their locally-owned motorcycle businesses there. Nice idea, but it sorta backfired. Yamaha just said "screw it," and shut down their Viet-Nam plant, at least for now.

*Earth Orbit* — A biker's wife is the pilot of the space shuttle *Atlantis*, at this writing. The crew is headed up to the international space station. Pilot-astronaut Pamela Melroy is the third woman to fly as a space shuttle pilot. Seems she hesitated about her husband getting a scoot. But listen to what she said: "*I thought to myself, the guy's an airline pilot flying international and I'm a shuttle pilot. Who am I to tell him it's not safe enough? To hold either of us back from doing something that we're really excited about, because the other person would be worried about you, would just be wrong. We just don't do it.*"

Now *there's* a "top-flight" woman with the right attitude!

*N.H.T.S.A. (National Highway Traffic Safety Administration)* — From these good safetycrats comes this critical information: "...on a national level, motorcycle deaths have for the last four years been steadily rising. The latest figures show that 3,181 people died in motorcycle crashes in 2001, up nearly 10 percent from 2000, according to Rae Tyson of *N.H.T.S.A.*

in Washington, D.C.

It's fairly obvious to me that some folks don't take into account that ridership has increased phenomenally in the last several years and many of these new riders – some of 'em baby-boomers who are just *now* starting to ride – have *never taken a riding course!* *N.H.T.S.A.* says they are perplexed at the sudden rise and tend to blame it on states that have repealed their helmet laws.

Well, let me tell them this: If we had *better* and *more* rider education, you'd see a big *drop* in accidents and death. And a *lot* of these new boomer-riders have never ridden a big bike, and that's what *N.H.T.S.A.*'s own stats say they're riding.

Well, if the last time you rode was on a Honda 350 in 1973 and you get yourself up on a brand-new Fatboy, you're just askin' for it if you don't get out and get some training.

A *whole* lot has changed in the past 30 years about riding. If we're all better riders and crash *less*, we can continue to tell *N.H.T.S.A.* where to put their statistics.

*Dehli, India* — So I come across this article from *Reuters*, and I find out that India's transportation situation is the same as in a *lot* of the poorer but up'n coming countries. In short, they all go nuts for motorcycles! Now, some folks think it's just because the buggers can't afford a car, and that *is* part of it. These are countries that are just now getting invigorated with growth and change — kinda like it was here in the U.S.A. a long time ago. Bikes are *the* most practical thing a person could buy there! Cheap on gas, but flashy and cool. There are a whole slew of models and wild colors — even from major

companies like *Honda* — that we *never*, ever see here in the US. Sounds great for them — I'll stick with my *Valkyrie*.

## NEWS and NOTES



The Recreation Fee Demonstration Program was created in 1996 through an act of the 105th Congress, HR 3109. The Act gave the *National Park Service (N.P.S.)*, the *Bureau of Land Management (B.L.M.)*, the *U.S. Fish and Wildlife Service*, and the *U.S. Forest Service* the authority to collect recreation fees on federal land.

The fees were to be used to address the backlogged recreation needs on our public lands. The fees were to be collected locally and to be used for maintenance locally.

Recently, U.S. Senator Jeff Bingaman (D-NM) introduced S. 2607, which grants permanent fee authority to these agencies. Additionally, the administration has expressed its support for the bill.

Although the *American Motorcyclist Association (A.M.A.)* supports the concept of small user fees to be used for the creation and maintenance of trails, as well as the concept of permanent fee authority, we remain skeptical of specific details of S.2607.

The bill allows the Secretary of Interior and the Secretary of Agriculture to require a special recreation permit for motorized recreation to "ensure resource protection or public safety". The *A.M.A.* believes that motorized recreation should be treated equitably, like any other valid form of recreation. A special permit in lieu of ordinary fees is unnecessary. Also, the bill does not recognize the important lessons learned through the demonstration project. The Bush Administration stated the following lessons: Recreation fees are administered

inconsistently from site to site; there is no distinction between entrance fees and user fees; the improvements made through fees are not readily apparent to the public; the current pass system is confusing to the public; a fee should not be imposed where there isn't an opportunity to enhance the visitor experience; visitors should not be "nickel and dimed" through too many separate recreation fee charges.

S. 2607 or any other attempt to grant permanent authority to implement fees must reflect these learned experiences. Please tell your member of Congress to reflect on these past experiences of the Recreation Fee Demonstration Program before granting permanent authority to the Secretary of Interior and the Secretary of Agriculture.

The *A.M.A.* and the *National Highway Traffic Safety Administration (N.H.T.S.A.)* announce a partnership on a national impaired-riding campaign. The program is intended to educate motorcyclists about the dangers of drinking and riding.

In 2001, 41 percent of the fatally injured motorcycle riders were impaired, with blood alcohol content (B.A.C.) of .08 g/dl or greater, the legal limit of impairment in many states. Impaired-riding issues were listed among the urgent recommendations of the National Agenda for Motorcycle Safety (DOT HS 809156), a national plan that was developed by the motorcycling community in late 2000.

The *A.M.A.*'s "Ride Straight" campaign will develop messages

specifically targeting motorcyclists and will incorporate segments of

*N.H.T.S.A.*'s current "Friends Don't Let Friends Ride Drunk" campaign. The *A.M.A.* will launch Ride Straight in mid-2003.

California Governor Gray Davis vetoed AB-2521, a bill to require all new and replacement traffic-actuated signals to recognize motorcycles and bicycles.

His veto message, signed September 18, 2002, read in part: "While I recognize the merits of this measure, I am vetoing this bill because it would result in unknown reimbursable state-mandated costs on local government by requiring them to install these new detectors."

London, England bicyclists have vowed to fight plans to let motorcyclists use bus lanes in metro London.

A two-year pilot scheme started in September, which would see motorcycles use bus lanes without penalty. If successful the plan could be a real breakthrough in opening up bus lanes throughout the country to motorcycling commuters.

But representatives of the bicycling community have already begun lobbying hard to get the scheme shelved, even before it gets off the ground.

Bicyclists fear increased competition from a lot of motorcycles, which have the worst crash and casualty rates of any road user.

This is despite the results from a similar trial on other motorways

which have operated since July. The Highway Agency reported no major problems, and was quick to stress that the trial, which takes place on motorway approaches to London, would not automatically lead to changes in urban area.

Vietnam will raise its tariff on imported motorcycles to 100 percent from the current 60 percent to compensate for the elimination of an import licensing requirement that helps protect domestic assembly operations.

Virtually all motorcycles in Vietnam are assembled in the country from sets of local and imported parts because a license required by the Ministry of Trade to import finished models is seldom granted.

That license requirement is to be lifted but the tariff rate will be simultaneously raised to 100 percent to protect domestic assemblers.

Vietnam's motorcycle assembly industry has been in chaos for several weeks since the government suddenly lowered an annual quota on imported parts to 1.5 million sets from 2.5 million. Officials cited a public outcry over the soaring number of motorcycle accidents.

*Honda Vietnam*, the country's largest motorcycle assembler, was forced to suspend production earlier this week because of the lower limit. Vietnam has seven foreign joint-venture motorcycle assemblers and 55 local assemblers.

Local media have reported that two other joint ventures, with Japanese manufacturers *Suzuki* and *Yamaha*, may also be forced to suspend

production soon because of the curb on imported parts.

Motorcycle ownership has grown rapidly in recent years as Vietnam's economy has expanded. The country, with a population of 79 million, now has 9.4 million motorcycles, one of the highest per capita levels in the world.

Last year, more than 10,000 people were killed in traffic accidents, of which 80 percent reportedly involved motorcycles.

Michigan Senate Bill 1413, introduced by Senator Valde Garcia (R-26) and referred to the Committee on Transportation and Tourism, would amend the Michigan vehicle code to make a person found responsible for a violation that causes injury to another individual who is operating or riding on a motorcycle, subject to a fine five times otherwise prescribed.

A three-judge panel of the United States Court of Appeals for the Second Circuit, in Manhattan, ruled 2 to 1 that Vermont lawmakers had a right to impose spending limits of \$300,000 on candidates for governor and \$100,000 on candidates for lieutenant governor.

The justification for the limits lay in "preventing the effective sale of time and access to public officials that results from the corrupting influence of excessive fund-raising and campaign spending," Judge Chester J. Straub wrote.

Such limits, Judge Straub said, were "necessary to safeguard the democratic process and the public's faith in its representatives."

Judge Ralph K. Winter dissented, asserting that the Vermont law violated candidates' First Amendment rights to free speech. Judge Winter said the law, even assuming the good intentions of its enactors, "suppresses ordinary political activity at every level of the electoral process."

Judge Straub and Judge Pooler were appointed by President Bill Clinton; Judge Winter by President Ronald Reagan.

The ruling threw out parts of the 1997 law, including limits the Legislature placed on contributions from outside the state. In addition, the majority sent the case back to Federal District Court to consider how much political action committees (P.A.C.s) can spend if they are lobbying on issues but not giving to specific candidates.

Washington State Department of Natural Resources (*W.D.N.R.*) has decided to seasonally (November 1 to April 1) close the officially allowed Walker Valley Off-Highway Vehicle (O.H.V.) Area despite the continued efforts of the *A.M.A.* chartered *Skagit Motorcycle Club* and *Northwest Motorcycle Association* to rectify the alleged problems.

Walker Valley is an off-road vehicle trail system located on state land managed by the *W.D.N.R.* with approximately twenty-eight miles of designated off-highway vehicle trails on 6500 acres.

A Horry County, South Carolina police officer will not face reckless homicide charges in relation to a fatal car versus-motorcycle crash last spring. The crash happened in the early morning hours of May 18. Officer James Costello's unmarked police car collided with a motorcycle.

A Michigan man and a Georgia woman were riding on the motorcycle;

both died in the crash. Officer Costello suffered only minor injuries. A Highway Patrol accident report showed the motorcycle was traveling at more than 72 miles-per-hour at the time of the collision. Horry County Solicitor Greg Hebrée says there was no evidence that would support a reckless homicide charge against Costello. Highway Patrol officials are still considering traffic violations.

California's new state law should help ensure that off-highway motorcycle and All-Terrain Vehicle (A.T.V.) users have places to ride in California in the future.

The law, co-sponsored by Assembly Speaker pro tem Fred Keeley (D-Boulder Creek) and Assemblyman Mark Wyland (R-Del Mar), includes many of the suggestions of the Stakeholders Roundtable, a group put together by the state's Off-Highway Motor Vehicle Recreation Division. The group includes *A.M.A.* Government Relations Department staff as well as other off-highway vehicle enthusiasts, environmentalists, property owners, law enforcement personnel and others.

Among other things, the new law requires comprehensive planning to improve the chances of developing off-highway vehicle recreation areas, and calls for studies to understand the need for developing off-road sports complexes.

## **M.R.F. and A.M.A. Working Together on Motorcycling Issues**

The *Motorcycle Riders Foundation* (*M.R.F.*) held its annual national conference, the *Meeting of the Minds*, in Lansing, Michigan, from September 26-29, 2002. Just prior to this meeting, the *M.R.F.* was successful in having legislation introduced in Congress to counter the new proposed rules and standards to be imposed on street bikes by *Environmental Protection Agency* (*E.P.A.*). It had been reported that *American Motorcyclist Association* (*A.M.A.*) met with the bill

sponsor to voice objections to the bill. On Friday, September 27, 2002, the leadership of *M.R.F.* and *A.M.A.* met to discuss strategies regarding the *E.P.A.*'s proposed regulations for street motorcycles.

The *M.R.F.* and the *A.M.A.*, as major national leaders in motorcycling issues, are both committed to communicating clearly with each other and working side by side on all of the issues that face motorcyclists today, so this meeting was very important for the members of both organizations. The result of this meeting between the *M.R.F.* and the *A.M.A.* is that a better understanding now exists on how we can support each other, even though we may choose different approaches to a particular issue.

The *A.M.A.* indicated that it would not oppose the *M.R.F.*'s legislative efforts to meet this *E.P.A.* attack on motorcycling, the small volume motorcycle manufacturers and the extensive after market. The *A.M.A.* has chosen to pursue the regulatory side of the *E.P.A.* issues for its constituency, while the *M.R.F.* will pursue both regulatory and legislative avenues.

After meeting with the *A.M.A.*, *M.R.F.* President Buck Kittredge addressed the *Meeting of the Minds* attendees and reported that the *M.R.F.* and the *A.M.A.* have resolved to work together on all of the numerous issues facing motorcyclists today, including

## Bringing Justice To "Three Strikes" Guidelines

As I pass my fifth birthday inside these walls and wire, I want to once again thank *A.B.A.T.E. of Oregon* for its continued support. The *A.B.A.T.E.* newsletter has been a constant reminder of the freedom I've been denied.

The late Mrs. Patsy Mink, former Senator, authored a bill (House Resolution 529) to adjust the terribly long sentences imposed by Federal Sentencing Guidelines.

I'm finally able to see a glimmer of light at the end of the tunnel and would like to invite all those of you who can, in conscience, to contact your federal lawmakers and ask them to pick up sponsorship of Senator Patsy Mink's bill to revive federal parole for *all* federal prisoners instead of just those under what's referred to as "old law".

Currently we're required to serve 85% of our sentences before going on what is called "supervised release", which is like parole.

This bill, HR 5296, would allow the parole board to release those of us eligible for parole after serving 2/3 of our sentence.


Be thankful for what we have — help others to achieve a similar level of creature comfort and security.





# Just the Facts, Please

Statistics are like a bikini: "What they reveal is interesting, but what they conceal is vital."

And what the *National Highway Traffic Safety Administration* (N.H.T.S.A.) has been concealing in their crusade to promote helmet laws borders on fraud. In their efforts to sway public opinion in favor of mandatory helmet laws, N.H.T.S.A. and others have been quick to point out an increase in Florida's motorcycle fatalities in the year following a repeal of their lid law. What they fail to mention, however, is that a jump in motorcycle ownership has outpaced the fatality rate, and *A.B.A.T.E. of Florida* has compiled the actual numbers to refute the apparently flawed statistics being circulated by the federal agency.

"These figures represent the statistics for the first full year of our amended helmet law," explains James "Doc" Reichenbach, President and Lobbyist for *A.B.A.T.E. of Florida* and chairman of the board for the *National Coalition of Motorcyclists* (N.C.O.M.). "As you can see, the actual number of deaths were up 11%, however the motorcycle registrations were up 20.4%, which represents an increase of over 40,000 new motorcycles on the roads. After all the figures are compiled according to the *Florida Department of Highway Safety and Motor Vehicles*, the death rate was actually down by 5.2%."

Also, based on the 40,000 new motorcycles on the road this past year, *A.B.A.T.E.* made the following estimates of what this amended law

has brought into the economy of Florida:

40,000 new motorcycles at an average of \$10,000 each: \$400,000,000  
 Sales tax on motorcycles at 6%: \$24,000,000  
 Registration fee on motorcycles: \$1,444,000  
 Change of title: \$ 1,190,000  
 Total: \$ 426,634,000

"This total is almost one half a *billion* dollars in one year that was put into the economy of the state of Florida," says Doc. "Of this amount, over 25 million dollars went directly into the state treasury for the budget. This also does not include the tourist money that increased because of Florida being a freedom of choice state. In 2001 over 300,000,000 dollars was spent in Florida at Bike Week during a ten day period." The 2002 figures are not available yet, but participation was up from 2001.

"I hope these figures will help anyone who has heard the bad publicity that has come of our amended law," Doc summarized. "Deaths per mile ridden are down and the economy has gotten a huge boost."

## Wisconsin Supreme Court Rules Against Helmetless Riders

The Wisconsin Supreme Court has ruled that All-Terrain Vehicle (A.T.V.) riders injured in accidents may have damage awards reduced by up to 100% for failing to wear a helmet. On June 26, 2002, the court issued a decision in an A.T.V. accident case that allowed a reduction in damages from a head injury because the injured party was not wearing a helmet, reports *A.B.A.T.E. of Wisconsin*.

Although this was an A.T.V. case, the court also stated that, "Our conclusion here pertains to helmet use while operating or riding a motorized, non-enclosed, moderate-to-high-speed vehicle such as an A.T.V. or like vehicle."

"The leaders and Legislative Committee of *A.B.A.T.E.* are taking this threat very seriously and giving it a Level One priority," reports Dave Dwyer, Legislative Chair for *A.B.A.T.E. of Wisconsin*. "We have already been in contact with legislators to let them know what is going on and how we feel about it."

Wisconsin State Senator Dave Zien, long time biker and member of the *National Coalition of Motorcyclists* (N.C.O.M.) Legislative Task Force, is working with *A.B.A.T.E.* to determine if the decision can be applied to motorcycle riders who suffer a head injury while not wearing a helmet.

"We intend to be ready with a bill to introduce when the new legislature comes into session in January," said

Dwyer. "If for some reason this decision cannot be applied to motorcycles, I feel that we should go ahead with language to clarify how the courts should handle the "no helmet" defense."

Wisconsin has enacted legislation that allows damages to be reduced by 15% for anyone injured in a car accident who is not wearing a seat belt, in reaction to an earlier Wisconsin Supreme Court decision regarding seat belt use and injury damages award reductions. But the high court refused to transfer that over to the helmet use case, even though they used the seat belt use ruling as a guide in their recent decision.

The court stated, "that, ultimately, is a question for the legislature."

### West Virginia Bikers Ask Court: "What is a helmet?"

Trial was to be held this summer regarding motorcyclist Mark Fike's traffic citation for not wearing an approved helmet while operating his motorcycle on SR 119 in Spencer, West Virginia. Mr. Fike could have pled no contest and paid a relatively small fine to avoid the hassle of going to court.

However, West Virginia State Senator John Mitchell and *Aid to Injured Motorcyclists (A.I.M.)* Attorney Ralph Buss, anticipating an unfavorable ruling, took the case to trial in order to obtain a verdict for the purpose of arguing on appeal to the State Supreme Court the issue of what is an approved motorcycle helmet.

At issue is what are the specific parameters of what is and what is not a legal helmet in the state of West Virginia. Federal Vehicle Safety Standards and Regulations; Article 57, Section 218 that sets forth helmet design regulations was to have been introduced in its entirety in order that it become part of the record for use on appeal. Walter Snyder, Coordinator of the W. Virginia Motorcycle Safety Education Program, was scheduled to testify regarding the meaning of *Department of Transportation (D.O.T.)* compliance. He was also set to describe his committee of eight persons' interaction with the State Police on helmet related issues.

During the preparations for trial, it was learned that the C.E.O. of the State Police would be unable to provide testimony regarding valid helmet compliance for West Virginia. It was also learned that there are no courses available to the State Police to train them to recognize a compliant helmet. Currently, officers use the "eyeball and instinct method" to determine compliance.

As neither the arresting officer, Sergeant. D. U. Garrett nor his superior, Colonel Hill showed up for court on July 31, 2002, the magistrate permanently dismissed the case for "failure to prosecute". At the conclusion of the session, the prosecutor jokingly suggested that perhaps when the bikers come back, one of them might wear a "bucket of lard with a D.O.T. sticker affixed to it and see what happens."

President of *A.B.A.T.E. of West Virginia*, Duck, and *West Virginia Confederation of Clubs* Chairman Widomaker, along with the

numerous other motorcyclists in attendance, vowed that they will have another day in court.

The leadership of West Virginia's motorcyclists' rights organizations are at this time considering what forum to use for their next confrontation.

Three of the issues under consideration are:

1) Does West Virginia Statute 17C-15-44 adequately inform motorcyclists as to what is an approved helmet and/or what is a non-compliant device?

2) Is the statute so vague that most persons cannot come to a reasonable conclusion as to the definition of an approved helmet?

3) Is the State required to have an expert testify on its behalf when the approved/not approved helmet design issue is again presented to the court?  
Stay tuned.

### City Sends Safety Message

Darlene Kimsey, vice-president of the *High Point Chapter* of the *Concerned Bikers Association of North Carolina*, was sick of hearing about motorcycle accidents, so she approached the city council with an idea to make drivers more aware of riders on the road.

"The public needs to understand that with the rise of riding, we are out there," Kimsey told the Greensboro News and Record. "Riding isn't just a

recreational thing anymore, but a mode of transportation.”

After almost a year of lobbying the city, Kimsey says High Point will be the first city in the nation to put up signs reminding motorists to share the road with motorcycles.

About a year ago, Kimsey went to the

North Carolina Department of Transportation to see about getting some signs posted along roads along streets throughout the state reminding motorists to share the road with motorcycles.

When the state rejected the proposal, Kimsey went to the city of High Point.

Following a letter to the city council, and several meetings with the city manager and city transportation officials, Kimsey was able to identify four city streets where the signs were needed, based on a high volume of motorcycle accidents.

The city is expected to erect four signs on each street, and the transportation department will monitor accidents on the streets to see if the signs have an impact.

While state transportation officials haven't approved signs for state-owned streets, Kimsey says they will be watching the project in High Point. "If we can show that the signs have an impact on reducing the number of accidents, the state may consider the signs," Kimsey said. "I am hoping it's something that will catch on."

California Governor Vetoes Red Light Bill

California Assembly Bill 2521, introduced by Assembly Member Jay

LaSuer (R- County of San Diego), would have required all new and replacement traffic-actuated signal devices to recognize motorcycles and bicycles, as well as new lighter cars, but was vetoed by Governor Gray Davis.

The bill passed through the legislature without opposition in both the Senate and the Assembly, but was doomed to defeat when it reached the governor's desk on September 18.

"Now that is unconscionable!" exclaimed Nancy Nemecek, chairman of the board for A.B.A.T.E. of California. "If any motorcycle rider was on the fence about Davis, this should show his true colors," she said in reference to the upcoming gubernatorial election in the Golden State.

Weird News of the Month

Dangerous Intersections More Safe?! British traffic consultant Ben Hamilton-Bailie told the British Institution of Civil Engineers that improving road safety by making intersections more dangerous may actually decrease accidents.

The approach has already proved successful in Holland and Denmark, and relies on the idea that drivers will be more careful if they perceive more danger. Without road signs and road markings, they are forced to slow down and make eye contact with other road users to establish who makes the next move.

This has lead to many new intersections in Northern Europe



resembling the days before cars were commonplace, and it is said that it has reduced accidents without affecting journey times, but it does rely on vehicles traveling below 20mph.

## Millenium Ride

Hello Everyone

These are my last few hours in the U.S.A.

Tucson, Arizona, about 60 miles north of Nogales at the Mexican border, is really not the "one horse town", you may think. A lovely ambience, very friendly people and is the fastest growing community in the U.S.A. Cactus plants of all shapes and sizes replace the roses and pansies. It's a desert here, and Tucson is surrounded on all sides by mountains that turn red at sunset. I was last here in 1984 with my brother hitch hiking when we got a lift with a cocaine smuggler who was on his way back to Nicaragua to get some more!

### Bike

I've been fettling the bike a little more by mounting Metzeler tire number eight on the front, fitting a new speedometer and a replacement Scottoiler (the wonderful automatic chain lubrication system), and getting the rear wheel aligned properly.

My wheels were recently inspected and the front was rebuilt by the kind people at *Buchanan's* before I left Los Angeles last week. That was the same day I picked up a new drive chain donated by *Glendale Harley-Davidson*.

There are three small cracks in the rear wheel that I am not worried about since there was one in Australia and I have covered 50,000 miles and some very tough terrain since and only two more have appeared. I'll keep my eye on it.

*Goodridge* gave me all new brake and oil lines with fittings. *Progressive Suspension* very kindly replaced my rear shock absorbers too. The

damping had disappeared in the last set. No wonder the rear end was behaving like a pogo stick!

En route to Tucson last weekend I got my first punctured tire since Russia and am glad to say my compressor is still working.

### Fundraising

I spent much of the week at *Iron Horse Motorcycles* here in Tucson who gave me the run of the workshop. Marty signed this *B.M.W.* dealer up as a corporate sponsor too in between local TV and radio coming in and out to interview me. Some of the time I spent at Foothills Community Church modifying my powerpoint presentation so that it can be given by a third person. Kim Brown will very kindly offer the virtual world tour to audiences in Tucson over the coming months. I tell you what this is really absolutely super and very kind of her. If anyone else out there is competent and prepared to donate time and effort in doing likewise please let me know, since we are still looking for that further \$65,000 to run the *Flores Project* for the full term. I landed at Foothills through Lisa whom I met in Nepal two years ago.

I have put little effort into fundraising but still some very kind groups have donated including \$500 from *A.B.A.T.E. of Ohio*, \$500 from Richard Sorensen at *Inn Management*, and a further \$200 from the *Airheads* Ontario, Canada, *Top Cats* the motorcycle club in Chicago, and *Lake Chapter A.B.A.T.E.* in Minnesota.

I don't normally do this but I feel compelled to mention my big disappointment with the Japanese motorcycle producers/distributors in

the U.S.A.. I don't mind that none of them made a direct donation to the *Flores Project*, using motorcycles to save lives, even though it has been high profile here. It is the way I was treated. Despite a full year of trying to get through to them there was not even a "thanks, but no thanks". I only asked for the opportunity to show them what we are trying to do. I'm so glad the Motorcycle Industry Council was not so arrogant and introvertish.

### Other preparations

*Aerostitch*, the adventure motorcycle outfitters sent me a large packet of goodies. I bought some new jeans, deciding on 30" waist since I'll start to lose weight again now. Today I made photocopies of all the essential documents like passport, new vehicle ownership document (since my engine number changed with the new one), *carnet des passage*, the bike passport, and a host of others.

On the communications front I am sorry if you did not get the last update or if you haven't had one for a while. It's a long story. I won't bore you with it. I have decided to stick with the Psion and Motorola for Central/South America, though British Telecom are proving as difficult as ever to work with in getting my S.I.M. card replaced. So I'll be back to paying too much for sub standard service. I left my laptop with Dave Scoggins in Los Angeles and the digital projector has gone back to C.T.X. who will send it

on somewhere else for me in the future.

I flew up to the *Meeting of the Minds* at the end of September in Michigan state, the premier annual event for bikers rights activists organized by the *Motorcycle Riders Foundation*, and supported by both the *American Motorcyclist Association* and the *Federation of European Motorcyclists Associations (F.E.M.A.)*. It was a special weekend, seeing all my friends, making new ones, and meeting Antonio Perlot who is my successor as General Secretary of *F.E.M.A.* I was also able to further the cause of the *Flores Project* and *Motorcycle Outreach* which will hopefully lead us to that \$65,000 and further.

So, with the bike in top condition, paperwork organized, things mailed off everywhere, I am free to get back to my adventure.

Thanks again America.




