We also raise money for organizations that represent motorcyclist's concerns such as BikePAC.

• You don't have to ride a motorcycle to belong to *A.B.A.T.E.* 

Many of our members just enjoy being around motorcyclists. (We're just *that* wonderful.) And they feel that the social and legislative issues we're working with are important to their community.

# A Brief History of A.B.A.T.E.

"You have to know where you've been to know where you're going!"

Easyriders magazine editor Lou Kimzey issued a plea in issue #3, October 1971, for bikers to come together to fight impending restrictions from the National Highway Transportation Safety Administration (N.H.T.S.A.) by joining a new national biker's rights organization called the National Custom Cycle Association. But because of a conflict with the acronym the name was changed in February 1972 to A Brotherhood Against Totalitarian Enactments (A.B.A.T.E.).

Easyriders began granting state charters around 1974, and Keith Ball was the original national coordinator. The biggest threat was that the U.S. D.O.T. (Department of Transportation) was investigating ways to restrict modified or customized "choppers" which they deemed unsafe, especially extended forks.

As the rights movement grew, Don Pittsley, a member of the *Huns Motorcycle Club* in Connecticut convinced his congressman, representative Stewart Mckinney, to introduce H.R.3869 to end the federal authority to withhold highway funds from states without helmet laws.

In July of 1975, Rob Rasor of the *American Motorcyclist Association (A.M.A.)*, Ron Roloff of the *M.M.A.* of California and Ed Armstrong of *A.B.A. T.E. of Chicago* presented the house sub-committee on surface transportation with convincing testimony to repeal the helmet mandates.

Later that year, with California being sued by the *D.O.T.* because governor Ronald Reagan refused to comply with the federal helmet law mandate, Roloff helped convince California senator Alan Cranston to offer the language of the bill as an amendment to the *1975 Federal Highway Act*, which passed with overwhelming support from the California delegation because of the impending lawsuit, and was signed by president Gerald Ford on May 5, 1976.

Not bad for a rag tag bunch of bikers with little or no previous political ambitions.

As a result of our newfound political clout, motorcyclists have successfully approached congress twice over the past few years, first to grant federal protections against insurance discrimination based on mode of transportation because many companies were denying medical benefits to employees injured in motorcycle accidents.

Then, [in the 1998] session, motorcyclists united to put together a pro-active agenda for bikers, and succeeded in lobbying it through congress.

So, there you have it.

The roots of *A.B.A.T.E.* and biker's rights run deep in the hearts of those of us who have accepted and, in turn, passed on the torch of freedom of the road.

At 10:50 a.m. CST, August 10, 2005 A.B.A.T.E. of Oregon won its greatest victory ever when president Bush signed T.E.A.-21-L. U. into law. Included in this \$286.4 billion transportation bill are \$25 million to fund all elements of the Motorcycle Safety Initiative, as well as an additional \$3 million for a study of motorcycle crashes. You will recall that the Motorcycle Safety Initiative's first official acceptance was by congressman Peter DeFazio who agreed to become lead sponsor of this initiative on March 23, 2002 at the request of A.B.A.T.E. of Oregon and the M.R.F. The three years that have passed since that historic moment we shared with congressman DeFazio in his Washington office have demanded constant effort by the entire motorcycle rights community throughout the nation to insure its passage. You were a part of that effort and you have made history. Nothing like this has ever been accomplished before. Congratulations and thank you!

I've enjoyed something of a vacation since trojan viruses totaled my computer's hard drive early in June. Being unable to send or receive messages left me with all this time on my hands. What to do?

### Ride!

During this time I put 5,600 miles on the *Harley* deuce which included a trip to Boise for the *Best of the West* and 2,700 on the *Hayabusa* including a trip to, and a lap around, *Laguna Seca Raceway* in Monterey. I think I

must have been due for a little two-wheel therapy because suddenly everything, including my involvement with *A.B.A.T.E.* seems exciting and important. ### **Douglas County Chaptarrr**

Shuffle up and deal . . . finally!!

After months of navigating the fine print of federal, state and local laws and rules, our chapter is ready to kick off a casino night fundraiser on September 24. Our persistence to expand this event by adding multiple *Texas Hold'em* tournaments ran into countless regulatory hurdles. The ultimate solution was to acquire a gaming permit for charitable organizations from the Oregon *Department of Justice*. Despite a few quirky adjustments to our original plan, *D.O.J.* gave our chapter a nod to proceed.

Quirky adjustments? Apparently *D.O.J.* never heard of 4-5-6, an abbreviated version of craps (dice), which, I'm told, is less complicated to learn, bet, and manage. So 4-5-6 is out and craps is probably back in. Also, they had concerns that our poster font was larger for the *Elks Lodge* than for the *A.B.A. T.E.* chapter name. A fairly simple fix. One of the biggest concerns was doing *Texas Hold'em* tournaments. The solution was a timely piece of new legislation signed by the governor, which allows *Hold'em* as a "Monte Carlo" game.

The next hurdle was doing a cash payout on the tournaments, a standard requirement in home games and other similar events. However, since this is a fund-raiser, no cash can be paid out. The solution: pre-paid debit cards as prizes to the winners. The down-side is that winning players have to wait for cards to be sent out on Monday after the event. The up-side is that this structure allows the host organization (*A.B.A. T.E.*) to provide prizes (debit



cards) at value amounts of our choosing. Essentially, we can take a rake, which in our case will range from 25 to 30 percent. For some folks, all this may sound way too technical. But in the realm of fundraising, this casino night structure holds great potential to be an effective model for our organization.

In anticipation of attracting more of the general public, this event will now be held at the Elks Lodge in downtown Roseburg. Their facility not only offers more floor space for gaming activities, but also will provide a full bar and menu. The ten dollar admittance at the door buys an entry ticket to the 50/50 drawing, a door prize ticket, a discount coupon toward a tournament entry, and \$100 worth of chips for play on the floor games (roulette, blackjack, craps, poker). An additional \$100 worth of chips can be purchased for \$2 throughout the night. At the end of the evening, these chips will all be redeemed for coupons that will be



- Cell phones are critical for keeping in contact incase of emergencies.
- If the situation arises where a bike is unable to continue, the group should reorganize.
- · Decide who stays with the disabled bike.
  - Choose a new ride leader if necessary.
- Reestablish the route so everyone knows where fuel and rest stops will be

Mel read an e-mail that was sent to Iris from Stan Porter of O.D.O.T. taken from

"Here all this time we thought that the manufactures really cared that riders got trained. Whether we're cynical or naive, we tend to believe the obvious: trained riders live to buy again. So whether we attribute it to enlightened self-interest or a genuine concern for the rider, we believe that manufactures really care about 'rider education.' But it's the little things that reveal that they don't so much care that riders are 'trained.' They do care a lot about who they're trained by. And that's the M\$F only.

So, in the past couple of weeks, I've found out that the two largest market share holders, Honda and Harley-Davidson, are so bent on maintaining M.S.F.'s monopoly that they're taking it out on the customer. For years, Honda has been giving a rebate to customers who purchase a Honda motorcycle and take a basic training course. Currently, it's \$75. In some states, that's enough to pay for the course entirely. In others, where training is free, it's a nice little perk.

But Honda won't give the rebate unless it's an M.S.F.-certified course. It doesn't matter if the state recognizes the training. It only matters if M.S.F. does it. It doesn't even matter if it's M.S.F.'s own training if it ain't the current model.

Too bad for Oregon, Idaho and Hawaii riders. Not to be outdone, Harley-Davidson is also bent on punishing the riders: You can't enter the brand new Harley-Davidson Saddle Up for Sturgis Œ06 unless you went through an M.S.F. certified course, which includes, of course, Rider's Edge.

Too bad for Oregon, Idaho and Hawaii customers.

(Ladies, in that case, I suggest you try the Suzuki Boulevard.)

So it certainly appears that the manufacturers aren't primarily concerned with the riders getting trained. Clearly, with B.R.C., they aren't concerned with riders getting well-trained. They just want them to go through the M.S.F. curriculum. Which means, of course, Canadian riders couldn't enter Harley-Davidson's contest. The rules don't say. But who cares about us Canucks anyhow? (I am, if you did not know, Canadian by birth, first-generation naturalized American citizen.)

But let's say Canadians can-because M.S.F. certifies the C.S.C. curriculum (which is a damn good one, btw.) So it's just American consumers who are penalized. It simply cannot be some pathetic attempt to pressure the recalcitrant states into conforming. That would be ridiculous. It does, however, impact riders negatively.

Change your ways, Honda and Harley-Davidson. Don't take it out on the customers."



### American Motorcyclist Association

The American Motorcyclist Association (A.M.A.) is monitoring a fatal crash in Pennsylvania, which injured several participants in the Chris Jones Benefit Bike Run and killed one rider. A Pennsylvania man crossed the center line and crashed into a charity ride that was being escorted by police, according to authorities.

The fatal crash occurred on Route 309 near Drums, Pennsylvania. William Delaney, 41, of Plymouth, Pennsylvania was killed, and his wife was hospitalized in critical condition. Other riders were injured. A report in the *Wilkes-Barre Times Leader* said Jeffrey M. Borrin, 23, the driver of the S.U.V., was driving with a suspended license and was awaiting sentencing on a previous drunk driving charge.

A new federal report on off-highway vehicle (O.H.V.) recreation in the United States shows popularity of motorized recreation among diverse ethnic communities. The study, published by the *U.S.D.A. Forest Service*'s southern research station, shows O.H.V. use is widely recognized now as one of the fastest growing outdoor activities.

The report was prepared for the Forest Service in relation to a national O.H.V. policy initiative expected to be finalized in August 2005. The policy will direct forests to designate roads, trails and areas available for O.H.V. use. The source of the data is the National Survey on Recreation and Environment (N.S.R.E.). N.S.R.E. is a collaborative project between the Forest Service, National Oceanic and

Atmospheric Administration, the University of Georgia, and the University of Tennessee.

The study showed the proportion of people age 16 and older who said they participated in O.H.V. recreation increased from 16.8 percent in 1999-2000 to 23.8 percent in 2003-2004. It also shows that hispanic participation grew at the fastest percentage rate, more than doubling between 1999 and 2004. The African-American participation growth rate also outpaced that of whites, growing 50 percent compared to 36 percent for whites. The report can be found at:

The U.S. Environmental Protection Agency (E.P.A.) has adopted the World Motorcycle Test Cycle (W.M.T.C.) as a G.T.R. (Global Technical Regulation), subject to approval by the signatories of the United Nations Global Harmonization agreement.

The American Motorcyclist Association (A.M.A.) notes that the G.T.R. proposes the test procedure without limits. In other words, it proposes to standardize the test procedure, but does not impact the emission limits set by each country. As the A.M.A. understands it, if adopted as written, the E.P.A. would be required to restate current HC, NOx, and CO tail pipe emissions limits in terms of the new test procedure, but not change the limits themselves. The E.P.A. will initiate a

rule making process next year for U.S. approval and the *A.M.A.* will be watching for any changes.

Texas has become the 19th state in the nation to have an off-highway vehicle program to create and maintain riding areas and trails. That's thanks to the hard work of *A.M.A.* community council leader Carol Smith, the *Motorcycle Industry Council* and others.

The new program, which takes effect September 1, will use money from a fee for O.H.V. decals, and fines assessed against O.H.V. users who violate O.H.V. laws, to acquire, construct, develop and maintain riding areas and trails.

Smith, director of the A.M.A. community council-Texas Hill Country, joined forces with A.M.A. government relations department staff in Pickerington, Ohio, and the *Motorcycle Industry Council* to make the program a reality.

A.M.A. legislative affairs specialist Royce Wood said Richard Hardy, the local lobbyist for the *Motorcycle Industry Council*, did a good job guiding the legislation through the Texas legislature. Smith was instrumental in testifying and letting lawmakers know how important an O.H.V. program is not only for O.H.V. enthusiasts, but for the Texas economy.

If you would like to work on trails issues in your state, the easiest way is through an *A.M.A.* community council, which is a group of local A.M.A. activists. For information on

Australian motorcycle operator permits should be given only to people who are already licensed to drive a car, according to a new study that recommends a radical overhaul of motorcycle licensing laws.

The study, by researchers at *Monash University*'s accident research centre, finds that regulations for motorcyclists are inconsistent across Australia and do not meet the highest international standards. It also recommends that motorcycle licenses should be regarded as separate and higher-class qualifications than car licenses, and that they be made more expensive to obtain.

The recommendations were greeted angrily by the *Australian Motorcycle Riders Association (M.R.A.)* labeling the proposals as a joke.

The study looked at motorcycle licensing and testing systems across Australia and compared them with best-practice systems overseas. It found that motorcycle riding required a far higher level of skill than driving a car, and that the risk of crashing was much higher for learner riders than for those learning to drive a car.

The report also recommends that engine size restrictions, now in place in Victoria, should be replaced with power-to-weight ratio restrictions.

But the *M.R.A.* said that skills and road rules testing should be made more comprehensive in order to tackle the crash rate for learner riders. The study recommends that governments ban novice riders from carrying passengers and insist on a zero blood alcohol limit for motorcycle novices, both measures that have already been introduced in Victoria but not in other states. (*The Age*)

British motorists are being urged to look out for motorcyclists as part of a new road safety campaign to reduce the number of motorcycle casualties on South Gloucestershire's roads.

Temporary road signs displaying the campaign web address http://www.smidsy.co.uk/ and other messages will be going up at motorcycle accident hotspots to remind drivers to look out for motorcyclists.

The planning, transportation and strategic environment commission claims that "Too many motorcyclists are being injured in road accidents in South Gloucestershire – and our statistics show that a significant number are happening because drivers are failing to see motorcyclists – particularly at intersections. This kind of [crash] is known as a 'S.M.I.D.S.Y.' accident – which stands for 'Sorry Mate, I Didn't See You!', and the campaign is trying to target these [crashes] in particular."

The campaign encourages drivers to log onto a web site to find out more information about motorcycling

accidents and also gained the approval of the *British Motorcycling Federation*. (*B.M.F.*)

The Bureau of Land Management (B.L.M.) has placed a notice of seasonal closure of public lands at the serpentine area of Critical Environmental Concern (A.C.E.C.), located in the southern portion of San Benito county and western Fresno county, California, to all types of motorized and non-motorized recreation use.

The restrictions are scheduled through October 15, 2005. This seasonal closure is needed to ensure visitor safety and protect public land users from potential health risks associated with naturally occurring asbestos found within the closure area. The *B.L.M.* may also implement a visitor use permit system to control public access during the period October 16-June 1. A permit system will provide an opportunity to educate the public on the risks related to recreation use in areas of naturally occurring asbestos.

# No Motorcycles Travel In South Dakota?

Washington, D.C. - As most everyone in the motorcycling community knows, the state of South Dakota is currently hosting the largest motorcycle rally in the country in Sturgis. Ironically, the Motorcycle Riders Foundation (M.R.F.) has learned the state of South Dakota has reported zero vehicle miles traveled (V.M.T.) for motorcycles in its annual reports to the Federal Highway Administration (F.H. W.A.) each year since 1997. In fact, according to information provided to the M.R.F. by the National Highway Traffic Safety Administration (N.H.T.S.A.), there was absolutely no motorcycle V.M.T. reported not only for South Dakota, but also for Illinois, Massachusetts, Missouri, Nevada, Pennsylvania or Texas from 1997-2003.

Additionally, the following states have reported zero motorcycle V.M.T. during one or more of the years from 1997-2003: Arkansas, Colorado, Georgia, Indiana, Maryland, Minnesota, New York, North Carolina, Ohio, Oklahoma, Utah, Virginia and West Virginia.

*N.H.T.S.A.* releases a report each year regarding motor vehicle traffic crash fatalities and injuries based on the *Fatality Analysis Reporting System* 



(*FA.R.S.*). Yet, with anywhere from 13 to 31% of the states each year reporting absolutely no motorcycle V.M.T., this highly-publicized government report uses taxpayer dollars to compare the number of fatalities for various types of vehicles to V.M.T. in order to determine trends and publish their findings as facts.

The M.R.F. expressed serious concerns in April, 2005 regarding the preliminary 2004 F.A.R.S. data released by N.H.T.S.A., citing a decline in vehicle miles traveled (V.M.T.) during the same period when motorcycle registrations increased substantially. Based on those concerns, the M.R.F. wrote a letter to N.H.T.S.A. questioning the validity of the data upon which these statistics were gathered and reported. N.H. T.S.A.'s response to the M.R.F. states V.M.T. data is actually collected by the F.H.W.A. and that, "N.H.T.S.A. believes the V.M.T. data collected by F.H. W.A. are the best data available. For the 1997 to 2003 period similar methods were in place to report the . . . data . . . Because of this, we believe these numbers are adequate for monitoring trends." (Both letters can be viewed at http:/ /www.mrf.org/nhtsa.php ).

The *M.R.F.* translates *N.H.T.S.A.*'s response as follows: Both the *F.H.W.A.* and *N.H.T.S.A.* know the V.M.T. data is inaccurate, but since it is collected in what they consider to be a consistent manner, the

inaccuracies are acceptable. The *M.R.F.* believes that simple rules of statistical research dictate a 13-31% variance is not a consistent manner that is acceptable for monitoring trends, and the *M.R.F.* will be investigating the *F.A.R.S.* data for further inaccuracies in the weeks to come.

"One motorcycle fatality is too many, and the *M.R.F.* remains concerned about any rise in the numbers," stated Karen Bolin, *M.R.F.* president. "The *M.R.F.* is committed to working with *N.H.T.S.A.* and the *F.H.W.A.* to take appropriate measures to reduce the number of motorcycle fatalities in this country. However,

the *M.R.F.* feels that the federal government has an obligation to report all vehicle fatality statistics in an accurate and responsible manner, and will continue to strive toward the release of more reliable information to the general public with regard to motorcycles."

# Highway Bill Finally Enacted: Motorcyclists' Concerns Addressed

Following ten deadline extensions dating back to September 2003, the 109th congress voted on July 29th to enact HR 3, the sweeping \$286.4 billion highway bill that reauthorizes federal transportation spending through September 2009, and president Bush signed the measure into public law on August 10th.

The final version of the massive 1,681-page document contains numerous motorcycle provisions lobbied for over the past several years by national, state and local motorcycle rights organizations and concerned individual riders.

In addition to providing muchneeded federal funding to rejuvenate our nation's crumbling infrastructure, the bill also makes available \$25 million in grant money for motorcycle safety training and awareness programs to individual states. The bill also provides for the formation of a motorcyclists advisory council to advise the federal highway administrator regarding how motorcycles must be included when designing future intelligent transportation systems.

HR 3 also includes nearly \$3 million for a new scientific study of motorcycle crashes to be conducted by the *Oklahoma Transportation Center*, located at *Oklahoma State University*. This marks the first comprehensive research into motorcycle crashes since the *Hurt Report* was completed in the late

1970s.

The reauthorization measure also stipulates that motorcycles will continue to be allowed to use high-occupancy vehicle (H.O.V.) lanes, and continues to prohibit local governments from excluding motorcycles on roads maintained with federal funding.

Lastly, for off-road riders, the legislation earmarks \$370 million from gasoline taxes to fund the *Recreational Trails Program*.

### Once Rivals, Bike Clubs Now Working Together

Once-notorious outlaw-biker rivals, the *Pagans* and *Warlocks* are working together to raise funds to fight discrimination, fresh from helping to repeal laws regarding motorcycle helmets and high handlebars, reports the *Philadelphia Daily News*.

What's more, these clubs have joined with non-outlaw bikers to fight against discrimination and police harassment in a political and legal forum, and threw their first annual *Summer Sizzler*, a biker family picnic, on August 21st, at the Nevlin Grist Mill park, in Glen Mills, Delaware County.

This was the first major fund-raiser for the *Confederation of Clubs* of eastern Pennsylvania, founded in April 1999. The confederation represents more than 1,000 members,





with an average age of 42, from 23 clubs. Members include *1 Percenters*, *Bikers Against Child Abuse*, Christian bikers, and *Clean and Sober* bikers.

It's one of 55 confederations in North America, the fastest-growing part of the national bikers- rights movement, with annual national conventions and a web site: http://www.aimncom.com/coc/

The confederations' aim is to stop police harassment of bikers and civilrights discrimination in housing, bars, and other areas, and to solve mutual problems, not settle scores among clubs, according to its local president, a *Warlock*.

"We're all bikers," said Kenny Plank, of *Longriders*, in Chester County. "There's no reason to be fighting each other."

Not all bikers in the local confederation are outlaws and not all outlaw bikers are gangsters. They are nurses, firemen, company owners, salesmen, judges and lawyers.

As confederation treasurer, "Patches" said his job was to "make sure all the committees are doing the right thing." That is, keeping within a \$5,000 party budget. After paying for expenses, said Patches, a member of the *Messengers Motorcycle Club*, known as a "clean and sober" club, "We'll have the legal means to protect ourselves."

"We're serious about bikers rights," he said. The confederation is "neutral ground."

At regular meetings at which two representatives per club have one vote, Norristown attorney Boyd Spencer regularly updates them about state and federal legislation, including the *U.S.A.P.A. T.R.I.O. T. Act*. Spencer said the law "targets three or more people with a common handshake, common purpose and common attire."

Spencer is a member of the national network of biker-rights lawyers in *Aid to Injured Motorcyclists*, or *A.I.M.*, founded in 1982 by California attorney Richard M. Lester, who started the national confederation and similar groups.

On legislative issues, the local confederation supports the Alliance of Bikers Aimed Toward Education (A.B.A. T.E.) of Pennsylvania, the main biker lobby; and Pennsylvania Coalition of Motorcyclists (P.C.O.M.), which monitors legislation.

The confederation supported member Warlocks and the Bikers Against Child Abuse (B.A.C.A.), both of whom sued police for allegedly harassing bikers in separate Toys for Tots Runs in Philadelphia and Delaware County in 2002. The Warlocks obtained a consent decree from the Philly cops and B.A.C.A., an out-of-court settlement from Darby Borough.

"Everybody is getting along together as a group and becoming more political," said "Rabbit," of *Men of Honor*. "It's good to see as many [clubs] agree on one thing."

At their latest confederation meeting, held in the middle of the summer when most organizations don't meet, the confederation drew more than 40 members.

Amid the banter, the president introduced "Q" as a nurse and a minister: "He can bury ya and marry ya."

For \$200, which would go to the confederation, he added, bikers could get married or renew their vows at the *Summer Sizzler*.

"Boyd will do the divorce," joked the president, referring to *A.I.M.* lawyer Boyd Spencer.

Later, Q identified himself as Steve Stoyke, 54, a member of *Association of Recovering Motorcyclists*, or *A.R.M.*, who rode five hours on his *Harley* from Frederick, Maryland to support the confederation. "To do a wedding, we line bikes up on either side," said Stoyke. "You can do a traditional wedding, or we can read from the *Harley* repair manual."

The minister asks the groom: "Do you promise to keep her cables greased and tires balanced?"

And he asks the bride: "Do you promise to keep his gas filter cleared, change his oil, and bring him in for maintenance?"

"This is America's last subculture," added Stoyke. "That's what keeps our country great."

### Weird News: Harley Helps Blind To See

A student at Penn State Behrend College in Erie, Pennsylvania has developed a process that may help the blind to "see" digital photographs. Using a process developed by *Harley-Davidson* called "rapid prototyping," 27-year old Jason Donnell hopes to produce 3-D images that a blind person could run their fingers across and "feel" the image, in much the same manner as Braille is used to read.

"With a *Word* document, you output to a printer," explains Donnell. "With rapid prototyping, the output is to a machine that uses a special type of paper, wax or plastic.

So, for example, if *Harley-Davidson* has something they want to include on a bike, but is not too sure about, they can input the information and it will produce an exact size copy of the item."

After a lot of hours writing and rewriting, Donnell has his program, but the results so far have been mixed. Because of the short time frame of the college project, he was only able to produce and test three examples.

"The test on a simple picture of a playing card were pretty good," Donnell told the *Valley News Dispatch*, "but the pictures of a tree and a ghost town were very tough and showed the need for more work."

N.C.O.M. conference details: Just call the *Sheraton*, or check their web site to register online. Among the issues on the agenda is the new proposed federal anti-gang act, along

with the *U.S.A.P.A.T.R.I.O.T.* act, and the possible effects on bikers. Don't miss it – free, on October 22.

### **Newsbits-N-Pieces**

New York, New York - The S.E.C. starts inquiry into Harley-Davidson according to the Associated Press. Allegedly, Harley announced they intended to limit short-term production and decrease planned motorcycle shipments. On April 13, Harley-Davidson said it would increase motorcycle shipments from last year's 317,000 units to a target of 329,000 units, below original plans of 339,000 units. The company also lowered earnings forecasts for the year, citing weak first-quarter sales and a glut of 2005 bikes on dealer floors. In response, Harley shares plunged to their lowest price in more than 14 months. The securities commission started inquiries because of complaints from shareholders. Harley said it is cooperating with the S.E.C., and noted that in light of the pending shareholder litigation, it wasn't surprised by the inquiry. What next, folks?

Wellington, New Zealand – A Kiwi set the world side-hack speed record. New Zealander Glenn Hayward, driving a 1,000 c.c. machine dubbed the Flying Kiwi, shattered the 19-year-old world speed record for motorcycle and sidecar on a straight stretch of highway on New Zealand's south island. Riding with a 60 kilogram (132-pound) weight in the sidecar,



Hayward reached a two-run average of 272 kph (170 mph), eclipsing the previous record of 222 kph (139 mph). A representative of the *International Motorcycling Federation* observed the record attempt, making it official. Y'wouldn't find me at half that speed with a sidecar! Riding those things takes some special talent!

Washington, D.C. – Our unhappy dealings with Dr. Jeffrey Runge from N.H. T.S.A. is ending with his departure from that agency to become chief medical officer for the Department of Homeland Security. Hopefully, his replacement at N.H. T.S.A. will have a more open mind when it comes to the welfare of bikers on the highways. Runge has been a headache for motorcyclists for the past four years.

Tacoma, Washington - Thurston county residents who have to raise their voices to be heard over the noise of a neighbor's dirt bike or motorcycle now have recourse. A county ordinance makes motorized vehicle noise illegal when it reaches 55 decibels on a neighbor's property about the same level as a conversation. The ordinance covers all noise not just O.R.V. (dirt bikes). The boom boxes in cars and carried on teen shoulders are part of it. Now that we can live without, but just the vehicle's own noise is a little different. Folks, have some kindness on your throttle and we can avoid more laws like this one!

Gas Prices At New Record - This

isn't really news, but the national averages have gone crazy and here in Oregon it's higher yet. Most of us save big time on fuel when we're on our scoots, but it stings worse and worse.

The real problem in my mind is the impact fuel costs have on the prices we pay for consumer goods. It's way past time for us all to be writing letters and sending e-mails to our elected officials in the federal government. The people can stop this if we get mad enough to scream at congress. The high cost of living is raising hell with us all, especially those on fixed incomes. Lets all get busy and write a letter or two.

Diesel Bike - There has been research for years on diesel aircraft engines. Why not diesel engines for motorcycles? Seems like a no brainer to me. Motorcycles have been evolving for nearly a century. There is even electric technology. Think about it, you would never have fouled plugs and you could still have those loud pipes some folks like so much, plus the advantage of even better fuel economy. Diesel fumes stink a little but what the hey! People will know we were there because their noses know! Emissions are lower than gas engines, too.

*Medical Malpractice* – There is a big fight brewing here in the Pacific Northwest, in Washington, over a ballot measure designed to limit your access to the courts there! To combat lawsuits by those patients injured by medical

The people who support this fund: Hospitals \$1.8 million, pharmaceuticals \$100,000, insurance industry \$830,000, medical l professionals and practices \$1.7 million, Washington medical association. \$733,000. And this just in Washington state.

We need to protect patients who are injured by the handful of bad doctors everywhere who cause most of the malpractice. We need also to protect our many good doctors from price gouging by the insurance industry.

Write your congressman and scream bloody murder wherever you are. remember to tell them that tort deform is bad for everyone! This stuff is nasty.

Stateline, Idaho - Remember the recent kidnaping of Shasta Groeneg and the murder of her family? Bet you didn't see it on TV, but bikers played a big role. More than 500 Harley-Davidsons and other motorcycles came to empty their pockets on behalf of the biker's daughter who survived the horrific abduction, The six hour benefit drew more than a 1,000 people who donated cash at the front door of Cruiser's Bar and Grill, a biker hangout in this town just east of the Washington state line. Total receipts were not announced. "You say 'bikers' and people think of gangs, but these people are the best people in the world," Groene said. "These people

step up for anything and everything." And you and I know it, don't we?
