#### NOTES FROM THE APRIL BOARD MEETING

There was a lot (as in "whole bunch") of discussion about the status of Jacob Morgan (Preacher) as State Coordinator. Preacher has resigned his position as CHAPTER Coordinator, not State Coordinator, as the rumor had it. Washington County Chapter is to present more detail on the events surrounding Preacher's resignation at the May Board meeting on Saturday the 11th.

Louise reported on our finances - we are doing okay, and the tax returns have been filed with us NOT owing any. Your State reps should have a hand-out from the meeting that breaks things down in a readable manner. A motion was passed giving Louise a vote of confidence for a job well done. Just a reminder - if you haven't got your chapter treasury report in for the third quarter (JAN. - MAR), you're a month overdue! It should've been turned in at the April State meeting.

A motion was passed to re-call the Newsletter Editor; Carolyn Meerzo was elected to the post of Interim-Newsletter Editor - she thinks she'll be able to enlist the aid of the former Editor, Gary Thompson, in the battle against ignorance of ABATE happenings, but had not heard back from him as of this meeting, and so would not commit him to helping out. It was decided to send a letter of gratitude to Griz and to allow him to retain his life membership in ABATE of Oregon. (See more about Life Memberships as "perks" elsewhere in this issue).

Dr. Dave asked that all chapter Legislative Directors call him Thursday evenings between 8 and 10 pm @256-5714, so the chapters can be kept up to date on happenings in Salem. A motion was passed to allow the purchase of a telephone answering 'droid for our Lobbiest's use - that's Butch and his number is 363-6106.

ABATE will purchase a computer - a motion passed to that effect, with the funds to come from the disaster fund and the chapters' \$50 ambulance funds. (See "The Eagle Has Landed" elsewhere in this issue.)

Teresa has applied for the \$1000 grant from the AMA for the Better Biking Program - no response as yet. There are BBP classes set for May, June, July and September. There'll be a BBP class in LaGrand on the 13th of July.

Two motions were passed that will eliminate "perks" in the future — one eliminates the practice of awarding life memberships to members for tasks performed; the other will stop the practice of awarding free admission to State Runs.

A reminder - ALL CHAPTER REPS MUST BE ELECTED BEFORE THE JUNE STATE BOARD MEETING!! STATE OFFICERS ARE NOMINATED FROM THE CHAPTER REPS, SO IF YOU WANT A CHANCE TO BE A STATE OFFICER, YOU FIRST MUST BE ELECTED TO REPRESENT YOUR CHAPTER AT THE STATE LEVEL. STAND UP AND SERVE!!

#### --> AN OPEN LETTER ABOUT FREE LIFE MEMBERSHIPS <--

At the April 13th State Board meeting, we returned the life memberships that were given to us by the Board after we had each completed a term as State Coordinators for ABATE of Oregon, Inc. We did this only after a lot of thought and after talking to other members of our chapter about it. Our reasons are partly personal & partly due to the finances and structure of ABATE.

PERSONAL REASONS: We joined ABATE to help us maintain our way of life & right to ride, and have an influence on the laws and conditions that affect us. We think that all members of ABATE share similar goals. We feel the dues are reasonable and serve an important purpose. It's good to let people know that they have done a good job. A free life membership tells them that, but only once. We would rather have a different, more constructive reward; someone to come and say, "You did such a good job it inspires me to do my best."

ORGANIZATIONAL REASONS: Offering financial rewards is a bribe of sorts, and can distract us from the real purpose of becoming an officer, which is to do a job. Giving certain officers a free life membership began as a way to reward them for personal sacrifice and dedication. A lot of other people have put in just as much time and work for ABATE as those who have been awarded life memberships; they have not been given the same recognition. In effect, we have divided our membership into two classes — those with special priviledges, and everyone else. Once we start, where can we stop?

Giving up our own life memberships was a personal decision that we feel good about, but we are not demanding the same action from anyone else. However, the giving away of free life memberships has grown beyond the original intent, and would continue to grow if we didn't change the habit. It already has a financial impact we can't afford, through loss of income from membership fees and State Run tickets; this loss would become greater over time as we gave away more life memberships. Besides, we already have enough hassle keeping things together, without setting more rules about who does or does not "deserve" this reward, or causing more resentment about the decisions.

For these reasons, we presented a proposal to the State Board, which was accepted by an overwhelming majority - to eliminate the practice of giving away life memberships, and also to stop giving away any free State Run (Fossil) tickets to ABATE members in exchange for any services, effective July 1; 1985.

In case the title above aim't clear, what we're covering here are the meetings held in January. February, and March. Somehow or other, I intend to distill twelve pages of typewritten boredom into roughly one page of something that's understandable and readable. I'll start with my resignation as Newsletter Editor in January. Doug Porter was appointed to fill the post; after three months without a newsletter, Doug was recalled; Carolyn Meerzo was elected as interim Newsletter Editor. I have agreed to help out until general elections are held in June. By helping out, I mean doing the majority of the work so Carolyn can concentrate on getting the membership records straightened out and up to date.

Teresa Hepker resigned her post of Legislative Director in January, so she could devote all her energies to the Better Biking Program. Dr. Dave was elected to the position later in the meeting. Please see the front page for Dr. Dave's phone # and times to call. In March, ABATE of Oregon set up a fund of \$1500 for the BBP; we also applied for a thousand dollar grant from the AMA (see April report).

It was decided in January to sell the ambulance, inasmuch as insurance for the vehicle, even on a stand-by basis, would be prohibitively expensive. A motion was passed to dissolve the ambulance program with Dr. Dave to be placed in charge - in March he presented a check of \$1200 to the Board. It was decided during the meeting to use the money to help purchase a computer, after study by a committee. (See "The Eagle Has Landed")

In February, Al Cole resigned as State Membership Secretary, citing poor health as a major factor in his decision. Al has served us ably for many moons, and his active perticipation will be missed. Carolyn Meerzo was elected to the post at the March meeting, and is in the process of transfering all the records over to our new computer.

#### -=> SYNOPSIS CONTINUED (=-

Taxes were a topic of discussion at the March meeting - Louise spoke on the subject, and told us that ABATE of Oregon is established under an Identification Number - each chapter that has a checking and/or savings account should be using that number. If you are using somebody's Social Security Number, the bank will have sent a form to the I.R.S. stating that THAT person had (your balance on Jan. 31st), and was subject to tax liability on any interest shown as paid to the account. Is that all clear? If you have ANY questions about your chapter's finances, or you need to know the I.D. number, please contact Louise in Bend so she can help you out. As the organization continues to grow, proper handling of our financial matters becomes increasingly important. We got no room for error, folks - it's gotta be perfect every time!

The 1985 Run Calendar was announced at the February meeting. Rather than list all the events here, I'd like to direct your attention to the page that appears elsewhere in this newsletter — it gives a listing of all the run dates, locations, and also, the dates and locations of the summer State Board meetings. This year, each month's State Board meeting (from June thru September) will be held at the location of whichever Run is occurring on that particular week-end. The on-the-road meetings will be in The Dalles, Newport, Salem, and Douglas County. Plan to attend at least one of them. Also remember, those of you elected as your Chapters' officers for the year MUST make at LEAST one Board Meeting within 90 days after your election.

I hope that brings everyone up to date on the major things happening at the State level. If you'd like more detail, ask your Chapter State Rep to let you see the minutes of the three Board meetings - you'll see what I mean about boring! - Sary

--> LEGISLATIVE REPORT - FROM THE CAPITAL BATTLE FIELD (=-

For some reason, I feel like the system really can work!! Boy, what a controversial statement. Half say bullshit, half say you're nuts - but, so far this year - "WE", that's right, A.B.A.T.E., -US-, you and me, "GREASY (TV STEREOTYPE) BIKERS" have not only gotten Representative Fambush to introduce two bills to the House, (and it looks like they'il pass easily, thanks to Teresa Hepker, who drafted the bills!!) but we have apparently shot down the PIP insurance bill!

I'll say one thing, and I'm sure our Lobbiest Butch Harbaugh will agree, it's been an uphill fight all the way. The Senate didn't cut us any slack in notification - Tuesday 7:15 am a call from Salem. Guess what? SB 887 (PIP) will be heard on Wednesday at 8:00 am. GREAT! Only 24 hours to notify 13 chapters, get insurance quotes, do DMV statistics for our testimony, then write the testimony, get 12 copies and be on time for the meeting in Salem. Hey, Superman ain't got shit on us because we did it. We put the insurance industry on notice that we aren't going to get raped no more!

Here are the current bills and their status, and what you can do to help!!

HB 2721 - adds M/C to Lemon STATUS - Pending Committee Assignment SPONSOR - ABATE of Oregon Protection Laws

HB 2717 - Requires any licensed driver STATUS - Pending hearing in House SPONSOR - ABATE of Dregon to have both written and Committee on APRIL 30 @ 8 am. skills test for moped operation

SB 887 - MANDATORY Medical Liability STATUS - Unable to go to committee due SPONSOR - Senator Walt Brown to compleations in the re-write Will probably die in committee.

| HB 2639 - MANDATORY HELMET for ALL | STATUS - Holding in House Human | SPONSOR - House Committee on Judicary | Resources Committee. No hearing | pending at this time\*


\*Let's hope for the session to end before the bill is heard.

## MOBILE BETTER BIKING PROGRAM RECEIVES \$1000 GRANT FROM AMA

Early this year, the ABATE State Board OK'd a proposal to apply for a Rider Contingency Fund Grant

from the American Motorcyclist Association, to help fund this year's Mobile Better Biking Program. The AMA approved our application, and sent us a \$1000 check just in time for the opening of our 1985 training season. Because of the way the Oregon Traffic Safety Commission reimburses our expenditures, the money provided by this grant will be recycled throughout the year, and sure helps us in the continuing challenge of Paying The Bills On Time. Thanks, AMA!

ABATE of Oregon, Inc. has set aside \$1500 for operation of the Better Biking Program, and will replenish the BBP account up to that amount at the end of each quarter. At the end of the year, after all OTSC reimbursements come in, funds exceeding \$1500 (not including the AMA's \$1000) will be returned to the ABATE general fund.

#### EDUCATION, NOT LEGISLATION?

Although the Better Biking Program has the financial support of ABATE of Oregon, Inc., it isn't clear if we have the active support of the members. The reason ABATE is involved in a rider education program, is because the members believe that "Education, Not Legislation" is the way to improve motorcycle safety. Our strongest argument against the helmet law, is that riders and car drivers need to be educated in order to reduce the number of accidents; and that a helmet law is only an attempt to save a few lives AFTER the accident has already happened.

YOU are one of the riders that could improve your skills by taking a rider training class; so is the teenager on the street-legal dirt bike, and the couple on the full-dress Goldwing, and the guy who's been riding Harleys for 45 years. We need to train large numbers of Oregon motorcyclists, since that's the only way we can prove we're right. If riders don't sign up, our argument in favor of education is going to fall flat on its face – and we'll be back to saving our heads in spite of ourselves.

What are we asking you to do? Take a rider training class. Help set one up. Go out and sign up other riders for a class. Learn about it, talk about it, write about it. Our future rights depend on the choices we make now.

Let those who ride, decide.

#### \* GUIDELINES FOR FLIERS \*

As summer approaches once again, I felt it would be useful to re-run this article. I hope those of you responsible for drawing up your chapter's run fliers will follow the guidelines below - they apply to the fliers you hand out as well as those that appear in the newsletter:

- 1) Try to make your message as brief and to the point as possible. Many fliers are thrown away unread because they look too "busy". Keep in mind that I generally reduce fliers to 1/4 size, which has the effect of "cramming" things together. Give a phone number to call for more information, rather than trying to cram everything in.
- 2) Vertical format, rather than horizontal, is prefered.
- 3) Allow at least 1/4" of blank paper on all four sides of the page.
- 4) Maps are great on the back of the hand-out fliers, but when you include a map for the newsletter, please do so on a separate sheet of paper. It's easier for me to copy and reduce them if I don't have to worry about something on the back side of the "master" showing thru in the "copy".
- 5) Please send me copys that are as close to the original as possible; i.e. the "first generation" copy. A copy of a copy of a copy can look awfully bad by the time the newsletter gets printed. Whoever is responsible for drawing up the original flier should send me the very first copy made, and USE WHITE PAPER FOR THE NEWSLETTER COPY! I can't emphasize this point too much!! Colored paper "originals" do funny things in the photocopier so use white paper (for me) only!!
- 6) Avoid using "banner" style headlines that consist of white letters surrounded by a black backround they reproduce and reduce poorly & require extra work to "clean-up" for printing.
- 7) There is NO ADMISSION CHARGED at any run sanctioned by ABATE of Oregon! Surprised? We are a "non-profit" organization, therefore, we can only ask for "donations". Please make sure your fliers use the word "DONATION". Also, please refrain from using the word "beer". Substitute "BEVERAGES".
- 8) Please try to have flyers to the Newsletter at least 60 days in advance of your run date. This is your Newsletter take advantage of it in order to reach as many people as possible.

I hope this will be of some help to you when it comes time for you to prepare the flier for your run. I also want you to know that I don't mean you shouldn't use colored paper for the fliers you hand out at meetings — it's just that I need white paper to make copies from. If you make up a flier and ask members to make copies, make sure THEY get their "master" copy on white paper as well. Thanks!



Thank you for your letter opposing HB 2639 (the motorcycle helmet bill). There will be public hearings on this bill in the House Human Resources Committee before it reaches the floor of the House of Representatives. As a member of this committee I will take your advice into consideration when debating the pros and cons of this issue.

The hearings haven't been scheduled at this time and probably won't begin until some time in May. If you have any further questions concerning the hearings or anything to do with HB 2639 contact (the committee administrator) Bruce Bishop at 1-800-982-1211 ext 85783.

Once again, thank you for expressing your concern over this legislation.

The letter above is one I received in response to my stand on the helmet bill currently residing in the House Human Resources Committee. I thought I would share it with everyone, and report on the current (as of April 28th) Legislative scene in Oregon.

The Legislature would like to adjourn on June 15th. If they do so, it would end the shortest session since 1975. About 2000 bills remain in committee, and many could be ignored with no apparent loss (especially the hel-

mittee, and many could be ignored with no apparent loss (especially the helmit bill and PIP bill.) The actual figure is 2,146 bills introduced this session, with 101 having passed as of April 22nd. So
far, it looks as if the bills that are going to be pushed (of major interest to us, anyway) are in the Transportation Committees. HB 2266, the 2¢ fuel tax, SB 213, creating five driver's license classifications, SB 30, making odometer tampering
a crime, are bills the committee chairmen would like to see action taken on before the session ends. Out of all the bills
currently in committees in Salem, it appears that money measures are targeted for the strongest pushes. Obviously, the information I have on bills due to be pushed is limited to what I've been reading in THE OREGONIAN - you will HAVE to stay in
touch with Dr. Dave in order to keep on top of what's going on in Salem. The Legislators love nothing better than slipping
stuff by on short notice - see Dr. Dave's report on the PIP bill hearing. It's also important to write to the people that
are involved in looking at proposed legislation. The letter above is the only reply I received to the nine letters I mailed
to ALL of the House Human Resources Committee members. However, just because I didn't receive nine replies doesn't mean my
letter writing was a futile effort. Those people DO take notice of their mail, especially when there's a lot of it all opposed (or for) a particular bill - look at what happened to the mandatory seat belt bill. Sure, it re-surfaced as a mandatory bill for those under 16 years of age, but at least we, as adults, won't HAVE to "buckle up" next year, and it's because
of letters that changed the tide of the Legislators' opinions. NEVER GIVE UP! WE CAN MAKE THE SYSTEM WORK FDR US!' - Gary




