Life itself is not without some risk, and life in a "Free" society can be very risky indeed. We all have to accept some risk if we want freedom in this country. Reduce the risk when we can, and then live with it. We should all have the right to make choices, good ones and bad ones, as long as we accept responsibility for the outcome. Think about that the next time you consider imposing your choices on someone else.

Now that Ron Wyden is Oregon's new Senator, it leaves a vacancy in Oregon's Third Congressional District. An election will be held to fill the remaining months of the third district term. First a special election will be held to determine the candidates from the Democratic and Republican Parties. As of this writing the candidates are: Democrats Earl Blumenaur (Portland City Commissioner), Shirley Gold (State Senator), Anna Nevenich (Nurse Portland). Republicans Mark Brunnell and Scott Bruun. It is very important for everyone to become familiar with the candidates for this office so that when you receive the ballot (vote by mail ballots will be sent to voters in mid March) you will be able to make an informed decision. Remember, while it is true that the person elected to fill this vacancy must run for election again in the fall at the general election, they will have the special advantages afforded only incumbents (postal privileges, incumbency, etc.).

#### comes: The AIM. . .ing Point

The AlMing what? For first time readers, and you veterans here's a short explanation: "AlM" stands for the "Aid to Injured Motorcyclists" program, founded about 10 years ago, by Richard M. Lester, a Los Angeles attorney, to assist motorcyclists hurt in wrecks. We were being mauled by hospitals, the police, the courts, and especially insurance companies.

Today, we are over a million strong, and growing worldwide. Bikers and others that carry the (FREE) AIM card (similar to a credit card in looks) on their person, have filled out a short form outlining a basic medical profile and who they want notified in the event of an accident.

This information is stored on a computer in California and is available ONLY to EMERGENCY PERSONNEL by means of an 800 number on the card. Personal addresses and phone numbers are NEVER DISCLOSED TO ANYONE, only information related to the emergency is used. Sign-up is completely voluntary, and members are NOT OBLIGATED to use an AIM lawyer but the card has the phone number if they want to.

What's neat is that ALL the costs of the AIM program are paid by AIM attorneys, personal injury lawyers who ARE BIKERS, that do mostly accident work for motorcyclists, and who donate LOADS of time to motorcycle causes. When they handle a bike or car wreck, they take a large portion of their earned AIM case fee, when there is a payoff, and put it back into the program. They don't get paid if you don't. The attorney fees that go to AIM are the SOLE support of NCOM (National Coalition Of Motorcyclists). Our welfare really does come first.

If you're in Oregon and don't have your AIM card, call me at Sam Hochberg's office, at 1-800-347-1106, or 224-1106 in Portland. Outside Oregon call 1-800-531-2424.

**CALIFORNIA HELMETS:** Had a talk with Bill Bish, the well-known bikers rights warrior from

NCOM, early in January, and the California Helmet law repeal bill has passed the Assembly. The next stop is the Senate, and passage there will take it on to law. The new law will apply only to riders under 21, adults will have freedom of choice! If this passes, it's a great victory for the whole U.S.. California is a lead state, and is often followed by other states.

**EVENT DATES:** The 6th annual **Best of the West** conference is April 13-14 in Vancouver, WA. Every rider in the northwest should make plans to attend. The **NCOM** conference is in Albuquerque, NM, May 09 -11. THESE CONFERENCES ARE VERY INFORMATIVE and I urge everyone that can, to get to at least one of them. Get in touch with me and I'll send you information.

Some of us in the Portland area plan to ride to the NCOM convention. Wanna go? Gimme a call and we'll work it out. The more the merrier. Lets show some Oregon spirit.

#### **NEWS BITS & PIECES...**

Australia: The Capitol at Canberra was inundated by 20,000 bikers demonstrating for highway safety. Road safety training is the key wherever you are..

Belgium: Our own dear Pepper Massey-Swan, who keeps NCOM going, gets going herself in February to the FEM (Federation of European Motorcyclists) convention in Brussells. She's representing AIM and NCOM. Go get'em Pepper!

Chicago: We've all heard the stories about bikes and big black dogs loving to ride in the back of pick-up trucks. It's gone a step farther. Amtrack is now offering transport of scooters from Virginia to Daytona for bike week, with luxury trips for the owners. It's embarrassing enough to haul a bike in a pick-up or on a trailer but a train defies my imagination. I thought we bought motorcycles to ride, not haul around the country. TRAINS! Makes me want to throw-up.

**Detroit:** 1995 was the second biggest year in history for BMW motorcycle (1994 was best). Since 1991, sales have risen 75%. I wonder, could the swing to foreign bikes be the result of the exorbitant prices we pay for

homegrown cruisers and baggers? BMW, by the way, builds bikes in Spartanburg, NC. Whether you like it or not a "BEEMER" is a good ride. John Bolin, another freedom fighter and good friend of mine, from Seattle, WA rode his "airhead" 1690 miles to Minneapolis, MN in May 1995 to the NCOM Conference in **TWO** days. That's IRON BUTT folks.

**Detroit Again:** Motorcycle daredevil "Evel Knieval" is working with the advertising department of "Little Ceasar's Pizza". Now he will land in *something soft that smells good.* 

Hanoi: Boasting 129 parking slots in the entire city the rest of the 48,151 other vehicles must be stored elsewhere. 

#### 1996 U.S. CONGRESS CANDIDATE SURVEY Melinda's Summary Statement

First impressions are everything. Both Republican candidates were very accessible and I was able to talk with them directly. Brunn was the only candidate who asked questions about the motorcycling community and Brunnel reminded me that he has been a member of ABATE of Oregon. They were the only two who commented that not all public lands should be used but only the parts which are designated for recreational use. Both Republicans ended the survey by stressing the importance of the constitution without any prompting from me at all.

The Democrats were a very different story. Gold and Blumenauer kept their distance and I ended up talking with campaign staff. In all fairness, Nevenich was out of town until a day before the newsletter deadline and a day late with her response. Nevenich went ahead and left her response on my answering machine. Gold, however, responded immediately with only one follow-up call. All candidates, except Blumenauer, prioritized this survey. His non-opinion required three additional follow-up calls. If he is this hard to reach now, what happens to us if he goes to Washington, D.C.?

Just a reminder that these are my thoughts and in no way represent either BikePAC or ABATE of Oregon, Inc. Brian Stovall designed the survey and I volunteered to do the rest of the work. Most of you would be surprised if I didn't have an opinion about this experience and didn't share it with you! Thanks to Mary Beth and Gordon for making sure this information got into the March newsletter. It is always an honor when I'm asked to represent bikers to the political community. If you're not registered to vote, do it TODAY. It's never too late.







#### A.B.A.T.E.of Oregon, Inc. Rules of Operation 1/13/96

- 1. NAME: This organization, hereinafter referred so as ABATE, is legally known as A.B.A.T.E. of Oregon, Inc. which stands for A BROTHERHOOD AGAINST TOTALITARIAN ENACTMENTS.
- 2. JURISDICTION: ABATE shall:
  - A. Have jurisdiction of all members and chapters and use of name and logo within the state of Oregon.
  - B. Maintain equitable relations between all its members and chapters.
  - C. Assure the democratic right to assemble, voice opinions and take action on matters of mutual interest to motorcyclists.
- 3. ORGANIZATIONAL STRUCTURE:
  - A. Membership:
    - 1. Applications:
      - a. Membership in ABATE shall he obtained and maintained through application to ABATE.
      - b. Each application for membership shall be accompanied by dues estblished by the State Board of Directors and submitted to the State Membership Secretary.
      - c. Memberships are non-assessable, non-transferable, non-assignable and non-refundable.
      - d. Each member will decide which chapter they want to belong to, or may decide to be a Member-At-Large(Indian Creek).
      - e. ABATE membership records will remain confidential, and will be used ONLY for ABATE purposes.
    - 2. Termination: Membership in ABATE will be terminated upon death, written request from the member, nonpayment of dues, theft of ABATE assest, or by decision of the Board of Directors.
    - 3. Duties of Members- It shall be the DUTY of each member of ABATE to:
      - a. Abide by the BYLAWS.
      - b. Conduct themselves in a creditable manner with regards to the organization.
      - c. Bring to the attention of the State Board of Directors' presiding officer any activity that is not in the best interest of ABATE.
  - B. ABATE CHAPTERS:
    - 1. To receive a Charter as a Chapter in ABATE a group must have:
      - a. Ten paid-up members.
      - b. Elect from those paid-up members a Coordinator, Secretary, Treasurer, Membership Secretary and one State Representative.
      - c. Make application to the State Board of Directors for a charter.
    - 2. To remain as a Chapter in ABATE the Chapter must:
      - a. Abide by the ABATE Financial Policy and Procedure Manual.
      - b. Send copies of Chapter minutes to the State Coordinator within seven (7) days of the Chapter meeting.
      - c. Insure particapation of Chapter State Representative at State Board of Directors' meetings, unless excused by State Coordinator.
      - d. Submit a monthly report to the State Newsletter by the 10th of each month.
    - 3. Any chapter in noncompliance with part 2(a,b,orc) of the above four requirements will have voting privileges at State Board of Directors' suspended until brought into full compliance. Chapter in non-compliance of 2(d) for a second month in succession will have voting privileges suspended until brought into full compliance.
  - C. ABATE State Board of Directors: The State Board of Directors will be the governing body of ABATE and will meet at a time and place to be determined by the State Executive Board.
    - 1. The State Board of Directors will be composed of one State Representative from each chapter, who will constitute the voting membership of the State Board of Directors.
    - A minimum of one-third of the chapters of ABATE must be present and eligible to vote to constitute a quorum.
    - 3. The State Board of Directors will use Roberts Rules of Order as a guideline to conduct meetings.
    - 4. The fiscal year of ABATE will be January 1 through December 31.
    - 5. Motions brought before the State Board of Directors which will directly affect the general membership will be reffered to the chapters for discussion and voted on at the next State Board of Directors meeting, unless a delay in voting will cause a disruption in the transaction of business by the organization.
- 4. RULES OF OPERATION:
  - A. The original Rules of Operation became effective July 1, 1980.
  - B. The Rules of Operation have been amended in 4/1983, 4/1984, 4/1986, 6/1989, 11/1993, 1/1995, 1/1996.
  - C. All changes to the Rules of Operations and the Bylaws must appear in the State Newsletter before being voted on by the State Board of Directors.

#### Bylaws effective

1/15/96

- 1. There is only one qualification for membership, that being the payment of dues established by the State Board of Directors. No group or class is required to join. No group or class is denied membership.
- 2. The election of State Officers of the State Board of Directors shall be held at the last meeting of each year by the voting membership of the State Board of Directors. The number of State Officers of the State Board of Directors he be at least, but not be limited to, six.
- 3. The State Executive Board shall be comprised of the following State Officers:
  - A. Coordinator
  - B. Vice-Coordinator North
  - C. Vice-Coordinator South
  - D. Vice-Coordinator East
  - E. Treasurer
  - F. Run Coordinator
- 4. The State Executive Board has the authority to:
  - A. Issue statements on the behalf of the organization
  - B. Expend funds
  - C. Take any action deemed necessary to accomplish the goals of the organization.
- 5. All members of A.B.A.T.E. of Oregon Inc. shall join and work together for:
  - A. Fair motorcycle legislation
  - B. Public awareness programs promoting motorcycling
  - C. Education programs to assist all motorcyclists, especially the young and/or novice rider, to reduce accidents.
- 6. All funds obtained from membership fees, donations, and organizational benefits shall be used for:
  - A. Education, rider and non-rider
  - B. Distribution of information
  - C. Legislative action
  - D. General costs incurred in the operation of the organization itself, none of which shall go to any member or officer with the exception of reimbursement of out-of-pocket expenditures directly related to A.B.A.T.E.activities authorized by the State Executive Board.
- 7. The Rules of Operation for A.B.A.T.E. of Oregon Inc. shall be used as the basis for day to day operations.

## 1996 Polar Bear Run Portland, Oregon

New Year's Day is a day of renewal, the promise of a new year. It is also a time to make those New Year's resolutions. This January 1st, a record crowd made it their New Year's resolution to ride in the Polar Bear Run.

682 registered motorcyclists began the new year on two wheels, enjoying spring-like conditions while they rode their favorite vehicles. Nearly 50 motorcycle clubs were represented this year, 194 of the registered riders were members of the American Motorcycle Association (AMA), and there were also several minors on the ride. Aside from riding, the Polar Bear Run was also a time to fellowship with old friends and to make new ones.

The Polar Bear Run is sponsored by the Trinity Road Riders, the Portland chapter of the Christian Motorcyclists Association. The ride is a non-profit motorcycle event that benefits motorcycle outreach missions in the United States and worldwide. The Christian Motorcyclists Association is based in Hatfield, Arkansas with chapters located all over the world.

Tom Young, the owner of Portland Touring Center, once again played host to the 13th annual Polar Bear Run. The doors were opened early, around 9:00am, and registration started soon after and lasted until after noon. When registration was

all said and done, 27 dozen donuts, a couple hundred bowls of chili, and several gallons of coffee had been served.

Three ride routes were planned because of the unpredictable Oregon weather in January: The Papa Bear, the Mama Bear, and the Baby Bear. This year, with dry skies and mild temperatures, nearly everyone rode the Papa Bear route. The Papa Bear route covered nearly 57 miles and lasted about an hour and a half. The riders took the route through parts of Clackamas County, featuring many curves and nice views. Then the route went through the Cedar Crossing Bridge, to Carver and along the Clackamas River. There was still evidence of the great wind storm of December 1995 to amaze the riders along the ride.

Pizza awaited the riders as they finished at Papandrea's Pizza in Oregon City. But on a day like this, many didn't go straight home after lunch, but instead took the long way home to finish out the beautiful day.

The Trinity Road Rider's next event is the Starlight Tour, Oregon's only night ride, and part of the Portland Rose Festival. The ride will start at Beaverton Honda-Yamaha in Tigard, Oregon and will begin at 6:00pm on June 8th. For information, call (503)786-2920.







#### OREGON SHARES CALIFORNIA VICTORY

NCOM Legislative Task Force Chairman and BikePAC of OR Legislative Director, Butch Harbaugh, & AMO Legis. Liaison, Lily Ward flew to Sacramento Jan. 6th to attend the Legislative Seminar at the Holiday Inn and the FREEDOM RALLY at the Capitol.

They attended to show support and to bring home some new ideas and enthusiasm. Since this was Lily's 1st legislative event trip, she writes this

from her perspective:

4PM Sat Flight 2795 left grey
PDX skies to what I thought would be
sunny California skies. Wrong! Fog so
thick we circled SAC 30 minutes before
they finally let us land, so we missed
the last shuttle by 5 minutes. Butch
called another and soon we were
enroute.

7:30PM Sat The Holiday Inn bar was full of black leather, hugs and introductions. I made a special effort to remember these names Butch introduced me to; I had a feeling I'd be seeing more of them. Some of the special people I met were Bill Bish (NCOM Legislative Director and Emcee of this event) & his wife, Darlene (member of Undaunted MC (for women), Quiet Ron (member Vagos MC and there representing Confederation of Clubs) & his wife, Buffy (President of Undaunted MC), Mark Buckner (MRF President) Paul Lax (Exec. Dir. ABATE of CA) & Twiggy (Easyriders photographer/reporter).

10 AM Sun Emcee Bill Bish opened with, "Remember when Dick Floyd said, "They (bikers) will 'get used to it' (wearing helmets) 3 years ago? Are we used to it?" The audience roared, "NO!"

The teamwork of MRF and NCOM was evident in the synergism of this melting pot of motorcycle rights Unity has flushed out the days of hoarding information; today with these events and the internet, we share information as fast as we get it. Lax urged us to take this momentum back home to our groups and \*get involved in the freedom fight!" Quiet Ron warned us to keep up the fight because 'they' will "always be on our backs." AMA's Rob Dingman gave statistics on the drop in motorcycle registrations in '91 (when CA became a helmet state) and the dollar loss in the motorcycle marketplace that resulted. He agreed that "there's no fat lady here; congress giveth and the congress taketh away--it's never over."

Mark Buckner reminded us of the Nat'l Highway Systems bill repealed on Nov. 28th and how that showed our

effectiveness as political motivators.
"We are unified now! We are respected
now!" CA may be 1st, but NJ, PA and GA
are close behind. (We hope OR is too!)
He warns of an impending "plateau"
however and states, "status quo is not
acceptable!" We have a "clear goal in
Washington DC; we need resolve!"

Bob Combs, CMDA speaker, spoke of the insurance rate hikes and injury

claims dilemma.

Our own Butch Harbaugh took the floor and spoke of biker culture, our 'unique' lifestyle in which we can ride across the nation and "help is truly only a phone call away," and of our right to choose our own destiny and to make our own choices about our personal safety. He shared our victory at getting the handicapped motorcyclist parking sticker passed.

U.S. Senator Ben Nighthorse Campbell commanded a full house of standing bikers! He spoke of freedom unbounded by state lines and our taking the risk to cross those lines. heat is worth it," he reassured us. We have a "code of honor, like my Cheyenne father" and he knows what it's like to be discriminated against. Ben rides to Rolling Thunder and he dares other senators to "go out there and tell a vet, 'now that you've saved our freedoms, we'll take yours away.'" orders us not to go public poll on the helmet repeal vote; all those non-biker entities "will gang up on you!" He added, "Stay focused on 1 issue at a time, sort out the good politicians from the fools, and never give up-sometimes they change their minds!

Noon. Lunch? Oh yeah, I guess we gotta eat. We dash to A&W for a bite and can't wait to get back into 4 terrific workshops they offered: While Butch "floated," I attended RUNNING SUCCESSFUL MEETINGS and picked up some great tips on meeting conduct, what works and what doesn't and how to 'handle' difficult people. (Gordon may want to print the "22 Deadly Sins" of a meeting leader in the newsletter.) Next I attended SUCCESSFUL RUNS & RALLIES and learned the MMA's secrets. The 2 workshops I only gleaned handouts from were: MEDIA & PUBLIC RELATIONS and POLITICAL CAMPAIGNING & GRASS ROOTS LOBBYING which I hear were great also.

5 PM Sun. Panel Discussion on "THE PUTURE OF MOTORCYCLING" kept Butch on his toes; he got 'picked on' a lot. He was asked, "What's the biggest threat to the future of motorcycling?" and answered, "the insurance industry" and of course elaborated in his

eloquent style. Mark Buckner answered, "Apathy" and Mike Osborn, ABATE-PAC Chairman & Board of Directors for ABATE of CA added, "the lack of young bikers replacing us threatens us too."

New York Myke of San Diego HD spoke of his visit to Bosnia and how thankful we can be that we can change laws here in America!

7 PM Sun. Hospitality Room, sponsored by Sacramento and San Diego HD, was filled with delicious food, excited bixers and lots of networking energy. Finally the crowd dispersed back to the roomier bar area where numerous mini-groups conversed intensely into the night. Butch disappeared with the passing over of the full moon, but I, being more nocturnal, upheld my reputation at giving the hotel jacuzzi something to swirl about. The pool provided a perfect transition between the full, dynamic day and sleep.

10 AM Mon. FREEDOM RALLY AT THE CAPITOL STEPS OF SACRAMENTO! Spirits were high as we thundered our bikes to the Capitol. I scrounged up an 'extra' helmet somewhere and borrowed Butch's leather coat and accepted an invite from my new Monterey friends to be packed on the back of a shovelhead similar to my own (back home snug in my I was greeted at the Capitol by shop). 2 of my Women in the Wind sisters, Gina and Ruby of Sacramento Chapter River City. At least 3,000 bikers poured into the inspiring Capitol building to absorb some of its history.

Noon. Sun. The speeches began. New York Myke added the word "freedom" just before "liberty and justice for all" in our pledge to our allegiance to our American flag. Many quotables pierced the crowd--phrases like, "Hey, maybe the system does work! " and "We ain't takin it any more!" (Paul Lax); and "The safest place in the world is a padded cell where there are no freedoms!" (Rob Dingman); and "We won't be around forever, but (Kathy Theodore held up a young boy) THIS is who's gonna be arouundi " and from a "This isn't about congressmen: helmets; it's about freedom; we know that; we do hear you. 'They' did it to you and 'they' could do it to me, so you've got my vote--hang in there! " and "I ride too and it's my opinion that you're smart enough that it's your choice and I commend your commitment to something that's been unfair to you for too long so <u>today</u> you <u>are</u> getting your freedom back and this time it will count because you will keep it! and "I paid my way through law school working at a biker bar and I learned 1 thing about bikers--you may get whipped now and then but you don't snivel; you fight! We promised you changes, well guess what, today you got'em! AND HE WAS RIGHT!

2 PM MON. The BIG moment was at We piled into the assembly room hand. and reluctantly obeyed Mike Osborn's "Shhhhh" at hearing the skewed statistics, the mother-of-a-son-killedon-a-motorcycle sob story, the pityploy presence of the quadriplegia who 'wishes' he'd worn a helmet one day long ago. But then it came--the 9 to 5 vote in our favor came through loud and clear, and it was evident that biker lobbyists had done their homework these past long 4 years and had effectively informed the right government leaders. We funneled back outside and screamed our victory! Butch and I were so happy for our California riding brothers and sisters, our eyes were as tear-filled as anyone's there! Hugs and handslaps dominated the scene as the celebrated roar of motorcycles gradually dulled; we were all now ready to return home to spread the news and to build on the momentum of this day in Sacramento.

4 PM Mon. Exactly 2 days later
Bill & Darlene Bish drove Butch & I to
the airport; we were happy but tired.
The flight home was quiet. It had all
been said. We gobbled down our bean
dip and chops and slept until the bumpy
runway or PDX Int'l Airport greeted us.
Thanks, Gordon, for driving us to and
from the plane and for keeping my
little cage safely parked at your home.

9 PM Mon. Butch delivered to his home and as I drove out into the darkness of the country road to Albany, I smiled with pride at the thought of being part of a movement so awesome as this and of being part of a wonderful, unique, culture—bikers! Already I'm thinking, what's the next step?

S>T>E>A>M>? No, 1st, we gotta do some voting, right? ARE WE READY? Get your pen, get set, VOTE! See ya at the polls. Meanwhile, Ride lite, Lily

### Teenagers, They Ask the Darndest Things

Not so long ago, our son Ryan would hang around our kitchen table engulfed in ABATE papers from diapers to toes. Born in 1977, Ryan entered life destined to become part of the motorcycle world.

That old mahogany kitchen table with the double swinging wooden leaves and heavy old armchairs spoke of much history in our motorcycling family, AMA and ABATE. Ryan, as a young lad and man, listened and entered into many wonderful conversations with thousands of motorcyclists from one end of America to the other around that massive solid antique table.

His inquisitive mind matured around motorcycle magazine editors, ABATE's best of the best from 50 states, club people, women in motorcycling, AMA members, motorcycle safety instructors, and motorcycle people of all ages, persuasions and sizes. Folks who were the "doer's" and contributed to our lifestyle were around our house daily.

By age 10, Ryan had been riding motorcross, slipping and sliding through streams, across fields, into woods and onto motorcycle safety courses for 5 years. Our family's 500 acre farm provided the backdrop for well-used trails.

By age 15, Ryan had been on a motorcycle in more than 40 states across America. At age 14, a road worthy 883 Sportster was given to him, to ride, in between Deb and I, to Sturgis and various points across this grand US of A. Yes, we realize it was not legal...we didn't get caught..enough said. Over the years, Deb and I have been damn lucky to have a kid who is also our best friend. The education and experiences this kid has received by growing up among bikers advances him in years, knowledge and life's values. Whether it be walking Main Street in Sturgis and Daytona or years back, helping Deb and I put together the Boogie, folding and stapling ABATE newsletters at midnight, taking the motorcycle class 18 times or working in my photography studio 12 to 14 hours a day for 10 days in Daytona or Sturgis, Ryan has always been there for us and most of the time with a smile. Deb and I could brag that we are the reason this kid is a bright young talented honor roll student. However, there are many reasons and people who share the limelight, that enter into the formula of his development and this 6' 200 lb., solid as-a-rock human being. Motorcycling and our people in fact deserve much credit for our son's great approach toward life, his healthy understanding of teamwork and believing in your fellow man and woman.

It was always motorcycle people who would fill in for Deb and I while we were 5 states away fighting for motorcycle rights. So many times Deb would place our 7, 8, 9, 10, 11, year old son on the back of an FXR with her and travel to whatever city so those young eyes and mind could sit in on a motorcycle safety instructor prep class. He would witness the dedication of motorcycle people believing in giving unselfishly for motorcycle people. He grew up hugging and sharing our brotherhood as we hugged each other. His young soul has been surrounded and focused by our spirit and our love for life and each other.

Ryan would join a motorcycle safety class on Friday night while I was on the other side of America and instructors would teach him to help by changing oil, wrenching on bikes, changing tires, loading and unloading, kicking cones. I would come home to a dialogue about the course and people and motorcycling that was simply not that of a normal 12 year old in this country. These same instructors would take Ryan riding or help him fix his motorcycle or take him racing or just be his buddy and listen. Ryan had 10 Dads who taught him respect, dedication, work, ethics, who shared lifes experiences with him and who would kick his ass when he needed an adjustment to reality.

Throughout his high school career Ryan would be the kid with the Harley parked next to the gym. The coaches, teachers, administrative staff all were constantly asking Ryan questions about ABATE and motorcycling. For those of you unaware, we live in Brown County, home of the Boogie.

Ryan's depth of understanding our fight and our focus and belief in the fight for our rights has rubbed off in his life. Today I listen to him explain ABATE, AMA and motorcycling issues to his generation with much pride. His life has been engulfed with our issues. His wisdom has been earned.

Now 18 years going on 30, this young man has seen America, excelled in sports, graduated from high school with honors, experienced the passion of motorcycle women and can work in the trenches beside you for twenty hours a day, if asked. Point being, success will enter this lads life.

He approached Deb and I this summer and asked if he could borrow my dresser and her FXR for a cross country vacation he and his buddy Donny wanted to take on Harleys. He was not kidding. The question was direct, "Hey Dad", he says "wewant to borrow your bikes and ride into Canada" Why Canada? Well, his buddy, Donny Brown, had never been to Canada.

How could either Deb or I say no? Our entire lives have surrounded motorcycling and the very class of motorcycle people. I have personally been in 8 states the last 4 months encouraging and speaking to many folks that motorcycling's future will come from motorcyclist's kids — Get and keep your kids involved, I have said repeatedly.


So, when my 18 year old son asked me to take a 2,500 mile ride on my bike, the answer was "Sure". Of course like any Dad, I spent the next two weeks reminding him of every potential problem he may encounter and so did the Harley dealer and so did Rod Taylor and so did his Mother and his Grandpa and Grandma. Most of our concerns were those which we have experienced, yet deep down we all know he must experience our world from within, by himself.

Finally, he and Donny left and together Ryan shared with Donny 18 years of motorcycle life for the next 10 days. They fished, camped, fixed broken motorcycles, explored Canada and lived the life we live. At 18, he has already begun to pass on information about our lifestyle to his generation. Ryan has an uncanny ability to communicate information about laws and his time at the State House. Ryan makes his buddies take a motorcycle safety class. None of his friends have permission to ride our spare bike unless they are a graduate of the RSS. The kid, in fact, leads by example.

They are, in fact, us. They are men. Ryan has written stories about 10 days on the road for English class at Ball State University this fall.

Your sons and daughters and my son will be the generation that fills our shoes in the fight for our rights. We have passed on our freedom for them to enjoy. Ryan respects that because he understands those sacrifices made by so many the 18 years he's been alive. He has learned to believe in us. This 18 year old man appreciates the fight.

## REPORT ON THE 1996 LEGISLATIVE AGENDAS OF THE 25 STATES WITH ADULT HELMET LAWS

After passage of the repeal of the federal helmet law mandate on November 28, 1995, one of the most asked questions of the MRF office has been: "What's happening with repeal efforts in the 25 States with helmet laws?"

In an effort to better answer that question Carol Simpson undertook a project for the MRF to get answers from the state motorcyclists' rights organizations. What she found in those 25 States is a lot of legislative activity. So far this year, 12 States have introduced legislation to repeal or modify their helmet law to allow freedom of choice. Two others have bills to make helmet law violations a secondary offense. Of the other 11, four do not have sessions in 1996, and Louisiana only handles appropriations bills in 1996. A few of the other States hope to introduce bills later this year and others have made strategic decisions to wait until 1997 to introduce helmet law repeal or modification legislation.

This project began the week of January 22. All 25 states with adult helmet laws were contacted regarding their legislative agendas for 1996. In addition to the helmet law repeal and modification efforts, we found many other bills affecting motorcyclists. This information is also included in this report.

During her efforts to produce this report, Carol drew on many resources. She spent many hours on the phone with legislative coordinators for the various state motorcyclists' rights organizations. Tracey Powell of the American Motorcyclist Association's government relations department provided considerable research and background material and she double checked much of the information we received. Bill Bish of the National Coalition of Motorcyclists provided some phone numbers for new contacts and other information. Carol also received information from different state legislative services and leadership offices. And, the National Conference of State Legislatures provided information on the legislature session dates, which immediately follow the State names in this report.

The first draft of this report was presented to the MRF Board of Directors at their January 27 meeting. On February 3, MRF president Mark Buckner presented an updated version of this report at ABATE of Pennsylvania's annual legislative and leadership seminar. This version of the report was generated on February 6 for this issue of the MRF REPORTS. The nature of legislation is that it changes and action can happen quickly. Therefore, this report will continue to be updated daily. If you know of legislative action that has taken place not included in this report or other bills that should be covered please call the MRF office. Also, Carol's new task is to produce a similar report of legislative actions in the 25 States without helmet laws. Look for that report in your next issue of the MRF REPORTS.

ALABAMA. February 6 thru May 22. ABATE of Alabama is looking at options for introducing and moving a helmet modification bill exempting those 21 or older.

ARKANSAS. No session in 1996. ABATE of Arkansas is exploring the possibility of a special session that might hear a helmet modification bill. Working on campaigns.

CALIFORNIA. January 3 thru September 1. AB 244, sponsored by Rep. Morrow, which would repeal the helmet law for those 21 or older, passed Assembly Transportation Committee on January 8, vote 9 ayes to 7 nays. It passed Assembly Appropriations Committee, on January 15, vote 11 ayes to 7 nays. AB 244 passed a Floor vote on January 25, 44 ayes to 31 nays. It will take a month or two after the Assembly floor vote for ABATE of California and the Modified Motorcycle Association of California to build sufficient support in Senate. Also, they are working to defeat Referendum Proposal # 200, a no fault insurance initiative on the March 26 ballot.

FLORIDA. March 5 thru May 3. ABATE of Florida is soliciting answers in a survey of all legislators. Question #4 asks for support of helmet law modification to give freedom of choice to motorcyclists 21 or older. They intend to pre-file House and Senate bills in November for the 1997 session.

GEORGIA. January 8 thru March 15. HB 1230 passed the motor vehicles subcommittee unanimously, 4 to 0, on January 22. HB 1230 passed the full house motor vehicles committee on a 7 to 1 voice vote on January 23. The bill, as reported out of committee, gave freedom of choice to those 21 and older. It also contained a provision for rider education for those under 21. The Rules Committee chairman added a minor amendment concerning mopeds. During floor debate on January 30, an amendment was added that would require all applicants for new motorcycle licenses to complete a motorcycle rider education course. An amendment to strike the helmet law modification was defeated, as was an amendment that would have denied state assistance (Medicaid, etc.) to those injured and not wearing a helmet. The vote to pass HB 1230 was 83 ayes to 82 nays. However, in Georgia it takes a constitutional majority of 91 ayes, not just a simple majority of those voting, to pass a bill. On January 31, the sponsor of HB 1230, Rep. Powell, moved to reconsider the bill and won on a vote of 104 ayes to 38 nays. ABATE of Georgia is building more support for HB 1230 to ensure 91 votes. The reconsideration vote, where they must have 91 members of the Georgia House of Representatives vote aye, is expected in early February. SB 438 which would create handicapped and antique tags for motorcycles has passed the Senate and is awaiting House action.

KENTUCKY. January 1 thru April 12. A bill modifying the mandatory helmet law to apply to only those under age 21 will be introduced the week of February 5. KMA/KBA plans to work bill through the House first, then move same bill through Senate — no companion bill. The House committee is expected to take action on the bill in late February. According to KMA/KBA, the Governor will sign the bill if it reaches his desk. They are working several other issues, including insurance discrimination; changing tag licensing to birth date instead of all in December when other taxes are due; handicapped tags for motorcycles; and monitoring health care reform package.

LOUISIANA. April 29 thru June 12. (Appropriations only in this short session.) ABATE of Louisiana is looking for support for helmet law modification bill. They want to add the phrase "under 18" to mandatory provision. They are also working on support for handicap tags. ABATE has made friends with the transportation committee staff on handicap tag issue. Membership is having great growth.

MASSACHUSETTS. January 3 thru July 31. A helmet modification bill has been filed in the House. It won't be printed until February, so no bill number is available. There will be hearings in April. The Department of Safety has made a commitment to urge "No" on repeal. There will be a State seminar on February 10 to educate and motivate Modified Motorcycle Association of Massachusetts members on supporting and working the issue.

MARYLAND. January 10 thru April 8. In the Senate, ABATE of Maryland is working to pass SB 334, which would change the law to require only those 17 and under to wear a helmet when riding on a motorcycle. In the House of Delegates there are two bills dealing with the helmet law. HB 978 is a companion bill to SB 334. HB 977 would exempt those 18 or older from wearing a helmet if they had completed a rider education course. They are also working on SB 84 which makes it legal in the entire state to park more than one motorcycle in a single parking space. This bill passed out of the Judiciary Committee with "do pass" recommendation. HB 96 authorizes the Motor Vehicle Administration to waive the road test for motorcyclists who have completed a rider education course. Also in the works is an anti-discrimination bill and a bill to make the funding for rider education more secure. The Senate Judiciary Committee held a hearing on SB 334, February 6, a vote is expected by February 9.

MICHIGAN. January 10 thru December 31. ABATE of Michigan is polling Senators to gauge the possibility of introducing a helmet law modification bill on the Senate side this year. A repeal bill failed in House in 1995. ABATE will only accept a Republican Senator on Transportation Committee as sponsor. There is active work to defeat HB 5000, which is a primary offense seat belt bill. Monitoring Transportation and Tourism committee hearings on graduated license system — HB 4763. There is no motorcycle related language in this bill, yet. ABATE is gearing up for major Motorcycle Awareness program. They have met with AAA and they will help with program. ABATE is supporting HB 5123 — raising speed limits. Polling candidates for elections.

MISSOURI. January 3 thru May 17. There will not be a helmet law modification bill filed this year. Freedom Of Road Riders is focusing on building an excellent legislature for 1997. There is a strong agenda for campaign work. Plans are to introduce 21 years and older freedom of choice bill in 1997. They are working on getting rider education program implemented. A bill with \$1000 fine for helmet ticket has been introduced; FORR is vigorously opposing.

MISSISSIPPI. January 2 thru April 8. HB 819, which would modify the law to apply only to those under 21, was introduced on January 25. Rep. Nettles, the sponsor, noted on bill "by request" of Freight. HB 819 appears to have died in subcommittee because it was not passed out by a February 6 deadline. Shelley Johnson is the new legislative director for ABATE of Mississispi.

NORTH CAROLINA. May 6 thru June 15. Drafting helmet modification bill. Expect Rep. Baker and Senator East to carry the bills, if the session is long enough for a successful outcome. This bill will modify helmet law to apply to those 18 and under. Some consideration is being given to some rider education legislation. Concerned Bikers Association of North Carolina is focusing efforts on researching the probability of passage of both issues.

NEBRASKA. January 3 thru April 1. LB 246, an equalization law making helmet law secondary offense, is a carry-over bill from 1995. The committee is expected to hold hearing and vote this session. ABATE of Nebraska is working for passage in "calendar bill" at end of session on full floor of unicameral legislature.

NEVADA. No session in 1996. They are doing candidate questionnaire, then voters' guide. There will be a candidates' night in August. The Nevada Association of Concerned Motorcyclists and ABATE of Nevada are working towards a goal of veto proof support for helmet law modification bill in 1997.

NEW JERSEY. January 9, 1996 thru January 8, 1997. New Jersey had to withdraw their bill from a house vote on January 4 in previous Assembly because of faltering support, after overwhelming wins in the Senate Committee and floor and House Committee. The repeal was reintroduced in the new session by Senator Kosco and the number is SB 440 (sound familiar?). The Senate Committee has already unanimously passed the bill and United ABATE of New Jersey is taking a breather to carefully gamer support and plan strategy. More votes in a month or so.

NEW YORK. Jan. 3, 1996 thru Jan. 2, 1997. Two bills to give freedom of choice to riders 21 years of age or older have been introduced. Sen. Johnson is sponsor of S 2165 and assembly man Parment is the sponsor of

A 1224. ABATE of New York is working to unify New York motorcyclists to promote support for these bills. ABATE is also promoting rider funded rider education bills, A 5233 sponsored by Assemblyman Gantt and companion bill S 3113 sponsored by Senator Johnson.

<u>OREGON.</u> No regular session in 1996. Special session on light rail issues. Motorcyclists have been advised by supporters not to intrude on this session but to seek second special session, probably will wait until next year. In 1996 ABATE of Oregon's and BIKEPAC of Oregon's major focus is on working in the elections.

<u>PENNSYLVANIA</u>. January 9 thru November 30. ABATE of Pennsylvania met with Governor Ridge in 1995 to build support for modification of helmet law. A full repeal bill, HB 1473, was introduced in April of 1995. Another House bill will be introduced by Representative Brown in February, which will exempt riders 21 or older from the mandate. SB 165 was introduced in January of 1995 and exempts riders 21 or older from the mandate if they have been licensed for two full years and have completed a rider education course. The plan is to schedule hearings and votes on bills to correspond with their Freedom Rally in May.

TENNESSEE. January 9 thru May 15. Identical bills to exempt motorcyclists 21 and older have been introduced, S 2427 sponsored by Senator Carter and HB 2421 sponsored by Reps. Burchett, Cole, Gunnells and Ford. CMT/ABATE has used letters of introduction from their members and supporters to gain support from legislators when the lobby team visits the hill. A preliminary hearing was held in Senate committee on January 30. House action is expected by mid-February. No votes have taken place to date.

TEXAS, No regular session in 1996. Texas Motorcycle Riders Association is focusing on Reality City for both the Democratic and Republican conventions. Democratic Convention, Dallas, June 7 and 8. Republican Convention, San Antonio, June 21 & 22. They will pre-file modification bills in both House and Senate in November for 1997.

<u>VIRGINIA.</u> January 10 thru March 15. HB 1093 would amend Virginia Code to adopt Snell, ANSI or DOT standards for helmets. This bill was introduced at the request of Virginia State Police and has been referred to House Transportation Committee. <u>ABATE of Virginia OPPOSES HB 1093</u>. HB 1374 is a technical correction bill to help better fund rider education. Other amendments to increase designated fund will be offered. ABATE of Virginia supports HB 1374. ABATE firming up HOV motorcycle usage with follow-up bill, HB 353 and companion bill S 1. Both S 1 and HB 353 have passed their respective bodies and final action is expected once they decide which bill will be acted on for final passage.

<u>VERMONT</u>, January 4 thru April 29. Freedom of the Road FOR Vermont reports S 37, which would reduce helmet law enforcement to secondary offense, is a carry-over bill from the 1995 session.

WASHINGTON, January 8 thru March 8. Have introduced HB 1408 and S 6259, a modification to exempt 21 and over from mandate. This session is too short for agenda to allow time for hearings and votes. ABATE of Washington and the Washington Riders Legislative Task Force are trying to make some progress with the Transportation Committee chairman in House. Senate committee chairman refuses to bring up S 6259 for a vote this session, effectively killing the bill for 1996. Motorcyclists across the state are gearing up to work election campaigns

WEST VIRGINIA. January 10 thru March 9. West Virginia has 12 motorcycle related bills introduced in the House. HB 2009 eliminates tolls for motorcycles on the Turnpike. HB 2587 repeals the mandatory helmet law for those 18 and older except novice riders. HB 2594 removes lights on requirement. HB 2677 changes the assembled vehicle title requirements for motorcycles. The other bills all focus on the rider education program and may be rolled into one bill. ABATE of West Virginia has their hands full with trying to get their rider education program

#### A MOTORCYCLIST GOES DOWN - DO YOU KNOW WHAT TO DO?

There's been a motorcycle accident! What can YOU do?

. You can help make the most of the "Golden Hour," the precious time between the accident and the emergency room.

Remain calm and think. Remember your ABC's:

Airway:

Make sure the patient has an open airway,

Breathing:

Look, listen and feel to see if the injured biker is breathing. If not, give 2 slow full breaths

into his or her mouth.

Circulation:

Check for pulse in neck. If no pulse, start CPR.

Assess the situation for safety factors. What is the traffic situation? Is the accident site secure? Is there a hazardous material spill, or gas leaking from the bike? Are power lines down? Is there a fire danger?

Form a safety line around the downed rider. Introduce yourself. Delegate someone to call an ambulance, preferably a woman (in case they need to go knocking on doors for help). Make sure they have as many facts as possible, including the exact location of the accident, how many people are injured and how seriously. The person calling the ambulance should hang up last.

Do not move the patient. Do not remove the helmet. Improperly removing the helmet can cause spinal chord injury, paralysis or even death (you can get a free helmet sticker that says: "WARNING - Do Not Remove Helmet Until I Am Examined By A Doctor" by calling Aid to Injured Motorcyclists (A.I.M.) at 800/ON-A-BIKE). If necessary, it is possible to give CPR without removing the helmet, even if it is a full face helmet (A.I.M. also has a free "Survival Card" that instructs how to properly remove a helmet from an accident victim if it is absolutely necessary).

Turn off the key to the motorcycle and shut off the gas.

Keep the patient talking. Ask questions; who are you, where are you, what day is it? Have someone write down all the details; vital signs, pulse, breathing. When the ambulance arrives, give them the notes and an honest evaluation of the patient's condition, including drug or alcohol consumption. Ask emergency personnel what you can do for them.

Talk with police when they arrive. Make their job easier by cooperating. Even after police and emergency personel have secured the site, you can continue to help the downed motorcyclist by photographing the accident scene, jotting down notes about the accident while they're still fresh in your mind, and make sure police get the names and addresses of all witnesses for the police report.

We have to take care of each other out there. Take a CPR course or, even better, a First-Aid class. Be prepared to take charge if someone goes down. It's better to know what to do and never have to use it than to waste your fellow rider's Golden Hour because you think that accidents only happen to other people.

The following summary is not prepared by the sponsors of the measure and is not a part of the body thereof subject to consideration by the Legislative Assembly. It is an editor's brief statement of the emential features of the measure.
