





### Comments from the Coordinator

I am aware that the practice of medicine is not an exact science and acknowledge that no guarantees or promises have been made as to the result of the testing procedures, care, or treatment in the hospital. I consent to and authorize the following:"

It's always strange to write one of these letters because I have to think a month ahead because you won't see this for a month. I have to try to say what I'm thinking now and look toward the time the newsletter will come out. The timing requires me to say "Hope you had a good Holiday Season!" and also, for those of you like me who

get stressed during the Holidays, "Praise the Lord and pass the Mad Dog, it's January 2nd!".

By the time you read this, we will have a bunch of new officers at the state and chapter level. I want to thank all of you for your efforts, whether you are retiring or staying for another sentence, oops, I mean term. I can't think of a person I've worked with who hasn't been an asset to ABATE. Thanks also go to your families and friends

because I am well aware of their sacrifices for ABATE and the cause of Freedom. Kim and I have had our set-tos, I love you Kim and Kristin and I thank you also. So now we have some new kids on the block, Welcome! You guys and girls are the future. You must understand the fact that you, as an officer, represent your members in your chapter as well as all members of ABATE of Oregon, Inc. Our job as officers is to lead the membership, represent the membership and also express the opinions of the membership at all board meetings, etc.

If your job is a Board Director, your job is most important and also a little complicated as you have the same responsibilities mentioned before as well as reporting all the information from the board meeting to your chapter and being the sole voting member from your chapter at a board meeting. You need to understand your chapter's wishes. You need to think for yourself also. You may be required to make decisions based on your own opinions, your chapter's opinions, your perception of your chapter's direction, or your best feelings about what's good for ABATE. To put it bluntly, "Tag, you're it!" The rest of us are just here to run the business and to facilitate the director's vote. So welcome to my nightmare. It's fun, it's Hell, it's sometimes some of both, but it's necessary if we want ABATE and our rights as Free Americans and Bikers. All of you who stepped up or who stuck with it for another year, I thank you.

On a sad note today, I was informed that the Keizer Chapter might turn in their charter. I'm sorry to hear that. We need everybody who cares involved and I hope all members in Keizer, Indian Creek, or anybody not involved in a chapter will still stay involved in our political and legislative efforts. This is what we are supposed to be about. I just want everybody involved knowing you are important.

So, after all of this are you wondering why the first paragraph? Well, it's about our upcoming fun and games in the Legislature. First, I've got a question for you relating to our President's current problems. If our President can loose his job for lying in court, how will our courts ever find somebody to fill District Attorney's positions? Personally, I have always felt that if politicians were doing each other, they didn't have time to do me. What to you think?

So back to paragraph one. Recently I had the dubious privilege of taking my daughter to the hospital to have her tonsils out. I had to sign this consent form which was much longer than the paragraph at the top of this letter. Some parts signed away my right to doctor/patient confidentiality, some parts explained that what they do to my daughter may require blood. The only way she could need blood to have her tonsils out is if they screw up. I signed papers saying I was aware that giving my daughter blood could kill or infect her.

I am a responsible, thinking human being and I understand the fact that people only "practice" medicine. I understand the fact that things go wrong, that not every aspect of medicine is predictable. I understand the reasons why the medical profession has to cover their butts when they tell someone "you" need to have your guts ripped out. Now I, as a mechanic, charge \$25 an hour. They charge \$900 per hour. If I was to make a doctor sign the same contract before working on his Mercedes, do you think I would get the job to cut on an inanimate object? I think not.

The medical professionals are "not" experts on accident prevention or road safety, we are! If I am in a hospital, and if I trust the man or woman I am talking to, I trust their best judgment and respect the fact that they are only "practicing" and I accept the risks involved. Most

people whose equipment I work on, including doctors, are unwilling to accept the concept that "I did my best, but your car died of complications, sorry!". So why, if once I'm in the hospital they are only "practicing", I have no guarantees, I am taking my chances. How is it possible that the medical professionals know so much about an area they are not professionally involved with, i.e. motorcycle and road safety, an area we have proved ourselves to be very knowledgeable about. I think the medical professionals have no business dictating our safety issues when they cannot even guarantee my safety once I am in their hands. How did they become such experts at injury prevention when they can't even promise to cure the injury, only "practice"? I think they should stick to their job and let us do ours. If they are such experts on injury prevention, maybe we should sue every doctor who is in charge of a helmeted rider who dies while they "practice".

I've got to wrap this up because my hand is cramping and I don't want to have to have some medical professional "practice" on it. We have a lot of work ahead of us friends, but if we stick together and work hard, we will get there. Faces come and faces go, but if the love of

Freedom of the Road lives on, we live on.


Happy New Year!





### STATE BOARD MEETING MINUTES

December 12th, 1998

Chris Vieira, Coordinator, called the meeting to order at 12:15. There were 13 chapters in attendance, with all eligible to vote.

COORDINATOR'S COMMENTS: This last year has been one heck of a year. When I got involved with ABATE, I never imagined myself in this job. I got involved because everyone need to stand up and protect his or her right to ride. Thanks to all who got involved this past year, and a special thanks to chapter officers, and a welcome to those new faces.

The Keizer chapter has decided to turn in their charter. I am sorry to see this happen, but I also know how much work it takes to keep a chapter going.

CORRESPONDENCE: MRF & NCOM news releases regarding Pennsylvania's helmet repeal passing both legislative offices and sent to the Governor.

### OFFICER'S REPORTS

LEGISLATIVE DIRECTOR: There has been a revision to the dates for BIKER DAYS. The first one is Jan. 22. A handout with information on "How a bill becomes Law". The Oregon Health Policy Institute is forming a committee to study helmet effectiveness. The facilitator of this committee, Eldon Edmondson has asked us to join the committee. Teresa Hepker has agreed to represent ABATE and BikePAC, and will be assisted by Melinda McCrossen. The Dept. of Health requested this study, to analyze existing data and studies, and then draw conclusions, attempting to answer 4 questions. The questions are #1. Do helmets prevent injury. #2. Do helmets increase risk of injury. #3. Are helmet laws effective? #4. Do helmet laws save public funds. The American Motorcycle Assoc. has been consulted and will forward information that they have to Teresa.

Now is the time to e-mail, write or call your Senator or Representative, and ask that they make time in their schedules for the BikePAC lobbyist, and to reserve an appointment time for the first Biker Day on Jan. 22nd.

Information received from Chicago's attempt to ban motorcycles from a portion of a major hwy. Plans are under way to challenge this under the new TEA-21 law forbidding bike bans on hwy that receives federal funding.

BikePAC REP: Make plans now to arrange to attend Biker days. Don't forget the first one is Jan. 22nd.

EDUCATION DIRECTOR: reports received from classes that took place recently. Thanks to Steve Corey, Steve Zentz and Ray Hamilton who presented a class on 5/27. Steve Corey and Jeff Bauder presented a class on 6/8th. STEAM is on track, make plans to be at CHEMEKETA community college on February 20th.







### Oregon Confederation of Clubs Report

I am proud to announce that Oregon now has an official Confederation of Clubs and ABATE of Oregon, Inc. is an associate member of this organization. As an associate member, ABATE has equal input and discussion rights to all member organizations, but no vote on board decisions. Historically, confederations have been formed world wide to fight for civil rights and against harassment, just as our organization was formed to fight anti-biker legislative issues. Over the years, these issues have tended to interrelate as evidenced by our battle with the "what is a legal helmet" war and the related harassment at Fossil and elsewhere.

I am aware that some members of ABATE are apprehensive about this association between ABATE and the clubs. My personal feeling is we all ride, we all suffer the same unfair attention from law enforcement and legislative BS. ABATE of Oregon, Inc. was formed to represent all motorcyclists, not just the "politically correct" as we see it. I think we owe it to ourselves and all bikers to work with this confederation. If it works, we are all better for it. If it doesn't, so it goes. Nothing ventured, nothing gained. Remember everybody, ABATE and confederation members, united we stand, divided we fall.

I want to say right up front that there is nothing secret about the membership or names of the officers in this confederation. I have personally seen the cops over-zealous "protection" at many of these confederation meetings, so I have personally decided I am going to be very careful about printing names of members, officers or meeting locations publicly because I don't want to make our "friends" in law enforcement's job any easier

The meeting was held in Portland at one of the member clubhouse after our November board meeting. Two representatives from each organization were invited. Tina, our Sergeant-at-Arms South, and I represented ABATE of Oregon, Inc. We paid our member donation, as did other Oregon clubs and associations. The meeting was held in a very professional manner and at this time there is only one order of business on the table. The business at hand is the designation of one club member as a "gang affiliate" by the Portland Bureau of Police. If this designation stands, it could influence sentencing if that person is convicted of committing a crime. This designation did not coincide with a with a criminal charge. Once designated as a "gang affiliate", that person has an appeals process available to them, but they would only get to appeal the Bureau's determination that they are a "gang affiliate" not the determination that the club or association is a "gang" or "criminal gang". The difference between "gang" and "criminal gang" has distinctions, but in the police paperwork I have read, they tend to use these terms interchangeably. So far the Portland Bureau of Police has refused to release information telling us how they decided this club is a "gang/criminal gang" organization.

At this point, I will give you their definition of a "gang/criminal gang". Study this and you will see that everyone from the Boy Scouts of America to ABATE of

Oregon, Inc. to the Portland Bureau of Police could be labeled a "gang/criminal gang". This excerpt from the Bureau of Police General Order dated May 17, 1996, section no. 640.05, Rev. #1.

### **Definitions**

- 1. A gang is an ongoing organization, association or group of three or more individuals who:
  - a. Use a gang name, common identifying sign or symbol, or acknowledge an identifiable leadership; and
  - b. Have a high rate of interaction among themselves to the exclusion of other persons or gangs.
- 2. A gang is criminal if individuals affiliated with it have committed two or more crimes which:
  - a. Benefit members of the group;
  - b. Are committed as part of an initiation process or membership ritual;
  - c. Are designed to announce the existence of the gang, its membership, or its territorial claims:
  - d. Are committed in response to the race, color, religion, sexual preference, national origin or gang association of the victim; or
  - e. Are designed to intimidate a victim in the name of the gang.
- 3. A gang affiliate is a person who participates in either the criminal or non-criminal behavior of a criminal gang listed above, or who actively pursues membership in a criminal gang by performing criminal acts intended to gain the approval of the gang.

At this point, the confederation decided to back the effort to fight this discrimination. NCOM/AIM attorneys Sam Hochberg and our own Spencer Neal will defend this "gang affiliate" member Robert Challis. I thank Robert, Sam, and Spencer for taking on this fight.

At the end of the confederation meeting, Tina was honored as the first and only woman anyone could remember being involved in club business. I am proud to have her at my side. She is a true freedom fighter and one of our best, man, or woman. I want to thank Tina's family, my family, and all family members who cover our butts so us active members can be involved. I would also like to thank the confederation members who respect our position that both men and women can be effective members.

After the meeting, I was very proud to get to see the #001 ABATE of Oregon, Inc. membership card in a glass case at the clubhouse. Luke Metcalf was our founding father and a member of this club. It was his card. Small world isn't it, brothers, and sisters.

### New Name, New Home for

### Motorcycle Museum

WESTERVILLE, Ohio - After eight years as one of the country's premier motorcycle showplaces, the Motorcycle Heritage Museum at American Motorcyclist Association (AMA) headquarters is in for landmark changes that include a new name, a new exhibit and a new, more spacious home.

All the improvements will be showcased at the museum's grand re-opening this summer, after staff members relocate the museum from its current home in Westerville, Ohio, to the new AMA headquarters in Pickerington, about 20 minutes from the current location and still in the Columbus metro area. As part of the move, the museum will be closed for several months so that extensive remodeling of the new facility can be completed and the new exhibit can be installed. The museum will close its Westerville location at 5 p.m. Dec. 17, and re-open this summer in the new Pickerington home that offers more than twice the exhibit space — along with new amenities for museum visitors.

"The new museum, complete with vaulted ceilings, plenty of exhibit space spread over two floors and covered motorcycle parking for visitors, will truly be a showplace for motorcycles and the people who have made them great," said Don Emde, chairman of the American Motorcycle Heritage Foundation (AMHF), which runs the museum. "And to better reflect our expanding mission, we'll have a new name in our new home as well: The Motorcycle Hall of Fame and Museum.

"The re-opening will mark a significant step forward for the museum we launched eight years ago," Emde continued. "And we're confident that the new facility – along with a planned addition to the museum that will come sometime in the future – will be a home for history like none other in motorcycling; a place that will honor our heroes, showcase their machines, and

create a direct link to motorcycling's rich heritage and colorful history."

Highlights of the changes:

- The new 25,000-square-foot facility will feature a unique, two-level display area, with magnificent vistas of display motorcycles both up close and looking down from the second-story atrium. The Motorcycle Hall of Fame and Museum, which will include an expanded motorcycle-theme gift shop, will be located in its own building at the AMA's new 23-acre Pickerington campus that also includes a new home for the AMA offices. Included on the site will be covered parking reserved for motorcycles only, and lockers nearby so that museum visitors can stow their gear before taking in the Hall of Fame and Museum.
- The new name The Motorcycle Half of Fame and Museum reflects one of the original goals of the museum board: the creation of a Motorcycle Hall of Fame. With the naming of "The First 124" Hall-of-Famers in 1998, that goal is much closer to reality. The Pickerington facility will include pictures, bios and memorabilia commemorating the achievements of those individuals, while planning continues for a future that will include much more as the Hall of Fame grows.
- The new exhibit to open this summer will be the museum's most ambitious ever. Called "75 Years of Excitement," the exhibit will feature more than 100 machines highlighting the AMA's diamond anniversary. Composed mainly of competition machines, this exhibit will span the years from early board-track racing to the era of night speedway, through hillclimb's dominance and then on to today's Grand National Dirt Track Series, the MBNA Superbike Tour, the Mazda Truck Motocross Nationals and AMA Supercross Series.

"The new facility will truly be world-class," said AMA President Ed Youngblood. "When we have the grand re-opening as one of the highlights of the year-long celebration of our 75th anniversary, I think AMA members and museum visitors alike will simply be awed."

### Trouble in Chicago

Chicago, IL. Wednesday, December 2, 1998, ... Alderman Barbara Holt (5th Ward 773-667-4658) introduced legislation in the Chicago City Council that would ban motorcycles from Lake Shore Drive, from 11 p.m. to 6 a.m. Alderman Holt claims noise and safety are the issues. Illinois ABATE members, including influential council member Alderman William J. P. Banks (36th Ward) decried this blatant discriminatory attack on motorcyclists. Citing Transportation Equity Act for the 21st Century (TEA-21) passed by Congress this year that prohibits motorcycle bans from roads using federal funds, the opposition to this new ordinance is gaining national attention. Not only is this a violation of federal law that could cost Illinois millions of highway dollars, it is also an example of a few Chicago Aldermen thumbing their noses at citizens and the Congress which constitutes reckless use of political power.

Alderman Holt and the co-sponsors are using the safety issue to justify discriminating against an entire class of vehicle users. A Chicago Sun Times article reported ... [Alderman Holt] said there may be a way around the federal protection. The city may not enact a law that applies only to motorcycles. However, if there's a safety issue involved, that negates the restriction. There's a safety issue involved, its noise and safety. There have been fatalities as a result of reckless driving by motorcycles' weaving in and out of traffic, Holt said, declining to cite specifics.

Steve Zimmer, Vice President of Government Relations for the Motorcycle Riders Foundation, said, If safety and noise are the main concerns the city should enforce the laws they already have on the books. Innocent motorcyclists will pay the price for overzealous politicians trying to make a name for themselves. The majority of motorcyclists are law-abiding citizens riding motorcycles that comply with the noise ordinances. Motorcyclists have several options on how to fight this ban. Zimmer stated, We intend to pursue efforts to stop federal money directed at the highway construction projects for the maintenance and refurbishment of Lake Shore Drive. I'm quite certain the majority of the Illinois Congressional delegation that supported the TEA 21 language will be very interested in this obvious disregard of their legislative intent. ABATE will be going to Springfield to revive past efforts to eliminate these types of ordinances.

In addition to the introduction of legislation similar to the federal prohibition of motorcycle ban language, an effort to legislate the elimination Chicago home rule could also be on the horizon. ABATE of IL agreed to hold up on such legislation last year based on the political promise that a previously raised motorcycle ban issue would be resolved through the Chicago administration.

STEAM is on track. The final draft of the program is being given to Gordon at the board meeting to be included in the ABATE newsletter. Murge from Salem Chapter says that Salem Chapter will provide food at the STEAM for the noon meal. It will be at a nominal cost.

Good news to start off: Oregon's Confederation of Clubs is up and running. Bill Bish from NCOM (National Coalition of Motorcyclists, 1-800-531-2424) told me the other day that ours brought the number of Confederations to 32 in 21 states, 2 in Canadian provinces, and several more about ready to form. These are the fastest-growing motorcycle rights activist organizations.

The Confederations are busy fighting for our rights in the courts and against harassment and discrimination, while the rest of us are working in the legislatures to change laws. This is the best teamwork we could ever ask for. We get a two- pronged sword. On top of that, most Confederations, like ours, encourage associate memberships for non-clubs, so that there's plenty of information exchanged.

Now all we need to do is get *ALL* motorcyclists to exercise their right to vote. We CAN put bikers in places of power, all we need to do is vote. Just look at what happened in the Governor's race in Minnesota! Ain't America great?

PORTLAND "GANG MEMBER" WINS! Bobbie Challis, a member of the Portland chapter of the Brother Speed M.C. was sent an outrageous letter from the Police, telling him he's a member of a CRIMINAL gang, as described in an earlier Sack. This case was a high priority for the new Oregon Our Oregon AIM (Aid to Injured Confederation. Motorcyclists) Attorney, Sam Hochberg, represented Bobbie PORTLAND, OR: Sam Hochberg has acquired a copy of the new NHTSA videotape that lobbies the general public about HELMET laws. This is an outright attempt in my mind to set in motion the demise of motorcycling in this country by going around the law that congress passed prohibiting NHTSA from lobbying legislatures. They do make compelling arguments about the value of wearing helmets - but what's far worse, the tape implies that without mandatory helmet laws, bikers will cost the public untold millions because we choose to ride scooters in the first place. The tape is free, just ask NHTSA to send you one. After all, it was our tax money that paid for it.

PENN: From the Internet comes disturbing news that the infamous "Trooper Devlin" won his appeal of the \$400.00 fine for killing Ken Fowler, a biker and family man on his way home, during an ill-advised car chase of a driver with expired plates. His fine was reduced to \$140.00 and I'll bet we'll see him reinstated in Penn's State law enforcement machine before it's done with. I've said before, if it had been me the least I could have expected would have been a sentence for manslaughter. Makes me SICK!

IRVINE, CA: The well known KELLY BLUE BOOK web site car dealers all over the U.S. use has a new section now that deals with the resale value of motorcycles. Time will tell if they run good info on what our scoots are really worth.



### One Active Members Comments on the ODOT Conference October 28, 29 and 30.

I was quickly reminded of why I live in the country. When traffic began to slow from 65 down to '0' at 7:00 a.m. on I-205 at Oregon City. When just two-hour's earlier I had left Oakridge the slow pace of rural America.

The DJ on the radio said there was a 'crash' on the exit to I-84 traffic was slowing. Well it took an hour to get to that exit that ment I was running late for the O.D.O.T. conference. I sure would of like to get there on time — Oh well.

Upon arrival at the Hood River Inn only five minutes late. I found the Orientation room, of course the only remaining seat is right up front. Great entry Black leather jacket, 3 piece suits, starched uniforms and professional dressed people everywhere, as usual you could hear a pin drop. So I seated myself right up front and heard how ODOT spends our tax dollars Federal and State.

First session's start at 10:15 'safety belts', 'communities/youth', 'law enforcement/speed/engineering' and ' impaired driving', which I attended. Seems to me that impaired driving is number one on the hit list. I do think this is an important issue, but it is going to create over policing, ODOT and police agencies across Oregon want to set up road blocks whenever where-ever for seatbelts/D.U.I.I. which they want to lower to .04 in 1999. We thought that roads were our The first thing that I notice was that important issues. motorcycle is not in the vocabulary of the people who engineer roads for ODOT or DOT period. They speak of cars, trucks, trains, pedestrians and mopeds but not motorcycles. I asked if they wished we would just go away and got a good laugh. ODOT is in the process of making signs bigger and brighter, that's a great idea in my book. ODOT is at this time trying a new/old idea that the European's like. The new ideas are

called roundabouts, they are a fancy intersection with an obstruction in the middle instead of a green light. All traffic enters by yielding right of way and drives around until your street is in front of you. Proven fact that more bicycle and moped crashes occur at these intersections. But Salem and Eugene are willing to gibe them a try. Seems cyclist in other countries avoid these like the plague.

With session one out of the way at 10:15 am we have a 30-Then its on to 'New Technology in minute break. Enforcement' this was about photo radar, Red light cameras Photo radar doesn't work in this state on motorcyclist because it needs a photo of your plate, but it only gets a picture of your face at this paint in time. This session ended at noon lunch break.

1:45 sessions resumed. I attended 'aggressive driving - what can be done' I learned at this session that the word accident no longer is used in the ODOT vocabulary. Randy attended 'How to Win Legislators and Influence Legislation' we did not attend 'Mini-Grants that Work' or 'Safety Investment program' this workshop ended at 3:00 p.m.

3:30 and I'm sitting in a workshop called 'Issues of the Maturing Driver' put on by the 55 alive people and the DMV. Scems that age had nothing to do with when you have to surrender your drivers' license. It's your ability to handle a motor vehicle and of course you're physical ability. They'd insulate me from a strength I'll need before my flight is done, and which, for some reason, cannot penetrate their thin transparency.

No, I'll leave the windows in their rack, waste the miles of range they offer, I'll sacrifice their efficiency to mine...Now for the first time, I'm taking a favor from my plane. It makes the Spirit of St. Louis seem more like a partner in adventure than a machine of cloth and steel.'

### More On Concealed Firearms Laws

A big thank-you to Spencer Neal for his excellent article on the possession and carrying of guns in the city of Portland. As a concealed permit holder and as a small-arms instructor both military and civilian, I would like to add some more info and some personal experiences of my own.

First, I would like to mention a few more places that forbid the carrying of a gun with or without a permit. You cannot carry a firearm in ANY federal facility. This includes a federal building or any building use by federal authorities. (You're local IRS office for example), you cannot carry inside a local Post Office branch. Several permit-carrying persons have, inadvertently, carried a concealed handgun into a PO just to check mail and were apprehended. It is also unlawful to carry a concealed weapon on or in any Tri-Met vehicle with or without a permit. There are other facilities that could trip you up such as the Donald E. Long home (Juvenile Lockup Facility) or other incarceration facilities.

ORS 166.250 allows a person, over 18, to possess a handgun (loaded) in their residence, place of business or in a recreational vehicle while it is being used as a residence. No permit or license is required but said individual must comply with ORS 166.270. (Ex-convict in possession). Persons with a carry permit should understand that other 'incorporated Areas' (cities or towns) may have laws of their own concerning carrying concealed weapons. If in doubt, unload you gun as per Spencer's article and ASK. Violations of concealed carry laws WILL forfeit your right to a concealed carry permit and can result in a fine and /or jail time.

I have been riding for over 50 years and have been a serious, lifestyle BIKER for 30 years. On several occasions I have been stopped by police on my Harley while carrying a concealed handgun. We know that a police officers adrenaline is rushing when pulling a Biker over. I cannot understand the reason for the adversarial attitude we are 'encouraged' to adopt toward police officers. I have sensed the apprehension of police when pulling me over and I try to DEFUSE the situation immediately. I inform the officer first that I am carrying a concealed handgun with permit a d I keep my hands on the handlebars!!! Here are some of the replies I have received: P.O. 'where is the gun now?' me, 'on my right hip' P.O. 'ok, just leave it there.' Next scenario: After informing the officer I'm carrying) P.O. oh, what kind of gun do you carry?' me, 'a govt. model .45' P.O. 'do you prefer such a large gun compared to a compact .45? me, 'I really like the feel and balance. I also use it in competition events.' P.O. 'what kind of events?' me 'IPSC shoots and the Place To Shoot Friday night shoots' P.O., 'yeah, with I could get to some of those events.' From this point we talked more about guns and the 2" amendment. This P.O. then said he stopped me for changing lanes several times without signaling. He then said 'it was nice talking with ya. Watch out for the crazies out there.' Then he left WITHOUT giving me a ticked.

There have been other times I was pulled over both on the Harley and in my car. I follow the same procedure and never once has any officer EVER asked me to show my gun or asked to examine it. Do you suppose that I'm doing something right??? Several years ago at Fossil when so many of us ere stopped for helmet checks, I was stopped too because my passenger was wearing a 'beanie' type helmet. I informed the

officer I was carrying and he just said 'ok'. He then went on to explain WHY the helmet was illegal and said that for our won safety we should get a good helmet. He was very polite and pleasant to us. We did NOT get a ticket!!! Do you suppose respect begets respect!!!

I'm sure many will take exception with me on this approach. All I can say is that it has worked for me for thirty years. One officer asked if he could ask a personal question. He wanted to know if the bikers who wore the 1% patch (I do not) have actually killed a cop to get to wear it. He was a very young officer and was told at the academy that that's what it meant.

We spend so much effort to educate the public about how we are really good people and so much effort to educated drivers of our rights on the road. But, has anyone ever given any thought to ask if ABATE might give a presentation at the police academy about what we are really like? Wishful thing I know!!! As an organization AND as individuals we consider police officers to be and adversary and to be treated as such. Of course it all started decades ago I know and we just keep it going with out attitudes. In the long run, we are the losers!!

### Daytime headlight may endanger motorcyclists

Since people are concerned about cars and trucks driving with their headlights on during the day, let's review the subject.

About 20 years ago a law was passed that required motorcycles to have their headlights on all of the time, day and night. It was determined that it would make the relatively small vehicles more visible to auto drivers, therefore they would be safer while using the roads. It seemed that it actually did have some merit and the accident rate between cars and motorcycles started to decrease.

Alone with the safety programs that wee instituted about the same time, Team Oregon Motorcycle Safety Training, and ABATE of Oregon's Motorcycle Awareness Program, the accident rate continued to decline.

Now the current feeling is that if using headlights make motorcyclists more visible, the 'Lets all turn on our headlights and we will all be safer on the road.'

What do you think happens to the motorcyclist? The very ones the law was drafted and passed to protect? They become invisible, just like twenty years ago.

With all due consideration, trucks and cars with their headlight on during the day should be ticketed for it because they are endangering the safety of others who have the same right to use the highways as any other vehicle.

### State recommends daytime use of headlights

Whether it annoys some motorists or not, Oregon state officials recommended that drivers turn on their car headlights during the day.

'Yes we do,' says Stan Porter, coordinator of the team Oregon motorcycle safety program in the Oregon Department of Transportation.

The reason, he adds, is that according to studies in the United States, Canada, and the Scandinavian countries, 'your twice as likely to be seen with lights on that without them.'

Lt. Greg Hastings of the State Police in Salem says the agency 'highly recommends' the use of daytime car headlights even though they are not required by law.

'It increases the ability of other motorists to see you,' he says in a telephone message to the D-H.

The Democrat-Herald asked ODOT and the state police about the daytime use of car headlights after the issue was raised in letters to the editor. A couple of letter writers said they were annoyed by other cars' lights being on during the day.

On Monday, Albany resident Mel Yeager, the safety director of the ABATE motorcycle organization, argued in a letter that the widespread use of car lights during the daytime could endanger motorcyclist because their headlights - required to be on in daytime - would no (not) longer stand out as much.

Thought no studies have yet been done, Porter acknowledges that this might prove to be a problem. For that reason, he says, Oregon allows motorcyclists to use modulating headlights.

State law says motorcycle may use daytime headlights that modulate - from dim to bright and back - between 200 and 280 times a minute.

Porter knows of two makers that equip their bikes with modulation headlights. For older machines, owners can get after market-modulating lights installed for under \$75, he said. The next step for motorcycles may be modulating brake lights, already provided by BMW but not yet legal in Oregon.


As for car headlights during daytime, these trends are at work:

- General Motors equips all its cars with daytime running lights. Now the company has begun to reduce the brightness of the running lights, according to Mitch Putman, parts manager at a Woodburn GMC store and a member of the governor's motorcycle safety committee.
- The National Highway Traffic Safety Administration is said to be pushing for a U.S. law similar to Canada's, which requires daytime running lights, though this could not be confirmed with the Washington agency.
- The use of car headlight not just automatic running lights
   during the daytime is increasing, state officials say.

Further, the state police recommend daytime lights in specially designated safety corridors such as Highway 34 between Interstate 5 and Corvallis in order to reduce accidents.

Porter says ODOT especially recommends the use of car headlights during the day on narrow two-lane roads such as those from the valley to the Oregon Coast.







### 9 SIMPLE WAYS TO IMPACT THE LEGISLATIVE PROCESS

### 1. BECOME A REGISTERED VOTER

In this age of computers legislators will simply input your name on their computer after receiving correspondence. If you're not registered to vote your letter means very little to that legislator. More often than not it ends up in the circular file. Every association should offer its membership voter registration information before each state and/or federal election, ie; why to vote, how to register, and where to vote, or a telephone number your members can call to receive voting information.

### 2. KNOW WHAT LEGISLATIVE DISTRICT YOU LIVE IN AND WHO YOUR LEGISLATORS ARE

Associations should provide each member with House, Senate, and Congressional district numbers on membership cards. Associations should also provide members with an annual Legislative Index that includes; names all state legislators, the district they represent, and their addresses and telephone numbers. Members can look on their membership card to determine the district they live in, and refer to the Legislative Index to locate the name of their legislator and how to contact him. The easier you make it for your member to be involved, the more likely they will write or call when the need arises.

### 3. KNOW THE BILL NUMBER, AUTHOR OF THE BILL, AND THE ISSUE

Each association should recap all bills introduced into their simplest form. People don't want to hear, "SF-222 changes Minnesota statute 1990 section 169.85 subdivision 6 relating to motorcycles and was referred to the Senate Transportation Subcommittee on environmental sub-codes 4 through 77...blah, blah, blah"

Members want to know the bottom line. They should hear, "SF-222 is a mandatory helmet bill that will be heard in two weeks." The more information you barrage your members with, the more likely the important information will get lost in all the really impressive but totally worthless 'mumbo-jumbo' you provided them. You don't need to impress members with everything you have ever heard on the subject. It's a waste of paper and a waste of your members time. Give them the meat and throw away the bun.

### 4. WRITE YOUR LEGISLATOR A LETTER

- A. Be specific and brief. Include the bill number you're writing about, how you want the legislator to vote, your position, and some data to substantiate it, or at least the reason you've taken the position you have. Ask for a written reply stating their position, and/or how they intend to vote.
- B. Don't threaten or intimidate. Don't say you'll have them voted out of office, unless you have the money and clout to follow through. The legislator may be undecided on the issue and a rude, threatening or intimidating letter may send them to the other corner. The legislator could also be on your side, and a negative letter could change his position.

### 5. PHONE CALLS

Use the telephone only for last minute impact. If a bill is scheduled for an immediate hearing and there isn't time to write a letter, by all means call. If you want to phone instead of writing because it's quicker and requires less effort, DON'T! A call does not carry the same impact as a letter in hand. If you phone your legislator, he may be on the way to a meeting, have his mind on the lobbyist standing outside his door, be in the middle of a project, or maybe just having a bad day. Any of these possible distractions could interfere with him giving you and your issue his undivided attention. On the other hand, if you write a letter, he reads it when he can give it his full attention and will then respond in writing, thereby giving you his position documented on paper. (Always useful in the event a legislator makes a commitment and perhaps changes his mind and doesn't want to follow through.)

### 6. HANDWRITTEN VS. TYPED LETTERS

Every association should encourage members to write handwritten letters of possible, or they should type letters on plain white paper. (Personalized stationary is fine, too.) Legislators tend to believe that if you take the time to sit down and write them a personal letter, you are also likely to be one who takes the time to go to the polls on election day and possibly vote against them. A handwritten letter from a concerned constituent often carries MORE weight than a professionally typed letter on your company letterhead.

### 7. PETITIONS AND FORM LETTERS

Associations should remind members that petitions and form letters rarely make a difference. Many times they end up the same place as a letter from someone who isn't registered to vote. Almost everyone has been asked to sign a petition of some sort. Most people will admit to signing a petition without even knowing the issue was, or caring about the petition they signed. They simply sign because someone aked them to. This fact does not go unrealized or unnoticed by the legislator receiving the petition. Petitions are for those too lazy to take time to speak their own mind. An issue that truly concerns you and/or affects your life should be given more time than it takes to scribble your name.

### 8. ENCOURAGE OTHERS TO WRITE

Talk to your friends, neighbor, family, and coworkers about issues besides your own. Talk to them about their position on property taxes, education, the environment, health care, and crime. That way when they see you coming, they won't think to themselves, "Oh no, here comes the helmet guy again." Ask them to write letters supporting your issue and offer to reciprocate on an issue they feel strongly about. Remind them, "the ox that gores me today may be the one that gores you tomorrow." Scratch their back, and they'll scratch yours. There's strength in numbers and numbers ultimately mean power.

### 9. FOLLOW-UP

This is the area which most associations and individuals need the most work. Write your legislator both before AND after an issue has been heard. Thank them for listening to your concerns, even if he voted in opposition of your viewpoint. This keeps the door open in the event another issue comes up in the future that requires you to deal with that same legislator.

Get involved with your legislator when the legislative session is in recess. Most people think a legislator only listens to your concerns when he wants your vote at election time. The reverse is true from the legislators viewpoint as well. Don't contact him only when you want his vote on one particular issue. There's a variety of ways which you can get involved during the off-season, like inviting your legislator to a neighborhood get-together, inviting him to ride the back of your bike in a local parade, passing out campaign brochures, putting together or distributing yard signs, organizing a charity ride in his district for a local cause, etc.

Most legislators will gladly make an appearance in their district. They need to keep their name in the public eye, and need to remain actively visible in the community. Name recognition is politically important, so legislators are quite receptive to requests asking them to attend various functions. They want constituents to know they're out working hard for the people that voted them into office.

### THE BOTTOM LINE...

If you and/or your membership want to get involved in the legislative process, you need to show them how to do it easily and simply. If the process is too difficult or burdensome for YOU, imagine how difficult will it be to convince your members to get involved.


