**ABATE** is a statewide organization with local chapters. Each chapter conducts business according to its own needs, under guidelines established by the state board of directors. The state board is made up of one elected representative from each chapter and state officers who are elected from the general membership. The state board meets monthly. State board and chapter meetings are open to the general membership and the public.

**ABATE** is a legislative action organization and have been instrumental in effecting fair laws concerning motorcycles.

**ABATE** is an Oregon non-profit corporation. Members are active in their communities donating time and materials to the Shriner's Hospital, senior citizens, scouting, Red Cross, Canine Companions, Camp Easter Seals, and other charitable causes.

**ABATE** sponsors fundraisers throughout the state for operating expenses and charitable causes. These events provide people with a chance to get together, have a good time, and share experiences and ideas for the betterment of motorcyclists statewide.

**ABATE** created the Motorcycle Awareness Program for high school driver education classes which is presented throughout the state.

**ABATE** produces public service announcements (PSAs) stressing safety and motorcyclist awareness. The PSAs are distributed to Oregon TV stations.

**ABATE** was instrumental in forming TEAM Oregon, the State of Oregon's motorcycle rider training program. ABATE organized and ran the first mobile Better Biking Program, now offered by TEAM Oregon. TEAM Oregon courses are offered at some community colleges and through the mobile program. Classes are paid for by course fees and a fee on your Oregon motorcycle license endorsement.
