KNOW ALL MEN BY THESE PRESENTS That

a natural person, or if more than one, each a natural person of the age of ~~twenty-one~~ ^{eighteen} years or more, do hereby incorporate the corporation named herein and hereby do adopt, execute and verify, in duplicate, the following Articles of Incorporation thereof:

ARTICLE I.

The name of the corporation is A Brotherhood Against Totalitarian Enactments

and its duration shall be perpetual.

ARTICLE II.

The purpose or purposes for which said corporation is organized are:

(1) To engage in any lawful activity, none of which is for profit, for which corporations may be organized pursuant to Chapter 61 of Oregon Revised Statutes;

(2) Dedicated to Freedom of the Road.

See the Oregon Non-profit Corporation Law, Chapter 61 of Oregon Revised Statutes, which provides that one or more persons may incorporate a corporation under Oregon's Non-profit Corporation Law by signing, verifying and delivering Articles of Incorporation in duplicate to the Oregon Corporation Commissioner at Salem, Oregon accompanied by a filing fee of \$10 and that at least three directors are required; space is provided in Article VI of the form for setting forth any provision not inconsistent with law for the regulation of the internal affairs of the corporation, including any provision for the distribution of assets on dissolution or final liquidation.
