Webster's defines the word organization; 1. An act of organizing or the process of being organized. 2. The state or manner of being organized. 3. Something organized or made into an ordered whole. 4. A number of persons or groups united for a particular purpose.

A.B.A.T.E. is a motorcyclist's rights organization and as such it should fit one of those definitions. It seems to me that the last of those would be the one which describes A.B.A.T.E. The persons being all of it's members and the groups being the chapters. That last one is somewhat of a problem. As a state and chapter officer I often times notice that chapters tend to isolate themselves from the rest of the organization. There are a few chapters that work with one or two neighboring chapters, but beyond that things seem to go awry. There seems to be a number of people in A.B.A.T.E. that treat their chapters as if they are private party groups. Camaraderie and brotherhood are both necessary and admirable but we can't lose sight of our overall purpose - to preserve our rights as bikers! To accomplish any of our goals we need all of the chapters support and participation. When a chapter has no representation at a state board meeting or doesn't seem to care one way or another about A.B.A.T.E. as a whole you can't help but wonder if we have any freedom fighters left in these areas of our state.

Another attitude which takes its toll on the health of our organization is one of egotism amongst some of our officers. Officer burn out is a fact of life in all M.R.O.s but some of it can be caused by the officers themselves. Most of us take pride in doing our jobs well but sometimes that pride becomes a feeling of protection of one's own ego. When this happens a person can become defensive of the job they are doing and develop an attitude of not wanting to be outdone. Potential new officers often times refuse a nomination to a position for fear of a lack of cooperation from the outgoing officer. The person who has experience and knowledge of a job should be willing to share those attributes with the new person and lend their support to help them be better than they were so as to make A.B.A.T.E. better for all of us. I don't expect anyone to change their personality, but try to look at it as when you work a job. There are people that you work with whom you dislike or even hate yet when you are there you put those feelings aside and do your job. Hopefully you became involved with A.B.A.T.E. because you cared about preserving our lifestyle, rights, and possibly regain some freedoms lost along the way. I urge all of you to please try to stay in touch with those feelings and that during the time that we spend doing A.B.A.T.E. business let's put our personal differences aside for the betterment of our organization.

As election time approaches, the attendance of state and chapter meetings becomes increasingly important. Important so that the information about the politicians and issues that will ultimately affect us all will get distributed to our membership. We as officers need to inform our members as to where we stand as an organization, but if we don't get the information ourselves from the state board meetings how can we do that? I know that it's hard, sometimes unappreciated work but none the less necessary. All of our members are important. And we as officers must recognize this fact. Also we must recognize that the organization as a whole is all of us and that without the state organization we all go out of business.

Let's not lose sight of our convictions. Keep the faith sisters and brothers and always remember - Winners Never Quit And Quitters Never Win. Till next time ride safe.

September 12, 1992

The roving meeting was called to order at 12:15 p.m. by Coordinator Roger Hendricks at Eisele's Park in Beull.

The minutes of the August '92 meeting were approved with the following corrections: Pg.2, ABATE Products, chapter rockers need to be ordered in advance through Angle and will take about 6 to 8 weeks to receive; Pg.3, under announcements, Steve Benson is to be removed as a contact person for the Kid's Clothes Program, Trish is the contact person.

Correspondence:

Roger read an article titled ABATE Sleeps While Freedoms are Taken. He will try to make it available in the newsletter. If you get a chance, please read this. We don't want the same thing to happen to Oregon.

Vice Coordinator:

No reports

Public Relations:

Rich talked about Team Oregon's new "endorsement" adds currently being aired, and talked about the new PSAs that he is currently working on. His new theme is "there may be more riding on it than you realize". He is targeting the auto driver awareness level. Watch for this in the near future.

State Run Coordinator:

Permits are taken care of, posters should be here today, need help with security, SE volunteered to work the gate with Joy, games are taken care of. Concessions need to contact Angle and fill out the paperwork. This is a private park. There will be a grounds map with rules on the back and there will be a release that needs to be signed.

Education Director:

Mel and Nick Oliver have been laying the ground-work for a pilot program to teach motorcycle awareness in drivers ed classes. Progress is going well and he will keep us posted. The Salem/Keizer area will be the test area and if successful he will contact the other chapters with information on how to get started. The concentration is on awareness and vulnerability.

Legislative Director:

Steve handed out updated candidates list. Roger showed the California Voters Guide so we could see how BikePAC is formatting our guide showing m/c friendly candidates. At this point we found out that Kraig is running for Mayor of Willamina and Jim Rhodes is running for councilman.

Membership:

Carolyn reported that we have 1309 members as of September 1, 1992. She said thanks for the laser printer, it works great.

Newsletter Editor:

Roger read Donna's report. Two counties had no report for the 3rd time, 1 for the 2nd time, and 1 for the first time. Be sure to send reports to the ABATE P.O. BOX.

She will not be able to continue as editor even if ABATE cannot find someone else to fill the office. She also had a list of skills needed for those who may be interested in being the newsletter editor:

Typing skills - at least 60 words per minute

- Some computer knowledge
- Communication skills, such as writing letters and talking with upset members
- Keeping information flowing in a timely manner
- Creativity willingness to experiment and take the criticism if it doesn't turn out
- Someone who can check their own work
- Someone who can remain neutral when information being turned in may cause controversy. Needs a level head to make the decisions on what should be run and what shouldn't without involving personal opinion

ABATE Products Director:

Angle reminded us again that chapter rockers need to be ordered in advance, and showed us the new "United We Stand" patch and the new screw/helmet pin.

Ways and Means Director:

Kraig reported that there are 8 Fossil T's left (1-M, 1-L, 6-XL) and he still has heard nothing from Gary of Washington County as to how he is doing with the box of color books.

Larry was able to get to the meeting. Still requesting pictures and he has just received some of Archie's stuff.

Treasurer:

Joy reported that through 9/08/92 we have a grand total of \$23,286.76.

REMEMBER: TALK TO JOY ABOUT INSURANCE FOR YOUR RUNS AND BE SURE YOU KNOW WHO NEEDS TO BE THE ADDED OR NAMED INSURED (Joy gave Roger the "added insured" bills to pass out to some of our chapters and she made requests from specific chapters for information that she needs ASAP for insurance to cover your events. Please remember that we now have some new procedures that we need to be following. If you have an event, contact her with questions so that you will not be caught unaware!!!!)

50-50 Drawing:

Don Stephenson won the \$29.50.

Old Business:

Tax Exempt Status:

Roger read portions of the two letters from the attorney. (We have spent approx. \$900 so far) There are still more questions to ask him, but at this point we have found out that we can donate money to hire a lobbyist. We can also hold raffles and do other fund-raising but if the amount is high, we need licenses and ways to document the fund raising. One question we are asking is if the chapter fund-raising is considered a part of the States or Individual-

Rich made a motion that was seconded by Mel "for ABATE of Oregon to donate \$5,000 towards the hiring of a lobbyist jointly with Bike PAC and AMO." After discussion, it passed with a vote of 15 for, 0 against, and 5 abstentions.

We have also been informed that our bylaws only need to be revised concerning the number of directors. Captain made a motion, Seconded by Rich, to "amend our bylaws to read as the attorney recommends". The motion carried with only one abstention.

The tri-fold committee had a meeting just before the board

meeting and went over some of the wording changes. We will be using the old tri-folds until we finalize and print the new version. They are still discussing a couple more revisions.

When Joy gets back we will start getting into our accounting procedures and get a committee going.

Insurance/trikes:

No insurance available if the trike has an automobile motor. 1994 was going to be the cutoff year unless the bike was manufactured. Some have been able to get insurance through their agents, but it doesn't look like it's an easy task.

Awards/NCOM:

Banquet is the 24th of October. Roger collected some of the chapter appreciation lists for the AWARDS Banquet. Bring the list to the next meeting if you haven't given it to him yet. Time is getting short and we need to get these printed. Mike Kopetski will be a speaker. Don't forget that the dinner is \$25.

Meeting of the Minds: Sept. 25-27, 1992. Reports to follow, the only thing we need is the donation check for presentation.

Swap Meet:

Strategic Training:

Roger has arranged for the \$225 Scholarship and people have been arranged to take the classes.

A motion made by Yamhill County which will affect the general membership was voted on today. Made by Jim Rhodes, Seconded by Donna Rhodes: "That 25% of membership fees be returned to the appropriate chapters as an incentive to local chapters to promote membership and give operating capitol to the chap-

The chapters voted and it did not pass. Three chapters were not present, two voted for (Yamhill & Washington), Rivergate didn't vote because they weren't at the last meeting, and the other 7 voted

It was brought up that more members need to start attending the Bike PAC meetings so they stay current with what we are trying to achieve in the political arena. (An idea was brought up that is already being worked on.)

New Business:



North Dakota Motorcyclists Joins The Race For State Representative

In January of 1992 I returned home from Phoenix from a National Coalition of Motorcyclists Board of Advisors meeting with a "what can I do that will help change the situation we are in" attitude. There was talk about getting involved in the grassroots of politics at the meeting. I was familiar with this since I had been a delegate to a District and State Convention in '88. Sherm Packard had run for office in his home state of New Hampshire and won. Randy Benson was running for Mayor in his home town back in Louisiana. But, me run for public office, naw I wasn't cut out to be a politician.

I wasn't home two weeks when I got this letter in the mail advising me that I was invited to a reorganizational district meeting. Our state had redistricted and I was now in District 30 instead of District 52.

The letter got set aside and it wasn't until the day after the meeting that I realized I had missed it. I called the man who had sent me the letter and apologized for not making the meeting. He then informed me that if I were interested I could attend the executive committee meeting the following Monday. I did, and from that day forward I realized we will have to get involved internally or we will never win the fight.

It wasn't long and I was on the Resolutions Committee for the state convention. A resolution is part of the Party Platform. The platform outlines the issues the party stands for. We tried to get

two resolutions passed, only one survived. It's worded as such: Whereas all states are geographically different and populated differently; And Whereas some rights should be left up to the individual states to decide; Therefore we oppose any use of federal funds to force state actions which limit individual rights.

It took a little while, but I finally let the candidate search committee know that I was interested in running for the House of Representatives.

I was able to get enough brothers and sisters to the District Convention that on the first vote on Caucuses we (Freedom of Choice) had the largest group. I am now endorsed by the Democratic Party for the House of Representatives from District 30 in North Dakota and will be on the November ballot.

If we are going to survive, we must get involved politically; we need representation. And as always it takes money to run a campaign. The National Coalition of Motorcyclists was kind enough to throw five hundred dollars into my campaign, plus a couple of hundred buttons that say Elect John "Butch" Olson. Thanks NCOM. It would be nice if all my campaign money came from just my brothers and sisters, so if you've got a couple of extra bucks and can see where I'm coming from, send them to the Butch Olson for House Campaign, 131 Airport Road, Bismarck, ND 58504.

BIKEPAC ADVISORY BOARD MEETING MINUTES September 13, 1992

Meeting was called to order at 12:10 pm at Main Street Pizza, West Linn, Oregon. Present were Executive Director Brian Stovall and Legislative Director Butch Harbaugh, (Treasurer Steve Benson was excused) Bob Hevle, Minda Schober, Dennis Deaton, Don Garino, Gordon Hieronimus, Rod Baker, Tammy Blakeslee, Dwight & Carolyn Hageman, Jack Fassel, Rotten Roger, Steve Dodds, Cindy Harbaugh, Mel & Sharon Yeager, Don Lawson, Teresa Hepker, Lois Gleason and Sam Hochberg. The minutes of June 14 meeting summarized, approved as corrected (Mel & Sharon Yeager were also in attendance at that meeting). Treasurer's report approved as read, and 10% of income approved for MRF. Income for August was \$595.25, expenditures \$963.49, leaving an ending balance of \$2,054.52.

MEMBERSHIP:

Jack Fassel reported that he has received letters from some expired members saying they will not renew because they don't hear anything from us. A motion was passed to mail our meeting minutes to entire mailing list, so our members will know what is going on. Our newsletters have been sporadic. Jack will check with Action Printer regarding their handling our mailings like they do for ABATE, and he can decide whether cost is reasonable. He has labels ready to send out a mailing this week. Teresa, Jack and Brian will work out mechanical details of it all, Cindy will help with preparing the mailing. Our ad finally showed up in Road Rider, got a call from Wisconsin.

TRAINING & GRANT WRITING:

Ed Halkyard will go next weekend for a training course in Portland on grant writing, and is learning about grant funding sources that may be available to us. Other persons to work with Ed are Teresa, Brian and Gordon.

Gordon will attend the Western States Training Seminar for three days next week. Don Lawson will be there on behalf of his other organization. Several other people from ABATE are attending on a group rate, \$60 per day per person. Tammy expressed interest, will check on last minute registrations. Brian apologized for not forwarding the information to her. Roger applied for and received scholarship assistance for the ABATE group.

FUND RAISING:

Poker Run: Lois has obtained AMA rule book and application sheet. Insurance from AMA is \$80. This will be a multi-organization poker run with end site for information booths. Butch offered the farm as an end location.

Lobbyist Fund: ABATE board meeting voted to give \$5,000 for lobbyist, with some stipulations - need a contract showing that it is strictly for lobbying. Further discussion follows later in the minutes.

War Chest: Rod reported that Bob Ingram's idea is that the war chest should be a three-signature account, strictly for fighting the helmet law. Bobby has found that people won't give money unless they know what it's for; and he thinks they will be more likely to donate if they think it's going to fight the helmet law. Butch - helmet issue is not the only issue in Oregon that needs to be dealt with, and BikePAC isn't going to take a narrow approach to legislation. Gordon - The war is to keep motorcycling alive; the helmet issue is

one battle. Brian - people who want to pay for only one part, can be served by establishing sub-accounts within the treasury which can be used only for the specified goal. Tammy - take the issue to the AMO meeting at the end of this month. Mel and Roger volunteered to go.

COMMUNICATION:

Gordon - we can't afford 900 and 800 numbers. Even subletting a service from a company that rents out time is very spendy, and that won't get you a number in the phone book. It's cheaper to use an answering machine and buy a separate phone line. Tammy could get a state surplus business answering machine. Butch and Tammy will check out whether we could buy one that allows the caller to interrupt the recorded message and/or choose between several recorded messages. It was generally agreed the number should be in Salem for quick message changes, especially during legislative session.

HANDLEBAR HANGERS:

Jack has price quotes, but will finish the voter's guide project before going any further.

VOTER'S GUIDE:

Jack has put in many hours on this. The draft must be in the mail tomorrow for Rob Rasor at the AMA, who must see our endorsements before he will okay AMA financial assistance. Jack doesn't know yet how much money the AMA will be willing to commit to this project. The guide will be sent to dealers, ABATE, AMO, any other organizations, Oregon AMA members (2500). If there are other organizations let Jack know ASAP so he can get enough printed. He has 2 more weeks to get the final version done, and needs help with follow-up phone calling to some candidates. October 1 is the target mailing date so that we have enough time to actually get candidates some support, and also the deadline for voter registration is October 14. Brian will help with the phone calling.

SPEAKERS BUREAU:

Mel & Nick Oliver have contacted Salem-Keiser schools, DMV, state police, Governor's Advisory Committee, and others. Objective: to let young drivers to become aware of motorcycles. They have a meeting set with Del Freeman of the Department of Education later in September to show him their draft for their pilot project. Salem-Keizer school district is willing to accept it as a pilot program for driver education classes in the high schools, set to start second semester this year.

After the pilot has been tested, program info will be provided to other groups throughout the state. Because the driver's manual covers bicycles well but devotes only one portion to motorcycles, the program will focus on motorcycle awareness.

Teresa will provide Mel and Tammy with an order form for the new MSF video and presenter's guide on sharing the road. After the pilot program, more funding will be needed. Brian suggested this could be a grant-writing project for Ed.

PUBLIC RELATIONS RESOURCE GUIDE:

Teresa & tammy said, "We're iame, haven't got going yet."

TEAM OREGON INVOLVEMENT:

Concept has not yet been introduced to ABATE Board. Brian will follow up with Rich. AMO has been reimbursing students for four years, Yamhill chapter for two years, some other chapters have done it, too. Brian can provide an article about how to get started as range aides and how helpful this is to instructors during a course. Team Oregon needs a constant influx of new instructors. Not an easy job but needs to be done!

OUTREACH:

Butch has spoken recently with Salem HOG and the Trinity Road Riders.

NCOM CONFERENCE:

October 23-25, NCOM has an international informational network and is sponsoring this conference for ten Northwest and Western states. Friday night will be a leadership round-table led by Swede Matzek, ABATE of Washington. On Sunday, Mike Kopetski will be guest speaker. Pepper Massey on AIM/NCOM; Brian on MSF, Slider Gilmore will bring his "Two-Wheel Trauma" presentation which is designed to prepare first responders at motorcycle accident situations. Only charge will be banquet on Saturday. Sarge will contact EMT's from Portland/Vancouver areas to invite them to attend Slider's presentation. Roger has arranged a band for afterdinner entertainment.

TAX STATUS:

ABATE retained an attorney to investigate ABATE's & BikePAC's tax status and how money can be transferred. The question is not whether BikePAC can hire a lobbyist (that's okay), but how the MRO's spend their money. A PAC is not the ideal way to fund a lobbyist because it is limited in how funds may be raised virtually ruling out Bingo as a funding source. ABATE can spend as much as it wants on a lobbyist but can't give money to CAN-DIDATES. BikePAC can give money to candidates and ballot measures, but ABATE can't. "Political Activity" means giving money to candidates, and this is what PACs are expected to do. ABATE could give money to the PAC for lobbying but this may raise questions in the Secretary of State's office about ABATE complying with the law restricting contributions for "political activity." It may be safer, and cleaner, for MRO's, to pay the lobbyist directly rather than funnel it through BikePAC, while continuing to use BikePAC to direct the lobbyist's activities as it was originally founded to do. Sam suggested thinking about setting up a parallel "BikeLobby" to serve the non-PAC functions and avoid the hassle.

LOBBYIST SEARCH:

Butch's search led him to propose Don Lawson as a candidate for the lobbyist position. Don is one of the original founders of ABATE years ago with Luke Metcalfe, and was involved in first helmet protest runs and the successful attempt to repeal the helmet law. He has a degree in Business Administration, and is pursuing a degree in public relations and communications. He is employed part time by a non-profit organization, doing fund raising, petitioning, rally organizing, and some lobbying. Don answered many questions and asked quite a few of his own, saying, "I am more comfortable being an advocate for something I believe in." He also pointed out that we may wish to utilize his extensive training in other areas, such as organizing and coalition building. Depending on what arrangements we make to employ him, there may be time when he doesn't need to do direct lobbying that can be spent on other useful tasks. The board agreed it would be a good idea to consider possibilities in this area, although our greatest and primary need is for someone to do the legwork in the capitol. Don agreed to provide Butch with his resume, driving record, and criminal record. It was then moved and passed that the Executive Board proceed with paperwork and negotiations with Don to engage him as our lobbyist.

AMA DISTRICT 28 REORGANIZATION PLANS:

Jack reported that the District 28 reorganization committee needs endorsement letters from 8 of the 14 AMA chartered clubs in Oregon in order for the district to come to life. Since BikePAC is one of these, Jack drafted a letter for Brian to sign, and offered BikePAC's services as the AMA legislative director. Jack also offered his services as a BikePAC rep to the District, and will find a

second person to serve as a rep. One idea under consideration is for all district runs to have \$1 charge for District and/or Legislative activities. Brian agreed to sign the letter.

SMSA CONFERENCE:

Teresa reported on the State Motorcycle Safety Administrators Conference she attended in Boston in August. The SMSA goal for the conference was to bring together a diversity of people and enhance the network of individuals and organizations working to promote motorcycle safety in the U.S. Teresa felt the conference was very well organized, met its goals, and was a worthwhile expenditure. This conference did a lot to educate many traffic safety volunteers about motorcycle safety issues. The Motorcycle Safety Foundation has released a new video called "Cars, Motorcycles & a Common Road." It comes with a Leader's Guide to help a speaker use it to make an effective presentation to an audience. The video and guide are available through the TEAM Oregon office (call 1-800-545-9944) for more information) or from MSF (714-727-3227).

ANNOUNCEMENTS:

Sarge described the 1992 Shriner's Toy Run route, which includes a parade down Broadway in ranks of 6. Raffle prize is a 90th Anniversary Low Rider with special paint.

Butch will be going as an NCOM rep to Austin, Texas, on October 3 to do a motivational speech at a rally at the state capitol. His topic will be, "Coming Together."

Steve Dodds - Yamhill County ABATE is co-sponsoring a candidate's fair on September 15. Les Aucoin will be there along with other candidates. Craig Markuson is running for mayor of Willamina, and Jim Rhodes is unopposed for city council.

Mel - Salem Chapter has had Mike Kopetski and his opponent Jim Seagraves come to speak. They decided to support Kopetski and are working with his campaign. Invitations to 9 other candidates in Salem areas, with a special invitation to Jeff Gilmour. If he attends, they will probably support him also.

Jack - State Senator Joyce Cohen, who has been reported as the probable next President of the Senate, had a horse riding accident and is hospitalized with a head injury. Get well cards should be sent to: Joyce Cohen, PO Box 385, Lake Oswego, 97034.

Tammy - AMO needs all organization's 1993 calendar dates by November 1 for inclusion in their calendar. Wiggy was in an accident a few weeks ago, is home from hospital. He would like cards, letters, visits, etc. Roy McClain, Jr., c/o PO Box 1298, Albany, 97321. The blood drive in his name is the biggest Oregon has ever had in one name, with 163 pints donated as of Tuesday of last week, just in Oregon. Wiggy will need more surgeries, keep the blood coming. Reports of donations are coming in from all over the country. If we keep it going, the Red Cross predicts this blood drive will be national news. They are so impressed that they have asked for AMO to promote a blood drive every year, in Wiggy's name.

ABATE Chapters didn't hold candidate forums or take part in the political process. They didn't actively campaign for friendly candidates either.

An ABATE member or two thought about running for the State Legislature but they found the effort to difficult. It was more fun to go down to the bar or to attend biker parties than to campaign. The one who did run was defeated in the primary.

Freedom was lost. Montana elected many pro helmet law candidates in the Primary Election. There is no reason to believe ABATE will work any harder for the General Election. A helmet bill will be passed. Everyone will groan about it, probably hold a totally ineffective protest or two which after all are another good time to party. Freedom to party is the big freedom most people care about anyway.

In a few years motorcycles will be illegal also. They will still allow you to have Harley stickers for the back window of your truck. You can still drive down to the weekly socials and party. No important freedoms will be gone, will they?

This is an update of the efforts to get Motorcycle Awareness into the public school driver's Education Program.


As we are all aware, there are far too many motorcycle accidents caused by auto drivers who "didn't see" the oncoming motorcycle. So, in a recent brainstorming session, Nic Oliver and I were given the task of setting up a program to make young drivers aware that we are out there on the road - that we have the right to share the road - that we are VULNERABLE (not dangerous).

Nic and I have been in close and personal contact with several people in the State Education Program, the Motor Vehicle Department, the Governor's Traffic Safety Commission and others who can be helpful in supporting our cause.

At this time, Nic and I will put together a pilot program that will be introduced in the Salem/Keizer area schools. After working out the bugs in the program we will ask for someone from your Chapter to contact the local high school in your area to do the same thing as we are doing.





QUESTIONNAIRE RESPONSE

Some good ideas and consistent thoughts. First let me say that all ideas, good or bad, are not necessarily those of A.B.A.T.E. of Oregon, but of the individuals that responded.

- 75% attend over half of their Chapter meetings.
- 25% attend State Board meetings, the rest leaving it to their reps.
- +75% are content with meeting time, place and day.
- 95% think Chapter meetings are orderly.
- 80% think State meetings are orderly.

Comments cover language, start on time, keeping control, rushing through parts to get done and a lot of support.

Do Officers listen? This question seems to be answered mostly aimed at Chapters, based on the fact that few answered questions about state as they don't attend. This said -- 75% say yes. The other 25% range from excellent, mixed feelings, half-heatedly and yes yes yes.

Keeping you informed? On A.B.A.T.E. 99.5%. Motorcycle issues 99%. Other motorcycle organizations events 75%.

As to alcohol. Even those that feel it is fine as is, feel that our image is being hurt. It needs to be left to individuals. Stop the emphasis. As adults you have freedom of choice, you can stop at other than scheduled places. Safety and education, promoted and

Do to raise money? Garage sales, carnivals, more poker runs, bike wash, spaghetti feed, greeting cards, kids clothes (logo'd), bike shows, start a business, bingo, Chapter booth at swap meet with donated parts, casino night, women's clothes, aluminum can drive, donation jars in m/c shops and an A.B.A.T.E. swap meet.

Cooperation between Chapters? Seems to be only between two or three Chapters. Centralized cooperation. Most feel good with what they have but think it would be better if it could be a state wide thing.

Cooperation between us and other M/C organizations? Necessary. As to good or bad it was a 50-50 count.

Comments. If not together - dirt, HOG, AMA, AMO, etc. -FREEDOM OF CHOICE is but a thought.

Make the State organization better? Runs, participation, professionalism, recruit non HD, perform duties of office, communicate, stop drinking - start riding, more cooperation with non-A.B.A.T.E., If we are doing our best, accept it, we care.

What's going right? Lots! Obtaining our own lobbyist. The Newsletter (several said so). Getting into PR, TV spots, this questionnaire, keeping us informed, who to write and sample letters, no smoking at indoor meetings and Fossil.

What laws should we be fighting for or against?

For? Guns. Choice on seat belt - helmet. Rider education, legalization of small helmets, legalization of marijuana/medical use, insurance reform, under 21 take riders course and moped to m/c endorsement.

Against? Helmets, FDA regulation, drug testing by employer, DEQ noise testing and any government regs on m/c's. This last includes special insurance, engine size, reflector vests, crash bars, mufflers, and on customs - handle bar height or seat height.

Other thoughts and directions? All issues, not just bikes, to do with personal rights. Attract other types of motorcycles (road, ninja). Change the acronym to reflect the 90's, teach the public (adult and child) about our lifestyle, all chapters pull on same issues, Easyrider rodeo and property. Property for a library, office, phone,

training area and camping. That A.B.A.T.E. gets instructors certified and start training and teaching the motorcyclist point of view. Initiative Petitions? Informed will convert. More PR / more recognition in the press and the community.

The specific statements on chapters will be given to those Individual chapters.

Indian Creek! Want to keep some roving meetings. More positive work with other MRO's. Publish others runs. Keep us informed. The rest of their comments are absorbed in the rest of this report.

I want to thank all of you that took the time to answer. We all will hopefully take these ideas and make something better out of this organization.

A LETTER FROM THE SKIPPER

There are fewer and fewer things gun owners can do for fun these days that are still legal. One of my favorite's is listening to Earl Blumanauer and Vera Katz desperately trying to sound as if they have any differences. But for pure entertainment value nothing beats calling the Multnomah County Sheriff's Department. The sheriff has been sending out a letter to recipients of new pistol licenses and included in the letter is the following information (quoted exactly): "Please be aware that TRI-MET regulations state "No person except a peace officer shall bring or carry aboard a district vehicle any firearm, knife, (except a folding knife with a blade less than 3 inches in length), an explosive device or material or any other weapon." It concludes by saying "If you have any questions please feel free to contact Sergeant Kathy Ferrell at 251-2431."

Well, I did have a few questions now that you mention it, so I thought I'd give Kathy a ring. Kathy is apparently no amateur and she had the good sense to be unavailable when I called. So I spoke to another member of the Sheriffs staff. At about this point I found out that although you should feel free to ask questions, the Sheriff's office doesn't feel any overwhelming compulsion to answer them.

The woman I spoke to made it clear that she really would prefer not to talk to me at all. Apparently she had some things to do which were actually important and answering questions was not one of them. Before she hung up on me, I did manage to sneak in a few quick queries.

For example, I asked, "is this actually the law? I have a copy of Oregon law in front of me and I see no mention made of this prohibition." "Well, no, it isn't actually the law, it's a TRI-MET regulation, we don't know if it would really hold up in court."

OK. Next I asked if there were any enforcement provisions? "I have no idea." What were the penalties? "I don't know."

Were people in other countries being made aware of this rule? "I really couldn't tell you."

Were holders of old licenses being told about this? "I don't know,"

Can I get a copy of the letter? "If you drive out to the Sheriff's office." Can't you just mail me one? "No!"

Why does the county encourage people to use mass transit and then tell them that their rights are void if they do? "I don't have time to talk to you. Goodbye!"

All in all a pleasant and enlightening exchange. Through the help of Senator Bob Kintigh's staff I was able to get a copy of the letter and a copy of the TRI-MET regulations. (The Senator's staff was helpful and informed. I have no idea what they are doing in government.) I read the regulations and felt I should point out another rule TRI-MET has. I am not making this up. In section 28.15 subsection (D) it states: "No person, except a peace officer, firefighter, district employee or emergency response professional shall operate ... a musical instrument aboard any district vehicle." THE DEFENSE OF LIBERTY DILEMMA -ORWHAT TO DO AND FOR WHOM TO VOTE

Recently, Mr. Bert Paul, in an article shared over the new CSC, Inc. bulletin board system (BBS), reminded us of the four boxes used to defend our freedom and liberty:

(1) Soap, (2) Ballot, (3) Jury, and (4) Cartridge.

It stands as self-evident truth that our freedom and liberty must be defended. So how do we proceed in this confusing election year?

First, we must keep in mind that it is only we, the Citizens of the United States of America, rather than the various local, state and federal governments, who are interested in defending the Second Amendment. The Second Amendment exists solely because the framers of the Constitution realized that the governments should not be vested with a monopoly on physical force. The armed citizenry represents the strongest bulwark against foreign aggression, civil anarchy (L.A. and post-Hurricane Andrew Florida and Louisiana), the all too common criminals (for the crucial time before the police can arrive), and against government abridgement of liberty. So what do we do with our four boxes?

I implore all of you to use the first three boxes to the fullest extent possible. Use the Soap Box by ... writing letters to newspapers, magazines and politicians; by supporting firearms education in schools; and by responsibly engaging undecided fellow Citizens in conversation on this subject (don't lose them by being overbearing). Even send money (that's right ... dollars) to pro-gun organizations.

Use the Ballot Box by voting for strongest pro-gun and civil rights candidates you can find. Get others to register to vote. If the pro-gun advocates can turn New Jersey around, who or what can stand against us?

Use the Jury Box when the soap and ballot boxes have proven a little weak or tardy. Remind all of your friends that when they sit on a jury, that they sit in judgement of not only the facts of the case, but also whether or not the law should be applied in that case. No one brought to trial in California, New Jersey, New York City, or anywhere else for mere possession need be convicted. Rebuke and reject the unconstitutional anti-gun laws.

What about the fourth box, the unthinkable box ... the Cartridge Box? It is dread of this fourth box which so motivates me to actively promote and advocate the use of only the first three boxes. However, many people have asked, "When do we use the Cartridge Box? When do we shoot?" Tell them not to worry; tell them, that as in all things, that their government will take care of them in this instance also. Should we fail to maintain our Liberty using just the first three of the four boxes, then the government will advise us by shooting at us first. They will come for our guns, our property, and the very lives of ourselves and our families. For now, all that we should make ready is our soap, our vote, our verdict, and our will.

Remember that throughout history and her story, no oppressed people has ever started a revolution. It has always been the misguided, self-perpetuating government which starts conflagration by violently attacking its own citizens. It happened that way at Lexington 200 years ago and again at Timasora, Romania just last year ...

For whom to vote for President in this election? Many have problems with President Bush, who would have easily had our active support if he weren't such an unrepentant liar on guns, taxes, and civil liberty issues. Combined with an anti-gun Congress of his own party, a President "Slick Willie" Clinton would unleash the Dogs of War upon us. So, instead of wringing your hands over for whom to vote for president, actively champion those Congressional and Senatorial candidates who support the Second Amendment absolutely.

[Editor's note: Although, this is about guns, you could very easily replace the word "motorcycle" in the place of "guns" and the 1st Amendment Rights instead of the 2nd Amendments Rights and see that we face the same problems that gun owners do. We could lose the right to even own a motorcycle if we don't start fighting for our rights now.]



GENERAL GUIDELINES MOTORCYCLE LOBBYIST

Job description: Butch will draft

Interview: committee representing the groups present will interview candidate - goal is to have this accomplished before September 13 BikePAC meeting.

Identified candidate: Don Lawson, currently 1/2 time lobbyist for Oregon Fair Share

Candidate will be asked to provide:

- Resume
- Criminal record
- Driving record

Discussion of employment conditions:

- · How much \$ is required? Will billing be by hours worked. or a retainer for the session, or some other arrangements?
- The lobbyist will work under direct supervision by Butch, and shall be responsible to the BikePAC Executive Board as an employee of BikePAC of Oregon.
- We do not anticipate the lobbyist doing hearing testimony under normal circumstances - this task to be reserved to our own designated representative.
- We expect the lobbyist to report verbally or in writing, on a weekly basis, to Butch, who will generate regular reports to the member groups. Items requiring immediate action will be reported directly to Butch, and will activate the phone tree. It is suggested that BikePAC provide the lobbyist with a pager if he/she is not already so equipped.
- We expect the lobbyist to be available to meet with the Boards of the member groups as frequently as possible, within the framework of his/her schedule. This will give the lobbyist and our members the opportunity to become familiar with each other and work toward a trusting and cooperative relationship.
- Butch will investigate whether it is reasonable and affordable to offer to share office expenses with Oregon Fair Share as a way to smooth the sharing of a lobbyist.

LEGISLATIVE CONCEPTS **EXEMPTIONS TO** MOTORCYCLE HELMET LAW

The State of Oregon shall establish procedures to allow individuals holding a valid motorcycle endorsement to apply for exemption from the motorcycle helmet law, under any of the followina conditions:

- 1. Medical judgement by the individual's personal physician that wearing a motorcycle helmet poses significant health risks for the individual. (Identification procedure: see below.)
- 2. Religious any person whose religious beliefs prohibit them from wearing a motorcycle helmet, shall be exempted from the helmet law. (Identification procedure: see below.)
- 3. Parade individuals shall be exempted from motorcycle helmet requirement while participating in an organized parade. (Identifying procedure: participation in organized parade.)
- 4. An individual riding an antique motorcycle en route to a bona fide antique motorcycle event shall be exempt from helmet requirement - motorcycle must be over 25 years old. (Identifying procedure: Vehicle must be licensed as an antique vehicle, not general-use vehicle? Such bikes typically have much less traffic exposure than general-use bikes, therefor less risk of accident.

IDEAS FOR IDENTIFICATION OF EXEMPTED OPERATOR

- 1. Reverse license plate color exemption code on driver's license. Investigation shall not be a primary reason to stop a vehicle displaying the special plate but if the operator is stopped for any other reason, he/she shall be required to display legal motorcycle endorsement plus exemption code. Problem: older motorcycle license plates are aiready blue with gold letters. Maybe a different color??
- Special add-on plate shall be issued plus same exemption code described in (1).
- Different color zebra sticker: other state use other colors, so this is probably not a workable choice.

LEGISLATIVE CONCEPT STATE RESPONSIBILITY ACT OF 1993

- The State of Oregon shall test and certify all personal safety devices required by State Law. Said testing shall determine whether the personal safety devices comply with standards required by State Law or Administrative Rule.
- Laboratories conducting testing procedures required by this statute shall be located within the borders of the State of Oregon, and shall conduct testing and certification procedures using the standards specified in Oregon Statues or Administrative Rules.
- All certification procedures, testing, and results of testing shall be open to public inspection during business hours.
 - 4. Penalties:

A. Failure by the State of oregon to implement testing and certification procedures by _______ (a certain date will be entered) shall void state law requirements for use of any personal safety device not subjected to testing and certification procedures as set forth in this statute.

B. Oregon retail and wholesale outlets shall sell only such

required personal safety devices as have been tested and certified by State of Oregon testing labs. Violation of this statute shall be a Class _____ infraction (?), and shall be punishable by a fine of _____.

LEGISLATIVE CONCEPT MOPED OPERATOR ENDORSEMENT

The State of Oregon shall require moped operators to have either a moped-only operator's license, or a moped endorsement on their driver's license, in order to legally operate a moped on Oregon's public roads and highways.

Applicants must complete written and hands-on examinations. DMV may at its direction waive portions of the required testing for persons who have successfully completed an approved moped and motorcycle operator training course.

LEGISLATIVE CONCEPTS MOTOR VEHICLE INSURANCE OVERSIGHT COMMITTEE

The State of Oregon shall establish a Motor Vehicle Insurance Oversight Committee.

The Committee shall be composed of Oregon citizens who are not employed in or have a vested interest in the Insurance Industry, and shall reflect a cross-section of Oregon motor vehicle insurance consumers.

Members shall be appointed by the Governor and confirmed by the Senate, and shall serve a maximum of two four-year terms.

The Committee shall be empowered to monitor and regulate Oregon providers of motor vehicle insurance, with the goal of ensuring that all citizens with driving records in good standing shall have access to affordable, reasonable motor vehicle liability/medical coverage.

KiddStuff WHO'S THE REAL PUBLIC BURDEN?

I have always believed Truth and Honesty will prevail. I certainly believe we will prevail in keeping our Freedom of Choice in the Hoosier state. It won't be easy, but if we keep ourselves clean and our stories straight, we will always be able to keep our heads held high.






