
To Scott at D.J.'s, we want to extend our appreciation for allowing us a righteous space and canopy to sell the parts from, thank you Scott!

## State Board Meeting Minutes

March 11, 1995

Meeting was called to order at Lane Co. Community College at 12:10 by Coordinator Rotten Roger. Minutes were read with no corrections. There were 11 chapters in attendance with 4 not present. All chapters present were in compliance with rules of operation.

Coordinators comments -- Things are moving along well legislatively. The legislative buddy system is working very well when it is used.

Correspondence--A letter was read from the AMA thanking us for the donation to the Spartanburg, SC harassment case.

Education Report-- Nic reports that 9 total Motorcycle Awareness classes were given to 238 students. The latest state that has expressed interest in ABATE of Oregon's M/C Awareness Class Format is Hawaii.

Legislative Report—was given by Butch Harbaugh. He reports that this seems to be the year for our push to regain our freedom. In the state legislature the years of working to change opinions of some of the legislators is finally starting to pay off. They realize that bikers are real people and vital to the state economy and sometimes even to their re-election chances. It was reported that fatalities have increased 48% since the helmet law was passed in 1987. This is attributed to young, inexperienced riders who are often under the influence of alcohol. A re-emphasis on rider education and getting ABATE re-involved in Team Oregon (which ABATE started) will be necessary to reduce fatalities. On the federal level there are now 125 co-sponsors for the repeal of the federal blackmail provisions in ISTEA.

Membership Report-- Given by Gordon for Mother. We have 1713 members down 24 from last month.

Newsletter Editor-- Gordon thanks the board for changing the date for the newsletter deadline. This will make it easier to get the newsletter out at the start of the month it applies to. Also in April a two month pin-up calendar will be available. The fax setup for the newsletter is working and available. The times to fax are Monday through Friday from 10:00 am to 2:00 pm. Any other waking hour you must call first to let Gordon get the machine ready. The fax number is (local Portland) 503 254 3259. If you send something for submission, Gordon requests the text to be sent as Courier font in 12 point. This is the type that the Recognition software seems to like the best. Also some photos from the chapters are needed. They should be focused and labeled and also well lit. Either color or b/w is OK.

Products Director- Last years Fossil T-shirts are available for \$5.00. Also the 20th anniversary pins and patches are available for \$3.00.

Public Relations-- Any ideas for new Public Service Announcement videos we can make are welcomed. Also the previous years tapes are being redistributed throughout the state.

State Run Coordinator— T-shirt designs for Fossil are due by the next state board meeting on April 8th. Also all chapters will again be responsible for bringing 2 boxes garbage bags, 2 cans of gas and 2 door prizes. Any medically trained people are invited to let Roger know so we can have volunteers for the first aid tent. Tickets are available now and many chapter reps have them. Any chapters wishing to do concessions need to get with Angie within the next few weeks. Chris Vierra also had a report about the things that caused the SOS run to be denied a permit for the use of land. Their permit was denied for things that reflected poor judgment on the parts of the attenders. Much of this was by non-ABATE members at the run. This brought up the fact that security is a serious business at runs and is necessary for the continuation of the runs that we all enjoy.

Treasurer's Report-- As of 3-11-95 we had \$1471.44 in checking, \$14,650.91 in Savings, \$1844.11 in Legal, \$478.80 in Education, \$1028.34 in Bulk Mail for a total of \$19,473.60. Joy also wanted to remind chapters that quarterly reports are due April 15. (Continue on next page)

We hope everyone is doing their part on calling our Congressmen, and Representatives. Being aware of bills and writing, FAXing, or calling will only benefit you!



Our South Coast Chapter met at Gino's Pizza Parlor on February 19, 1995.







#### GUNNY'S COMMENTS . .

I've been reading some of the stuff that comes across Sam's GIZMOS and its surprisingly interesting, at least to me. Here is some of what is happening in our world:

A Texas State Senator has just introduced a bill in the Texas legislature to REPEAL THE TEXAS HELMET LAW. He says there is no that evidence helmets make motorcycling any safer. I'm sorry, according to all the information I have, I have to agree with him. Educating bikers and the general public about the dynamics motorcycling will save lives. all these United States the five safest motorcycling states states without the mandatory hat

You don't think bikers have bucks to spend? According to news reports there was \$212,000,000.00 spent at the Daytona bike week last year in 10 days. If that's not significant money give it to me and I'll figure out some way to dispose of it.

There was a protest biker run, in Melbourne, Australia recently because there are only 300 bike parking areas in the city and 25,000 biker trips into town each day.

Motorcycling isn't dead in China where 5.277 <u>million</u> motorcycles were built in 1994!

It took 334 police to arrest 13 bikers in Berlin, Germany recently. Three were charged with weapons offenses. The bikers were suspected to be members of "motorcycle gangs".

biker in England sentenced to lose his driving privileges for two years for allegedly traveling at 178 mph on a highway. The charge was reduced after it was proved the bike would only do 160 mph. I don't think I want to travel that fast but I guess some do. You can still expect to pay the fiddler for the dance.

Women in India are having problems with motorbikers riding up close and copping a quick feel and roaring off. Kind of offbeat sexual harassment.

On a more serious note, alcohol still is the major cause of injury and death in accidents for both cars and bikes. We need to get rid of the notion, "it won't happen to me, I just had a couple beers". Booze and bikes don't mix folks. Lets face it. None of us want to go to a friend's funeral because they got drunk and rode a motorcycle. We say don't let your friends ride when drinking yet we continue to rub the public nose in that image.

Motorcyclists in general are perceived to be a bunch of drunks because our scoots are seen in front of bars and taverns. It doesn't matter that we stopped for a soda and a sandwich. It does matter that we rode in on a bike and we are in a tavern or bar where spirits are sold. Would it be too much trouble to park in back or a little farther down the street? For some reason motorcycles don't blend in like Chevys, Fords, and Pick-up trucks do. We can't expect Joe and Jane public to stop looking out for our safety if they continue to believe we are not responsible citizens. LEGISLATION . . .

In Oregon and Washington, DC there are several bills being introduced that will effect us as bikers. We have the opportunity this year to get some things done that will help us all. We won't have the same circumstances in our legislative bodies either in Oregon or the Fed. again for at least five years and maybe not then, according to the folks at BikePAC. The window is open now so lets take advantage of it.

Write those letters and make those phone calls. Join a group or organization that works in the political arena. Just being a member helps us all. Call me for information and I will put you in touch with someone that can help you. Call 503-224-1106 or if its a toll call use 1-800-347-1106 or call my home at 503-777-8410. There is a message machine and I WILL return your call.

Lets do all we can to make our lives what we want them to be. Life shouldn't be like fertilizer and just happen. That makes us vegetables.

Send me your ride and run schedules and I will put them in print. Just remember I need them three months in advance because I write this column a month ahead. Example: I write January for February print so I need your March and beyond schedule. Let me hear

Sam Hochberg of course is our "Home Boy "AIM attorney and I continue to be Chief of Staff for The AIM program in Oregon. Use the same phone numbers listed earlier in this article to let us know when you would like us to talk to you. It's FREE.

#### <u>Secretary</u>, <u>Treasurer</u>, and <u>Membership</u> <u>Reports</u>

Cindy gave a synopsis of the minutes from last meeting. Steve reported that we have a total of \$3,867.72. It is divided between the PAC account (\$270.00) and the business-related account (\$3,597.72).

#### Old Business

#### Oregon Legislation

- 1. Butch told that us Legislative Concepts now have bill numbers but they haven't been printed yet. Once printed, you can get a copy mailed to you free of charge by calling 1-800-332-2313. Butch has been lobbying to get these bills assigned to the Transportation subcommittee because we have supporters on that committee including the chairman, Cedric Hayden.
  - HR.3419 Helmets required only for those under 18 years of age.
  - HR.3414 The State
    Responsibility Act says
    that the state must
    test and approve any
    product or service that
    it mandates.
  - HR.3422 Vendors can only sell helmets approved

by the Dept. of Transportation.

- HR.3421 Medical exemption allowed for those who cannot wear a helmet for medical reasons.
- HR.3420 Penalty for not wearing helmet drops from Class C to Class D infraction (same as seat belt).
- 2. We need bikers at the Capitol every day. So be a legislative buddy and get to Salem and talk to your buddy. And come to Bikers Days at the Capitol on March 17 and April 7. Meet at 10:00 on the front steps. We get a tour from 10:30 12:00. We'll be introduced on the floor of the House of Representatives by Rep. Lonnie Roberts. We should have bike parking available in front. Be there.

#### Federal Legislation

The trip to Washington, DC was a There's a great huge success. article in the March issue of ABATE of Oregon's Newsletter. But for those unfortunate people who don't get that publication (well worth the \$20 membership), here's the "bottom Senate bill S.388 removes the helmet law from the penalties. Senator Hatfield will probably vote with us. He believes in State's rights to decide for themselves. Senator Packwood is undecided. He needs calls and letters. House bill

HR.899 also removes the helmet law from the ISTEA penalties. Rep. Furst is a co-sponsor. Send her letters to show your appreciation. Rep. Cooley is a co-sponsor and а definite Rep. Wyden might go supporter. with us. Send letters and make calls to help push him over the Rep. DeFazio will vote with us and will consider cosponsorship.

Wayne Curtin called Brian with some great news. HR.899 has 110 sponsors....this is wonderful. There 1,250 were bills introduced this session and only 25 have more than 100 sponsors. Of those 25, thirteen are part of the Republican's "Contract with America" so we've got one of only twelve bills with such a large body of initial support. A lot of credit goes to the MRF's efforts to get people from all the states to come to DC, and to those folks who made the journey, and talked their talk and walked their walk.

#### New Business

Butch, Brian, and Teresa attended the Women in the Wind meeting on 3/4/95 to give them information about BikePAC.

The ATV riders were going to be at tonight's BikePAC meeting (which is why we had it scheduled for 6:00) but there wasn't anyone here. Butch said they need to call him because they have major issues pending in the legislature.



## News from Your BikePAC Lobbyist in Salem

as translated from Butch through Cindy

Our Legislative Concepts have been assigned bill numbers. News Update as of March 14: They are now printed and have had their "first reading" on the House floor. You can get your copy free of charge by calling 1-800-332-2313. It's time to write to your Representative and ask them to support these bills now. Next, the bills go to the Speaker of the House, Rep. Bev Clarno, where they will each be assigned to a committee. Once that happens, we'll know who to target our lobbying efforts toward.

HR3419 Helmets under 18 only

HR3414 State Responsibility Act

HR3422 Vendors only sell approved helmets

HR3420 Class D infraction for not wearing helmet

HR3421 Medical exemption from wearing helmet

2/8/95 - Butch met with Rep. Bill Markham (Douglas County). He signed onto all of our legislative concepts as an original co-sponsor. Several people attended Ron Wyden's Town Hall Meetings over the weekend of 2/18/95. Wyden was given a copy of the Motorcycle Guide for Non-Riders and educated about some of our issues. He promised to have one of his staff members get back to us.

2/20/95 - Butch met with Rep. Cedric Hayden who is the chairman of the House Transportation Sub-Committee. He was supportive and promised to get our issues onto the agenda for the Republican Caucus.

2/21/95 - Butch and I met with The Speaker of the House, Rep. Bev Clarno. She is very supportive and took down a list of our bill numbers. As soon as they are printed, she'll hand-deliver a copy to Rep. Bob Tiernan. He is the Chairman of the General Government Committee which is the umbrella over the Transportation Sub-Committee. This will help us get a hearing on our bills. As we left the meeting she said, "Just remember that when I get done with this job, I'm going to ride. I want my face in the wind. And I don't want to wear a helmet."

2/21/95 - Butch, Judd Whitcher, and I met with Rep. Bob Montgomery (Judd's legislative buddy). He is already big on our side. He was endorsed by BikePAC and he sincerely believes the way we do.....it should be an individual's choice.

2/21/95 - Butch met with Rep. Liz VanLeeuwen. She indicated that she would support our bills. She is "on our side", as usual.

2/22/95 - Butch and MaryBeth met with one of Ron

Wyden's staff members (Lou Savage) in Portland at his request. He said that he would contact the Oregon Traffic Safety department for an accounting of how they spent the federal highway funds that they received as part of the ISTEA bill. Mr. Savage said that he would get back to them.

2/22/95 - Butch met with Sen. Joan Dukes. Last session, Sen. Dukes was angry because the police were using the helmet law to harass motorcyclists. She told the Dept. of Transportation to come up with a definition or list of approved helmets. When Butch told her that this had not occurred and that the harassment was as bad as ever, Sen. Dukes got very mad. She took Butch to the Legislative Council and told them she wanted them to write a bill that says "a helmet is a helmet is a helmet."

2/23/95 - Butch met with Lonnie Roberts to discuss the status of our legislative agenda.

2/24/95 - Butch had planned to attend a meeting with Bear and Rep. Terry Thompson of Newport. Unfortunately, Butch had vehicle problems and was not able to attend.

2/25/95 - Butch met with several state officers and other ABATE folks at MaryBeth's house to strategize for the fight in the coming months. Things are happening very quickly. We discussed the following:

- Get legislative buddies. Need to be a constituent. See Action Guide for description of duties.
- 2) Biker's Day at the Capitol in Salem: March 17 and April 7.
- Press conference to announce our legislation (as soon as its printed and ready for it's "first reading").
- 4) Buddy Buttons for legislative buddles. Teresa will look into it.
- 5) Hearing presentation should be multi-people, multi-media.
- 6) Need meetings more often, will discuss at BikePAC meeting on 3/4/95.
- Legislative buddy program needs a state coordinator to keep list of Reps and Senators and their buddies. Publish list in Newsletter. Roger

will ask Max. Each chapter's Legislative Director is in charge of that chapter's buddy program. Keep a list of who is a buddy to whom.

- 8) Publish schedule of Town Hall Meeting in Newsletter. Attend these forums.
- 9) Mon, Wed, Fri are lobby days. Butch will go with you to meet your legislative buddy. He can also make the appointment for you. He will meet you about an hour early and give you a tour of the Capitol. Then he'll go to the meeting with you. It really helps his lobbying effort to be with one of the Rep's constituents at these meetings. He makes it easy and lots of fun.
- 10) Roger and Larry are making the rounds of ABATE chapters in the state to get them motivated and moving. We need to put on the effort now. The time is ripe. Let's do it!!!!

2/26/95 - Butch, Mary Beth, Gordon, Larry, and Patty attended the Salem ABATE meeting.

2/27/95 - Butch checked on the status of our bills (not printed yet) and met with the Visitor's Service folks to plan our Bikers' Days.

2/28/95 - Butch and Darrell O. from Salem HOG met with Darrell's legislative buddy, Rep. Kevin Mannix. Rep. Mannix said that he would talk to Rep. Cedric Hayden on our behalf.

3/1/95 - Butch checked on the status of our bills (not printed yet) and touched base with the Legislative Council and with Janet Atkins who is the administrator for the Senate Transportation Committee.

3/2/95 - Butch checked on the status of our bills (still not printed) and he met with Rep. Lonnie Roberts to arrange for him to introduce us on the floor of the House of Representatives on Bikers' Day.

3/2/95 - Butch ran into Gov. John Kitzhaber and talked about our issues. He gave the governor a copy of our document for non-riders. Gov. Kitzhaber told Butch that he had friends who are members of ABATE in Roseburg. He said he'd read the document and looked forward to discussing the issues with Butch.

3/2/95 - Butch gave an interview to a free-lance journalist.

3/3/95 - Butch gave a presentation at the Lincoln Country ABATE meeting. Special thanks to Rick Rau of R&R HOG for his gracious invitation for Butch to spend the night at his home.

3/4/95 - Butch, Brian, and Teresa attended the Women in the Wind meeting in Albany.

3/4/95 - BikePAC meeting at 6:00 followed by fundraiser for BikePAC Legislative Fund put on by Southeast Portland Chapter of ABATE. A huge thanks to this chapter for their efforts....they raised \$524.00. But it wasn't all roses. Several motorcyclists were stopped and harassed by the police during the poker run portion of the fund-raiser. But we aren't sitting around complaining...we're taking it straight to the Legislature....see 3/8/95 below.

3/6/95 - Butch and Larry Schalk met with Larry's legislative buddy, Sen. Shirley Gold. Sen. Gold has traditionally been supportive of the helmet law. After hearing from Butch and Larry, she promised to take another look at it after she reads our non-rider document. She was especially taken aback by the amount of police harassment we have endured in the name of helmet law enforcement.

3/6/95 - Butch talked with Ed Halkyard about establishing communications with the Governor since Ed lives in his home town and is an associate of his.

3/7/95 - Butch met with Visitor's Services representative Dea Knickerbocker who has been ever so helpful working with Butch to coordinate our Bikers' Days.

3/7/95 - Marty Coon, Butch, and I met with Rep. Patti Milne. She is supportive of our agenda since she feels that safety is a personal responsibility and that the government is out of bounds when attempted to legislate safety. She was impressed with our education programs as an appropriate alternative to legislation.

3/8/95 - Butch met with Rep. Lonnie Roberts and presented letters that were written by the SE Chapter members who had been harassed by the police during their poker run to raise funds for the BikePAC legislative fund. Rep. Roberts was outraged that this continues to happen to us.

3/9/95 - Butch met with the staff of Sen. Greg Walden's office to ask that he introduce us on the Senate floor during Bikers' Days. He agreed to do so. Butch also shared the non-rider guide with his staff and helped prepare the introduction.

3/10/95 - Bills HR3414, HR3419, and HR3420 are printed and read on the House floor......

#### yippee-i-o-i-a!!!!!

3/11/95 - Butch gave a presentation at the ABATE State Board Meeting. Everyone is enthusiastic about our chances for success in this session and looking forward to Bikers' Days at the Capitol.

3/12/95 - Butch and Larry Schalk attended the Salem ABATE meeting to inform them of our legislative agenda. Butch accepted nomination as Legislative Director for this chapter (as if he doesn't have enough to do). He also got volunteers to help with coordination at Bikers' Days. This chapter is really getting on the legislative bandwagon and that's great!!!!

3/13/95 - Bills HR3421 and HR3422 are printed ......... yahoooo!!

3/13/95 - Butch talked to Rep. Lonnie Roberts to strategize for upcoming hearings. He is quite upset about police harassment and will work with us to get our bills passed. He stated that he will "speak with the appropriate people". He said we're doing a great job

and we have a good chance of getting our bills passed.

3/13/95 - Butch talked to the person at the Oregonian in charge of the Calendar of Events and an announcement about our Bikers' Day on March 17 should be in Thursday's paper.

3/13/95 - Butch ran into former Rep. Jeff Gilmore who said we're doing well and to "be persistent".

Well, I know of one very persistent person and when we get the helmets off our heads (which could be soon, if you help), we'll have Butch to thank in a big way. But let's not make him do it on his own. Be a legislative buddy. Write to your Representative. Attend your ABATE chapter meetings to keep abreast of the latest happenings because it's moving at lightening speed. Go to the Capitol on Bikers' Days (March 17 and April 7). Do your part if you want the wind in your hair.

## How are we doing in the Oregon House?

11 Representatives that have Legislative Buddies, which is 18% of the 60 Reps. We need more!!!

And we have 13 Representatives who say they will vote YES on our bills.....22%.

#### Think about this...

It was usually on Fridays and Saturdays that Hype rode his chopper, but this Sunday looked too inviting to waste on suds and the boob tube. A run for the day to Virginia was more in order.

Bidding his of lady a fond goodbye and reminding her to clean up the dog\*\*\*\* on the rug, he put on his mandatory day-glo orange helmet with the emergency

lights on the sides and the face shield with the word Motorcycle imprinted on it in yellow phosphorous. Then he headed for the shed, buttoning up his mandatory steel-mesh safety jacket which also had Motorcycle on the back in two-inch day-glo. He couldn't find his good pair of mandatory slide shoes (steel-lined and orange), so he had to use the red ones. Ever since they'd enacted the new 1976 cycle laws he'd been feeling slowed down a touch, for some reason, as if he were weighted down. Funny...

Making his way to his ride, a good ol' '75 Sportster with the new AMF oriental engine casing unit and oriental seat and tires, he inspected the mandatory siren-and-light sissy bar and lifted up the mandatory precautionary telescopic rear flag in hot-red with orange letters and cycle emblems (also in day-glo) on it, and locked it in place.

MAKE THAT DECISION.....



Greetings from the riding brethren just north. At the request of Gunny Hutch, Butch Harbaugh, and Brian Stovall, I thought I'd drop in and spread the legislative word from Washington. There has been a great deal of confusion as to the legal status of our "Helmet Law", (in lieu of the June decision), and rumblings in Olympia this year. Before addressing the above, a personal note.....my lid is off to all of you from Oregon who took the time, expense, and effort, to come up here over the summer/early fall, and fight helmet tickets. Statewide the dismissal rate continues to be very high. I hope you were successful also. If any of you have tickets pending, and care to venture up to a judicial hall and challenge, please know ABATE of WA will help in anyway possible.

Last the 3rd District Appellate June Court(Spokane) found our "Helmet Law" to be unconstitutionally vague, and in violation of the 14th Amendment. This decision stands, but in no way opens the freeways of choice. Within days, under advisement of the State Attorney General's Office, the WSP issued an "emergency rule". Their answer to the Appellate Court's order to rewrite the WAC, or helmet standards. Under Washington law, the WSP was requested to hold a public hearing prior to the "new WAC's" permanent adoption. Public notification was carried out in whisper tones, and had it not been for some diligence, the riders here would have missed it. However...the word got out, the WSP was treated to five hours of testimony, and then promptly did as expected: adopted the "new" WAC. From June thru October the WSP unilaterally enforced the "Helmet Law". October thru the present has seen law enforcement once again stop riders not wearing helmets. Between June and October, hundreds of riders challenged tickets in court, and won. Washington currently has a jambalaya with it's helmet statute. Superior Court Judges rule the law unconstitutional, and find the WSP not in compliance with the 3rd District Appellate decision. One county, Benton, (the Tri-Cities area) is now a "helmet choice" zone.... thanks to the work of Ed Alden. We continue the battles in the courts, not only rider by rider, but Marty Fox & Ed Alden have a statewide case pending in Thurston County(Olympia). Our "LID LAW" is a definite "stay-tuned" situation.



Of course the final answer to all this is legislative. Knowing this we took our first helmet bill to Olympia this year. HB1408 would do the following: require mandatory use age 21 and under, remove all regulatory and interpretive powers from the WSP and simplify the definition of "antique" motorcycles. There is other clean-up language included, but this is the thrust of the bill. After many hours at the Capitol, it became apparent(much to our surprise) that this bill had a serious, and genuine support. It did not take the WA Traffic Safety Commission,(WTSC) long to see that either. They exerted considerable effort in planting ISTEA fears among key House Committee members. It worked...

In the home of the infamous Harborview Study, ISTEA brought the curtain down. The WTSC was aware if given a hearing, this bill might....would....pass! We would be there to refute the ISTEA dilemma. The current political climate along the I-5 corridor(with the possibility of toll-roads looming), would not allow a chance to a bill that might put "Federal Highway Dollars Lost" in the newspapers. No hearing this year for our bill, however a formal request has been made to the Transportation Committee...for a presentation on this issue...to be made during an interim work session. HB1408 will also automatically carry over to next year. We'll be right back down there...

ISTEA necessitated a trip to Washington D.C. As Butch will tell you, one delegate, namely me, went grumbling all the way to the airport. He will tell you that I was unsure if we could be effective, nothing moves quicker than a snail's shell on the federal level, etc..blah,blah, and all the other neurosis one finds in legislative junkies this time of year. But as I learned long ago, Oregon has persuasive people. Two of us went from WA, and I'm pleased to say 7 of our 9 Congressional Representatives have signed on to HR899. We're working on the Senate side.

My appreciation to Gordon Hieronimus for giving me room in the Newsletter. Gratitude and excitement for all of you in Oregon. We all are watching and waiting with optimism the legislative events in Oregon. Someone well known keeps saying, "It's the year of the BIKER." He could be right.....

# How An Idea Becomes LAW



### " BIKER DAY "

BikePAC of Oregon sponsored "Biker Day" at the Oregon State Capitol on March 17, 1995. "Biker Day" was organized so that Bikers throughout the state could better understand the legislative process and to familiarize

themselves with their State Capitol Building.

Many motorcycle organizations were represented, ABATE, AMO, HOG, OVMA, GWRRA, and others. ABATE members from the Portland area met at the Union Oil 76 Truck Stop in Aurora and rode as a group to Salem. The Capitol Building is currently undergoing repairs to the rotunda. Butch Harbaugh was able to get permission to use part of the construction zone directly in front of the Capitol Building for motorcycle parking. Teressa Hepker and Brian Stovall distributed Biker Day Buttons. There were special buttons for the people that have volunteered to be a Legislator's Buddy. As the Bikers came into the Capitol, they were directed to the Bill Room so that they could get their own copy of the Oregon Legislative Guide, and the Bills of interest to motorcyclists; H-3414, H-3419, H-3420, H-3421, H-3422.

The Bikers were first shown a video "How an idea becomes a law". We were then taken on a tour of the Capitol that included a stop at the House of Representatives. It wasn't until we filed into the gallery above the House floor that I realized how big of a group we were! Every seat was filled with a few people left standing! (The House gallery holds approximately 150 people) We were then introduced to the House by Rep. Eileen Qutub (R-Beaverton). I think the Representatives were very impressed by the size of our group. The next stop on the tour was to the Senate Chambers. The Senate had just adjourned but Sen Greg Walden (R-Hood River) was on hand to answer questions. (yes, Sen. Walden favors freedom of choice for adults) Next was a stop at the Governor's Office. This office is used for ceremonial purposes only. While we were there the Governor dropped by to take pictures with four young ladies representing a local festival (I don't remember what festival) and the women presented Governor Kitzhaber with a wooden sculpture produced by a local artist. This concluded the tour so we thanked our guide Dea and went to lunch.

After lunch I decided to try and see my representative Kate Brown. I went to her office but she was not back from the morning session. I spoke to her aide Joseph Martorano and to my surprise, he remembered me from our phone conversations in September. I talked to him about the legislation that was introduced by the request of BikePAC and asked if he would speak to Kate Brown about them. Then the door opened and Kate Brown walked in and I introduced myself. I was pleased to know that she also remembered me from our previous conversations. She said she thought I might be among the group of Bikers that was introduced to the House. She said that it was wonderful that we had taken the time to visit the Capitol and it was also great to see the beautiful bikes outside. We discussed the bills at great length and I went through the Oregon Motorcycling Issues publication with her. She seemed very interested in the accident statistics and was not aware of the harassment that we have been confronting. The meeting lasted about 30 minutes and I think I left her with a new perspective on our issues. I asked her to please contact me or Butch Harbaugh if she has any questions about motorcycling issues.

What did we accomplish with "Biker Day"? I think we left the members of the legislature with a positive immage of "bikers" and I think we gained respect for our ideas and ourselves. I was told that our group was one of the best informed, attentive, and well-mannered groups ever to visit the Capitol. EVERYTHING was positive that day. It felt like there was electricity in the air. Our legislators DO pay attention to their constituents, especially when they take time

from work or other important activities, and visit the lawmakers on their own turf.

Thank you to the motorcyclists who, on short notice, realized the importance of attending "Biker Day". Once again we will ride free in Oregon and it will happen through the efforts of dedicated individuals like you.

For those that could not be there March 17, all is not lost. You can be part of an even bigger "Biker Day" on April 7, 1995.

Let me close with these words from Theodore Roosevelt.

"The credit belongs to the man who is actually in the arena, who gives valiantly, who knows the great enthusiasm and the great elation and spends himself in a worthy cause. Who, at best, knows the triumph of high achievement and who, at worst, if he fails, at least fails while caring greatly, so that his place shall never be with the cold and timid souls who know neither victory nor defeat."

#### LETTER WRITING TIPS

Don't hesitate to write

to your legislator if you have something to say that you think should be called to his attention.

Letters from constituents, which arrive every day at a legislator's home or office, are one of the best indications of what the voters are thinking about.

Thoughtful, sincere letters on issues that directly affect the writer get the most attention. Such letters are often quoted in committee hearings or in debate.

BE BRIEF	Write about one bill or issue at a time. Keep it short and to the point. A one-page letter will surely be read and is always the most effective.
BE LEGIBLE	If your handwriting is legible this is the best way to write your letter. You might write a draft first, then make a second copy to make it neater and shorter.
	If your handwriting is not easy to read, use a typewriter or ask someone else to write as you dictate, then sign the letter yourself.
BE POLITE	Show respect even if you feel the politicians don't respect you. Avoid being threatening, demanding or abusive. It's an immediate turn-off. Be courteous and reasonable.
BE NATURAL	Use your own words. Legislators are sensitive to grass-roots opinion, and they want to know what you think. Your honest, straightforward communication counts.
	Tell the legislator how a bill will affect you. Will it affect your income? your quality of life? do you think it intrudes on your privacy or your rights as a citizen? is it based on wrong information?
SAY THANKS	Write when your legislator does something of which you approve. They hear mostly from people who are against something, and that gives them a one-sided picture of their constitu-
	ency. A note of appreciation will make your legislator remember you favorably next time you write.
CONGRATULATIONS	Winning an election is no easy task. Congratulations from you will also help your legislator remember you in a good light.

Like the "right to vote," you have the "right to write." LEGISLATORS SPEAK FOR YOU.

You elected them, so you have the responsibility to tell them what you think. Send them a message, so the next time you vote, they can't say they didn't hear from you.

buying rolls or books)

SOMETHING TO WRITE ON Bring clipboards, tables with chairs, or any surface smooth and sturdy enough to write on

WHO TO WRITE TO Have a list of the legislators you want letters to go to. Include complete addresses. Make

sure names are spelled correctly.

WHAT TO WRITE ABOUT Have a list of current issues/bills, position papers, action guides, and newsletter articles on

hand for reference. Discuss the subjects before letter writing begins.

LEGISLATIVE DISTRICTS State legislative director/committee should obtain maps and directories of legislative dis-

tricts, for each local chapter, from the Secretary of State/Elections Board. These materials

should also be available from County Clerks/Elections Boards.

SPELLING Have a dictionary on hand.



# Capitol Hill-How to Use It Like a Washington Lobbyist

Capitol Hill, or Congress, the legislative branch of the government, is just beginning to be used as a source of information. Very few people have been aware of this treasure trove of unpublished data. Over the years, the Congress has probably held investigations on any topic you can think of, with experts providing their opinions. The documentation for a given committee or subcommittee hearing provides an unmatched reference source for anyone researching current events or other topics.

The information available from Capitol Hill can be used to serve two ends: to monitor legislation, and to investigate a specific topic. Here is a brief outline on how to use this information to achieve both these purposes.

### Monitoring Legislation

The best source for determining if there is specific legislation pending in a given area is the Bill Status Office, Capitol, Washington, DC 20515/202-225-1772. By searching a computerized database, this office can provide you with the answers to such questions as:

Have any bills been introduced covering a given topic?

What is the status of a given bill?
Who sponsored the bill?
On what date was it introduced?
What committee and subcommittees have held hearings on a given bill?
What other bills are similar?

You must provide a key word for the subject you want searched. It is most likely that the legislation you are interested in is pending before a given committee or subcommittee. Armed with the name of the committee provided by the Bill Status Office, you can contact those on it directly in care of: Senate, Capitol, Washington, DC 20510/202-224-3121, or, House of Representatives, Capitol, Washington, DC 205157202-224-3121.

Once you have reached the committee in question and are able to talk with the staff person covering your bill, you are now in a position to obtain the following information:

A copy of the bill

A copy of any hearings held on the bill

A description of where the bill will go once it leaves the committee

An analysis of the likelihood of the bill moving out of the committee

An estimate of the time involved for the bill to move out of the committee

If your bill is scheduled for action on the floor of the House or Senate, you can monitor its activity by the hour by listening to the recorded messages heard on Cloakroom numbers. It's like being on the floor of Congress yourself. The numbers are:

House of Representatives Cloakroom Republican/202-225-7430. Democrat/202-225-7400. Senate Cloakroom Republican/202-224-8601. Democrat/202-224-8541.

### Investigating Topics

See "Senate and House of Representatives Committee Hearings."

The federal government is the world's largest storehouse of little-known sources of information, expertise and benefits—and Members of Congress are an important key to this treasure chest. A call to the local office of your congressman or senator can often save you from the many pitfalls that keep people from taking advantage of government resources, e.g., they don't know what's available, they don't know where to look, or they get tired of fighting the bureaucracy and give up.

Most Senators have several offices throughout the state to help constituents with individual problems. In addition to asking your Senators for assistance, ask your Representative who also has one or more district offices. Instead of making a long distance call to Washington, D.C., usually you can get help in the city where you reside.

While the Member's staff in Washington, D.C. essentially works on legislation, the home offices are primarily set up to provide assistance such as help with the Social Security Administration or government student loans. These so-called "case workers" try to resolve problems at the state level but sometimes refer difficult cases to the Washington staff. Although the quantity and quality of the service will vary from office to office, it is still worth your effort to contact them.

### California EPA Developments

Pending court approval, plans to make California's already stringent emissions standards for motorcycles even stricter appear to have been put on hold.


The decision, which follows an agreement reached between the U.S. Environmental Protection Agency(EPA) and members of the Coalition for Clean Air and the Sierra Club, is likely to have a significant impact on both road and off-road motorcycles sold in the state.

Originally, the EPA had planned to establish new clean-air regulations that would have applied to all motorcycles sold in California after 1995. Industry sources speculated that the new regs would effectively ban the sale of two-stroke off-road motorcycles and likely require the use of catalytic converters on street bikes in the state.

Under the terms of the agreement, California officials now will have two years to develop an alternate clean-air plan that will replace the sweeping changes proposed by federal officials. More importantly, the delay will give the motorcycle industry additional opportunities to help shape the final regulations.

"The real significance of the Federal Implementation Plan(FIP) delay," noted a memo circulated within the industry, "is not in the additional time provided for compliance, but on the focus and commitment for completion and implementation of a California States implementation Plan which will replace the FIP when approved. The motorcycle industry has worked closely with the California Air Resources Board to retain current motorcycle emissions standards in the State Plan."

The agreement must still be approved by the U.S. District of California. But that approval is considered likely, putting the two-year delay into effect.



### FIGHTING MANDATES

It seems motorcyclists are always trendsetters. We were seeking out "Blue Highways" long before William Least Heat Moon. We were wearing leather before MTV. And we were way out front on the latest fad to hit Washington D.C.: opposition to unfunded federal mandates.

We didn't invent the term "unfunded mandates," which is being used to describe the process by which the federal government orders states to institute programs without coughing up any money to help pay for them. We called that process federal blackmail. But it's the same thing. And we've been fighting this battle for years, particularly when it comes to one issue--mandatory helmet laws.

Late in 1991, the U.S. Congress passed a major transportation bill that included a mandate intended to coerce states into enacting helmet laws covering all road motorcyclists. As with so many other mandates, the federal government didn't offer to help with the costs of enforcing such a law. In fact, using federal highway construction grants as a club, the federal government actually worked out a way to punish states financially if they refused to pass mandatory helmet laws.

When we said that was unfair--that the federal government had no business blackmailing the states into passing traffic laws--we looked a bit like David facing Goliath. But three years later, it now seems that the notion of state sovereignty is becoming popular again; and motorcyclists aren't the only people tired of having their decisions made for them on Capitol Hill.

In early February, the House of Representatives overwhelmingly approved legislation that would prevent the federal government from enacting unfunded mandates directed at the states. The Senate passed a similar bill earlier this year. This legislation, if signed into law by President Clinton, would affect only future federal programs, so it would not repeal the helmet-law mandate. But it does indicate an important change in policy in the nation's capital.

"It means we're taking a great step back from the arrogance of Washington, D.C.," says Rep. Deborah Price (R-Ohio), a supporter of the bill. And it appears that this trend isn't likely to end there.

"Our job now," says Ohio Gov. George Voinovich, "is to convince Congress to reassess existing mandates, which drain our resources and prevent us from providing the services that our constituents pay for with their hard-earned dollars."

Ohio is one of 25 states without a helmet law that meets the federal requirements. The others are: Alaska, Colorado, Arizona, Connecticut, Delaware, Hawaii, Idaho, Illinois, Indiana, Iowa, Kansas, Maine, Minnesota, Montana, New Hampshire, New Mexico, North Dakota, Oklahoma, Rhode Island, South Carolina, South Dakota, Utah, Wisconsin and Wyoming. Since last October, those 25 states have been penalized for their non-compliance by having a portion of their highway construction funds diverted into other programs.

But help may be on the way in the form of legislation to dismantle unfunded mandates that are already in place.

On February 10, Rep. Don Young (R-Alaska) introduced H.R. 899, a bill to repeal the federal helmet law penalties. He recently circulated a "Dear Colleague" letter to other members of Congress in which he began gathering support for that repeal.

Rep. Scott Klug (R-Wisconsin) has hone one step farther. He has introduced a bill the he calls the States' Rights Empowerment Act of 1995. This bill, designated H.R.607, has a broader target.

"The legislation," says Klug, "would do away with federal regulations that blackmail states to implement laws governing the use of motorcycle helmets and seat belts, mandate minimum speed limits, and set 21 as the age for legal drinking.

"It's time to move away from the 'papa knows best' form of governing at the federal level," he adds. "I strongly believe the decision-making authority should be returned to the states."

Klug says he is not opposed to the intent of these laws, but he feels that the use of millions of dollars in highway construction funds to pressure states into doing the federal government's bidding is unfair.

"Wisconsin would lose \$26 million if it failed to comply with these laws," Klug notes. "I am confident

that if freed from this financial blackmail, each state's officials would use their own judgement to evaluate the merits of each of these proposals."

Sen. Ben Nighthorse Campbell(D-Colorado), a longtime supporter of motorcycling issues, echoes Klug's views. In a speech on the Senate floor introducing a bill that would relieve states of the burden of complying with the federal helmet mandate, Campbell drew a distinction between the merits of helmet use and the issue of federal blackmail.

"Mr. President," he said, "let me be clear. I am not opposed to people wearing helmets. Quite the contrary. What I am opposed to is the federal government blackmailing states to pass laws. It simply is not good policy to force states to funnel funds from one state transportation activity to another. It should be pointed out that the money the federal government wants to redirect is tax revenue already paid by state residents."

Campbell's bill, designated S.234, would exempt states that do not have mandatory helmet laws from federal penalties as long as those states have motorcycle safety programs in effect. The bill would also delay the effective date of the federal penalties to allow states to develop safety programs.

In addition, Sen. Bob Smith(R-New Hampshire) has introduced a bill, designated S.360, that would repeal both federal helmet and seat-belt mandates. And freshman Sen. Olympia Snowe(R-Maine) is putting together support for her helmet-mandate repeal bill, S.388.

"State governments are closer to their citizens than the federal government is to its constituents," Snowe explains. "Surely, these democratic institutions understand the best interests of their citizens on this issue, and the federal government should respect their decisions."

With all this talk about limiting the federal government's power and repealing federal mandates, Congress is beginning to sound a little like a meeting of motorcyclist rights organizations. And we wouldn't be surprised to hear a congressman or senator take the floor sometime this session and utter the words many helmet-law opponents have been using as a slogan for years:

"Let those who ride decide."

merica: I love this place!
Not only do we have the
greatest country on earth, but
also some of the most inventive people
you'll ever meet. Take Bill Ruger Jr.
and Rick Gray, for instance.

Bill is president of Sturm, Ruger and Company, a gun manufacturer based in New Hampshire and Connecticut. Those two states don't have helmet laws covering adult motorcyclists, and that apparently doesn't sit well with Bill. So his company enacted its own helmet law: It denies health insurance coverage to employees injured on motorcycles unless they were wearing helmets.

What if the rider is blameless and obeys every traffic law? What if the motorcyclist is hit by a driver who runs a red light, or has been drinking?

Tough luck, Ruger says. Should have worn a helmet.

Now, I like helmets, and I always wear one when I'm riding. But this is insurance discrimination, plain and simple. Especially considering that Ruger doesn't require car-driving employees to wear seat belts to qualify for insurance.

If you've read our letters section lately, you've seen a lot of reaction on this issue. Many of you have been outraged that a gun maker would discriminate against an activity based on its perceived risk, and some wonder how Ruger would react if motorcycle companies cut health benefits for employees injured while hunting.

Bill Ruger has been inventive in his responses. First, his company sent out a letter from a guy who said he was a motorcyclist and a Ruger employee. He allowed as how Ruger "was really trying to work with us on this." How? By handing out the telephone number of

the New Hampshire chapter of a head injury organization.

It was creative PR, but you didn't buy it. This is about insurance discrimination, you told Ruger in your letters, not about helmets.

That wasn't the only thing you said you weren't buying. Individuals, clubs and entire police departments wrote to Bill, pledging not to purchase Ruger guns until he began treating motorcyelists like other employees.

The pext letter Bill sent was addressed to me. Again, he tried to turn this into a debate about the effectiveness of helmets. We printed part of his lengthy letter in January, and asked him to explain why car drivers who don't use seat belts, drunken drivers and people who eat fatty foods all qualify for coverage under Ruger's insurance plan, but law-abiding motorcyclists don't.

Your letters continued to arrive. So in his latest attempt to quiet the storm, Bill is sending out a form letter that claims we didn't print his letter. Read that January issue again, Bill.

Ruger is also taking a new tack with his latest mailing. He's dropped the shell games about helmet effectiveness, and is now telling the truth: Sure, this is discrimination against motorcyclists, but by God, that's Ruger's Constitutional right.

Here's how Bill puts it: "We believe in the freedom to make personal choices and the non-intervention of government into insurance issues; but we cannot be expected to insure

all our employees for every conceivable enterprise that they may wish to undertake."

In short, it's horrible if the government screws you, but it's OK if your company does. Safe choice, Bill. Since this isn't a government policy and you aren't an elected official, there's no way we can vote on

Or is there?

Enter Rick Gray, the AMA's newest trustee. Gray was meeting with AMA, ABATE and Motorcycle Riders Foundation members recently when they came up with a brilliant idea.

Sturm Ruger, you see, is a publicly held company, with shares traded on the New York Stock Exchange. And a stockholder with even one share of stock is entitled to attend Ruger's annual meeting, vote for the board of directors, and publicly question the officers of the corporation.

Rick bought some shares in Ruger. So did Rob Rasor, our vice president of government relations. Both plan to attend Ruger's annual stockholders meeting May 19 in Phoenix.

You're welcome to join them. All it takes is a single share of Ruger stock.

Can't make it to Phoenix? No problem. You can assign your vote to a proxy, like Rob or Rick. You'll find all the information you need in our story on page 62.

I sure hope Bill Ruger has special motorcycle parking set aside on that day. I suspect he'll need it.

### FLIRTING WITH THE IMAGERY

n February, we published a story entitled "Caught in the Crossfire," documenting a resurgence of outlaw motorcycle gang activity in the United States. Our story noted that an outbreak of gang violence during the summer of 1994 resulted in several killings and prompted a reaction by law enforcement agencies over half the nation.

The increased visibility of these outlaw groups has already had a direct and adverse effect on responsible motorcyclists, and many fear that media treatment of these events could propel us back to 1947, when a motorcycle event in Hollister, California, took an ugly turn. Life magazine's coverage of that incident indelibly tarnished motorcycling as an activity for drunks, misfits and destroyers of public property.

Just about the time we were exploring this unpleasant subject in American Motorcyclist, the major motorcycle manufacturers were releasing their 1995 advertising campaigns. One of the new ads carries the headline: "You don't have to cause trouble. Just look like you're capable of it." The copy for the ad goes on to say, "Just once, wouldn't it be cool to ride into town and have the sheriff look at you and mutter, 'Better keep an eye on this one.'"

Cool, indeed! Just like the couple we wrote about who found themselves staring down the muzzle of a policeman's shotgun after innocently riding into Hackettstown, New Jersey, last summer in the wake of a shooting at a motorcycle event. They must have looked "capable" of causing trouble.

Another ad presents a dark and gloomy picture of a motorcycle sitting beneath a prison wall. The copy suggests that the bike is so "bad" it could only have been spawned in a jailhouse.

There are other ads, though not as



explicit as these, that toy with the images and ideas which caused the myth of the American motorcycle outlaw to take root.

These advertisements confound me. Some of them would be bad under any circumstances, but their appearance during this resurgence of outlaw motorcycle gangs is inexplicable. The notion of manufacturers flirting with this kind of imagery makes you wonder if they are even in touch with the reports of gang activity broadcast in major markets from New York to Chicago. Is there really anyone in America today who doesn't get CNN?

It also makes you wonder what these manufacturers must think of their customers. Do you believe that motorcycling gets a burn rap from Hollywood and the news media? Then just step back and take a look at how it is depicted by some of the very people who take our money in exchange for motorcycles.

Why must our own industry joke about and exploit motorcycling's dark side? What is wrong with messages about mobility, pleasure, freedom, camaraderie, excitement and joy? I've always thought those were the reasons that responsible people buy motorcycles.

But maybe that's the problem. Maybe some of the manufacturers have decided that responsible customers just don't provide a large-enough market. If you believe that's the case, then surely there are misfits, troublemakers and losers

out there who can come up with the price of a new motorcycle. All you have to do is get their attention by appealing to their seediness and sense of alienation.

Flirting with this kind of imagery is a dangerous game. It serves only to validate and reinforce the picture of motorcycling that Life magazine created nearly 50 years ago. The same picture that has been perpetuated time and again by public officials, the entertainment media and corporate giants like American Express. Motorcycle manufacturers who indulge in this kind of image-making are only further endangering an industry that is already vulnerable enough.

Will American Motorcyclist decline this kind of advertising? That's a tough call. While I deplore the idea that our own industry would stick demeaning or insulting messages under the noses of its own customers, I also believe that people (and corporations) have the right to express their own views, regardless of the fact that they may be ill-advised, mistaken or stupid. It is not up to the AMA to become the moral watchdog for the motorcycle industry, though I realize that some of our members believe we should.

We've already received bitter complaints about some of these new ad campaigns. For the most part we'll make our position known and hope that advertising directors and their agencies become more mindful of their responsibilities to the motorcycling community and more sensitive to the feelings of their customers.

But in the most egregious cases, we'll draw the line. In fact, we already have. One such ad was rejected from this issue.

# AMA Washington Report

Rob Dingman, the AMA's Washington, D.C., representative, offers the following briefing on legislative activity in the nation's capital.

With the 104th Congress well into its first 100 days, during which the House of Representatives has promised action on measures contained within the "Contract with America," some very exciting things are already happening with regard to motorcycling.

For instance, a number of bills have been introduced concerning motorcycle helmets. In the House, Rep. Scott Klug (R-Wisconsin) has introduced H.R. 607, designed to remove the federal mandates which have been imposed on states that do not have mandatory helmet or seat-belt laws, a 55-mph speed limit, or a 21-year-old drinking age.

The idea behind the Klug bill is that states should be free to make their own decisions regarding these matters and not be subject to coercion from the federal government. Rep. Klug is quick to point out that if he were a state legislator, he would support mandatory helmet laws. Not surprisingly, H.R. 607 faces opposition from Mothers Against Drunk Driving (MADD). That opposition could work in motorcyclists' favor, however.

Even members of Congress who would otherwise be supportive of a measure to reduce federal infringement on states' rights may be reluctant to do so over the objection of MADD. So, at the request of Alaska motorcyclists, Rep. Don Young (R-Alaska) has introduced H.R. 899, which repeals only the penalties on states that do not have mandatory helmet laws. Rep. Young's bill provides members of Congress with a more politically viable alternative.

In the Senate, freshman Sen. Olympia Snowe (R-Maine) has maintained a tradition she started in the House by once again introducing legislation to address the helmet issue. Sen. Snowe's bill, S. 388 is the same as Rep. Young's bill. Motorcyclists all over the country owe a debt of gratitude to Olympia Snowe, who has chosen to champion our cause in the Senate after being such a strong advocate for motorcyclists' rights in the

House.

Although the Snowe bill will be the primary focus of motorcyclists' lobbying efforts, other bills have been introduced in the Senate. Sen. Ben Nighthorse Campbell (D-Colorado), who in addition

to being an original cosponsor of S. 388, has introduced S. 234. which would eliminate penalties states without mandatory helmet laws if those states have motorcycle safety

programs. Campbell

introduced S. 234 as a possible alternative in case S. 388 doesn't garner enough support. Legislation introduced by Sen. Robert Smith (R-New Hampshire), S. 360, would repeal both the helmet and seat belt penalties. The state of New Hampshire is one of three states that will face penalties for not having mandatory seat belt laws.

The potential for full funding for the National Recreational Trails Trust Fund is encouraging news on the off-highway front. The Coalition for Recreational Trails (CRT) deserves much of the credit for securing the Clinton administration request of full funding for the program. The CRT worked with Sen. Ben Nighthorse Campbell to solicit the support of Transportation Secretary Federico Pena.

The CRT is simultaneously working another strategy. Last year the House passed legislation containing provisions concerning the trails fund. Among these provisions was one which would provide contract spending authority for the program in the amount of \$6 million with the ability to secure additional funding through appropriations. The CRT is currently exploring the possibility of having the House-passed provisions regarding the Trails Act introduced as a standalone bill in both the House and Senate.

The stand-alone bills will help build grassroots and therefore congressional

support for the measures which will be essential to secure their passage. The ultimate objective will be to have the stand-alone bills incorporated into a larger piece of legislation such as that designating a National Highway System

(NHS), which must be passed by September 30 of this year.

The NHS legislation is also another possible vehicle we hope to use to repeal penalties states without helmet laws. With these two issues on the line. the NHS becomes a very important piece of

legislation for motorcyclists. Rep. Bud Shuster (R-Pennsylvania), chairman of the House Transportation and Infrastructure Committee, which will write the NHS legislation, has laid out a very ambitious schedule for his committee so that when the House has dispensed with the "Contract with America" it can turn its attention to items under the jurisdiction of the Transportation Committee, such as the NHS.

Inclusion of our issues in the NHS legislation is not a done deal. While Rep. Shuster was one of the authors of last year's NHS bill which included the Trails Act provisions, he has opposed previous efforts to remove the penalties on states without helmet laws. It won't be any easy in the Senate, either. Sen. John Chafee (R-Rhode Island), chairman of the Environment and Public Works Committee, which will write the Senate NHS legislation, championed the imposition of the federal penalties in the first place. Also, last year's NHS bill did not include the Trails Act provisions.

We've got our work cut out for us. We can only make things happen if members of Congress hear from their constituents: YOU!
