# Minutes for State Board meeting

Aug 12, 1995

Meeting was called to order at Lane County Community College at 12:11 by Vice Coordinator Mitch Maxwell. There were nine chapters present. There was a motion to waive the reading of the minutes from July. Coordinator's Comments:

None.

Correspondence: None.

## Reports:

Education Director: Nic Oliver reported on a Motorcycle Awareness Class. Instructor training for MAP signed up 17 new instructors. The first certified instructors were issued their certificates. They are Jennie Lindi, Tom Halley, Walt Allegar and James Mason. Also a lifetime certification was given to Mel Yeager.

Legislative Director:Brian Stovall reported that as the House of Representatives reconvenes in September, we need to put pressure on to pass HR 899. At this point it is the fifth most sponsored bill in the 104th congress. Ron Wyden is still the only representative from Oregon who is not supporting HR899. Brian says: GET BUSY. Membership: Mother's report shows membership at 1708 a loss of 52 since last month.

Newsletter Report: Gordon says he needs articles, preferably written by us about our summer experiences. Now that the legislative season in Oregon is over there is a need for material sent in by our own members.

Products: Angie Jensen had no report.

Public Relations: Ken Ray. The PSA tapes were returned at the start of the meeting and it was reported that the quality has deteriorated. New copies will probably need to be run.

State Run Coordinator: Rotten Roger was out of town so there was no report. For all who have not heard, the Freedom Run is canceled.

Treasurer:Joy Hoover reports account balances as of August 12 was: Checking Account: \$2,272.56, General Savings \$24,724.34, Legal Fund \$1,854.65, Education \$389.01 for a total of \$26,215.88.

## **Unfinished Business:**

Meeting of the Minds: The need to make a decision about sending ABATE of Oregon officers to Little Rock for MOTM was discussed. A motion came from the floor from Stacey (Columbia River) to send two officers to the meeting with ABATE paying for travel and lodging. It was seconded by Jennie (Douglas County). The vote was Y(9) which was unanimous PASSED.

Education Director and Louisiana The request from ABATE of Louisiana to have Nic come and teach the Awareness Program was tabled until new information can be gathered.

### **New Business**

Assistant for Education Director The need for an assistant for Nic in the education post was discussed. There was a motion from the floor by Marty Coon (NE Portland) to create the position of Education Director II. Seconded by Stacey (Columbia River). Vote was Y(9) unanimous PASSED.

Volunteers were requested for the newly created position and Jennie Lindi volunteered. No other nominations or volunteers were brought up so Jennie Lindi was given the position.

Sergeant at arms-South position had been left vacant so nominations were taken. Bill Woodall volunteered and no other nominations were received. Bill Woodall was assigned the position.

Brian Stovall discussed the fact that he may need to re-up for the MRF board of directors and not resign as he originally intended. He asked for a general consensus of whether the state board would support that. There was much affirmation.

Hi from Salem.

Well it's all over but the crying! "Fox Creek '95" has come and gone, and left some controversies behind it. The head count stood at approximately 1100 people at 9:00pm Friday night, at midnight on Saturday, Dewitt Security informed me there were over 5200 through the gate. After the event was over, Mark Dewitt told the promoter(Larry Bolton of San Cemente Productions) the total was 1700. Seems to be quite a discrepancy, is it possible there's money involved?

The other big issue to confront now is the unprecedented harassment experienced by the people coming to and going from the run, particularly by motorcyclists. There was a very strong presence of the Polk County, Independence City, and Oregon State Police that were stopping vehicles on flimsy or non-existent probable cause. Helmet and handlebar tickets seemed to be the order of the day and the attitude of the officers ranged from amused to menacing. discretion was almost ludicrous. Bob Avery said that the "Cruzers for Christ" were stopped and searched....JUSTICE!!?! This is just one example of the ridiculous behavior of the police surrounding this event. I highly encourage anyone that was harassed(whether a ticket was issued or not) to contact Sam Hochberg through the offices of Richard M. Lester(1-800-531-2424). Sam is a very competent attorney who is assembling documentation regarding these matters. I'm hopeful that there will be sufficient evidence to justify a class action lawsuit. This is a very serious matter. In my opinion, harassment is the most important issue to face ABATE of Oregon while between legislative sessions. Please discuss it at your chapter meetings and have your State Rep bring your input to the State Board meeting.

I would like to thank all of the people, clubs and organizations that helped to put on this event. The Christian Motorcycle Association and "Cruzers for Christ" served free soda pop all weekend to the thirsty masses. The Free Souls MC did a great job of putting on the bike games and the "Classic and Antique Motorcycle Association" (CAMA) organized the bike show and provided judges. J.C. Russe of Wildcat Enterprises, made the trophies for both and wound up with his picture in the Sunday Statesman Journal. Front page news, that is pretty unusual, considering the conservative tone of our local paper. Unfortunately, due to the high production cost for the run, there doesn't seem to be any profit left for Salem Chapter to distributed the local charities we support. We had hoped for the sum of \$20,000.00 to donate to those in need. Oh well, car washes anyone?

As a side note, Larry Bolton, CEO of San Cemente Productions, states that, due to a lack of cooperation from A.B.A.T.E. of Oregon, he will not renew his membership and wishes no participation in future A.B.A.T.E. events. Good luck Larry.







# Missouri governor signs rider education bill

Missouri Gov. Mel Carnahan has signed legislation that will establish a self-funded rider education program in the state. The law makes Missouri the 45th state to offer motorcycle training to its residents through a program paid for by motorcycle riders.

With less than two weeks left in Missouri's scheduled legislative session,

it appeared that time was running out for passage of a rider educabill vear. But motorcycle activists. ied by the AMAchartered Freedom of Road Riders of Missouri, found an unrelated bill in the state's House of Representatives to which

they could attach their rider education legislation.

The House bill, H.B. 717, originally addressed commercial vehicle and federal compliance issues, but the bill's sponsor, Rep. Don Prost (D-Caruthersville), agreed to attach the rider education amendment to it. The bill passed the Legislature with the amendment intact and will take effect August 28.

The new rider education program will be funded by a \$2.75 surcharge on motorcycle instruction permits and a \$5 court fee on traffic violations involving a motorcycle. The court fee will be doubled to \$10 for infractions involving alcohol. The money will be deposited into a motorcycle safety account that will be

used to administer the program. Successful completion of the program will enable new license applicants to obtain a motorcycle endorsement without having to take the skills test at state licensing agencies.

An additional amendment attached to H.B. 717 will reduce the penalty for not complying with the state's mandatory helmet law. Previously, riders convicted of violating the helmet law were subject to fines of up to \$500 and the possibility of up to a year in jail. The new penalty equalization amendment treats helmet

violations as a traffic infraction, carrying no points, no jail time and a maximum fine of \$25.

# Desperately seeking Ruger

Bill Ruger, where are you?

We're thinking about organizing a search party to locate the head of Sturm. Ruger and Company. We know he must be lost, because we were promised he would meet with us several weeks ago, and since then we've been unable to reach him by phone or by mail.

Ruger became a household name among AMA members when his gun manufacturing company started discriminating against its motorcycle-riding employees last year. No employee would be covered for injuries resulting from a motorcycle accident, the company decreed, unless the employee was wearing a helmet and eye protection at the time of the crash. This, in spite of the fact that New Hampshire, Arizona and Connecticut, the three states where Ruger is based, don't have helmet laws covering adult motorcyclists.

Of course, car-driving Ruger employees aren't facing similar restrictions. They can drive without wearing seat belts and still qualify for health-care coverage. They can even do something illegally irresponsible like drinking and driving without losing their health insurance. Only motorcyclists have been singled out.

That policy drove a wedge between Ruger and many motorcyclists. And now, company President Bill Ruger Jr., himself a motorcyclist, is allowing the situation to deteriorate even further. After we were given assurances that he would sit down with us to discuss our concerns face-to-face, Ruger apparently has decided to stonewall us. All of the AMA's attempts to contact him and set up the meeting have gotten no response.

The promise of a face-to-face meeting seemed to be a real breakthrough in this controversy, which has now lasted a



full year. After we reported what was going on at Ruger last year, a large number of AMA members who are also gun owners wrote to say that they would not purchase Ruger weapons until the company reinstates health-care benefits for all motorcyclists. Many of them noted that it seemed particularly strange for a gun manufacturer to discriminate against employees' lifestyle choices on the basis of perceived risk. Some even sent their Ruger guns back to the company in protest.

Early this year, the issue entered a new phase when the Riding Ruger campaign was started by a group of activist motorcyclists, including AMA Trustee Rick Gray. The idea was to encourage motorcyclists to buy shares of Ruger stock and then protest this policy at the company's annual stockholders meeting in late April.

Robert Rasor, AMA vice president of government relations, and Gray both attended the stockholders meeting to voice our concerns about the company policy. Shortly before the start of the meeting, they approached Stephen Sanetti, vice president and general coun-

set of Ruger. Sanetti said Ruger was willing to meet with Rasor in the near future to discuss the health-insurance issue. During the meeting Rasor publicly thanked Ruger for his commitment to discuss the issue.

On May 8, Rasor called Sanetti and proposed a meeting date during the week of June 5. Sanetti said he would try

to firm up a date at Ruger's convenience during that week. Rasor followed up his phone call with a letter to Sanetti on May 15.

Sanetti responded in a letter dated May 30, stating, "I immediately passed your request on to William B. Ruger Jr. on May 8. He indicated he would get back to you regarding dates. To expedite this, please contact William B. Ruger Jr. directly. Many thanks for your

courtesies and cooperation."

Since then, Rasor has attempted to do exactly what Sanetti suggested. He called Ruger on June 5, 6 and 7. Each time, the company president was unavailable. So Rasor wrote Ruger a letter on the 9th and waited for a response. On the 22nd, Rasor called Ruger again.

As this story is being written, the date is mid-July, more than a month after the meeting was supposed to be held. So far, Ruger has failed to respond with either a telephone call or a letter. And the "courtesies and cooperation" Sanetti noted in his letter to us are starting to wear thin.

"We have conducted our business with Sturm, Ruger and Company in a non-confrontational manner," says Rasor." That approach appears to have gotten us a string of promises, but no action whatsoever. It is now time to rethink our tactics.

"The Riding Ruger campaign," Rasor adds, "is already preparing for the 1996 shareholders meeting. While we maintained a low profile at the last meeting, we may have to take a more active stance to make certain that our concerns

are addressed."

What can you do? The first step is to buy even a single share of Ruger stock, which is currently trading on the New York Stock Exchange for approximately \$30. It is important that your name appears as the stockholder of record. This will en-

sure that you can assign your voting rights to another motorcyclist if you are unable to attend the next shareholders meeting.

Then, write a letter to William B. Ruger Jr., president, Sturm, Ruger and Company, Lacey Place, Southport, CT 06490. Tell him that as a stockholder, you're concerned about the direction your company is taking. And add that you're disappointed at his failure to live

up to the commitment he made to meet with the AMA.

Next, contact the AMA's Government Relations Department at (614) 891-2425, or write to the department at: 33 Collegeview Road, Westerville, OH 43081-1484. We are taking several steps now to prepare for next year's company meeting, and will use your letters to build an activist mailing list of AMA members who are Ruger stockholders.

"Our approach to the 1996 meeting," promises Rasor, "will have a decidedly different tone than the last one. We want Ruger to know there are too many of us to ignore."

# Massachusetts trail lockout

Officials in the Commonwealth of Massachusetts' Department of Environmental Management (DEM) are considering a proposal that would prohibit any form of recreational trail riding in all of the state's forests and parks.

The proposal, circulated in a memo from Commissioner Peter C. Webber to DEM board members, would permit only special one-day events sponsored by what state officials identified as an "appropriate organization."

Webber summarized the sweeping nature of his proposal in his memo, stating," Any off-road vehicle in the forest on a non-event day will be breaking the rules, period."

The Massachusetts proposal has already attracted national attention within the off-highway recreation community. Cliff Glidden, deputy director of the California Off-Highway Motor Vehicle Recreation Division, wrote to Webber offering to share his experience in how to construct a management program that would safeguard the environment while also being responsive to the needs of the state's tax-paying off-highway enthusiasts.

# Oregon Helmet Law Defense Summer, 1995 Update

"As long as it has a DOT sticker"

The New Law: The 1995 Oregon Legislature passed a landmark bill that is intended to reduce police harrassment of bikers for wearing so-called "illegal" helmets. Generally, under HB 3422, passed unanimously by both houses and signed by the Governor, the Federal standard for helmets no longer applies. It also reduces the fine for violating the helmet law from a Class D to a Class C infraction. The new law becomes effective September 9, 1995; probably only as to citations arising on or after that date.

Summary: Effective September 9, 1995, if it looks like a helmet, and it has a DOT sticker on the outside back of the helmet, it's legal to use in Oregon. See below for details.

The New Standard: The Federal standard under FMVSS (Federal Motor Vehicle Safety Standard) 218 is no longer directly applicable to the enforcement of the helmet law. You, the police officer, and the judge are no longer responsible for trying to figure out whether your helmet passed all the tests and specs set out in the FMVSS. Instead, there is a new, simplified definition:

Motorcycle helmet means a protective covering for the head consisting of a hard outer shell, padding adjacent to and inside the outer shell and a chin-strap type retention system with a sticker indicating that the motorcycle helmet meets standards established by the United States Department of Transportation.

Note that the requirement is merely that there be a STICKER indicating that the helmet meets DOT (this refers to the FMVSS) standards; in other words, that it have a DOT STICKER on the outside, which is described in FMVSS 218. This is the only reason you would look to the FMVSS, for the description of a DOT sticker. The labelling INSIDE the helmet, which is required by the FMVSS is NOT a sticker, it is NOT the label designated to indicate compliance with the FMVSS, and I believe that the new law does NOT require that you have a label inside the helmet, but only a DOT STICKER on the outside.

But My DOT Sticker Fell Off: This is a tough problem, because a legal DOT sticker, according to the FMVSS, is one placed there by the manufacturer. Perhaps you can submit your helmet to the manufacturer, through your local shop, to have a new sticker affixed. If anyone besides the manufacturer puts a DOT sticker on your helmet, it is technically not a legal sticker. If you put one on yourself, although the helmet might then appear to pass legal muster, you may be putting a sticker on what actually is an unsafe helmet, and you may also expose yourself to criminal prosecution, if you are found out.

Should I wear my beanle now? There are two areas to consider, the law and safety. As to the law, the intent of the legislature was, I believe, to eliminate ticketing and harassment for people wearing helmets, and the new law SHOULD eliminate ticketing if the beanie has a DOT sticker. But, I fear, so many police learned how they thought they could identify "illegal" helmets under the old law, that it may be some time before all the police are reeducated. So, you may well still be stopped and ticketed. If you are, please be sure to call my office and talk to me or to Gunny to get some help. I'm at 224-1106 in Portland, or 1-800-347-1106.

As a matter of safety, I think the beanie poses some problems. I don't know of any studies, but I've heard anecdotally of several accidents where it appears the beanie-style helmet was effective in preventing injuries, and at least one other where the light weight of the

beanie may have stopped serious neck injuries from become paralyzing injuries. On the other hand, there is less skull coverage area, a thin shell, and almost no impact-absorbing padding. And, I know of at least one instance where the beanie shattered into shards, going into the biker's head, killing him.

I own and ocassionally use a beanie helmet. All in all, I personally opt for the full half-shell, police-style shortie helmet over the beanie. But at least now, we have freedom of choice over the style of helmet that we didn't have before. ...as long as it has a DOT sticker.

# The AIM...ing Point GUNNY'S COMMENTS...

Well, there's another survey out that says 79.2 per cent of the people in the United States oppose repeal of motorcycle helmet laws. Of course, you don't see too many car drivers wearing those helmets they'd like you to wear. Make no mistake here, I personally advocate the wearing of protective headgear when on a motorcycle. I've seen lives saved. I simply don't believe the wearing of helmets should be mandatory. HELMETS DON'T PREVENT ACCIDENTS. It takes education, not bad laws or heavy handed enforcement. It's just a matter of freedom of choice. But I'm probably preaching to the choir.

If you want to talk about head injuries, I'm sure there are more as the result of people slammed about inside cars than there are from motorcycle mishaps. Head trauma and twisted lower back injuries in cars are more expensive to treat, and the treatment takes much longer on the average than motorcycle injuries. This information comes from the North Carolina Hospital study.

## INTOXICANTS . . .

This is still the biggest problem we have in all facets of driving is the drinking or substance abusing driver. When we figure out how to eliminate this, we will save thousands of lives each year. Nearly sixty per cent of the deaths from motorcycle accidents are alcohol or substance abuse related. Like it or not, just one beer is all it takes to impair your judgment. On a bike, that can KILL you. 'Nuff said.

PUBLIC BURDEN . . .

Motorcyclists are just as likely to pay their medical bills as anyone hospitalized from any accident. Some people talking to the Oregon legislature quoted the Harborview study, and said 63.4% of the injured bikers relied on public funds to pay their bills. Yeah...the same study said 67% of the overall hospital population also relied on public funds. Motorcyclists look fairly good when the whole truth is known. Particularly, when only point six-four per cent (.64%) of the trauma victims hospitalized in this country are motorcyclists. Based on that

information my elementary math tells me we are point four-two per cent (.42%) of the hospital's public burden. That's 42 cents of every 100 dollars spent. There is probably more spent on kids scalded with hot water in homes around the country than that. Falls from horseback are the number one cause of head injuries in this country, not motorcycles!

Children injured and killed from parental abuse is a far larger and more expensive problem in this country than medical costs resulting from motorcycle accidents. We are not the burden that some people claim we are. Some priorities need adjusting.

## **NCOM Regional:**

The annual Region One NCOM conference is in Honolulu, HI on Oct. 7, 1995 at the Holiday Inn, Honolulu Airport. There is a special room rate of \$70.00 plus tax (cheap for Hawaii), a free shuttle from the airport, and 10% off in the bar and restaurant. Pepper Massy-Swan, the Executive Director of NCOM, tells me that Randy, our Hawaiian connection, is working on a Luau for us on Sunday, after the conference. The phone number for reservations is 808 / 836-0661. Be sure to ask for the NCOM conference rate. You really don't want to miss this event.

## **NEWSBITS AND PIECES...**

Amsterdam: Local police working with bikers are staging a rock concert with bike games and driver demonstrations with an eye toward education for the young riders in that country. Why can't we do that?

Belgium: Bikers are having a problem with more road bans. The Flemish government says if they want bans lifted come up with noise limitations for motorcycles. We are having similar problems in this country in some residential communities and AMA has instituted suit in some cases. We call it DISCRIMINATION in America.

Austria: A producer of crash barrier post protectors has announced a big reduction in price. This is expected to reduce fatality rates over there, from bikers hitting barrier support posts in accidents. Way to go! Let's get some ROAD safety going, not just bike safety!

Sri Lanka: Midwives are given

motorcycles to reach their pregnant clients. It seems they can cover their territory much faster that way, and they are more efficient in their work. Why didn't I think of that?

Italy: In Naples the Italian police now have a patrol called *Falchi* or "Street Falcon". These guys, on Honda 650 Dominators, romp after bike-riding purse-snatchers and arrest them almost immediately after the crime. This came about to combat the rising numbers of purse snatchers using motorcycles for snatching and fast get-a-ways. Ride 'em cowboy.


U.S.A.: In Key West, Florida, Chi Chi, a pot-bellied pig resident of this town, is in imminent danger of losing his reproductive prowess over his attempt to impregnate a brand new Harley-Davidson. 





# FEDERAL HELMET REPEAL BILL SCHEDULED FOR ACTION IN THE HOUSE

The following letter from Wayne Curtin, our Washington, DC lobbyist, tells you everything you need to know about the situation in the nation's capitol.

August 9, 1995

Dear MRF Member:

I am writing you because we are at a critical point in our effort to repeal the federal Section 153 penalties on states without helmet laws. Your action and help are needed, TODAY, to help us push for, and win, a vote for freedom in the U.S. House of Representatives.

### WHAT'S HAPPENED SO FAR - Victory in the Senate

On June 21st, the United States Senate voted 64 to 36 to repeal the mandate of Section 153. As a result of that vote the Snowe-Campbell Amendment became Section 142 of the National Highway System Designation Act of 1995 (S.440).

This key victory for motorcyclists' right to ride free was won in the face of the bill's manager, Senator John Chafee, fighting the repeal of his beloved federal helmet law. This victory gives our issue a major boost as our efforts are now shifted to the House of Representatives.

The efforts of the almost 300 motorcyclists that have been sent to Washington by the state motorcyclists' rights organizations from 37 states have laid a strong base of support in the House of Representatives. When Congress adjourned for its summer recess on August 4th, there were 201 sponsors of Rep. Don Young's bill H.R.899, which would repeal the Section 153 penalties on states without helmet laws. Two hundred and eighteen members is a majority of the 435 member House of Representatives. H.R.899 is the 5th most sponsored House Bill in the 104th Congress!

## WHAT HAPPENS NEXT - The House to Act in September

When Congress returns in early September, the House will begin immediate consideration of its version of the National Highway System (NHS) legislation. Rep. Bud Shuster, chairman of the Transportation and Infrastructure Committee, is expected to introduce the House version of the NHS legislation when the House of Representatives returns at noon on Wednesday, September 6th. The surface transportation subcommittee will then mark-up that bill later in the day, September 6th. The Transportation and Infrastructure Committee is planning on marking-up the NHS bill on Thursday, September 7th.

This quick action by the committee would allow the House of Representatives to take floor action on the NHS legislation during the week of September 11th. Once it passes the House there will be a conference committee to work out the differences between the House and Senate bills. Both the House and Senate must pass, and the President must sign, the conference reported NHS bill before September 30th, or all 50 states will lose close to \$6 billion in highway funds.

## THE PROBLEM - Chairman Blocking Action

Chairman Shuster has stated he wants a "clean" NHS bill. By this he means he does not want the NHS bill to include any policy changes to the Intermodal Surface Transportation Efficiency Act (ISTEA). What he wants to do is include a provision in NHS that would force ISTEA to be re-authorized in 1996, instead of 1997. Then, in 1996, he would consider policy changes to ISTEA during the re-authorization process.

We have been told that the NHS bill will include a one year moratorium on the Section 153 penalties. If that provision became law

it would mean the penalty on states without helmet laws would be suspended for one year.

As General McAuliaffe, commander of the 101st Airborne, said to the Germans when they demanded he surrender Bastogne during the Battle of the Bulge: "NUTS!!"

#### THE SOLUTION - Grass Roots Activism

During Congress' summer recess, we need to create enough grass roots heat in congressional districts that Members of Congress come back to Washington, on September 6th, demanding a vote on including H.R.899 as an amendment to the NHS legislation.

#### YOUR ACTION IS NEEDED - Voice of Constituents

Between now and September 6th, your Congressman or Congresswoman will be back in their congressional district. During that time you need to speak to your Member of Congress. You need to impress on them the importance of having the text of H.R.899 amended into the NHS legislation.

There are three ways you can go about speaking to your representative. First, you can call their district office and ask for an appointment to meet with them. Second, if you can not get time off work or arrange to meet with them personally ask to talk with them on the phone. Tell the staff it is important you meet or talk with them because they will be voting on an issue important to you as soon as they return to Washington in September.

If your representative does not meet or speak with you on the phone then your last resort is to find a "town meeting" the Member of Congress is having in the district and you can try to catch them there. Or, you can go sit in their district office for a few days until they meet with you.

You should also get your friends, family and other members of your state motorcyclists' rights organization to call or write your Member of Congress.

Your representative must go back to Washington in September committed to do several things:

1) To vote in favor of an amendment, the text of H.R.899, to the NHS bill.

2) If they are not already a cosponsor of H.R.899, we need them to sign-on as a cosponsor when they return on September 6th.

3) To speak to Chairman Shuster, and subcommittee chairman Rep. Tom Petri, about the importance of including H.R.899 in the NHS legislation.

4) To oppose any Rule to bring up the NHS legislation on the House floor, unless H.R. 899 was amended into the bill in committee or the Rule provides for offering H.R. 899 as an amendment on the floor.

Your action today is important to our goal of repealing the Section 153 penalties on states without helmet laws in 1995. REPEAL, not suspension, of this federal mandate is our goal.

Your personal contact is more important now than every before. The recent lobbying campaign on the House version of the Tele-communications bill has created a controversy. Thousands of telegrams were sent to Congress in a "manufactured grass roots ad campaign".

Several Members of Congress have charged they receive telegrams from people who did not know of the issue, who were young children, who are dead, who have been out of the country for several months, and in one case a Member claims to have received a telegram from himself. If you talk to them face to face or on the phone your Member of Congress will know it is the opinion of a real grass roots constituent.

In closing, please act today! The most important action for you to take is to call your Member of Congress and ensure they will vote for repeal of Section 153 penalties on states without belimet laws.

#### FEDERAL LEGISLATIVE ALERT

Although the U.S. Senate included a repeal of the federal helmet mandates in S. 440, the Senate's version of the National Highway System (NHS) bill, concerned motorcyclists must continue to press the House of Representatives to include similar repeal language into the House NHS bill. Then, both bills will go to a conference committee to reconcile any differences between the two proposals and recommend a final version for passage. If both the Senate and House bills contain a repeal of the Section 153 ISTEA penalties against states without helmet laws, it greatly increases the likelihood of a repeal being included in the final legislation. However, House Transportation and Infrastructure Committee chairman Bud Shuster (R-PA) has stated he wants no demonstration projects or ISTEA "cleanup" amendments included in the House NHS bill. Please contact your Congressional representatives, especially those on the transportation committee, and ask them to cosponsor H.R. 899 by Rep. Don Young (R-AK) and to support including such repeal language in the House NHS bill. H.R. 899 currently has 198 cosponsors. Keep up-to-date on our efforts to repeal the national helmet law by calling the NCOM Legislative Hotline at 1-(800)-300-NCOM.

## VIRGINIA HOV STUDY SUPPORTS MOTORCYCLE USAGE

Besides requiring states to pass helmet and seat belt laws, ISTEA also mandated that motorcycles be permitted to travel on federally funded high-occupancy vehicle (HOV) lanes unless they created a safety hazard or adversely affected HOV operations. Although motorcycles had previously been banned from traveling on Virginia's HOV lanes, the Commonwealth Transportation Board (CTB) begrudgingly complied and authorized motorcycle travel as of September 21, 1992 for a two-year trial period. At the same time, according to the Virginia Coalition of Motorcyclists (VCOM), founded by Aid to Injured Motorcyclists (A.I.M.) attorney Tom McGrath, the CTB authorized the Virginia Department of Transportation to conduct a study in hopes it would show that motorcycles did indeed present a safety risk on HOV lanes and would justify reinstating the ban. The study, which cost over \$140,000 in taxpayer funds, found that "motorcycles account for as much as 3% of the annual traffic on some HOV lanes...however, in the 2 years after the CTB authorized their travel, there were only five motorcycle crashes on HOV lanes." Contrary to anticipated findings, "The study recommends that the CTB allow motorcycles to continue to travel on HOV lanes."

## DATA SHOWS HELMET LAWS INEFFECTIVE

An analysis of 1993 motorcycle accident and fatality data, compiled by the Motorcycle Industry Council (MIC) from official transportation sources in each state, shows that the 25 helmet law states account for 61% of all motorcycle registrations (2,352,293 out of 3.850.216 total), but are responsible for 64% of all accidents (52,270 of 81,332) and 64% of all fatalities nationwide (1,557 of 2,401). In addition, helmet law states have a higher fatality rate per 10,000 registered motorcycles (6.62 versus 5.64) as well as fatalities per 100 accidents (2,98 vs. 2,90). A related report from the National Highway Traffic Safety Administration (NHTSA) reveals that 54.4% of the 2,394 motorcyclist fatalities in 1992 were wearing helmets!

The A.I.M. network of attorneys puts a substantial portion of its legal fees from motorcycle accidents back into motorcycling by being the sole financial sponsor of the National Coalition of Motorcyclists.

## BIKERS UNITE BELFAST & DUBLIN IN BIGGER THAN BORDERS DEMO

ICOM, July 28, 1995 — Irish and English motorcyclists gathered in Belfast on July 22 for a historic ride to Dublin. Craig Clinch (Motorcycle Action Group Ireland/ICOM European Coordinator), one of the individuals organizing the Demo stated, "Three thousand bikes made the Bigger Than Borders Demo run between Belfast and Dublin, which is a really significant event as no one has been able to do this before because of the war in Northern Ireland." European riders proved that they can rise above sectarian differences for unity and freedom of choice.

The Demo was held to protest the European Commissions proposals for the dreaded Multi-Directive. "For years we have been one of the few sections of the community who have been quite happy to be united in our enjoyment of motorcycles", said Liam Gallagher of MAG Northern Ireland. "Now our freedom is under threat from the draconian measures proposed by the European Commission and we intend to use our unity in the fight against these proposals. We will not be legislated off the road!"

Representatives from the Federation of European Motorcyclists, MAG Ireland, MAG UK Northern Ireland and three other European riders groups, made speeches on O'Connell Street in Dublin outside the building which marked the start of the Irish uprising against the English in 1916. Then MRO representatives from north and south exchanged the Irish Tricolor flag with the Union Jack, something which has never been done before.

The run was over 150 miles, the longest motorcycle demo ever held in Europe and passed off without incident. "Lots of good feeling all around about this one", said Clinch. "The thousands of English riders who came over loved it! We feel that riders rights not only leads the way politically in Europe, but also can rise above the problems of national divides, something that is really important to us."

European riders are to be congratulated on a job well done in the name of unity, liberty and peace.
