#### BIKERS WIN LEGAL CHALLENGES OVER "CLUB COLORS"

CONFEDERATIONS OF CLUBS, November 18, 1997 — Two recent legal actions have favored the right of motorcycle clubs to wear "colors," as guaranteed under the U.S. Constitution's First Amendment freedom of speech protections.

In early August, the County of Santa Barbara and the Santa Barbara County Sheriffs Department agreed to settle a lawsuit brought by the Bravados Motorcycle Club, based upon actions by about a dozen Sheriff's deputies to refuse club members entry into the Santa Barbara County Fair on April 29, 1995, because they found their club "colors," or back patch, to be "gang attire."

Police officers offered to let the Bravados enter without their vests, but the club decided instead to file suit against the county and the Sheriff's Department. "It is our right to wear our vests," said David Cordero, treasurer for the club that has been in Santa Barbara for more than 30 years. "We are proud to be Bravados." The club members claimed their First Amendment rights were violated by a dress code that discriminated against their style of clothing.

The lawsuit was pursued by the Southern California Confederation of Clubs, of which the Bravados MC is a member club, and the Sheriffs Department and county eventually agreed to settle for \$10,000 in damages and about \$15,000 in legal fees. In addition, the Bravados also won the right to attend the fair in full club regalia.

"This was a great victory for the Bravados MC and the Confederation of Clubs," said Richard M. Lester, founder of Aid to Injured Motorcyclists and legal counsel for all Confederations of Clubs throughout North America. "It validates our position that bikers should not be discriminated against based solely on their style of dress or mode of transportation."

In another matter, in late July the Free Souls Motorcycle Club reached a settlement agreement with the Sheriff's Department of Clark County, Washington, and two of their deputies who had allegedly informed various bar owners within their jurisdiction that they would not respond to "911" emergency calls if the proprietors chose to allow patch holders in their establishments. The owner of Omar's Steakhouse and Lounge in Vancouver agreed to testify, and the Confederation of Clubs Washington pursued the lawsuit on behalf of the Free Souls.

In exchange for dismissing the lawsuit, the Sheriff and his deputies agreed to a number of stipulations, including paying \$20,000 to the Free Souls MC for legal expenses; not to campaign for other bars and taverns to adopt "no colors" policies; to develop a written protocol for deputies to use when discussing perceived problems regarding wearing of "club colors" with owners of such establishments; and to basically avoid conflict and confrontation with the Free Souls MC and to cooperate with the club in the resolution of any future concerns.

Both of these cases should send a strong message to state and local law enforcement that motorcyclists are tired of lying down and taking it, and through the various Confederations of Clubs are standing up for their legal rights! With 25 Confederations in 20 states and 1 Canadian province, this is the fastest growing segment of the motorcyclists' rights community. See you in court.

When I read the first line of Tony Pan's e-mail my heart sunk. I thought somebody had come up with an easy way for the government to grab your sled. On the contrary, Tony has apparently worked his butt off to protect us from that happening. Congratulations brother!

From Wisconsin:

On November 19, 1997, the Wisconsin Senate passed AB96, the motorcycle confiscation bill. It now goes to Governor Tommy Thompson for his signature. This bill is of national importance, especially in light of the fact that thousands of motorcyclists are expected to visit Wisconsin in 1998 for the Harley Davidson Motor Company's 95th Anniversary. Three years ago, Michael F. Hupy & Associates law firm started getting calls about motorcycle confiscation, at the hands of police. Most often seized were vintage Harley Davidson models, with suspected altered VIN's. After some research, Tony Pan Sanfelipo, an accident investigator for Hupy, specializing in motorcycles, verified what he had suspected all along. Harley owners are notorious for

changing the motor/frame configuration on their cycles. Many after market parts are used also, including frames. The police prefer engines, frames, and transmissions with matching numbers. In the real world, that's not the way things are. After at least twelve cases were brought to court by Hupy attorney, Tim Rymer, many pro bono, and won, the word got out that there was a remedy for biker's whose motorcycles were being held indefinitely. But court was a costly and time consuming remedy, and Michael F. Hupy & Associates, S.C., are personal injury attorneys. Their dedication to motorcyclist's rights moved them to provide free seminars aimed at teaching area cyclists about the registration system in Wisconsin and Harley's numbering system. Soon after, Tony Pan Sanfelipo met with state legislators to inform them of the problem, and helped to draft a bill to resolve the problem. He got ABATE of Wisconsin to get behind the effort, as well as the National Motorists Association. After three years of hard work, the bill passed both houses in Wisconsin and now awaits the Governor's signature. Tony is chief road captain for Governor Thompson's Cycle Tours and has already discussed the problem with the governor. There should be no problem on that end.

What does the bill do? If a motorcycle is seized by authorities in Wisconsin for suspected altered numbers, the seizing agency must start a formal proceeding for forfeiture within thirty (30) days of confiscation (60 days if criminal proceedings are pending). If the seizing agency does not

return the property, and the owner is forced to go to court for relief, and the judge orders the property returned, the seizing agency must pay the attorney fees and court costs.

This was a major piece of motorcycle legislation, and garnered broad bi-partisan support. A principal co-sponsor of this bill was Senator Dave Zien, the motorcycling senator from Wisconsin, and a long time friend of Tony Pan's and a client of Michael F. Hupy & Associates, S.C. We expect a formal signing ceremony to be held with Governor Thompson and Michael F. Hupy & Associates, S.C., plans on continuing with instructive seminars on this bill, Harley Davidson numbering styles and what to look for when buying used motorcycles. They want to help bikers to avoid buying questionable motorcycles that may have been stolen. At the same time, the law firm is dedicated to assisting bikers who have purchased a motorcycle in good faith and no substantiated proof of theft exists.

News from ABATE of Maryland, Anne Arundie Co. Chapter. November 25<sup>th</sup>, the District Court of Anne Arundle Co. dismissed the case against Bill Gawthrop, an ABATE member. ABATE attorney, Bruce Bereano, successfully argued the case based on the "no list of approved helmet, no law" strategy. This approach has won many cases in the various counties of Maryland. The state's highest court is scheduled to hear an appeal on Helmet Mike's victory in St. Mary's Co. on December 9<sup>th</sup>. Circuit Court for St. Mary's Co. ruled the state helmet law unconstitutional. MRO's in Maryland our fighting hard and it is felt they are very close to a statewide victory.

Hi Steven,

My name is Patty Davis, ABATE of Louisiana, and I thought you'd be interested to know what we're up to down here, in light of Maryland's fantastic victories and other battles being fought in the courtrooms across the country.

For the last several months, several of our members, including myself, have been gathering "evidence" in preparation to file suit against the state, challenging the helmet law here, based on the "No list, No law" approach. What

we've done is contact a variety of State Trooper headquarters around the state and the Louisiana Department of Public Safety (DPS) asking for a list of approved headgear and eye wear.

You see, there IS a list [in Louisiana], written back in 1983, just after our law was passed the last time, however it has never been revised since that time. According to the law, the Commissioner of Public Safety is supposed to "establish, maintain, and publish" a list. Most of the products on that [old] list are not even manufactured any more!

But here is the real kicker... it took me meanly of investigative research to find this list. A very nice clerk at the Law Library in New Orleans took it on as her pet project and produced it for me. BUT! The responses we have gotten from the State Troopers and the DPS are incredible:

"Yes there's a list of helmets, but no list of eye wear."
"No there's no helmet list, but there is a list for eye wear."

"No there's no list, but we suggest you buy a DOT or SNELL certified helmet."

And here's my favorite from the DPS, the agency [legally] responsible for "establishing, maintaining, and publishing" the list...

"We don't maintain such a list, we suggest you try your local motorcycle shop."

Isn't this great! It's quite obvious that they are having just as hard of a time figuring out what a legal helmet is as the rest of us! One trooper even sent me a pile of NHTSA pamphlets about motorcycle safety! Big help there!

The attorney who will be filing the suit for us is planing to file in February. Looks like the Maryland case will be of great assistance to our case. Kinda hard to defend a law that is so misunderstood and enforced so inconsistently?

Feel free to make any suggestions. We're open to all ideas. Maybe, just maybe we won't have to go to battle again with the legislature in '99!

Thanks for all the work you do for motorcycle rights.

The following is a communication I received from the National Motorists Assn. regarding their attempt to make air bags optional for everyone, not just those in high risk groups. I have advised them I would send this along to The List and request that you act on their petition request. At the same time, I took issue with their risk-benefit statement - citing the NY study - and arguing that the ration is actually much worse for helmets. I asked NMA to support our attempts to have mandatory helmet laws repealed in the remaining 23 states.

I'll keep you informed of their response. In the mean time, make up your petitions, get 'em signed and ship them in.

Last week we sent some of you a "call to action," asking that you write a petition to the National Highway Traffic Safety Administration requesting a reconsideration of the air bag rule that was announced Nov. 18. We provided a copy of the petition written by our NMA air bag expert Jim Walker, which included 24 points, and asked you to use it to formulate your own petition.

Below is the NMA's official petition requesting a reconsideration of the rule. If you haven't already written your petition requesting reconsideration, feel free to use the information in our petition, (You can also include points from Walker's petition.) to craft a simple request that emphasizes the reasons you feel are most important. It's best to craft your own personalized version. With your help, we can make it clear to NHTSA and DOT that we believe their handling of this issue has been unacceptable, and that the controversy is not over.

The 45-day window to submit these petitions goes to 1/2/98, but it is best for petitions to arrive by 12/29/97. You can find the final rule and all related documents at <a href="http://www.nhtsa.dot.gov/airbags">http://www.nhtsa.dot.gov/airbags</a>, and they will be the first items on your screen.

PETITION TO RECONSIDER THE FINAL RULE ON AIR BAG ON/OFF SWITCHES AND AIRBAG DEACTIVATIONS, WHICH WAS ISSUED ON 11/18/97

This petition is being submitted in response to requests from NMA members, who are fully aware of both the benefits and risks of air bags, but would prefer that they not the federal government—be allowed to decide whether to use their air bags. Dear Administrator:

The National Motorists Association petitions the National Highway Traffic Safety Administration to reconsider the Final Rule on Air Bag On-Off Switches, issued under Docket No. NHTSA-97-3111 for these reasons:

During the public comment period on this rule, NHTSA received more than 600 comments from individuals. Approximately 500 of those individuals supported deactivation, or simple wiring disconnection, as the method to turn off air bags. The other 100 supported either switches, or both switches and wiring disconnection. Nearly all of these individual commentaries supported deactivation on request for anyone who asks, without regard to whether they fall into one of the risk groups defined in the final rule. The new rule denies the request of nearly all-individual commentaries. This means that NHTSA requested and received sincere comments from 600 individuals, and denied them all.

The National Transportation Safety Board and the Insurance Institute for Highway Safety supported deactivation on request, without regard to being in a risk group. The new NHTSA rule denies the request of the NTSB, the federal agency charged with the safety of all forms of transportation, as well as the most visible insurance industry highway safety group.


NHTSA's own estimates (even considering the use of 20% to 35% depowered bags available from 1998 model

vehicles) still reflect a killed-to-saved ratio for passenger-side air bags of about one child killed for seven adults saved. Not all of those at risk can be protected under the final rule.

NHTSA says they are not aware of cases where children were saved by airbags. Air bags have essentially no benefits for children, contrary to statements by NHTSA in the 1970's and 1980's, but have clearly negative results, as measured by recent deaths. By not allowing switches for vehicle owners who may carry children in their cars, the rule expressly raises the risks of child deaths, with no known benefits provided to children.

NHTSA data estimates in Table 11 of the Final Economic Assessment show that full fleet impacts of air bags on non-fatal injuries will result in the injury of 32,220 people, while reducing injuries to 66,486 people. No other federal regulation ever known, in any field of endeavor, mandates negative effects on about half the number of people who receive positive benefits. This risk-benefit ratio is simply unacceptable for a mandated device. Every vehicle owner who wants a switch or wiring disconnection for an air bag, for any reason whatsoever, must be allowed to make an informed choice of which risks they agree to undertake.

NHTSA discusses many plans for potentially safer Advanced Technology or Smart Bags. These discussions have no bearing whatsoever on the needs to modify the air bags which are currently installed in 1997 and earlier model year vehicles.



#### **REQUESTED AGENCY ACTION:**

Based upon the above points, the National Motorists Association requests that NHTSA modify the rule recently issued for air bag on-off switches and take the following specific actions:

- Make switches freely available to anyone who

#### PR Director Report December 1997

This has been another busy month. You will see by the attached official press releases that ABATE bikers were high profile again this month. I need to hear from South Coast, Washington County and Portland Chapters if they received any media coverage on their Toy Runs. I also helped Art West write an article about the Musicians' Benefit for the Shriners' Hospital Toy Run in Portland for Thunder Press. With a few changes, it was also submitted to the Cascade Blues publication.

I would like to address something that happened to me, in relation to these releases. I received a call from an ABATE member, who attends State Board Meetings that a member of her chapter had been contacting the media. She wondered if I could write up something. However, the press release had already been written and sent out to all media sources in the

What was different is that this volunteer was contacting individuals at the radio and TV stations, instead of sending out a fax to some machine in the middle of the night, which is what I was doing. This is very valuable work and very much appreciated. But, it will be wasted energy if I don't get those contact people into my database, so that I can personally fax the release. Here I was being asked to write up a press release for media sources that had already received the press release!

The bottom line is, not only do we need all of you to be making positive contact with the media, but when you find a friendly connection, the information must be reported back to the State PR Director through your State Rep, PLEASE. I also need to know who showed up for these events, so that I can put them on the "A" list. But you've heard me say that at least a dozen times.

My last request in this report, is lead time. If you want to get into a monthly publication, the press release must be written at least two months before the event so that I can schedule it, get it approved by the State Coordinator and get it out in time for the publication's deadline. If you want the media to show up for the event, you should still be asking for help at least a month in advance so that you can personally contact and connect with local media sources, which I can't

Lastly, I've included a copy of the press releases so that you may copy them next year. Please pay particular attention to Washington County's press release. Because I was given plenty of advance notice, it actually got into the Oregonian. It was also the most fun to write because of the specific information that was given to me... How much money was raised last year, which legislators would be attending, etc? Don't just send me a flyer, tell me what the "story" is all about in your own words and I'll turn it into a first class press release for you. I promise!

# TEAM OREGON HONORS PARTNERS IN SAFETY

The TEAM OREGON Motorcycle Safety Program recently honored several groups, organizations and individuals for their contributions in making Oregon's roads safer for motorcyclists and motorists alike. The awards were presented during the 13<sup>th</sup> Annual Instructor Awards Banquet, held November 22 in Salem. More than 90 people attended this awards celebration, including Tim Buche, President of the Motorcycle Safety Foundation, who provided the keynote address and presided over the awards presentation. In all, thirty-three people from across the state and region were recognized.

Top Instructor honors went to Angela Barkes, a Senior Instructor from the Portland area who was recognized as Instructor of the Year. Ms Barkes has been an instructor and safety advocate for six years, and is credited with teaching more than 100 beginning and experienced rider courses.

Rookie of the Year honors went to Dinah Stilton, a TEAM OREGON instructor who resides in Tacoma, Washington. Ms Stilton received her instructor training in June 1997 and since has taught five classes covering two-weekends each at TEAM OREGON'S Portland Community College, Sylvania Campus facility.

Linn-Benton Community College took the top honors in winning the Sponsor of the Year Award. LBCC has been an active and valued partner for all of TEAM OREGON's thirteen years.


#### Dear ABATE Members,

My worry is too many of us in this country could care less whether the government tells us how and when to do things. I question that legacy for our kids. Its easier that way for us because we don't have to exercise our own gray matter to make decisions about our safety or attire. But what about our kids, don't they deserve better? I pray we think so. Enough of my philosophising. I hope your holidays were gratifying.

News bits'n pieces: Maryland: A man here has invented a new motorcycle helmet. Get this: it's complete with turn signals, running lights, and a brake light! I don't know if you plug it into your scoot or what.

How long do you think it's gonna take before the folks from NHTSA (The National Highway Transportation Safety Administration) and their pals try to jump on this one, and try to make it mandatory safety equipment? Never mind the thing must weigh several pounds and strain the neck muscles even more than the headgear many of us are required to wear now. I wonder what happens to your neck when you reach the end of the connection tether to the motorcycle? I'm real sure I don't want to find out from personal experience. Where does this nonsense end?

Britain: Motorcycle and scooter sales are still on the rise here.

Washington, DC: The MRF (Motorcycle Riders Foundation) reports that a House subcommittee has moved out a bill which would ban the Federal agency of NHTSA from lobbying state legislatures. NHTSA has been pounding legislative pavement in the states for helmet laws. If this bill passes, we can count it as one of our biggest victories for motorcycle rights in this country. It means we won't have to fight NHTSA - at least not directly - on helmet laws in the states. If it passes. Contact the MRF for more.

China: The 250,000 motorcycles in South China's Guangdong Province have become the major means of transportation. The 1.07 million people living in the city of Shantou, for example, own 180,000 motorcycles. The problem is now motorcycle jams instead of car jam-ups! transportation isn't used as much there because of the economy of the bikes. Terrible thought! Can you imagine? Japan: Motorcycle production for 1997 is up over all by 23.2% over 1996. Yamaha led with a jump of 64.7%. When is the USA going to get on the bandwagon? Bikes and scooters have been proven environmentally friendly and economical to operate. Belgium: Last April at the International Rider's Rights Conference, the idea of uniting the Federation of European Motorcyclists (FEM) and the Motorcyclists Association (EMA) to form the Federation of Motorcyclists Associations (FEMA) germinated.

FEMA's first meeting is in Brussels on January 10, 1998. It is felt that the combining of the two groups will make them a more effective force for the recovery and maintenance of rider freedoms in Europe and reduce much of the duplication of effort that now takes place. We here in America might do ourselves a favor and watch this closely. It wouldn't be the first time we learned from the European community. Why should we reinvent the wheel every time we do something?

Sam's AIM Tip O' the Month is about complaining. Loud

and clear and promptly to your doc, that is, if you get in a wreck. He's seen from personal experience in trials, arbitrations and settlements with those cheap insurance companies, that if you don't tell the doc all that ails you after you've dumped your bike, it's going to come back to haunt you. Right in the pocketbook.

The reason is that if your problem isn't in the doc's chart notes, it's like it didn't happen. And if there are large gaps in your treatment and complaints - like if the first time a symptom shows up is six months after the accident - they can chew you up and spit you out in court. So the short word is, don't be macho, men and women alike. Tell the nice doctor where it hurts. And then get well, and try to stay out of wrecks!

Gunny again: Hey, don't forget that the Aid to Injured Motorcyclists (AIM) program is there with legal help for ALL motorcyclists injured in accidents, and we are as near as your telephone. 1-800-531-2424 is for nationwide assistance from lawyers who ride. Sam Hochberg's office for AIM in Oregon is 503/224-1106 or 1-800-347-1106 if you're outside Portland. I can be reached at the same Oregon numbers if you have questions for either Sam or me. # INTERNATIONAL LEGISLATION Shaping Up the Laws that Shape Your Future

#### ITALIAN COMPANY INTRODUCES LIFE-JACKET FOR MOTORCYCLISTS

According to Coordinamento Motociclisti, the Italian manufacturer Futura recently introduced an "air-bag" life-jacket which automatically inflates within two seconds to prevent spinal injuries to motorcyclists involved in crashes. The life-jacket was unveiled May 29, 1997 by aerospace engineers at the Politecnico Institute of Milan. Weighing less than half a pound, the garment uses a cable connected from the motorcycle to a carbon dioxide canister fitted to the back of the jacket.

CANADIAN VICTORY OVER NO FAULT INSURANCE The government of British Columbia has announced that No Fault Insurance will not be imposed on the riders and drivers of that Canadian Province. No Fault was being actively considered by the government owned insurance company (ICBC) as an option to escalating premiums. In B.C., insurance rates have gone up about 300% over the past two decades due to the highest accident rate in North America. No Fault was successfully fought by the British Columbia Coalition of Motorcyclists (BCCOM) and various other groups led by the Coalition Against No Fault who feared the loss of the basic right to sue for injuries. pain and suffering. In addition, No Fault was deemed to be very discriminatory against motorcyclists as we are commonly injured in accidents that are caused by the other driver. No Fault injury benefits would have been based on earned income which would have to be proven by income tax forms. The young, minimum wage earners, students and those who work for cash would have received little or no compensation for their injuries. The ICBC will implement various other measures in an attempt to keep rates down, including impounding vehicles of owners with unpaid fines, a graduated license system and increased investigation of insurance fraud. BCCOM hopes that these changes will result in fewer accidents and eventually lower rates without crippling the motorcycle industry as No Fault has done in other jurisdictions, such as in Ontario where insurance rates doubled and numerous models were blacklisted.

FRENCH RIDERS FACE BIKE BAN The French Federation of Motorcyclists (FFMC) is protesting a decision to include motorcycles in the traffic restrictions when pollution rises. In France, because a bike cannot be considered as being a High Occupancy Vehicle (a minimum of three occupants in a car) and because they cannot use liquid gas fuels (GLP), they are automatically outlawed when pollution levels reach a certain point. On the contrary, Athens, Milan and Rome are some examples of large European cities where motorcycles are allowed when the pollution levels rise. FFMC has pointed out to French authorities that motorcycles have distinct advantages over cars in town, such as contributing to traffic fluidity, parking ease, transport time, saved stress and fuel consumption, but have thus far not recieved an answer to their concerns.

# ABATE OF OREGON STATE BOARD MEETING MINUTES DECEMBER 1997

The meeting was called to order at 12:15 PM by Larry Schalk, State Coordinator. There were 10 chapters represented with 9 eligible to vote.

Coordinator's comments: Larry was disappointed at the State Board turnout in November, and at the Planning Session. State officers are not the guiding force of this organization, the chapter representatives are. If your chapter wasn't represented, you need to find out why.

Correspondence: Christmas cards from ABATE of Delaware and Bishop's Sanitary. Letter from Lonnie Roberts regarding the Toy Run.

#### Officer's reports

Legislative Director: Federal: Congress has recessed and our Senators and Representatives are back in the state. Now is a good time to seek them out and lobby for positive motorcycle legislation. Remember, the federal legislation sets the stage for what we can do here in the state, and we are currently in our best position ever to control our future at the federal level. State: Bikepac reorganization e-mail has not had too many replies. We need more input. Please take the time to respond. We also need to start work now planning for the upcoming elections. Several previous supporters are petitioning for candidacy. Please support them in their efforts. TEAM Oregon presented an award to Bikepac and ABATE for our work during the legislative session in getting the increased funding bill through.

Education Director: STEAM planning nearly complete. All chapter officers are expected to attend. Brenda Trainer-Huber brought up contacting the State Education Board regarding the Motorcycle Education Program into the school districts where we are experiencing some resistance. Mel will follow up on this. Chris Viera is still reviewing the "impaired" rider program that OSP is offering its officers.

Education Director II: No report.

Membership Secretary: Mother not in attendance, Larry gave her report. Numbers are still dropping, but show that we are larger than last year.

Newsletter Editor: Still need everyone to help getting ads.

Products Director: Prices reduced on several products. Think Holiday gifts!

P.R. Director: Another busy month on the PR scene. I was able to help write press releases for the South Coast, Washington County and Portland Chapters toy runs. Please, let me know if I can help you, just be sure to give me enough lead time to prepare, and receive approval for the release.

# Proposal to amend ABATE's financial policies and procedures Result of ABATE planning meeting 10/26/97

#### Delete the requirement that Chapter's forward 25% of profits to the State Treasury.

- A) Chapter resentments about the 25% "tax" gets in the way of unity and cooperation statewide.
  - 1) The 25% "tax" is a problem, especially when it must be deducted from the income for an event, regardless of whether the bills have been paid yet.
  - 2) These funds provide only about 5% of ABATE of Oregon's annual income.

## II) Convert chapter bookkeeping to computers and submit all Chapter treasurer's reports on disk.. Using a program called "Quicken."

- A) Need to elect a new State Treasurer means that we must simplify the chapter treasurers' reporting processes and the way the books are kept at the state level.
  - 1) ABATE of Oregon has been fortunate to have had Joy Hoover as State Treasurer. She is professionally trained to deal with bookkeeping for non-profit organizations. A CPA who looked at her work estimated that she has been doing work that is worth \$10,000 or more a year, for free.
  - 2) A candidate for the State Treasurer's position has agreed to accept the position if all Chapters will agree to convert to computerized bookkeeping using Quicken, and inexpensive and simple program.

#### III) Adopt an event sanctioning procedure and guidelines for when and event must be insured.

- A) What does "Sanctioning" mean?
  - 1) "Sanctioning" is a system to help Chapter's plan and organize their events, and protect ABATE of Oregon, Inc. from lawsuits and tax penalties.
  - 2) By completing a sanction application/checklist, a Chapter will be able to identify whether insurance is required for a specific event, and will be able to verify that their promotional materials contain the information that ABATE of Oregon, Inc. is required by law to disclose.
- B) What events must be sanctioned?
  - 1) Any event in Oregon that is promoted using "ABATE of Oregon," "ABATE" or the ABATE logo.
- C) Why is this necessary?
  - 1) To reduce abate of Oregon's risk of being sued for negligence.
  - 2) To limit the risk of being fined by the IRS. Failure to disclose that contributions to ABATE of Oregon are not tax deductible could result in a penalty of up to \$10,000.00.
- D) Who would decide when an event would be snactioned?
  - 1) The chapter will submit to the Board a sunction application/checklist and a rough draft of the flyer, tickets, and/or posters to be used to promote the event.
  - 2) Sanction will be issued when:
    - (a) All items on the checklist have been checked off.
    - (b) All required information is included on rough drafts of posters, flyers, tickets, etc.
    - (c) If the checklist indicates that ABATE of Oregon requires that the event be insured, the Chapter will pay the premium.
      - (1) Chapters are encouraged to consider liability insurance for all events regardless of the guidelines of the sanction application checklist.
      - (2) Chapters may seek insurance coverage form sources other than the main ABATE of Oregon liability policy. A policy purchased form other sources must provide benefits that equal or exceed the benefits of the main policy.
    - (d) If there appears to be a scheduling conflict, either with another ABATE sanctioned event or with other major motorcycling events, the Board will determine whether to sanction the event as requested, or recommend a change to avoid the conflict
    - (e) Remember: too may events in the same region at the same time will reduce the attendance (and profitability) of all of them.

#### E) Timelines

- 1) Insured events
  - (a) Sanction applications for events that need insurance are due at the April board meeting for events scheduled between June 1 of that year and May 30 of the year following.
  - (b) Insurance premiums are due with the sanction application.
  - (c) If an event must be added to the main insurance policy after the state organization has paid the premium in June, the sponsoring chapter must pay and fees that the insurance company charges, in addition to the event premium.
  - (d) If an event is canceled within certain time frames (dictated by the insurance company). The insurance company will refund the premium; and such refunds will be passed back to the chapter that paid the premium.
- 2) Non insured events
  - (a) Chapters are encouraged to submit applications for all the events at the April board meeting.
  - (b) Applications may be processed at any board meeting so that Chapter can continue to conduct smaller, less complicated events throughout the year, as they do now.




