

Our chapter is holding it's 3rd Annual Round Saddle Mountain Run the end of this month, Saturday, June 27th. We will be leaving Robs Restaurant in Seaside at 10:00AM. Our first stop is in Astoria at the Eagles, where we hold our meetings. These folks have been just great with us and we recently gave them a plaque of appreciation. Our next stop will be in Clatskanie at Colvins Pub, a good place for anyone coming from inland to catch us.

Next it's a scenic putt to the little town of Vernonia and a stop at the Cedar Side Inn. This stop may be subject to change to the little bar across the street since at this writing I've been unable to reach them by phone. By run day we'll have it squared away. After that it's a hop, skip, and jump to Hwy. 26 and a stop at Olneys. They have a nice outdoor deck and if the weathers good that's where I'll be! Also another great place to catch us.

Finally we're on our way to the end in Seaside at the Relief Pitcher. He hosts our annual chapter spaghetti feed prior to our toy run each Christmas. Mike is a great guy and will be putting out the food for our run. Hamburgers, beans, and potato salad. He has a nice beer garden out back complete with bar-b-que.

And now before closing a brief word, since we're on the subject of runs, regarding "run captains", or "road captains".

On JJ's run I had the outstanding help of my road captains, Jeff Oletske (our chapter coordinator), Lenny Meyers, Lenny Pletsch, Chuck Jensen and Michael T. These guys really worked hard to keep things running smoothly.

I am surprised that few people recognize the function or the purpose of these folks.

I realize on a run of this size you ride with people you're not used to riding with and I recognize we're not 1%. Also everyone has different skill levels. The 1%ers definitely know the function of road captain tho. As co-run coordinator for our chapter, I haven't

seen the ABATE guidelines for run operations lately so may I refresh you as follows;

- 1. Road Captains functions provide for guidance. (It's not just a case of follow the leader.) Sometimes routes require change. NO ONE should pull out before the road captain.
- 2. Road Captains functions provide for traffic control. They block, and stop traffic. They also deal with the AUTHORITIES. They help keep "the Pack" together by creating the flow thru traffic.
- 3. Road Captains functions also deal with road obstructions. HAND SIGNALS, and a knowledge of them is important! Hand signals were meant to be PASSED DOWN THE LINE!
- 4. Ultimately, Road Captains functions if observed as above spell out SAFETY and EFFICIENCY for you! Road Captains usually will be designated by flags or armbands or patches. If you don't know who your captain is ask.

They appreciate your cooperation. In addition, road captains are also usually responsible for planning the route and stops for gas and food, (and beverage) availability. They also keep an eye on the mirror for stragglers or breakdowns. They secure the run truck. Upon occasion it may be necessary for the road captain to ask for assistance. If you are asked, do not accept the responsibility unless you are capable of fulfilling the request. There is a lot more to being Road Captain than being "the leader". It's major responsibility.

On JJ's run things went well for the most part. Bikes that pull out at random are particularly troublesome in a city like Astoria. Also there were several times I pointed out road obstacles, or motioned to slow down. When I looked in my mirror, these signals were not passed on.

I've been riding a long time and I guess it just makes me nervous when my traditional training isn't observed by others. I figured everyone knows this stuff but they don't. If you ride in a 1% club you'd be fined big time for some of the above infractions.

Oh Well, I'll get off my soap box now and wish all you mothers a Happy Belated Mothers Day., and hope everyone had a safe Memorial weekend. (Fossil) This month is also Washington's Spring Opener in Zillah.

Rot Path

Is it Fossil yet y'all?

Remember them grey ol' weeks of days in May that seemed like such a dirty trick after that spell of warm weather? Probably a best fergotten bad memory to us now that June is here.

Forward into the past.

Here's a headline fer ya:

ROT PATH NEARLY SIDE-SWIPED AND RUN OFF ROAD

ROBERTS, OREGON

Rot Path, that well beloved user of apostrophes and horrible grammar in the monthly A.B.A.T.E. newsletter, narrowly escaped serious injury or death on Tuesday, 14 April 1998.

After working overtime that night, he was riding his scoot southbound through the community of Roberts southeast of Salem about 2140 at the posted speed limit of 35 mph. A vehicle approached from behind and began following less than 2 seconds off of the bike's rear wheel.

As Rot Path came abreast a sign south of town that eliminated the speed limit he began to accelerate. Only then did he realize that the tailgater was starting to pass him. This is a section of road with double yellow center lines just before a curve. As the car pulled along side Rot Path, another vehicle suddenly appeared rounding the curve. The passing car swerved back towards Rot Path's side of the road.

Rot Path's cat-like reflexes and Experienced Rider Course training cut in automatically. Braking, swerving, swearing, and honking Rot Path just barely managed to avoid being hit by the passing vehicle. That driver didn't even slow down to see if the motorcyclist she nearly hit was okay. She sped off at speeds Rot Path estimated to be about 71.3 mph.

Rot Path advises anyone riding on River Road South out of Salem to watch out for a late-model grey Ford LTD, license plate 783-AJX with a inoperative brake light driven by a young lady with long honey-blonde wavy hair.

"I ain't puttin' up with this kinda thing any more," stated Rot Path. "Rot Path is contacting the Marion County District Attorney to swear out a complaint against that driver. These kinda cage drivers gotta be held responsible fer their actions out on the road. If we don't start makin' `em account fer themselves, they're just gonna keep takin' chances until some poor innocent scooter tramp gets hurt, paralyzed, or kilt."

Unfortunately our computer software is having a terrible time translating the previous statements into English.

It seems that Marion County has a little publicized program in place that allows citizens to report and have citations issued to drivers who endanger other users of the roads. Get as much info about the vehicle an' driver as you can, then go down to the District Attorney's Office across from the Marion County Courthouse. They'll review yer situation an' if ya got enough to go on, they'll initiate proceedin's. You'll need to go before a judge an' attest that yer facts are true, then a citation'll be issued to the chowderhead who nearly did ya in.

As noted above, Rot Path ain't takin' it no more. All cage drivers are on notice that endangering bikers is gonna cost `em fines an' increased insurance premiums.

The flip side of all this is that we, as bikers, gotta keep educatin' drivers, especially young ones, to watch out fer us two an' three wheelers out there on the asphalt.

There's a couple of ways to go about it: The first is A.B.A.T.E.'s on-goin' program where designated riders go into the school driver ed classes an' give a presentation. The second is to catch up with errant drivers an' ask 'em why they did what they did an' did they realize they could have hurt or killed another human bein' by their actions. (This second action has gotta be used with desecration as there are some real bad-asses out there on the road. It's also the most effective with cage drivers 'cause it makes 'em do something unusual — think.)

On to other things...

Rot Path was a bit tardy gettin' to the March chapter meetin' cause he was hangin' around with a bunch of rocket scientists. (No, not traffic light engineers.) These was the model kinda rockets an' there was a bunch of `em converged at a field west of Sheridan blastin' smoke trails into the sky. Rot Path got so carried away with watchin' `em that time kinda gotta away.

Split fer Salem an' found 18 fine folks along with 6 bikes at the meetin'. Got volunteers to pick up an' set up parkin' signs fer the May Awareness Rally; heard about Democrats proposin' to link reassurance to licenses instead of vehicles ('bout time, eh?); set up a Fox Creek committee meetin'; decided to convert the chapter generator to gas to avoid manifold icin'; an' formed a Toy Run committee.

just sighs an' hops on the bike sans helmet to putt off after him. Turns out the rocket was a lot further away than he thought. He hops on the back of the bike an' we bounce across a country road to another field an' keep searchin'. Finally Rot Path's keen vision spots the wayward model an' it's recovered.

Comin' back on the road must have been a sight fer anyone who was lookin': motorcycle, two lidless riders, an' a six-foot rocket. Just the shadow of it was enough to make Rot Path crack a grin. 

Pounding the Pavement Pays Off for the AMA's Washington, DC government relations team in their effort to urge legislators to sign a letter authored by Representative John Shimkus (R-20th,Ill) to support language originally introduced in the Senate version of the Highway Re-authorization bill (S.1173) that would ban NHTSA (National Highway Traffic Safety Administration) from lobbying State legislatures in opposition or support of any legislative initiative. As worded, the legislation would continue to allow NHTSA to provide factual testimony at the state level should they be called upon to testify. It would, however, dramatically limit NHTSA's ability to spend federal tax dollars to lobby state legislatures. NHTSA has in recent years created videos, pamphlets and other materials with step-by-step instructions to enact helmet laws to aggressively lobby against motorcyclists.

The lobbying effort, spearheaded by AMA Washington Representative Edward Moreland and Legislative Assistant Kelita Svoboda, consisted of a letter writing campaign to members of Congress, intensive phone negotiations, and personal visits to Congressional and Senate offices. Moreland and Svoboda were joined by Steve Zimmer of the MRF and Denny Danks and Mark Maxwell of ABATE of Iowa in contacting the Iowa Congressional delegation. Moreland, said, "We made a great deal of progress in a short amount of time. Everyone involved made a tremendous contribution to the effort. Indeed, we would like to thank each member of Congress who assisted us in getting this letter into the hands of Representative Shuster (R-9th, PA) prior to the date the Conference Committee convenes to consider final language. The combined efforts of the AMA government relations team, along with our friends at the MRF and ABATE of Iowa, enabled us to keep this crucial legislation before the eyes of those members of Congress empowered to decide the fate of this very important language."

Co-signers to the letter are: Rep. John Shimkus (R-20th, Ill), Rep. Leonard Boswell (D-3rd, IA), Rep. Howard Coble (R-6th, NC), Rep. Jerry Costello (D-12th, Ill), Rep. Phil Crane (R-8th, Ill), Rep. Jennifer Dunn (R-8th, WA), Rep. Dennis Hastert (R-14th, Ill), Rep. Ron Kind (D-3rd, WI), Rep. Don Manzullo (R-16th, Ill), Rep. Anne Northrup (R-3rd, KY), Rep. James Sensenbrenner (R-9th, WI), Rep. John Shadegg (R-4th, AZ), Rep. Ted Strickland (D-6th, OH), Rep. James Traficant (D-17th, OH), Rep. Jerry Weller (R-11th, Ill), and Rep. Don Young (R- at large, AK). Contact these people and thank them for their continued support.

A bill that threatened to increase Kentucky motorcycle insurance premiums dramatically by mandating no-fault insurance coverage for motorcycles nearly became law. Actually, the bill did become law—but not before the compulsory no-fault insurance provisions were stripped via the approval of a substitute bill in the Kentucky House Banking

and Insurance Committee, reports the American Motorcyclist Association (AMA).

SB-55 (Seum-Dist. 38), as originally introduced, would have stripped from Kentucky statute the protective provisions that exempt motorcyclists from the requirement to purchase Basic Reparations Benefits (no-fault insurance) for their motorcycles. The state provides that motorcyclists may purchase this coverage at their option.

The supporters of SB-55 claimed that uninsured and underinsured insurance coverage was not available for Kentucky motorcyclists and that this bill was designed to fix this. In fact, SB-55 had nothing to do with uninsured and underinsured insurance coverage, which is readily available to Kentucky motorcyclists, but tampered specifically with Kentucky's no-fault insurance law as it pertains to motorcycles. Under no-fault, the costs of accidents caused by car drivers are

Under no-fault, the costs of accidents caused by car drivers are shifted to the motorcyclists they hit. The resulting claims, in most cases for accidents in which the motorcyclist is not at-fault, drive premiums up drastically.

Three states—Massachusetts, Delaware and Hawaii-tried to incorporate motorcycles into their no-fault systems. In all three states, the motorcycle insurance industry virtually collapsed as rates soared and insurance carriers withdrew from the market. And all three states subsequently scrapped portions of their no-fault systems to accommodate motorcyclists.

SB-55 was on a fast track through the legislature. The bill had passed the Kentucky Senate without question and was well on its way toward passage in the Kentucky House when the AMA mailed an alert to Kentucky AMA members and the House Banking and Insurance Committee.

An overwhelming response by concerned AMA members in Kentucky, and motorcycle clubs like Saddleback East and Chapter G, GWRRA resulted in the adoption of an innocuous substitute bill to SB-55 by the House Banking and Insurance Committee. Instead of making no-fault insurance mandatory, the substitute bill affirmed that motorcycle insurers in Kentucky must have Basic Reparations Benefits coverage available for purchase for those motorcyclists wishing to do so.

"SB-55 had the potential to be quite costly for Kentucky motorcyclists," noted Sean Maher, AMA Legislative Affairs Specialist.

The motorcyclists who voiced their concerns and the legislators who responded are to be congratulated for tempering this ridiculous initiative to mandate no-fault insurance for motorcycles."

In an article titled PUTTING A LID ON IT by Don Babwin of the April 19, 1998 Chicago Tribune Sen. John Cullerton has thrown in the proverbial towel. With nothing to show for years of trying to push through a bill that would require motorcyclists to wear helmets, the Chicago Democrat says enough is enough. "Basically I've given up," said Cullerton, who has been trying to enact a helmet safety law since 1989.

What Cullerton has butted up against is the same kind of organized effort that happens whenever a state considers forcing motorcyclists to strap on helmets. In the late 1960s, for example, motorcyclists circled the Capitol after Gov. Richard Ogilvie signed into a law a helmet safety bill ruled unconstitutional months later. In Cullerton's case, the opposition has been A Brotherhood Aiming Toward Education, a motorcyclists organization known as ABATE.

Opponents, including ABATE, say that helmet use is none of the government's business. "Basically it's a fundamental issue of freedom of choice," said Todd Vandermyde, ABATE's legislative coordinator. "Government should not be making these decisions for individuals."

"They're too organized," Cullerton said. "A hundred thousand are active." And he has found "no corresponding group to push for the law."

"Some (ABATE) people will work precincts for (politicians). It is hard to find people to work precincts," said Cullerton.

Cullerton said he doesn't see much "political will" to enact a motorcycle helmet law. He said for now he will be content to "nibble around the edges until people come to their senses."

One way he's done that is with a bill that would require anyone who registers a motorcycle in the state to become organ donors. "The least you can do is make sure if they are in a crash we can get their organs," he said.

Vandermyde said ABATE will fight that bill, which is stuck in the Rules Committee.

Minnesota Governor Arne Carlson signed pioneering legislation to prohibit discrimination against motorcyclists. Minnesota became the first state in the nation to make it illegal for any place of public accommodation to restrict access to motorcyclists simply because of their chosen mode of transportation or group affiliation.

While every state has laws to protect against discriminatory actions based on race, creed, religion, gender, etc., and such discrimination is prohibited by the United States Constitution, Minnesota has set the precedent for including motorcyclists as a protected class of citizens. Several states have introduced similar legislation to include anti-discrimination protections for style of dress, mode of transportation or club insignia, but Minnesota's new law specifies motorcyclists and can serve as model legislation for other states to follow. It states: "A place of public accommodation may not restrict access, admission, or usage to a person solely because the person operates a motorcycle or is wearing clothing that displays the name of an organization or association."

Bob Illingworth, lobbyist for Minnesota's motorcycle rights organizations, summed up the victory by saying, "Although this is a great win for all motorcyclists, in Minnesota and throughout the country, it is indeed sad that we have to have a law passed to guarantee that those who ride motorcycles have the same rights as any other citizen."

It's not exactly a scene out of "The Paper Chase," but a group of students at the University of Denver College of Law have formed what they say is the nation's first legal society devoted to motorcyclists and the issues we face.

Working with their faculty adviser, these students have made plans to conduct a series of charity rides to benefit the Children's Legal Advocacy Group of Denver. Society members are also researching motorcycling issues for an upcoming law review article. And they have supported the reelection campaign of Sen. Ben Nighthorse Campbell (R-Colorado), a longtime proponent of motorcyclist-rights issues in Washington, D.C.

"Given the variety of legal issues motorcyclists face in this country," notes Eric Lundquist, AMA legislative affairs specialist, "it's great to see these law students getting involved." Forest Service Management Reorganization — From a statement of U.S. Secretary of Agriculture Dan Glickman on Forest Service Management Reorganization April 28, 1998

"For many years the Forest Service has suffered from serious accountability and financial management problems. We know this from our own internal USDA work, as well as from other sources including the General Accounting Office, our Office of the Inspector General, and from the Congress. These problems can no longer be tolerated. This situation makes it difficult for our field personnel to offer the kind of service the American public deserves."

We've been working closely with Forest Service Chief Mike Dombeck on a series of steps to address these problems. Chief Dombeck and I are announcing a number of actions we are taking that are designed to improve the management of the Forest Service. While the Chief will provide the details, there are essentially three things we are determined to help the Forest Service accomplish: put an organization in place with clear accountability for both program and management objectives; make sure the Forest Service has the resources it needs to address the substance of the management problems; and fill key leadership positions.

"We must all work together, on the same team, with the same message –and the same mission – so the Forest Service can address its problems and continue to serve vigorously the American people in the 21" Century."

And you thought fighting a helmet law was tough?

Saudi Arabia's recently opened Harley-Davidson dealership must close three times a day for prayer. By law, the nation also prohibits women from riding motorcycles.

While in Nevada you are required to yield to cows and will be considered at fault for any accident involving cattle.

A possible European ban on bike rebuilding could come from the new European motor vehicle recycling directive. If enacted, it would ban private dismantling and rebuilding of motorcycles using old parts. A similar German law introduced at the start of April bans private recycling by requiring all old vehicles to be given back to car dealers or to authorized recyclers. The German law does not include motorcycles, but the European one (End of Life Vehicles Directive, COM(97)358) does.

German riders asked the Federation of European Motorcyclists Associations (FEMA) to alert other European riders to the potential problems if motorcycles are left in the EU directive, and to warn against apathy which would seal the fate on private recycling (rebuilding).

Australian motorcyclists may be forced to fit front number license plates to their bikes under a recommendation from their Parliament's Committee for Road Revenue.

In a document leaked to the press recently, the committee said that motorcyclists were currently "enjoying immunity from roadside speed cameras" which are unable to record the license plate numbers on motorcycles as they do on cars.

The document is quoted as saying; "Motorcyclists are much more likely to speed, so this means the potential for revenue earnings is greatly reduced." The report recommended that license plates be mounted on the front fender, perpendicular to the top surface of the guard, of all motorcycles to enable speed camera detection.

No homicide charge for trooper

State cop charged with reckless driving in accident that killed motorcyclist Tuesday, April 28, 1998

A state police trooper whose out-of-control cruiser killed a motorcyclist on a winding York County road will not be charged with vehicular homicide, the York County District Attorney's office announced today.

Called to investigate the accident involving Trooper Gerald Devlin and the motorcyclist, the DA's office decided to charge Devlin only with reckless driving, driving at an unsafe speed and failure to drive on the right side of the road, all summary offenses.

The crash occurred on Route 851 in Codorus Township around 5 p.m. March 29. Devlin had turned his cruiser around to pursue a car that had no inspection sticker. Shortly after turning around, Devlin crashed head-on with a motorcycle

driven by 39-year-old Kenneth Saunders Fowler, of Monkton, Md.

"I don't think anything would be gained by charging the trooper," District Attorney Stan Rebert said. "It was a terrible tragedy; he was doing his job but he exercised extremely poor judgment, and Mr. Fowler was killed."

Two weeks ago, state police investigators turned over their preliminary findings to the DA's office.

Rebert's office investigated the accident while state police conducted a 'parallel, internal investigation,' Rebert said. The results of that investigation are expected soon, he said.

An accident reconstruction revealed Devlin was speeding at the point of impact, driving 58 mph in a 45 mph zone, just south of the Route 516 intersection.

The curve has 30 mph yellow warning signs, but those signs are only a warning and are not enforceable speed limits, police said. The yellow warning sign facing Devlin's direction of travel, in the westbound lane, had been missing for more than a year.

The car that was being pursued has not been located.

ABATE of Iowa is happy to announce that Iowa's handlebar height restrictions have been repealed effective July 1st. The law has been in effect for years, but rarely enforced until last summer, when proof of liability insurance for all vehicle operators became mandatory. Law enforcement agencies in some areas began using the handlebar height as a reason to stop motorcyclists to check insurance cards. ABATE of Iowa targeted this repeal as a priority during this legislative session.

On a much more somber note, Dan Klesner, ABATE of Iowa District 18 Coordinator from Ft. Madison Iowa, passed away tonight following a one-vehicle motorcycle accident May 2nd. While details are still rather sketchy, is has been reported that Dan was the last in a group of motorcycles, and had tried to avoid a dog that ran out in front of him.

Dan's wife, Nina, received a broken arm and leg. She has been released from the hospital and will be home convalescing.

Dan had resurrected the defunct District 18 a couple of years ago, and gotten the district back on its feet. District 18 was one of the founding organizations of the Big River Rally, which takes place in Ft. Madison each June. He will be sorely missed by the riders in this area.

EDUCATION DIRECTOR REPORT

The monthly State Board Meeting was hardly over when I started to receive reports from Jud Whitcher about the classes he has been doing and the students taught in the schools. HOWEVER, he is the ONLY one who has submitted a teaching report for the last month. On March 18, he taught one class at Sandy High School to 27 students. On this occasion he was assisted by Lee Austin and Kerry Trotter, of SE Portland chapter of ABATE. The teacher, (Mr.)? (Ms.)? Ehrhart noted on the report form "It's great when you remember to come even when I forget that you are coming". The student comments reflected that they really enjoyed the fact that someone took the time to come to the school to educate them and that they enjoyed the clothes and the message.

On April 15th, he went to Sandy High School and again presented the Awareness class to 26 kids. Again, the teacher Ehrhart stated that he was glad to have the class presented to his students. The kids also noted that they enjoyed hearing about the reasons that motorcycles need more consideration on the road. Again, the big interest was on the clothes and the professional manner in which Jud grabbed and held their attention through the whole class. Many liked the movie and a few didn't. This is usual.

On April 29th, Jud presented the Awareness Program to 70 students at Gresham high School, (if I read his report correctly) It indicates 35 B, and 35 G. I think this means 35 boys and 35 Girls. The teacher, Don Knight, said 'We liked the relaxed method of presentation. Good, Much hard information for new drivers.

It seem that the school year is quickly drawing to a close. Some of the districts are going to have driver's ed during the summer. Make those contacts. Help protect our safety on the road. Do your part. A few instructors can't do it alone.

I'm a defense contractor working for the Department of Defense at NAWCAD Pax River. I have a 98 FXSTC which is my 3rd Harley, been riding about 20+ years and I've been reading a lot about helmet laws and have been hoping the Maryland helmet law would be rescinded but it doesn't look good for this year. There was a lot of effort by many people but the safety nazis over rode another freedom of choice decision. I've sent numerous letters asking for the repeal myself and every response comes back to safety issues and cost vice the real reason, which is freedom of choice. Since every response only talks of safety I decided to look into some military testing on helmets to see what I could come up with and found several interesting reports from the US Army Advanced Research Lab: USAARL Report No 86-11 / Biodynamics Research Division / Improved Design Criteria For Crash Helmets / R. Fred Rolsten & J. Haley Jr. / May 1986 Impact Protective Comparison of the SPH-4 Flight Helmet to a Commercial Motorcycle Helmet Basic conclusions:

1. The motorcycle helmet tested did not provide adequate force attenuation to prevent concussion and/or serious injury at all energy levels greater than produced at a 1-meter drop height.

2. Existing helmet standards permit the production of helmets which provide less protection than is possible, practical and feasible.

3. The motorcycle helmets tested could be changed to provide more adequate protection by the doubling of the liner thickness to approximately 2.5cm.

USAARL Report No 85-5 / Biodynamics Research Division / Dynamics of Head Protection / Impact Protective Comparison of the SPH-4 Flight Helmet to a Commercial Motorcycle Helmet / R. Fred Rolsten & J. Haley Jr. / July 1985 Basic conclusions:

- 1. The motorcycle helmet tested did not provide adequate force attenuation to prevent concussion and/or serious injury at all energy levels greater than produced at a 1-meter drop height.

 2. Existing helmet standards permit the production of helmets,
- 2. Existing helmet standards permit the production of helmets, which provide less protection than is possible, practical, and feasible.
- 3. Using the US Army's SPH-4 as a referent, the transmitted force from helmeted-head impact measured by headform accelerometers can be reduced by 50% with only 0.1kg increase in helmet weight. This dramatic force reduction can be achieved using a thicker, but lower density foam liner and a larger, but thinner exterior shell.

USAARL Report No 88-15 / Biodynamics Research Division / SPH-4 US Army Flight Helmet Performance 1983 -1987 / Peter Vyrnwy-Jones, Bernard Lanoue, Douglas Pritts / August 1988

Basic conclusions:

1. The most common sites for helmet impacts are frontal (38%) and lateral (30%). The rear of the helmet was involved infrequently and severe damage invariably was associated with nonsurvivable accidents.

2. N/A

- 3. Abrasion, delamination, and fracture were the most frequently recorded type of helmet damage. Punctures were rare and associated with nonsurvivable accidents.
- 4. Helmet standards, which require the use of hemispherical impact surfaces and puncture resistance testing are unrealistic and bear no relation to the type of helmet damage actually observed in practice.
- 5. Earcup damage continues to be a major problem and basilr skull fractures correspondingly were the most common single type of skull fracture sustained.
- 6. 9. too much to write right now.

10. Helmet loss, rotation, and stability remain a major problem. The factors mainly responsible are:

The improved dot fasteners continue to fail in survivable accidents. The retention tab system is of inadequate and variable strength. The napestrap does not appear to prevent the forward rotation of the helmet during impact sequence. Foam liner protection is inadequate in the frontal and lateral areas, where most impacts occur. Over 90% of all amnesia or unconsciousness were subsequent to frontal, lateral or facial impacts. There is a concern about the quality of helmet fit in the field as opposed to laboratory conditions.

I have more info and a lot more detailed such as methods of tests etc, and I'm more than willing to send a copy of them if they could be of some use.

Letter to the editor

A recent motorcycle accident 4 miles north of Albany really got my attention. The driver of the motorcycle was killed in the crash and his passenger was injured. According to the newspaper report the motorcycle was changing lanes at the time of the incident. As the Education Director of ABATE of Oregon, it is my task to keep track of such incidents and to keep our membership informed as to the probable cause. One of the conditions that has concerned me greatly in the past is the way the worn ruts in the highway have been patched.

Anyone who drives I-5 knows that the road has been overlaid in the ruts only, instead of paving the entire lane. This creates an additional hazard for those who ride motorcycles. As the patching material wears out in a few months, there are additional ruts created which multiply the hazards for motorcyclists. I have brought my concerns to Oregon Department of Transportation at their annual conference last fall. I know that motorcyclists are few in number, and that change takes place slowly in the way things get done when dealing with the government, so our message is mostly ignored. This needless death was undoubtedly caused by the worn-out paying in the ruts in the road. Having ridden my motorcycle back and forth from Albany to Salem five days a week for 17 years has taught me to avoid those ruts by riding off to the side of the lane and to never cross them in rainy weather unless forced to do so. Can we expect everyone from out of state to have the same experience to rely on? Not at all. Oregon must change the way the roads are resurfaced to protect the safety and lives of ALL motorists who use those roads. How many other crashes have been caused by those ruts?



From The

GUNNYS SACK

I just returned from the annual National Coalition of Motorcyclists (NCOM) and Aid to Injured Motorcyclists (AIM) conference, this year in Dallas, Texas. I attend these functions annually and come home pumped up and ready to slay the dragons with renewed vigor. These conferences are so full of information one person can't fully absorb it all. It was a doozy: 575 bikers from around 40 states, representing ABATE's and similar MRO's, and representing 70 patch clubs as well. The Confederations of Clubs around the US were represented too. There are currently 25 of them in 18 states. The patch clubs gave birth to the motorcycle rights movement, and now, in the COC's, they're coming back to fight discrimination in the courts.

This year I rode the scoot to the NCOM conference, and the trip was spectacular. I've never seen so much green in the parts of the country that are traditionally brown! All the deserts are bright green and flowers everywhere I looked. It's as if "El Nino" has given us rebirth.

There is rebirth among bikers with our ongoing fight for liberty in this country. One concept I finally figured out from one of the seminars at the conference is that freedom is relative. If you have a family or if you own anything of any value, then these things take commitment, and there is diminished freedom in that sense.

LIBERTY is what we really need to be concerned about. We create what freedom we want, but to exercise those freedoms as we choose as bikers, we need to limit intrusion from legislative bodies that know nothing of our lifestyle, and that would restrict out liberty.

I'm talking about the force feeding of things like NO FAULT insurance (which is NO BARGAIN insurance), and being excluded from the planning of the new SMART highway systems being tested all over the country. There are tollgates on some highways in some states that do not recognize motorcycles! And we still face discrimination in many motels, restaurants, and lounges. Try getting a room here in Oregon at our annual Rhody run in Florence if you're on a bike. There are still private communities that refuse to let motorcycles on the streets where the bikers own homes! As I mentioned last month, in Belgium, trikes are banned from highways and they want passengers to wear seatbelts if they are restored to the road. In other parts of Europe motorcycles pulling trailers are not allowed. In Germany they're fighting road bans on roads they all pay taxes to maintain.

All this is worrisome because these things affect ALL motorcyclists, regardless of whether you are a club member, part of an association, or unaffiliated. These things are starting to show up in our own country and we need to be vigilantly watching for the problems they create for us.

HELMETS: I've heard some flack directed at those state biker groups that have made compromises to get their helmet laws modified, as happened in Texas and Kentucky. In some cases, they've accepted a requirement for health insurance or for rider ed., to ride free. I rode in Texas on this trip, and got to pull off my hat for awhile. I was not stopped to see if I had taken a rider course or had health insurance.

NCOM's position has been to assist and support the bikers rights groups in their states to fight their fight as they see fit for their state. NCOM has been staying out of the business of trying to dictate to the state motorcycle rights people what's best for them. That's a local decision.

Now I'm not saying it's right or wrong, but these folks made a compromise to succeed when many of the rest of us failed. They now have a choice in their own lifestyle. They're legislative warriors that have learned to use the system to their advantage. They can go back later and remove some of the compromise insurance provisions they didn't like, but that they felt they needed, as a political reality, to get their bills passed. They are, at least, riding with FREEDOM of choice.

Bikers in these states now also have more credibility in their legislatures. By changing their helmet laws, they now have the opportunity to be effective with still more work of protecting the rights of their people.

DISCRIMINATION: Next, bikers may look for protection of their civil rights, as I learned at the NCOM conference they did in Minnesota. We heard about the nation's FIRST LAW specifically protecting civil rights of motorcyclists in public accommodations! Congrats to bikers there!

NEXT: The '99 NCOM convention will be next May in Phoenix. I hope that you all will consider attending. My promise to you is that you will NOT be disappointed. If you go and learn nothing you'd have to be a walking box of rocks. We not only learn from our contacts with the various motorcycle rights groups around the country; we have the opportunity to impart our knowledge to others. Some of you might enjoy the West Coast regional conference, Dec. in Honolulu. I'll keep you posted as to date and time.

AN UGLY INCIDENT occurred recently at the funeral of a fallen brother. Tim Stewart was a good guy, and a mechanic my boss Sam Hochberg's mechanic as well - at Columbia Motorcycle up in Vancouver, WA, who tragically died on his bike in April. He was also a member of the Free Souls M.C. Members of his and other area clubs went to the funeral to pay their respects, as did Sam Hochberg and I.

Sam and our other riding lawyer, Spike (aka Spencer Neal), got pulled out of the chapel by upset bikers, because the Vancouver PD and Clark County Sheriffs were out in the parking lot of the fineral home, writing down the license plates of the bikers there to mourn. They refused to stop, and refused to leave. After legal arguments didn't work, Sam asked the cops why they had to do that, to disturb friends and family who were there to mourn, with such RUDE behavior. The answer of this cop? "Because I can." Those words are going to echo in my head for a long time. All in all, it was a very sad day in Vancouver, for more than one reason.

News Bits' n Pieces: Denmark: Good news here: The trailer ban for motorcycles has been repealed here. Motorcycles will be able to pull trailers in this country for the first time later this summer. Congratulations warriors, job well done.

Pennsylvania: The outrage over the death of Ken Fowler at the hands of PA state trooper Devlin continues with Devlin having to pay a paltry \$400.00 in traffic fines after killing a man on a motorcycle while this cop was chasing a traffic violator that had committed the crime of driving with an expired inspection tag on his car. How long must we allow law enforcement representatives to violate the laws of this land with impunity?

Nevada: You are required to give COWS right of way here and will be considered AT FAULT if you injure one on the roadway. Australia: Bikers here face the possibility of putting a license plate on the front of their scooters because roadside speed cameras cannot identify them by plate number from the front or side!

Sam's AIM Tip O' the Month: This time it's not a legal one, it's a riding tip: Sam's seen a number of accident cases between large trucks and buses and bikes - and you know who loses in that one. It usually happens on four lane roads, with two lanes in each direction. You see a big truck or bus moving from the right to the left lane, so you figure you can just get around it in the right lane. Don't do it. These big guys need to swing left first, before they turn right. If you're on the right when that happens, you get cut off big time.

Keep the round side on the bottom. Gunny, Oregon AIM Chief of Staff






NEW BUSINESS


