

Bits and pieces are happening down here right now. Still not much is going on with the Chapter.



Enough soapbox....







### CARRYING FIREARMS IN PORTLAND, OREGON

For you folks who live in or travel through Portland, I thought you might know about some of the city's ordinances, found in Portland City Code 14.32, about carrying firearms which appear to be stricter than the state's laws.


First, it is unlawful to carry a firearm, loaded or unloaded, upon one's person in a park, school, or public building.

Second, it is unlawful for an person on a public street or in a public place to carry a firearm upon his person, or in a vehicle under his control or in which he is an occupant, unless all ammunition has been removed from the chamber and from the cylinder, clip, or magazine. A few extra traps for the unwary exist here. If you are traveling with someone in a vehicle and that person has a firearm in that vehicle, unknown to you, you could be arrested!! Also, emptying the firearm is not good enough; the cylinder, clip, or magazine must also be emptied.

Both of the above sections do not apply if you have a concealed weapons permit EXCEPT that no one can carry firearms into the Multnomah County Courthouse or the United States Courthouse by order of the courts.

Finally, it is unlawful for any person carrying a firearm upon his person, or in a vehicle under his control or in which he is an occupant, to refuse to permit a peace officer to inspect that firearm after the peace officer has identified himself as such. It appears that even if you have a concealed weapons permit you have to produce the weapon for inspection and I have no doubt that the cop will not let you have your weapon back until after he has concluded his investigation at the scene. This particular code section probably explains in part why cops want to know the identities of every person in a vehicle regardless if that person is a driver; once they get your name from you, they run it through the computer and if you hold a concealed weapons permit, it will show up. The next step is that the cop demands to know if you are carrying. As I have said before the mere fact that you have a concealed weapon permit does not alone give the cop reasonable suspicion to conduct a pat search of your person for weapons. And as I have said before, you never have to say ANYTHING to a police officer including and especially your identity. Drivers have to produce identification, however, as do passengers who are being cited for violation like a seat belt violation.) The only safe thing ever to say is: 'I want to speak with my lawyer."





### California Riders Face New Emissions Regulations

WESTERVILLE, Ohio -- The future course of motorcycling in California -- both on and off the road -- could be set over the next several weeks by an agency of the state government, reports the American Motorcyclist Association (AMA).

The California Air Resources Board (CARB) is set to release new emissions standards for road bikes and modified rules for off-highway bikes. And the consequences may be felt by motorcyclists throughout the country.

In the road-bike arena, CARB's latest plan would slash maximum allowable tailpipe emissions by more than 80 percent over the next 10 years. That would make the California standards 12 times as strict as the federal standards governing motorcycles across the United States, and three times as restrictive as the toughest standards even being proposed in Europe. In the process of meeting those standards, CARB officials say, motorcycle manufacturers will be forced to adopt car technologies like fuel injection and catalytic converters that would raise the cost of new motorcycles substantially.

The proposal, unveiled at an Oct. 7 public meeting of CARB officials, actually represents a compromise from the board's previous plan, which would have cut emissions from road motorcycles by 90 percent. The CARB plan would phase in the new standard in two stages, with a 50-percent reduction in emissions by 2004 and the full reduction by 2008.

However, motorcycle industry officials say the CARB compromise plan still goes far beyond any cost-effective approach to motorcycle emissions control. They have proposed an alternate plan that would reduce tailpipe emissions from new motorcycles by 40 percent over the same 10-year period.

The two major forms of emissions being addressed by the standard are hydrocarbons (HC) and oxides of nitrogen (NOx). Road motorcycles over 250 cc in California are limited to a total of 2.1 grams of HC and Nox per kilometer traveled currently. The CARB plan would lower that to 1.0 grams per kilometer by 2004 and to .4 grams per kilometer by 2008. In addition, carbon monoxide levels would have to drop from 12 to 6 grams per kilometer in 2008.

The CARB presentation at the meeting indicated that virtually all motorcycles sold in the state by 2008 would have to use computer controlled fuel injection, three-way catalytic converters with feedback control, and pulse air injection systems to meet the proposed standards.

Currently, only a handful of high-end motorcycles come with any of those.

"CARB estimates that those changes would increase the cost of a new motorcycle by about \$278," said Robert Rasor, AMA vice president of government relations. "That estimate is much too low.

"Currently, one motorcycle manufacturer offers carberuted and fuel injected versions of the same model, and the difference in cost for that one element is \$800. Based on that, it's likely that the cost of these emissions standards will easily total more than \$1,000 per motorcycle, which could amount to a 20 percent surcharge added to the retail price."

The AMA was among several groups arguing against adoption of the new standards at the CARB meeting. Those groups noted that the lower volume of motorcycle sales makes it more difficult to amortize the cost of new emissions control equipment in the motorcycle market than in the automobile

market. It was also pointed out that the nature of motorcycles, many of which come with exposed engines, makes fitting carlike emissions plumbing much more difficult.

And with California leading the nation in motorcycle sales, it's likely that these changes will have a significant impact on motorcycles sold throughout the county.

"Every manufacturer will have to have these regulations in mind when assembling a product line for the U.S.," said Rasor. "Models that don't lend themselves to such add-on devices may disappear from the American market, and California only models are likely to appear, raising the costs of warehousing and distributing all road motorcycles."

Meanwhile, California's off-highway motorcyclists can only wait for additional news about a CARB plan that will have an enormous impact on them.

At the Oct. 7 meeting, CARB officials announced that they are amending a controversial set of emissions regulations governing off-highway motorcycles that have been in effect for nearly two years. Those regulations have effectively prevented the registration of all two stroke motorcycles and ATVs for recreational use on public lands.

The AMA, along with its District 36, 37, and 38 organizations, has worked with the California Motorcycle Dealers Association to get those standards amended since they were first implemented. And a compromise has been reached that maintains the existing standards, but provides two important exceptions. The first allows non-complying motorcycles to be used in competitive activities like enduros and desert races. The second opens up the possibility of registering non-complying motorcycles for non-competitive use in specified areas during times of the year when air quality is expected to be good.

"The serious effects of this regulation can be seen in the fact that prior to these standards, nearly 100 different models of motorcycle were eligible for registration as off-highway vehicles in California," said Rasor. "Today, that number is seven.

"We are disappointed that we were not successful in getting this regulation eliminated," he added, "but we are hopeful that we can at least open up significant riding areas during major portions of the year."

Unfortunately, CARB's final list of open areas and seasons wasn't available in time for the Oct. 7 meeting, and it is not expected to be released until Oct. 13.

"This is a proposal in which the devil is in the details," said Rasor. "If the final plan includes significant opportunities for off-highway motorcyclists, then our efforts over the past two years will be worthwhile. At this point, however, there's no guarantee that will be the case."

CARB is expected to make its final decisions on both the road and off-road emissions issues at a meeting scheduled for 9:30 a.m. Dec. 10 in Sacramento. In the meantime, the two sets of standards are open to public comment. ### Auto Choice Reform Act

In the weeks just prior to the Meeting of the Minds a piece of legislation created quite a stir around the nation. The Auto Choice Reform Act of 1997 (the No Fault Insurance Bill), originally introduced as S. 625 in 1997, stalled in the Commerce Committee and appeared to have little chance of passage. On September 9, 1998 the sponsor, Senator McConnell (R-KY), revived the bill by introducing the same language with a new bill number S. 2454. The bill was placed directly on the calendar under General Order number 568, bypassing the normal committee procedure. It was this circumventing of the normal process that created much of the discontent.

The bill is an attempt at tort reform. Each state would have the option of offering the "no fault" option, and the consumer would also have the option to participate or not. There was nothing mandatory in this bill. Language was included in two separate sections of the bill that would exempt motorcycles, described as "any vehicle with less than four weight bearing wheels." The bill is not going anywhere this year as it does not have time to get through the House even if it passes the Senate. As a courtesy to the sponsor it may get a cloture vote (a parliamentary procedure to end debate and have an immediate vote). This would give the sponsors an accurate measure of support for the proposal for possible activity next year; however it will have to start the process over again and will face the committee process.

### **Intelligent Transport Systems**

On this issue we have been keeping abreast of developments in the US, whilst forming a Working Group of our members.

We have asked the European Parliament and Commission to ensure that where cars are equipped with "detection" systems (anti-collision), these systems must recognize the presence of small vehicles. We don't want to be rammed by cars driven by people who are not paying attention because electronics are making all the decisions. We also demanded that privacy of individuals is protected and that any systems installed for fee collection are anonymous.

We found that Taiwanese authorities are arguing quite strongly that motorcycles must be a part of such systems (details available) whilst our WG members have produced a number of briefing documents.





### Legal Protection of Designs

Though final votes have yet to be taken, it looks like we've finally come out OK on this one, that is, we've achieved equality of treatment with car drivers. But for a while there it looked as though car drivers would be able buy half-price replacement wings, lights, windscreens (or other common repair parts) from a non-OEM supplier who copied the original design.

However some common motorcycle repair parts could not have been copied for a full 25 years, so we would have only been able to buy the full-price OEM part. Cheaper pattern parts (e.g.. fairings) simply wouldn't have been available. Imagine what an increase in monopoly pricing would mean to insurance prices, repair bills, and the profitability of stealing bikes.

The discrimination was not intentional, the problem was with the definition of a "repair part." The situation would have exacerbated the current situation: we know of cases where a European OEM producer has threatened court action against an aftermarket producer.

The new agreement is that there will be no European harmonization just yet, but that any change in national (read State) law must be in the direction of market liberalization. That's OK for us.

We thought we were beaten many times on this one, but our final (fingers crossed) success shows that it is worth going that extra mile for your aims.




### Vision Zero

This is the new approach to road safety aiming for zero deaths and serious injuries from road accidents. The Swedish originators have already admitted that motorcycles are not compatible with the theory and want bikes banned. They since stepped back from these alarming remarks, but nevertheless the policy is in place.

We believe that removing every element of risk from life is a dangerous threat to the enjoyment of every human being and perverse to basic human instincts. This idea is totally unrealistic and will lead to an abnormal society.

This approach is already being accepted in Holland and Norway, with the Norwegian bikers, represented by NMCU, taking the same approach as the Swedes in trying to make the system work for the good of bikers. We should all keep a keen eye on this one. The Swedish scientist responsible for the theory (Claes Tingvall) has just started work in Australia.



### The past year in Europe

Before I tell you what we've been working on in the last year, I want to bring your attention to the United Nations agreement signed on 25 June committing world economies to global vehicle standards. Our efforts to maintain enjoyable motorcycling for our children goes global. Check out the MRF White Papers where we take at look at EU legislation and try to identify what is and what isn't a global issue.

The big happening for European riders' rights was the amalgamation of FEM and EMA to become FEMA. I know it is the name for the US Federal Emergency whatever, but it's a small world, and besides, it feels like we are sometimes dealing with federal emergencies! We are now 22 national organizations of 17 countries and have embarked on a program of developing the movement to deal with the challenges that lie ahead.

Although there is still no riders' rights organization in Spain, riders of most EU applicant countries of Central and Eastern Europe are getting organized (e.g. Poland, Hungary, Slovenia) and there is a new organization in Croatia.

The 1998 Fun Bike Ride with Members of the European Parliament went well, sponsored by Harley Davidson, Hein Gericke and Shoei, with several of the 30 staff and Members exclaiming that it was the best Parliamentary session so far. Relations with the transport section of the European Commission (the EU bureaucracy) are improving further, with funding approved this year for planning the 1999 Young Rider of the Year Event, which FEMA is helping to organize with the FIM and producers association ACEM.

The current hot legislative issue for us is the End of Life Vehicles Directive. It was written for cars, but the bureaucrats included bikes because their brains were unable to comprehend the intrinsic difference between cars and bikes. Motorcycle recycling is, in our opinion, inherent in motorcycle use, and there is no need for a Directive. Cars maybe, bikes no. If we accept this one, our love of dismantling and rebuilding from a range of parts could be dependent on the issue of a certificate of destruction, and our breakers could be wrapped in unnecessary red tape.

Classic owners may have frames awaiting restoration taken away for destruction, and big brother might pop around at any time to ensure your vehicle is stored how they want. FEMA is arguing for 4 things: - exclusion from directive apart from basic environmental requirements for breakers (details on request) - a 100% rebuild clause (you can build your own bike from 100% re-used parts) - a collectors clause whereby those who store old vehicles will not incur a cost - and a new study including a full environmental appraisal of motorcycles (taking into consideration not only the fuel consumption and emissions, but also raw materials and energy used in manufacture, transportation to the market, use of parking space, congestion causation, and all the other things that are conveniently ignored.)

We're busy lobbying Members of the European Parliament in preparation for the serious talks in the autumn.

30 Sept. 1998

Yesterday in Brussels the Transport Committee of the European Parliament supported the proposal by Brian SIMPSON MEP (PSE/UK) to exclude two and three wheeled vehicles from the End of Life Vehicles Directive.

A further amendment by Antoine-Francois BERNARDINI(PSE/F) supported the position taken by SIMPSON.

Another SIMPSON amendment says "vehicles intended for museums or classed as vintage vehicles preserved by museums or private owners shall be excluded from the provisions of this directive."

This opinion will be taken into considered by the Environment Committee when it examines the Directive in detail next month. Motorcycling organizations are campaigning for exclusion from the Directive due to serious fears of steep price increases and restrictions on home recycling.

All motorcyclists are strongly advised to contact their Members of the European Parliament on this issue.



### Clothing Standards

We were working within a coalition of bike and clothing producers, the FIM and its professional lobbying group EPPA in an effort to stop clothing standards. The existence of standards could have easily lead to compulsion.

A series of mistakes by some members of the coalition, not us nor FIM itself, resulted in our work being run out of time, but we were offered a compromise by the bureaucrats. That is, to change the scope of the standards to cover professional use only (emergency services, dispatch riders, police perhaps). This was accepted by FEMA members provided that a clear definition of professional use was included.

It is not nice being held hostage to a bunch of safetycrats who have nothing better to do, and commercial interests of testing houses who want as much business as possible. Coupled with European Commission ambiguity which tells you what you want to hear depending on who you are, and a lack of motivation to bring local rider pressure to bear on the British Standards Institute, we had no choice. It was either for professional or all road riders.

Compromises stink and we hope insurance companies won't try to apply the standards to road riders. In the meantime clothing producers are expected to produce a voluntary quality label for road riders' clothing. It will be

a barrier to future attempts to expand the scope to cover road riders, and help to deal with rogue producers who mislead consumers.

Another lesson learnt for us, when it is important, do it yourself.

much as 40 years and fined up to two million dollars. I don't know about you but I can't afford that kind of time or money. Livingston, NI: October was the start of this state's new MOTORCYCLE MOUNTED PARAMEDICS! Twelve of 'em from the Saint Barnabas Health Care System will share in the use of two BMW motorcycles set up for emergency medical care. The idea is that ambulances don't do very well fighting congested traffic. Scooters can cut through the traffic better, and these biker paramedics can start lifesaving procedures a lot more quickly than an ambulance. Many lives will be saved by this innovative idea. It's been in use in Asia for some time now with great success. Isn't it great when Joe citizen realizes scooters are good for something besides running over! New Hampshire: At the Republican Party Convention here, the GOP adopted these items as part of their platform: 1) To support the right of all adults to freely choose the use of seat belts and helmets; 2) Oppose any legislation to further restrict the rights of law abiding citizens to own firearms and to justly defend themselves, their families, and their property; and 3) Repeal any existing legislation which is inconsistent with the second amendment rights of the constitution. Maybe there really is light at the end of the tunnel and it's not just a figment

OREGON: Here's another real victory, folks. Ken Ray, a delegate to the Oregon GOP convention, and Bob Avery (a.k.a. Bagger Bob), managed to get HELMET language included in the Oregon GOP platform! Listen to this: "We believe Oregon citizens are as responsible as citizens in other states in making free choices in transportation options. Therefore we call for raising Interstate Highway speed limits in lower density areas and removing helmet and seat belt requirements for free citizens" Congrats to the hard work of bikers in the Oregon Republican party. Washington DC: Just this last week I saw a picture of research taking place involving the AIRBAG device on a Honda Goldwing motorcycle. The picture was in a recent newsletter from the MRF. I've been screaming about this for more than three years, and now it's in our face. I first saw this at an NCOM (National Coalition of Motorcyclists, for the uninitiated) convention several years ago, when representatives from Europe showed us video tapes of testing that was going then in "Jolly Olde England." I have a copy, if there are any interested groups out there that would like to see it. We'd better pay attention to what's going on across the pond.

Pennsylvania: We've been reporting on these developments for several months now. The latest: Ex-trooper Gerald Devlin's appeal was postponed until November 25th. He then will attempt to show why his inappropriate high speed chase was justified and why he shouldn't be fined, even though biker Ken Fowler lost his life because of it. If this individual should prevail in this case he could conceivably sue the state and get his job back. It wouldn't be the first time such shenanigans have taken place in our justice system. The Pennsylvania bikers are keeping us posted, and so will I.

UNITED ARAB EMIRATES: Ten days in jail and 50 lashes if you're caught speeding on your scooter here. It's part of a crackdown on road racing and speeding, because fines don't

appear to be enough of a deterrent for speeders. It's plenty for me folks. I have a very low tolerance for the kiss of the lash.

OREGON: Big Brother strikes big time. Some weird stuff here, friends. Seems Portland's finest are now sending out "Gang Affiliation" notices to known patch holders; or at least to one of them, so far. If you're wearing a 3-piece patch, they pretty much just conclude you are a member of a CRIMINAL GANG! They've set up this funky procedure where you can challenge the designation. Turns out all you contest is whether you ARE a member. You CAN'T challenge their assumption that your club is a criminal gang. Sam Hochberg, our Oregon AIM Attorney, is taking the case on, along with civil rights lawyer Spencer Neal, a.k.a. Spike. Sam and Spike are still in the early stages of looking at this. I'll be following this story, so stay tuned.

Reminder: Our Oregon Aid to Injured Motorcyclists (AIM) attorney Sam Hochberg can be reached for any legal questions at 503-224-1106, or 1-800-347-1106. He's also Sambikelaw@aol.com. Sam will always talk with you, and if he doesn't do the kind of legal work you're calling about, he will generally find you someone he trusts who does. Through the AIM program, we also now provide criminal representation, although Sam doesn't do that himself. Sam will fill you in on that aspect of the AIM program. Access to Aid to Injured Motorcyclists is always 24 hours a day, at 1-800-On-A-Bike, or 1-800-531-2424.


Sam's AIM Tip O' the month: Just a few short words this month on traffic infractions: These little tickets won't send you to jail, but they'll eat up your pocketbook. Know that if you are convicted in most SMALLER courts, like a little Justice Court or Municipal Court, these are usually NOT full-blown courts, in that any conviction is always appealable, with an appeal bond,

to a regular State Circuit Court in that county. So, if you get stuck in a podunk court, know that you can always appeal to the chief podunk court. Check the time limits on that with the local court clerk.
