

# Frequently **Asked Questions**

#### What is A.B.A.T.E.?

We are a State Motorcycle Rights Organization (S.M.R.O.) dedicated to educating riders, drivers, and elected officials about issues affecting motorcyclists.

We help fund a political action committee (BikePAC) that directly interacts with the legislature about motorcycles issues and bills that affect us.

#### What does A.B.A.T.E. do?

We promote motorcycle awareness, education, safety, and liberty through community involvement and legislative action.

Chapters hold monthly meetings to share information and socialize. They also plan and put on runs, campouts, swap meets, and other activities to generate operating funds.

#### What does "A.B.A.T.E." mean?

A.B.A.T.E. stands for A Brotherhood Against Totalitarian Enactments. The organization was formed when legislators passed bills adversely affecting riders without consulting them.

We also do business as A Brotherhood Aimed Towards Education.

#### What is BikePAC?

Founded in 1988, BikePAC members track legislation, brief officials, and report to A.B.A.T.E. about issues affecting motorcyclists.

# A.B.A.T.E. and BikePAC Legislative Victories

**1977** – Oregon helmet requirement repealed.

1979 – Rider safety program proposed by A.B.A.T.E.

**1981** – *Team Oregon* rider safety legislation passed.

1988 – Voter referendum reinstates helmet require-

BikePAC formed for motorcyclists' legislative efforts.

**1995** – Motorcycle helmet definition standardized. (HB-3422)

1997 – Adult helmet freedom of choice bill passed, vetoed by governor.

**1997** – Federal court equates federal testing standards with Oregon helmet definition.

1999 – Motorcycle handlebar height regulation repealed.

2001 – Riders given choice to fuel bikes at service stations. (HB-3885)

#### 2001-2013

Hostile capitol environment to motorcycle legislative efforts.

**2015** – "*Dead Red*" bill passes. (SB-533) Riders allowed to proceed if light not triggered after one cycle.

2017 - Reckless drivers held accountable for motorcyclist harm. (HB-2598)

2021 – You assist in getting legislation passed that benefits Oregon motorcyclists.

Legislators didn't give motorcyclists these victories. We had to work hard together to gain or regain our rights.

- Rick Prentice did not receive full minutes from October meeting.



# **Executive Board Officers Reports**

**Coordinator** – Troy Stevens Introduced Mel Yeager and Don Mason for *BikePAC*.

#### BikePAC report:

Mel has been dragged back in as treasurer.

Looking for new *BikePAC* treasurer and membership person.

A.B.A.T.E. is main supporter of BikePAC.

When matters need to be decided at the state capitol, *BikePAC* represents motorcyclists. They are able to respond within a day or within a few hours if needed to contact legislators or even visit the capitol if needed.

Like all organizations around the world, *BikePAC* enthusiasm is diminishing. If *BikePAC* is to operate next year, they need to add two officers.

Don Mason with Paula have drafted an article to be published in the state newspaper asking urgently for two officers: secretary along with combined membership and treasurer. They will not have a quorum to go forward starting in January without those offices being filled. Without an executive board, they cannot operate. They cannot vote or spend money.

Most people are running around with face masks. Legislators are not meeting in person.

2020 has not been an Oregon legislative year, so it has been difficult, but not devastating.

Next year, 2021 will be important for us to have representation in Salem at the capitol.

\$2,200 is in the general fund.

Most of the money in the legislative account is still there because it was not used this year.

It costs us about \$5,000 to get a bill through the legislative process. There are six months of expenses. (Parking, cell phone, use of room at the capitol, etc.)

Karen has reported that *A.B.A.T.E.* paid \$5,000 for 2020.

Earliest we can donate to *BikePAC* again will be 01 January 2021.

Legislatively *BikePAC* will be pushing for the lane sharing bill unless *A.B.A.T.E.* membership comes up with something more urgent.

Lane sharing affects the largest districts ie. Portland.

Patty McQuinn (Portland-D) has retired. A republican has filled this seat.

Thank you, Karen, for stepping in during my absence today.

A couple things:

1. I have completed the first step to updating Duffy's Road List. (See attached draft.)

We currently have 31 confirmed folks who can help a stranded motorcycle rider in an emergency.

Thank you to all of you who got back to me and are still able to do this service.

There were 45 names taken off the list due to multiple reasons.

Lincoln County added four names, which brings our total up to 35.

## **Our Greatest Gift**

## "always" is better than "never"

One of the greatest gifts we can give to others is the investment of our energy into things we care about.

Just look at common everyday objects around you. Notice how they are made. There are no sharp corners to jab or injure you. Someone cared enough to design them that way. They invested a bit of themselves so that people they would never meet would have slightly better lives.

Half a century ago in the middle of this month, a person who would become yer crusty ol'editor reported to the Armed Forces Induction Center in Portland. # Bikers Brave Pandemic For N.C.O.M. Convention

Although smaller than normal due to the Covid-19 threat, the rescheduled *N.C.O.M.* convention held 16-18 October in Indianapolis succeeded in being there for those dedicated freedom fighters who were determined enough to brave a deadly health crisis to be here for each other, explained a masked *N.C.O.M.* chairman James "Doc" Reichenbach.

Legal and legislative seminars and roundtables were socially distanced but fairly well attended, considering the dire circumstances. Seats at the dinner tables were mostly filled for the *Silver Spoke Awards Banquet* to honor bikers rights activists such as:

- Author and filmmaker John E.
   "Black Dragon" Bunch II.
   (Entertainment)
- Jad Breiner (Sons of Silence Motorcycle Club) editor of Brothers Behind Bars (B.B.B.) newsletter. (Media)

- N.C.O.M.'s Ron Roloff Lifetime
   Achievement Award presented

Dates and location for the 36th annual *National Coalition of Motorcyclists* (*N.C.O.M.*) convention in 2021 have yet to be finalized, so stay tuned for further details as they are announced.

# California First State To Ban Gas-powered Vehicles

Governor Gavin Newsom announced that he aggressively moved California further away from its reliance on climate change-causing fossil fuels by issuing an executive order on 23 September mandating that all new passenger vehicles be zero-emission by 2035.

His historic action will require all passenger vehicle manufacturers to shun internal combustion engines and fully electrify their line-up, meaning that manufacturers who wish to continue to sell in the Golden State will only be allowed to sell new electric cars and pickups after the deadline.

Motorcycles are not included in the definition of passenger vehicles, but the order does contain a clause to achieve 100 percent zero-emission from off-road vehicles and equipment operations in the state by 2035, which would presumably include all new A.T.V.s and dirt bikes.

The executive order only applies to the sale of new vehicles and will not prevent Californians from owning gas-burning automobiles or selling them on the used car market.

"This is the most impactful step our state can take to fight climate change," said governor Newsom as California has become the first U.S. state to join with fifteen countries that have already committed to phase out gasoline-powered vehicles.

## A.T.V.s Get City Street Approval

Off-road tourism got a boost with news that a city has opened its streets to side-by-side and A.T.V. traffic.

In central Wisconsin, the Tomah police department reports on its *Facebook* page that A.T.V./U.T.V. routes within the city of Tomah are now legally opened for operation and use.

Some key points related to A.T.V./ U.T.V. operation within the city of Tomah:

- Unless otherwise posted, the routes within the city include all roads with a speed limit of 35 mph or less.
- A.T.V.s and U.T.V.s may only be operated on approved routes from 6 a.m. to 10 p.m.
- Operators must be 16 or older and possess a valid license and proof of insurance.
- All other state statutes related to the use and operation of an A.T.V./ U.T.V. are applicable.

# Innocent Biker's Persistence Nets New *Harley*

The Texas biker may have deserved a speeding ticket, but he didn't think the traffic stop warranted questioning, roadside investigation, pat-down search, or enduring an hour of detainment along the roadway waiting for a drug-sniffing dog to arrive on the scene, resulting in inconvenience and embarrassment because a police officer had guessed wrong.

Statistically, police are terrible

at determining which motorists are worthy of being detained and searched, often relying on signs of a driver's deception such as twitching, fidgeting. or lack of eye-contact, all of which research has long debunked as signals of lying.

There are no non-verbal and verbal cues uniquely related to deceit, a 2011 review of deception research concluded, while a 2005 study of Texas police found officers performed barely above random chance in being able to discern a person telling the truth from a liar.

Texas police performed just under a million searches during traffic stops last year, according to figures reported to the Texas commission on law enforcement. Though hit rates vary by department, only about one in five resulted in contraband being found.

Yet Texas enforcement agencies seized about \$50 million in forfeited funds in each of the past five years, with proceeds split between police and prosecutors and used to fund more searches.

Police once needed probable cause that a crime was occurring to investigate motorists during a stop.

But in 1968, the U.S. supreme court allowed brief stops based on a lower standard of reasonable suspicion of wrong doing.

A later decision clarified that if the officer can't specify why he suspects a crime is afoot, a traffic stop may last only long enough to check the drivers paperwork and write a ticket

or warning.

Most recent national analyses of traffic stops have focused on the disproportionate rate of police searches of black and hispanic motorists, though a federal measure currently under consideration in congress could add motorcycle riders to that profiling study group.

And so this biker was relieved to finally be allowed on his way with just a ticket, but knew it wasn't right and figured his motorcycle club vest must have raised the officers suspicions.

Innocent people rarely protest meritless searches, so finding an attorney to take his case was difficult. The overwhelming number of legal challenges occur in suppression hearings, when an officer's suspicions were correct. (Contraband was discovered and the defendant seeks to have the evidence tossed on procedural grounds.)

With the help of an Austin attorney who represents motorcyclists, the angry biker filed a lawsuit against the Texas trooper in early 2019. Soon after reviewing the dash cam video, lawyers for the Texas attorney general's office said they were ready to settle.

# Motorcycle Club Sues County For Event Cancellation

The East Bay Dragons, founded in the 1950s as the first all-

black motorcycle club to exist in California's bay area, has filed a federal lawsuit against Solano county alleging they concocted a reason to cancel a planned club event at the fairgrounds after hearing that one of the clubs members had an association with the *Black Panthers*.

Still in its early stages, the suit claims that the *Dragons* planned a 60th anniversary event at the Solano county fairgrounds in Vallejo, but the event was canceled at the last minute, after the *Dragons* had spent thousands in fees and planning.

According to the lawsuit, trouble for the planned August 2019 event started when a county employee learned that a member of the *Dragons* owned a bakery in Oakland, proudly located at the site of the *Black Panthers* first headquarters

The suit claims all of this was a problem for the county employee, who allegedly remarked that the *Black Panthers* were the greatest threat to the internal security of the country, and started working to cancel the *Dragons* event. As a result of this, the suit alleges, fairgrounds staff invented the ruse that there was a credible threat to the safety of the event, but there was no credible threat at all.

This insidious belief of *E.B.D.*'s threat traveled all the way to Oakland and with the help of the Oakland police department, at the conclusion of the 60th anniversary celebration on 02 September 2019, the *E.B.D.* were surrounded by Oakland police department officers due to racist motives, the civil complaint says.

In East Oakland, the biker club is beloved, says councilman Larry Reid, who said their clubhouse in his district has distributed food on Thanksgivings and toy drives during Christmas.

# Transportation Report: Motorcyclists Danger To Themselves

A transport consultation released by the Oxford county council has branded motorcyclists as pollution-emitting liabilities to safety. The paper outlines transport and connectivity plans, which are clearly biased against motorcycle riding, and goes to great lengths to champion bicycles, walking, and public transportation.

Rather than just side with pedal power and walking, the public document goes on to set a worrisome precedent by labeling motorcycles and their riders as dangerous polluters. Just two of the antimotorcycle statements read, "Statistical evidence suggests motorcyclists are a danger to themselves," and "Motorbikes are mostly still using fossil fuels to run, meaning they are environmentally unsound, not sustainable, and contribute to air pollution."

The *British Motorcycle Federation* (**www.BMF.co.uk**) has now picked up the case and are chasing the council to have the anti-biker rhetoric dropped from the official paper.

"The Oxfordshire transport panel have cynically used the current Covid-19 crisis to attempt to force through the adoption of this outrageous transport plan," charged B.M.F. chairman, Jim Freeman, further stating that "The B.M.F. urge all members to be especially vigilant at this time in scrutinizing local authorities and other bodies who may use this crisis to bury news concerning similar discriminatory attitudes and moves."

# A.I.M. Expo, I.M.S. Postponed Due To Coronavirus

Following a meeting of the M.I.C. (Motorcycle Industry Council) board of directors, the difficult decision was

made to postpone the 2021 A.I.M. Expo, the industry's annual trade show to 2022 due to Covid-19 directives limiting gathering size, travel restrictions, and a myriad of other obstacles created by the pandemic. "There are too many unknown factors limiting our ability to create a safe environment that will also deliver the experience and R.O.I. our exhibitors and attendees expect."

Likewise, the *International Motor-cycle Shows* (*I.M.S.*) have announced that its annual November through February winter tour across the U.S. has been canceled as a result of Covid-19 and the risks involved with large crowds at indoor venues. In its place it has launched *Progressive I.M.S. Outdoors*, revamping the tour's nearly forty-year stint to transition from the traditional convention center setup to a new open outdoor experience to take place between May and September of 2021.





## Clip This Corner, **Avoid A Helmet Ticket**

IT IS HEREBY ADJUDGED AND DECLARED that Oregon House Bill 3422 means that as long as a motorcycle rider is wearing a protective covering on his head that has a hard outer shell, padding adjacent to and justice the outer shell and a chin-strap retention system with a sticker indicating that the motorcycle belinet meets standards established by the United States Department of Transportation the rider is in compliance with state law with respect to his helmet and a police officer may not inquire further to determine if the helmet worn meets United States Department of Transportation testing standards.


