We help fund a political action committee (BikePAC) that directly interacts with the legislature about motorcycles issues and bills that affect us.

What does "A.B.A.T.E."mean?

A.B.A.T.E. Stands for A Brotherhood Against Totalitarian Enactments. The organization was formed when legislators passed bills adversely affecting riders without consulting them. We also do business as A Brotherhood Aimed Towards Education.

What is **BikePAC**?

Founded in 1988, BikePAC members track legislation, brief officials, and report to A.B.A.T.E. about issues affecting motorcyclists.

STATE COORDINATOR


As I keep seeing articles about Martha's Vineyard. I can't help but think about the time I spent there. It was the summer of 1990, in the middle of August.

I was all excited to be camping on the island for six days. I booked my camp site at the only camp ground on the island a month in advance. The ferry ride to the island was long. I talked to many people on the ferry. Most of the people I talked to were going to the island for work. I thought it was odd that they didn't live there. I found out later that they could not afford to live on the island with the wages they were paid.

As I rode my Suzuki Cavalcade and pulling a cargo trailer off the ramp of the ferry, a police officer motioned for me to park the bike. His first words to me were. Where are you heading to on my island. I told him the name of the campground. Then he asked what is your business for being on the island and how long will I be staying for. As I talking to him I was still excited about being there. He then looks over the bike and trailer. He tells me that my trailer needs to have a license plate on it. He then asked for all my information, "license, registration, proof of insurance" As I am getting all of this for him, I am trying to explain to him that in Oregon you do not need to license a trailer under a certain size. As long as the vehicle pulling the trailer is licensed in Oregon. He said their is no such law like that. He then goes to his patrol car to run my info. It seemed like an eternity. He then came back and told me to go straight to the campground and park the trailer. He said, if I see that trailer on the island before you leave I will have the motorbike, and trailer confiscated. That was my first time of ever being treated like a second citizen but I did not want to let that experience ruin my trip.

So off to the campground I went, still with a smile on my face. I pulled up to the office at the campground. By the way the name of the campground is, Martha's Vineyard Family Campground.

At this time in my life, I was still in the military, had a short hair cut, did not wear leather motorcycle gear. In fact I was wearing jeans and a nice button up shirt. So into the office I go. I put the reservation on my credit card the month prior to me coming to



the campground. So everything was already paid for all I had to do was sign for the stay. The receptionist informed me that the police officer called them to confirm my reservation. After I got everything signed they showed me where my sight was on the map. Then told me that I can not ride my motorbike into the campground. I had to park it across the road in employee parking. I was stunned, speechless, dumb founded. I asked them why is that. All they would say is that's the rules of the park. I pleaded my case with them. Stating that it's not a loud Harley-Davidson. That It's quieter then most cars. I even tried to talk them into just letting me ride it to my camp site to pull everything out of it and to drop off the trailer. Nope not even to drop off the trailer. Now I am getting upset at this point. I thought f*** them I'll just leave the island. I asked for my money back and they refused to refund me any of it. So I stayed on the island. I tried to make the best of my time there. I can say I was the only biker on Martha's Vineyard that I seen.

I found out after buying some food and alcohol on the island why those workers did not live on the island. I can say in 1990 I paid \$28 for a half case of Budweiser. \$6 dollars for a gallon of milk. All the food was outrageously expensive. Nothing was cheap on the island. The locals made me feel like I was an illegal alien from a foreign country.

So where am I going with this story? I know living here in Oregun us bikers do not have this problem of being discriminated against, or profiled like I had happen to me on Martha's Vineyard. It is a problem in many area's of the United States, and other Countries around the world. We as ABATE members, need to make sure that this (profiling) never comes back to Oregon. Just because I ride a motorbike does not mean I carry a gun, or that I am out to hurt anyone. I do not drink or do drugs. (It's been 22 year's that I have been clean, and sober.)

Just because you ride a motorbike should not make you, or anyone out there into being labeled a bad guy. (You can put your own interpretation of a bad person here.)

We should not tolerate Abate of Oregon as being labeled racist, or a Nazi group. Our organization is not about being a part of any of those types of organizations, nor any other type of hate group.

Abate is an organization that is against totalitarianism enactments. We need to make sure that this never becomes an issue in Oregon again.

HOW CAN WE DO THAT YOU ASK?

Good question. If you feel you have been labeled or profiled, or know of someone that has been, you should contact me or your State Board Representative for your Chapter. You and A.B.A.T.E. can take this to BikePac of Oregon. From there we can see if it has merit. With out it being documented we have no action. If we let stuff like that go on and on we will only have our selves to blame. We will loose all of our rights that we have worked so hard for.




We have big planes for next year. Thank you to all that did come out with your bikes and those that helped.



Get in as much riding as you can now, I feel we may see wetter and colder conditions this winter. Clean those bikes, change oil and always check your bike over before you ride, it may save your life.



Our next Chapter Executive Board Meeting will be on November 22nd at Round Table Pizza at the corner of SE Holgate & Foster Rd.








Two Rivers Chapter



Veterans Day honors all of those who have served the country in war or peace — dead or alive although it's largely intended to thank living veterans for their sacrifices., commemorating the end of World War I.

For some inexplicable reason, the bill set Veterans Day commemorations for the fourth Monday of every October. On Oct. 25, 1971, the first Veterans Day under this new bill was held. We're not sure why it took three years to implement, but not surprisingly, there was a lot of confusion about the change, and

many states were unhappy, choosing to continue to recognize the day as they previously had — in November.

Within a few years, it became pretty apparent that most U.S. citizens wanted to celebrate Veterans Day on Nov. 11, since it was a matter of historic and patriotic significance. So on Sept. 20, 1975, President Gerald Ford signed another law (Public Law 94-97), which returned the annual observance to its original date starting in 1978.

Other countries celebrate it, too, in their own ways.

World War I was a multinational effort, so it makes sense that our allies also wanted to celebrate their veterans on Nov. 11. The name of the day and the types of commemorations differ, however.

Canada and Australia both call Nov. 11 "Remembrance Day." Canada's observance is pretty similar to our own, except many of its citizens wear red poppy flowers to honor their war dead. In Australia, the day is more akin to our Memorial Day.

Great Britain calls it "Remembrance Day," too, but observes it on the Sunday closest to Nov. 11 with parades, services and two minutes of silence in London to honor those who lost their lives in war.

Thank you for your service.

<u>World War I</u> officially ended when the Treaty of Versailles was signed

on June 28, 1919. However, the fighting ended about seven months before that when the Allies and Germany put into effect an armistice on the eleventh hour of the eleventh day of the eleventh month.

For that reason, Nov. 11, 1918, was largely considered the end of "the war to end all wars" and dubbed Armistice Day. In 1926, Congress officially recognized it as the end of the war, and in 1938, it became an official holiday, primarily a day set aside to honor veterans of World War I.

But then <u>World War II</u> and the <u>Korean War</u> happened, so on June 1, 1954, at the urging of veterans service organizations, Congress amended the commemoration yet again by changing the word "armistice" to "veterans" so the day would honor American veterans of all wars.

For a while, Veterans Day's date was changed, too, and it confused everybody. Congress signed the Uniform Holiday Bill in 1968 to ensure that a few federal holidays — Veterans Day included — would be celebrated on a Monday. Officials hoped it would spur travel and other family activities over a long weekend, which would stimulate the economy. page 17

As motorcycling technology continues to advance, your ability to repair your own motorcycle or seek out an independent mechanic may get restricted as manufacturers do not make repair information or parts available for purchase.

Consumers are facing this problem with almost every product they own, from their phone, to their tractor and for AMA members, their motorcycles and ATVs. This issue is collectively known as "Right to Repair" and put in the

simplest terms, right to repair is the idea that when you buy something, you have the right to repair it or seek an independent repair shop to do the work and as part of that the manufacturers must make the parts and information needed for these repairs available to the public for a fair and reasonable price.

Fortunately there is a bill in the U.S. House of Representatives, the REPAIR Act (Right to Equitable and Professional Auto Industry Repair), H.R. 6570, that would ensure that motorcyclists and independent repair shops have access to the information, tools, and parts needed to repair motorcycles.

The AMA is asking you to tell your Representative to co-sponsor this bi-partisan bill and protect your right to repair.

Support your right to repair in Congress

If you would like to learn more about Right to Repair, you can read the Federal Trade Commission Report to Congress from May 2021 "Nixing the Fix" which details the ways some manufacturers limit repairs by consumers.
