Following Covid 19 we understand that everyone went through a very hard few years. Once again we will be waiving the usual vendor fee and ask only that you pay the event entry fee for each person that you bring in. Entry fee is \$45 for Abate members and \$50 for non-members. This is for a 12x12 space. Additional space is \$20 per 12x12 area.

You are responsible for a \$100 clean-up deposit which will be returned when your area is inspected.

Vendors are responsible for providing all equipment needed to conduct business. Tables, chairs, power source, etc. are the responsibility of the vendor. Potable water is available on site. Disposal of garbage into the provided dumpster is the responsibility of the vendor. Garbage bags will be available at the information booth. A.B.A.T.E. of Oregon, Inc. will not be held responsible for any aspect of your business. There is no guarantee of attendance – attendance volume is subject to weather.

All Food Vendors are responsible for any permits, licenses, and city, state or county fees applicable to their businesses.

Please be prepared to make a donation for the door prize drawing. This is a good way to advertise your product and help A.B.A.T.E. to continue having this event.

Vendors using generators need sound-deadening boards. This is a courtesy to other vendors and campers.

No solicitation allowed in camping areas.

No electricity will be provided.

Potable water is available on site.

Vendors will not be admitted to site prior to 9 a.m. Thursday of the event.

Pre-registration by April 30th assures your space. You will receive (by mail) a placard to place on your windshield which will enable you priority access to the grounds on set up day (Thursday).
